CONSTITUTION.

ARTICLE I. This body shall be styled the 'ARKANSAS BAPTIST STATE CON-VENTION.''

ARTICLE II. The Baptist State Convention shall be composed of Messengers from Baptist Associations and Baptist Churches, on presentation of proper credentials or satisfactory evidence of their appointment.

ARTICLE III. Associations shall be entitled to five messengers and Churches to three, and the State Central Committee of the Ladies' Aid Society shall be ex-officio members of the Convention.

C.

ARTICLE IV. It is distinctly understood that this Convention shall have no ecclesiastical jurisdiction, nor in any way interfere with the Constitution of any Church or Association.

ARTICLE V. The object of this Convention shall be to supply the destitute regions within its bounds with the unadulterated Word of Life, and a living ministry, and to aid by appropriate and Scriptural means all destitute and feeble Churches, and also supply communities with such books as may be approved by this body, and as may be thought best c ilculated to communicate information as to the distinctive doctrines and ordinances of the Gospel of Chr st as received by our denomination, and to aid and encourage Ministerial and Gospel and General Education, Missions and Sunday School Work, and to gather denominational statistics.

ARTICLE VI. The Convention shall elect by ballot annually a President, two Vice-Presidents, a Secretary, Assistant Secretary and Treasurer. Also appoint one brother from each Association and thirteen other brethren who shall compose the Executive Board, seven of whom shall constitute a quorum; said Board to hold office until their successors shall be appointed.

ARTICLE VII. The Convention shall convene on Friday before the first Sunday in November, each year.

ARTICLE VIII. This Constitution may be amended at any regular meeting of the Convention, two-thirds of the members present concurring in the measure, except the fourth article, which shall forever remain unaltered.

PROCEEDINGS.

CONWAY, ARK., Friday, Nov. 3, 1893.

The Convention was called to order at 10 A. M. by J. M. Hart, President W. E. Penn led 14 singing, "How Firm a Foundation," and W. P. Throgmorton read a selection from Romans 12, when W. E. Penn led in devotional exercises. The Chair appointed as a

Prof. A. G. Robertson, of the Southern Baptist Theological Seminary, was by unanimous consent, allowed to present the wants of the Seminary whilst the Committee on Credentials were preparing its report.

A subscription was taken in aid of Ministerial students at Louisville amounting to \$244.90.

AFTERNOON SESSION.

After singing, the body was called to order. Prayer by M. M. Riley.

The election of officers was declared the order of business. W. E. Penn was nominated for President; also W. P. Throgmorton, W. E. Atkinson and A. W. Files. On motion of J. G. B. Simms, it was ordered that the brother receiving the largest number of votes be President, and the one the next highest number First Vice-President and the one the next highest number Second Vice-President J. C. Wright, J. J. Haynes and W. H. Cash were made tellers. The ballot having been taken was spread and W. P. Throgmorton having received the highest number of votes was declared elected President of the Convention A. W. Files having received the second highest number was declared First Vice-President, and W. E. Penn receiving the next highest number was declared Second Vice-President of this body.

Nominations for Secretary being in order, J. G. B. Simms, T. S. Potts, W. F.-Blackwood, W. Theo. Smith, H. Beauchamp and J. H. Amacker were named. T. S. Potts withdrew his name and J. G B. Simms asked to be relieved from further duty, after having held the position four years. The ballot was called for and W. T. Box, J G. Doyle and W. P. Kime were appointed tellers On motion ordered that the candidate receiving the second hignest vote shall be declared Assistant Secretary. The ballot was spread and W. F. Blackwood and J G B. Simms were declared elected respectively as Secretary and Assistant Secretary of the body.

W. P Throgmorton then came forward and took the Chair as President-elect of the body, and made suitable remarks upon the oecasion, which were supplemented by remarks from J. W. Ford, of St. Louis.

Election for Treasurer being in order, W. A. C Sayle declined to serve again, but nominated C. W. Walker, of Little Rock.

On motion, the Secretary was instructed to cast the ballot of the Convention for C. W. Walker, which was done, and he was declared duly elected.

S. H. Ford, by permission, spoke tenderly of the past, and of departed brethren.

A resolution was then offered by W. T. Box, which was refer-

W. P. Harvey, of the Western Recorder, was introduced and addressed the Convention.

S. H. Ford, of the Christian Repository, then made a short address.

F. C. McConnell, Asistant Secretary Home Mission Board of Atlanta, Ga, then addressed the Body.

P. M. Johnson, returned Missionary from Telugu Mission, South India, addressed the body.

Corresponding Secretary of Foreign Mission Board, R. J. Willingham, then addressed the body.

T. P. Bell, Secretary Sunday School Board, of Nashville, Tenn., addressed the body.

Committee on Divine Service was then appointed, consisting of J. G. B. Simms, G. W. Bruce and G. E Hilliard

The Board on Ministerial Education submitted the following:

Your Board desire to make the following report: The past year has been one of great anxiety to your Board in the collection of sufficient funds to meet necessary expenses. We realized the financial condition of the country, which was shown last year, in the meagre pledges at the Convention for this work. We have not been able to pay the expenses of as many young men as we desired. There are a number of promising young men who feel called to the ministry and who are without means to defray their expenses while at college. Your Board has been very careful in the expenditure of every dollar, and we feel that the young ministers who have received aid give promise of earnest, self-denying and willing service in the future.

The entire expense of a young minister at Ouachita for the scholastic year is \$100.00. There are several Churches in Arkansas who are amply able to select a young minister and support him; and your Board earnestly beg that these Churches take this matter under consideration There are some brethren in the State, of ample means, who might support a young minister during the year. There can be no other more effective way of preaching the gospel. There are young ministers now ready to enter college if sufficient funds can be given. Shall we refuse them aid? Let the Convention answer All money is deposited in bank and checked out to the young men, as requested, and all means should be sent through the Board with instruction, if preferred, for whom sent.

The great need of the State today is talented, consecrated, zealous leadership—young men full of missionary zeal, self-sacrificing and humble. We have the native talent and God has laid His hands upon many. Will our Baptist brotherhood not in a tangible way answer the call for the coming year?

M. P Moody then addressed the Convention on the American Baptist Publication Society.

The Committee on Home Missions submitted the following, report, which was adopted:

The continued benedictions of Almighty God upon the work of our Home Mission Board, call forth the profoundest gratitude of all our hearts. The baptisms administered by the Missionaries of this Board last year reached the unusual number of 5 274, and the total additions to the Churches under their charge were 11,247. Among the agencies of this Board our *Home Field* occupies a necessary place, bringing facts and encouraging information about the work in all departments. F. C. McCouncil has been chosen to the office of Assistant Secretary, and already his work among Associations and Conventions is hailed with enthusiastic favor and good will.

Missionary operations are fostered under the auspices of the Home Board in Cuba and among the Germans, colored people, Indians on our own native land; also special efforts are being made in destitute portions of some of our large cities, notably New Orleans, Kansas City, Jacksonville and Knoxville

This Board employed twenty-four Missionaries in the bounds of the Arkansas Baptist Convention last year. As a further reason why we should extend hearty sympathy and earnest cooperation towards this work is the fact that this Board gives dollar for dollar for all we donate toward our State work

The Havana house of worship has been freed from all indebtedness. The financial condition of the work was never better. \$105,481.18 were expended on this work last year. The outlook is most encouraging. The blessings of God are resting on our Missionary work in all lands. We "begin" at Jerusalem, we "go" to the uttermost parts of the earth, according to the commands of our Lord. We cannot unduly press our work at home, for if proper instructions from God's word be given our strength at home will be strength abroad. E. B. MILLER, Chm'n.

The State Mission Board made the following report, and it was adopted:

To the President of the Arkansas State Convention:

The State Missionary Board is competied to report as much of failure as of success during the past Conventional year, and although a statement of our ill-success in the early part of the year, is calculated to cast a gloom over our prospects and to produce pessimistic forebodings of the future, we feel that the Lord has been with us and the last half of the year has been, notwithstanding the unfavorable environments, a success From causes not well understood your Board failed in the beginning of the Conventional year to raise the means necessary to discharge its obliga tions to the Missionaries in the field,

To refer to the various methods to which the Board has resorted in order to keep the S ate work before the denomination, and to raise the needful means to maintain all of our Missionaries actively at work, would be scarcely necessary in this report.

Suffice it to say that of the Missionaries who were in the field and earnestly at work when your Board held its first meeting after its organization, eleven were continued for this year and an additional number was subsequently added equal to two. The names of those who were carried forward from last year are as follows: H. Beauchamp, J. G. Doyle, W. W. Gardner, W. B. Herndon, H. Rhodes Moran, A. I. Minton, L. Quinn, Giles C. Taylor, T. J. Woodard, D. C. Yeargin and C. W. Strickland And the names added subsequently were: J. A. Edmondson and A. W. King.

The State Convertion which met at Fort Smith last year, while it made it the duty of this Board to elect a State Missionary, at the same time released the Board from the responsibility of raising or providing for his salary and at the first meeting subsequent to the adjournment of the Convention, a Missionary or Evangelist was elected, but who after mature reflection, declined to accept and on four subsequent occasions the Board elected an evangelist for the State work, but neither one of whom were induced to accept the work and from that time forward, or from April 4th last, finding no suitable man in the opinion of your Board who would engage in the work they ceased to make further effort in this direction. \tilde{c}

MISSIONARIES AND THEIR WORK FOR THE YEAR

H. Beauchamp held 325 services, paid 730 visits, had 37 additions and collected \$588.50.

J. G Doyle held 226 services, paid 346 visits, had 25 additions and collected \$350.

D. C. Yeargin held 75 services, paid 360 visits, had 24_{11} pdditions and collected \$105.

T. J Woodard held 53 services, paid 122 visits, had 13 additions and collected \$41.40.

L. Quinn held 174 services, paid 307 visits, had 15 additions and collected \$275.

W. W. Gardner beld 95 services, paid 176 visits, had 3 additions and collected \$283.

C. W Strickland held 49 services, paid 106 visits, had 3 additions and collected \$49

H. Rhodes Moran held 220 services, paid 164 visits, had 21 additions and collected \$219.50.

FOR ELEVEN MONTHS

W. B. Herndon held 196 services, paid 280 visits, had 55 additions and collected \$256.

FOR TEN MONTHS.

J. A. Edmondson held 90 services, had 28 additions and collected \$126.

FOR NINE MONTHS.

A. W. King held 63 services, paid 39 visits, had 14 a ditions and collected \$73.75.

FOR EIGHT MONTHS.

John West held 280 services, paid 90 visits, had 30 additions and collected \$200.

Giles Taylor, E. P. Minton, W. H. Melton and S. W. McCarty did work under the direction of the Board amounting in the aggregate to 525 services, 240 visits, 85 additions and \$350 in collections

In addition to the work done by these Missionaries, special work was done for the Board in holding meetings by L. F. Taylor, M. Slaughter D. C. Hardin, J. N. Shook, G. W. Thomasson, C. W. Strickland, J. S. Thomas, A. G. McManaway, T. L. Fulbright, J. D. Cook and W. J. Kirkland, amounting in the aggregate to 200 services, 145 additions and \$161 in collections.

TOTAL AMOUNT OF WORK DONE.

Services held, 2522; visits paid, 2854; additions to Churches, 502, and amount collected for various objects, \$2815.15.

It is to be remembered that several of our Missionaries were employed for only one or two Sundays per month and that their reports of work done cover only the time they were under our employ.

But our treasury, the meantime, remained empty and the first quarter having ended, something had to be done for our Missionaries in the field. But when different efforts had been tried and no help seemed available, the source from whom Arkansas Baptists have so often been blessed and aided, our noble Home Board, at Atlanta, reached out its hand and relieved our situation, and greatly to the relief of your Board, they furnished all the means necessary in this very trying ordeal to relieve our embarrassment; and from this same generous source have we been able to keep those self-sacrificing brothers in the field through the year, supplemented in the latter part of the Conventional year by some dollars raised on our own field.

An amendment to the Constitution of this body was then sub mitted and recommended as follows:

In article 6 of theConstitution, in third line, strike out all after "seven" and insert, "One brother from each Association and thirteen other brethren who shall compose the Executive Board, seven of whom shall constitute a quorum."

Motion carried, to refer the recommendation to the Committee on Plans and Recommendations.

Motion carried to postpone-the regular order of business, and that we hear the report of the special Committee on Plans and Recommendations.

The Committee on Plans and Recommendations then submitted a partial report recommending the amendment, as above, to the Constitution of this body.

After much discussion on the amendment, the Convention bowed in prayer, led by J. M. Haut.

After further discussion, took a recess until 2 o'clock P. M. Prayer by Harvey Beauchamp.

AFTERNOON SESSION.

Convention called to order by the President. Prayer, led by P. M. Johnson.

In response to a telegram from J. A. Booker, President of the Colored Baptist College, of Little Rock, the Secretary of this Convention was ordered to answer and request his presence at our meeting next Monday.

Discussion was then resumed on the amendment to the Constitution of this body, and after being fully discussed, it was unanimously adopted.

Instead of the assignments previously made to the Presbyterian church, the following are substituted: At 11 A. M. tomorrow, J. M. Robertson, and at 7 P. M., M. M. Riley.

J. M Robertson, chairman of the Sunday School Board, then submitted the following report :

First Annual Report of the Baptist State Sunday School Board:

When this Board was created a year ago, its members believed that there was a general demand for its existence. They had no idea of the difficulties that would arise. Now, after a year's experience, we are convinced that no uninspired men could have foreseen the obstacles that have presented themselves

We have simply done the best we could under the circumstances, and now commit the results to God, praying that he will pardon mistakes and bless the work.

We were instructed by the Convention to incur no debts. This would have been our policy had no instructions been given. We put it of record here, that we recognize the right of the creator to command the creature. We have not been in the least handicapped by any action of the Convention.

We could take no action looking to the employment of a Manager or Evangelist, until pledges could be secured for his support. While this was being done, we secured a promise of \$500 from our Sunday School Board at Nashville, Tenn., and opened

correspondence with the American Baptist Publication Society at Philadelphia, Pa., seeking co-operation with that Society in the Bible and Colportage departments of our work. This correspondence was as follows, and fully explains itself:

Jonesboro, Ark., January 10, 1893.

Dear Brethren:

At the last session of the Arkansas Baptist Convention a State Sunday School Board was created and located at Jonesboro, with instructions to do Sunday school evangelistic and colportage work in the State. On the periodical literature question the Board was instructed to use our own literature,—the Arkansas Convention is a memb r of the Southern Baptist Convention, and the Board at Nashville is, therefore, our creature and the literature our property. Our State Board, in its published policy, declares that it shall be the duty of our Evangelist to comment our literature, but to receive orders for any literature published under Baptist auspices, when voluntarily tendered.

We have arranged with the Board at Nashville to pay part of the salary of the State Secretary or Evangelist.

It is our purpose to do colportage work, under the supervision of our Secretary, and in this department we desire co-operation with the American Baptist Publication Society.

What can we do with you in this work?

We expect to organize, through our agen y, the State into suitable districts and put a colporteur in each district. We will need to have such books in hand, or subject to order, as we can handle successfully. Will your Society furnish this stock of books, to be paid for as sold, from month to month, our Board becoming responsible to you for su h payments?

If it should become necessary in some cases to guarantee salary to colporteurs, will vour Society become responsible for any part of such salary? If so, what per centum?

Will your Society become responsible for any part of the salary of our General Secretary, as manager of colporteur work? If so, what per centum? We expect to p 1y about \$900 and expenses.

Will your Bible department make us a donation in this work of Bibles and Testaments?

Please consider and write us fully about these matters. Our State is a rich field for Missionary work of this sort We desire to begin work by March 1, at latest. By order of the Board.

In reply to the above communication, our Board is in receipt of the following from the Secretary of the Publication Society:

Dear Bro.: Yours of the 10th, concerning the appointment of an "Evan-

gelist," is received. When it came we had long had under consideration the appointment of a State Sunday School Missionary for Arkansas, having been urged and requested to such course by many good brethren in the State. Of course we were in ignorance of the action of your Board. Believing that you brethren of the Board and Convention could best judge of a suitable man, and wishing its endorsement of Rev. J. S. Thomas, having had personal knowledge of hin as a previous appointee of this Society in another State; he has now b en appointed as Sunday School Missionary for this Society, and is now under engagement.

Our Missiona y department is nearly \$6,000 in arrears for the current fiscal year. Our Board is inflexible in its purpose to avoid wilful debt, and we do not feel justified in making additional appointments in your State, or in incurring further expenses, until our receipts from your State can be more liberal.

Bro. Thomas has already been appointed, has accepted, and has been commissioned. We earnestly hope that the cause, interest, and work of the Baptists in Arkansas may be greatly blessed and prospered. Our sympathies are with you in every effort to promote the cause of Christ and to do good. This Society has been helping constantly by its grants, appropriations and otherwise the interests in your State.

This letter, revealing the fact that we could expect no help from the Society in the way of either books or Bibles, and not even soliciting our patronage as purchasers, was so surprising and discouraging, that, for a time, we contemplated attempting no work at all. We did not see how it was possible for a foreign Society and our own Convention to occupy the same field at the same time, independently, without hartful friction.

The Society had appointed a "State Missionary" for Arkansas, without consulting our Convention or its Boards, and for that reason declined to confer with us about books and Bibles. We paused to hear from the pastors. Their letters came promptly and numerously, and after this touch with the brethren of the State, we concluded that the 65,000 Baptists of Arkansas were able to manage their own affairs, and so we decided to push our own work, as entrusted to us by the Convention.

The question of securing a man to lead in the work became a serious one This question was finally settled, we believe, by the Lord himself, and R C. Medaris, of Tennessee, was secured. He entered upon his work May 20, at a salary of \$75 per month and expenses. The results of his labors are shown by his and the Treasurer's reports, to which we refer as parts of this report.

With pleasure we note the fact that there has never been a dissenting vote in any meeting of our Board, and that the plans of

the Board have been cheerfully adopted by Bro. Medaris and his plans promptly adopted by us.

We take this occasion to earnestly and heartily thank our Sunday School Board at Nashville, Tenn, for a contribution of \$500 paid into our treasury. Without this generous aid, we would have been able to accomplish but little. In addition to this, that Board has, at our request, donated literature to Mission schools to the value of \$96,38.

We also return thanks to the brethren throughout the State who have nobly helped us by their words of encouragement, their prayers and their gifts

The work has been a success beyond our most sanguine expectations We have been able to purchase and supply all Bibles and Testaments called for, to sell and give away many valuable tracts and books and to organize a goodly number of schools Realizing the disorganized condition of our forces, and the eminent danger of disintegration that threatened our State, we have given more attention to foundation work and to organizing the forces for another year, than to immediate results which show we lon paper

By reference to our Treasurer's report, it will be seen that our total receipts have been \$839.72; expenditures, \$744.96; leaving a balance on hand of \$94.76, which, with over \$1,000 piedged for next year, make a safe basis for operations in the future

For want of funds we have been unable to put as many workers in the field as the interests of our cause demand, and our stock of books and Bibles has been limited. We need at least ten men in the field all the time and such stock of tracts, books, Bibles and Testaments as that number of laborers would require. Our inability to meet this demand for laborers has been a source of serious embarassment.

The record of our year's work is made up. We bring back the power delegated to us by the Convention, and lay it down where we found it. May the richest blessings of our Lord be upon the Convention and all of its agencies!

In closing our report we suggest:

1 That the Sunday School Board be abolished and that three members of the State Board be specially designated as a Sunday School and Colportage Committee.

2 That the Mission Sunday School and Colportage work of the State be consolidated under the management of the one Board, and one man to be known as General Manager.

3. That R C Medaris, who has proven himself to be preeminently fitted for the work, be elected by the Convention to the position of General Manager at a salary of \$1,200 per annum and expenses Respectfully submitted,

The Convention was called to order by the President. Singing by W. E. Penn. Prayer by J. M. Hart.

Special order for the hour being the report of the Committee on Foreign Missions, the same was read by T. S. Potts, and is as follows:

It affords your committee great pleasure to report the glorious

work done by our Foreign Mission Board during the past year, and that it is growing in interest, power and magnitude all the time; yet we can but feel sad when we think of the many privileges and opportunities which we have neither appreciated nor improved We believe the call of the Baptists of America to the work of Foreign Missions was as clear, and assuredly divine, as the call of Paul into Macedonia, only, instead of the voice of a man saying. "come over into Macedonia and help us," there was the voice of Judson calling from India, saying: "If the Baptists of America will undertake the work here, I am ready to consider myself their missionary." It was the call of God, and let us thank him that our fathers were not disobedient to the heavenly mission which sent it, and that from the very beginning his blessing has been upon every effort and gift, and labor of love. But when we see the vast fields white and ready to harvest, and hear the calls of helplessness and longing coming from hearts struggling toward the light, and also the calls of weary workers for helpers to stand beside them and break the bread of life to the perishing, we feel with the prophet, Our people do not know, they do not consider or the needy and dying would not long call in vain We need knowledge, information; this and this only, will increase our interest and stimulate our zeal and give us an abiding love for the work. This information may be had through the Foreign Mission Journal, published at Richmond Virginia, by our Foreign Board, R J Willingham, editor Great impetus and interest has been given to the work during the last year by the Centennial movement, which resulted in the collecting of \$60,000 and in sending out in the last few months of forty new missionaries

There are now a number of missionaries ready or almost ready to sail for their field of labor, among whom are Peyton Stephens and wife, who sailed October 19; W. B Bagby and wife, who are only waiting the result of the war in Brazil before returning to their work. — Newton and wife will return to Africa in a few days.

The Board recently appointed Misses Willie Kelly, of Marion, Ala., and Lottle Price, of Asheville, N C, for North China and they will sail with R. T. Bryan Miss Lottle Moon will sail this month.

A new name appears in our reports this year. In place of H A Tupper, who has for twenty years been the efficient Secretary of this Board, we have that of R J Willingham, who comes to us for the first time as Corresponding Secretary. We welcome him in the name of his Master and ours, and give him most hearty assurances of earnest co operation and support. May the Lord open to him the hearts of our people and make him his own chosen instrument in the enlargement of his work.

The receipts of this Board during the last year have been \$155.937.23 Certainly a good sum; but compared with our abilities and responsibilities a meagre sum indeed.

The Committee pleads for the enlargement of the work, for more systematic effort in our Churches and more generous contributions by our people. The field is the world, and under the Master's commission it is our duty to take it for Christ. Let us pray and work and give and so Lelp to bring in that glad day when the kingdoms of this world shall indeed become the kingdoms of our Lord and his Christ.

On motion all titles were ordered stricken from the Minutes Minutes read and corrected and approved.

The Trustees of Ouachita Baptist College submitted the following report:

In submitting this, our annual report of Ouachita College to the Arkansas Baptist Convention now in session at Conway, we lift up our praises to the God of all grace for his many blessings bestowed upon our beloved institution during the past year.

While the total enrollment was slightly less than the previous session, the average attendance was much larger, the average age of the pupils greater and the standard of scholarship much higher, Students were matriculated from forty-eight counties in Arkansas and from seven States. Of the 298 students enrolled, there was about an equal division of young men and women. The last year's successful management of the internal working of the College more than ever demonstrates the wisdom of making Ouachita a co-educational institution. We find that moral character and intellectual standing determine a student's true status at Ouachita. A wisely regulated rivalry between the sexes has proved to be a healthy stimulus toward genuine class work. Flexibility in the elective course of study forbids overwork on the part of young women in competition with young men. We note with satisfaction the special supervision and painstaking care of President J. W. Conger in these matters.

It is gratifying to know that the spiritual and physical, as well as intellectnal, condition of all pupils receives special and careful attention. During a series of revival meetings held in the Arkadelphia Church last spring many students were received into the fellowship of the Church by experience and baptism.

SCHOLASTIC BENEFITS.

There were forty-two students who received all or in part, free tuition. Of this number eleven were young men preparing for the work of the ministry, the other beneficiaries were children of ministers. This class of matriculates is increasing annually. The money for their maintenance and for necessary repairs and improvements on the buildings is limited. It becomes necessary, therefore, to increase that sum if the College continues to admit all beneficiaries who come. The deficiencies occurring in this department must finally be met by donations from the Churches or from endowment. The College and its beneficiaries all belong to the Baptists of Arkansas.

THE PRESENT SESSION.

Taking into consideration the general depression in finances the present session opens more favorably than last. The faculty is stronger, and additions have been made to the library and laboratory.

FINANCES.

The financial condition of the College remains about the same as last year. It was deemed wise by your Board not to press our claims during the money panic. The time has come, however, when the debt on Ouachita College must be paid off, and additional funds ratsed for the colargement of the institution, if we are to meet the demands upon us. The Board is devising plans looking toward the accomplishment of this end. From present encouragements we confidently trust that by the next meeting of this Convention all debts on the College will be provided for and a permanent endowment inaugurated.

The report of the Trustees of Central Baptist College was submitted as follows:

The last year, which was the opening of this school, was not as successful as we had hoped it would be. Like most new enterprises it met with unforeseen obstacles. We have not been discouraged, however, and are pressing on today with bright assurances of early success.

President C. M. Williams in December last, gave to us notice that he would terminate his contract with the Trustees at the expiration of his year, six months off. Reasons satisfactory to himself caused him to close the school about April, in advance of the end of his term.

On April 10 we contracted with Prof. S.E. Thompson, of Waco, Texas, for several years Vice President of Baylor University, to take the position vacated by C. M. Williams. The terms of the contract are quite similar to those made with C. M. Williams, except that we have granted S. E. Thompson a lease for seven years, and he assumed the burden of erecting all needed outbuildings and fencing. The campus is accordingly handsomely enclosed, and good out buildings have been constructed. The school opened on September 18th as advertised, and we are glad to report that the attendance is quite satisfactory, considering past embarrassments. The faculty are well selected and all the branches usually taught

in colleges are taught here. The President intends extending the curriculum and increasing the faculty from time to time as the attendance may require or render necessary.

The Guaranty Committee have completed their contract with the Trustees by finishing up the two lower stories of the building. Ample accommodations are now ready for forty boarders, beside faculty and attendants. About twenty-one young ladies from abroad are attending the school. The entire attendance today is fifty-six.

On February 7th last, H. P. Edmonson, Frank White and A. G. McManaway were elected Trustees for a period of three years from February 13, 1893.

On April 3 the Board was reorganized A G. McManaway was elected President, John G. B. Simms Secretary and H. P. Edmonson Treasurer.

The three Trustees whose terms of office will expire next February are T. M. Jackson, John G. B. Simms and G. W. Reeves.

Your honorable body are asked to name five brethren from among whom their successors may be chosen, as required by the College Charter.

We feel very thankful that the present session of this Convention occurs at the seat of this institution of learning We request that all delegates and friends will avail themselves of the opportunity to visit and inspect the buildings and grounds and witness the workings of the school.

Without antagonisms for any, either older or younger school, which is fostered by our people, we earnestly ask that the great Baptist brotherhood of Arkansas shall no longer send their daughters to other States, but that they here make use of facilities for education as good as they can get abroad and thus, by building up a home institution, contribute to the elevation of our denomination in Arkansas in our own eyes and in the opinion of others. We feel that our denomination is to be congratulated on the elegant buildings which they here own free from debt, and which stand as an everlasting monument to the liberality of the people of Conway. What smaller or more modest recognition of this can be asked, than that our people bestow upon this school a most liberal patronage?

Pending discussion of report of Trustees of Ouachits, on motion further consideration of same was postponed until after the Committee on Plans an Recommendations could make a report, which they did as follows:

Your Committee on Plans and Recommendations beg leave to submit a partial report as follows:

1. That the Sunday School Board be not abolished.

2 That the Sunday School Board employ a Secretary.

3. That the Sunday School Board and the Executive Committee cultivate the closest possible business relations in the prosecution of their respective aims, and that they confer together freely with the object of lessening expenses and increasing efficient results

4. That the Executive Board employ as soon as practicable a competent Financial Secretary.

Report on Woman's Work was read and a motion to adopt same was carried as follows:

We, your Committee on Woman's Work, beg leave to report: It is doubtless true that nothing has contributed so much to the success of Christianity as the consecrated efforts of our Christian women. Our Heavenly Father has always seen fit to greatly honor the faithfulness of His handmaidens. It was she who was last at the cross where our Savior expired and first to visit the tomb to embalm his body. The importance of her co operation in Christian work was duly recognized by the Apostles, one of whom does not fail to speak praisingly of "those wonen who labored with me in the gospel " The closing chapter of Romans mentions no less than fifteen such women. It was Priscilla as well as Aquilla who expounded the word of the Lord more perfectly to Apollos To be sure this was in a private manner. Timothy, an Apostolic man, was a more effective Christian worker because of the principles learned at the knee of his mother Eunice, and that of his grand mother Lois.

The Apostle's direction as to women speaking in the Church does not by any means imply that they were to fold their hands and take no active part in the work of our Master's Kingdom.

Although it does not appear that they are fitted by nature or Divine call for the ministry, still there are broad fields in which they should labor. It is a cause for congratulations that our people are coming to recognize so fully and correctly the true position of women in the Church. The great need is to organize our women and give them every possible encouragement. The weak and strong Churches alike have felt the power of their consecrated work, and all will suffer unless this is done. Many of our Churches do not realize the latent power in their women.

We think the present organization of our women a most wise and helpful one. They are doing a grand and noble work in distributing Missionary information and in securing systematic cooperation of the women and children in raising money for the various denominational causes. They not only demand and deserve the earnest help of their pastors and brothers, but the work of our Churches will be greatly crippled unless they receive such help. A resolution adopted by their meeting is deserving of special notice, viz: "We as Baptist women set our faces against all modes of gambling and selling by chance." We have also the pleasure of presenting amost excellent report of the Woman's Central Committee. H. BEAUCHAMP, Ch'm. Resolved, That we have heard with interest and sympathy the statament made by J. A. Booker, concerning his educational work among and for the colored people of our State; and we recognize in him an able and fearless exponent of what we deem correct principles for the training and upbuilding of his race.

Resolved, That the Executive Board of this Convention be and they are hereby directed to consider what measures may be adopted so that we as Baptists may foster and aid our colored brethren in the work of building their College at Little Rock, which was lately distroyed by fire.

Resolved, That our Executive Board further consider what can be done by us as a denomination, by way of instructing our colored brethren in Minister's Institutes, and in sending Missionaries among them within our State; and that they be empowered and directed to take any action in the premises which their judgment shall dictate.

Report of J. S. Thomas was read for information, and the following resolution was adopted:

We thank Bro. Thomas for the good work he has done during the past year, but for the future we think it best to do our Sunday school work through our own State Sunday School Board.

Motion carried to adopt the Report on Education, as follows:

Your Committee on Education submit the following: The past year has been one of growth in the desire for Christian education. The Baptist youth of Arkansas more than ever before are seeking advantages in our Colleges, and parents are beginning to realize the great responsitility upon them in giving their children advantages not simply in the common free schools and high schools, but in our Baptist schools and Colleges. It is not necessary to argue in this report, the wonderful power accruing to our people consequent upon a thorough and well articulated system of denominational schools throughout the State. Not only do we need the strong College with broad and extensive curriculum, with latest methods and splendid equipment, but we must have a few good high schools, wisely located and managed to prepare pupils for the College. Therefore, your Committee would recommend that a Board of five brethren be appointed by this Convention which shall be known as the

EDUCATIONAL COMMISSION

of the Arkansas Baptist Convention The duties of this Commission shall be to encourage, foster and more permanently establish existant institutions under the control of the Convention; to plan, organize and conduct other educational enterprises, especially high schools; to legally receive school property from donors and to thus represent this Convention and to wisely correlate all Baptist Colleges and High Schools in the State.

In the event of the adoption of the above recommendation, we suggest that the Committee on Education be discontinued. For the work of Ouachita and Central Colleges, we refer to the reports of the Boards of Trustees. These Colleges are the pride of our people, and every Baptist in Arkansas should take special interest in their growth and enlargement.

We note with pleasure the increased interest in Mountain Home College, which has opened its first session under most favorable conditions, with W. S. Johnson, a graduate of Ouachita, as President, aided by nine assistants This Institute is an outgrowth of a necessity for higher education in the northern part of the State This College is not intended to rival other Colleges, but to supplement the work of Ouachita and Central, and to make stronger our Baptist educational forces We commend it for patronage and prayers of our people, especially in Northern Arkansas.
