CONSTITUTION.

ARTICLE 1. This body shall be styled the "BAPTIST STATE CON-VENTION."

ARTICLE 2. The Baptist State Convention shall be composed of messengers from Baptist Associations and Baptist Churches, on presentation of proper credentials or satisfactory evidence of their appointment.

ANTICLE 3. Associations shall be entitled to five messengers and Churches to three, and the State Central Committee of the Ladies' Aid Society shall be *ex-officio* members of the Convention.

ARTICLE 4. It is distinctly understood that this Convention shall have no ecclesiastical jurisdiction, nor in any way interfere with the Constitution of any Church or Association.

ARTICLE 5. The object of this Convention shall be to supply the destitute regions within its bounds with the unadulterated Word of Life, and a living ministry, and to aid by appropriate and Scriptural means all destitute and feeble Churches, and also supply communities with such books as may be approved by this body, and as may be thought best calculated to communicate information as to the distinctive doctrines and ordinances of the Gospel of Christ as received by our denomination, and to aid and encourage Ministerial and Gospel and General Education, Mission and Sunday-school Work, and to gather denominational statistics.

ARTICLE 6. The Convention shall elect by ballot annually a President, two Vice-Presidents, a Secretary, Assistant Secretary and Treasurer. Also appoint seven brethren who shall compose the Executive Board, four of whom shall constitute a quorum; said Board to hold office until their successors shall be appointed.

ARTICLE 7. The Convention shall convene on Wednesday before the first Sabbath in November, each year.

ARTICLE 8. This Constitution may be amended at any regular meeting of the Convention, two-thirds of the members present concurring in the measure, except the fourth article, which shall forever remain unaltered.

EUREKA SPRINGS, October 30, 1890.

The Arkansas Baptist State Convention was called to order in the Opera House, by the President, W. E. Penn, at 10 o'clock, A. M. this day. The r45th Psalm was read and prayer offered by the President.

The chair announced the first business to be the election of a President. James P. having been collected and spread, Brethren I. R. Hall and G. W. Reeves were declared elected, respectively, as First and Second Vice-Presidents of this Convention, and invited to seats upon the rostrum.

Brethren Box, Locke and Manard were appointed tellers to hold the election for Secretary, Assistant Secretary and Treasurer. Brethren Simms and Ball were nominated for Secretary, and Brother W. A. C. Sayle for Treasurer. By consent, the chair announced that the candidate receiving the highest number of votes for Secretary would be declared elected as such, and that he who received the next highest number would be considered as elected Assistant Secretary.

Brother Sayle having no opposition for Treasurer, the Secretary, on motion, was instructed to cast the ballot of the Convention for him, which was accordingly done, and he was declared duly elected as such.

The ballots for Secretary having been called and spread, Brother Simms was declared to be the choice of the Convention for Secretary, and Brother Ball for Assistant.

Brother Grammar, in behalf of the churches of this city, delivered an address of welcome to the Convention, which by request of the chair was responded to on behalf of the Convention by Brother A. B. Miller.

On motion of Brother Pace, Professor Sampey of the S. B. T. Seminary, at Louisville, was requested, at a suitable moment, to address the body in the interests of that institution.

Brother Conger, in behalf of Brother A. J. Holt, presented to the Convention a gavel made of olive wood grown upon the Mount of Olives. The presentation was accompanied with suitable remarks, which were responded to by the President.

On motion of Brother Gibboney, the thanks of the body were tendered Brother Holt, for the gavel.

Brother J. B. Searcy read the following report, as Secretary for the State, of Foreign Missions:

FOREIGN MISSIONS.

Your Secretary of Foreign Missions would report that there has been a steady increase in this work from year to year. Last Convention we reported \$2,028.44 contributed during the previous year. This year we report for the year closing with this meeting of the Convention, \$2,166.93. Until last year the contributions from all parts of Arkansas were counted together. But last year by request, the Foreign Mission Board of the Southern Baptist Convention reported funds from the General Association of bouthwest Arkansas with funds from Indian Territory, and that is considered a separate district from the territory of the Arkansas Baptist

State Convention. Arkansas contributed last year to the Southern Baptist Convention Board of Foreign Missions, \$2,252.27, but \$250 of that amount was credited to the General Association of Southwest Arkansas and Indian Territory. This year I do not report any funds that went into the hands of the Foreign Mission Board, through that organization, which of course circumscribes our field somewhat, and yet we report more money received during last year than any previous year of our existence. The Arkansas Baptist Convention is asked to furnish, from within its bounds this year \$3,000, exclusive of the \$500 asked from the General Association of Houthwest Arkansas and Indian Territory. This is an increase over what we have ever done, but we are able to increase, and it is the hope of your Secretary that this amount will be promptly raised.

The Secretary read the report of Committee on Home Missions which, having been discussed, was adopted, as follows:

HOME MISSIONS.

The work of the Home Mission Board of the Southern Baptist Convention has been unusually successful during the year which has just closed. Their field is the destitute portions of the South land, together with New Mexico and Cuba. They work in co-operation with the various State Boards, giving and receiving assistance. They have in this way given our own State much assistance, and are still aiding us. Out of very gratitude we should reciprocate this assistance.

In Cuba this Board has had the most phenomenal success that has visited any modern Mission field. Our apostolic Brother Diaz, of Cuba, together with some of his associates, have suffered much persecution from the Catholics during the year. But all this has but added interest to his work and filled the workers with greater zeal in the Master's cause. Let us assist this great work. We especially request that money, which our charches designate for this work, shall be so distinctly stated that it shall not be otherwise appropriated. We trust that every church in the State will take up at least one collection for the Home Mission work of the Southern Baptist Convention this year.

The report of Committee on Publications was submitted by Brother Swindall, and was amended, discussed and adopted to read as follows:

REPORT OF COMMITTEE ON PUBLICATIONS.

Your Committee to whom was referred the question of Christian literature, would respectfully report: People eat and think, but we are more constant and persistent in our thinking than in eating and drinking. Food builds up and makes our bodies sound and strong, or weak and corrupt, according to the character of what we eat. So our moral natures are made up of the material of our thoughts.

"As a man thinketh so is he." Hence the necessity of good, truthful and morally healthful and sound religious literature. A child may be taught some wrong principle in science, to no serious or permanent injury; but faulty moral principles may work his eternal undoing. Therefore your committee would recommend,

First, The more persistent and daily study of the good Word of God, which is so sadly neglected, even by professors of religion.

Second, We would recommend next to the Bible, our own State paper, the Arkansas Baptist. We can but appreciate the sacrificing and successful carrying forward of that enterprise by its faithful and judicious editors, who should be rewarded by our people in putting it into every family of our great State, and always paying for it in advance.

We can trust without fear the Kind Words series and recommend it for our Sunday-schools. Outside of these let there be liberty.

To the Arkansas Baptist State Convention:

The Executive Board, at the close of the meeting of the last Convention in Little Rock, organized by the election of Elder J. P. Eagle, President; J. K. Pace, Secretary; Dr. W. A. C. Sayle, Treasurer.

THE STATE EVANGELIST.

At the first meeting of the Board, Elder B. G. Manard was elected State Evangelist for the ensuing year, and he entered upon the prosecution of his duties about November 1st, 1889. His enthusiasm and efficiency in the exercise of his duties have been highly gratifying to the Board, and, so far as we know, to the Baptist brotherhood throughout the State. He has been with the Board in its meetings, whenever possible, and his practical knowledge of the wants of the field has been of untold value in the laying and execution of plans.

SPECIAL ENCOURAGEMENT.

While we shall not attempt to mention all the evidences of encouragement, a few facts might be mentioned, as follows: The Second Baptist Church of Little Rock at the beginning of this year, became self supporting, paying her pastor \$1,200, and recently a Mission Sunday-School was organized in West Little Rock.

The church in Argenta, or North Little Rock, now has preaching twice per Sunday, Elder J. H. Meyers having taken charge of that church July 1st, 1890. In four months it has doubled its membership, and now a new meeting house is being built, which will be worth when finished, \$1,000 or \$1,200. .

The church at Van Buren has about settled the balance due on their property, and is more encouraged now than at any former time in the history of the work there.

New houses of worship have been built at Corning, costing about \$1,200, and at New Lewisville, at a cost of about \$1,500. It may be said of all the fields occupied, that the missionaries have done good work, and the outlook is encouraging.

Pending discussion of the report, the hour for adjournment arrived and the Convention was declared adjourned. Prayer by Brother D. C. Hardin.

AFTERNOON SESSION.

Called to order at 2 o'clock. Singing.

Consideration of the report of the Executive Board was resumed, pending which the hour of 3 o'clock having arrived, the special order was taken up, which was the report of Committee on Ministerial Education.

The report reads as follows, and was presented through the chairman, Brother J. J. Taylor:

REPORT OF COMMITTEE ON MINISTERIAL EDUCATION.

To prepare men for standing alongside of other educated men in the ministry; to prepare them for standing in the face of opposers of the truth; to prepare them them to wield the pen of ready writers; to furnish the Mission field with suitable men; and last, but most important, to prepare men to preach more powerfully the Word of God—the unsearchable riches of Christ—these are the considerations calling for earnest attention to the subject of Ministerial Education.

But it may be asked in what regard should men be educated who had been called of God into the ministry? We deem it of great importance to impress the fact that such men need first, the kind of mental training that other men need to fit them for other occupations—and even a broader foundation is necessary for the Christian minister, than for the learned professions. We do not regard grammar, and arithmetic, and geography, as beneath the consideration of the ministerial student.

Again, let it be impressed that nearly all the young men called of God are poor, and God lays their education on our hearts and hands. At Ouachita College 25 young men last year received free tuition; 10 are there now, but others want to come. The students there receive instruction twice per week on theological subjects. We recommend that the churches seek out such as they have good reason to believe are called of God to preach the Gospel, and encourage them to attend the College.

We recommend, second, that the pastors urge a better preparation on the part of young men by attending college before entering the Seminary, and when such preparation is made, urge them to enter the Seminary for finished theological training.

The report was then adopted.

The report of the Board of Ministerial Education was read pending discussion of that of the Committee on same subject, and reads as follows:

REPORT OF BOARD OF MINISTERIAL EDUCATION.

Your Board on Ministerial Education report, that during the last session of the College 25 young ministers entered College, a goodly number of whom remained during the session. Some left before the end of the term. for want of means. Nearly all of the latter left because the pledges made to them by their churches and Associations failed to materialize. During the year, \$848.53 have been put into our hands for Ministerial Education, exclusive of \$700 for tuition, in all \$1,548.53. Out of this amount 15 young men received aid to the amount of \$757.13; \$5.80 was spent for postage and stationery, and there remains on hand (\$75.50.

A continued and extensive correspondence has been carried on, yet we are grieved to report that of the pledges made a year ago at the Convention there stands to-day unpaid the amount of \$161.75, though many letters, private and public, have been written.

We urge that pledges be made and then paid.

There are now in College ten young ministers, some of whom need help, and there are some others in the city and vicinity who would be in school if possible, and scores of others throughout the State waiting for an opportunity to come. The Board deem it a wise policy to concentrate on the tried men who are nearly through school, thus enabling them to get on to the field and begin to aid others in turn

We do not think it wise to lavish aid—if we could—on boys just converted and licensed and sent to college, before any evidences are given that they will be preachers. Yet money sent for them is received by them.

BOARD OF TRUSTEES OF OUACHITA COLLEGE.

The Board of Trustees of Ouachita College would respectfully submit the following report:

At the annual meeting of the Trustees on June last, Prof. J. W. Conger, the able and efficient president, was re-elected for a term of three years, satisfactory arrangements having been made with him, and he continues in the highly responsible position in which his success has been so marked and phenomenal, and he has called to his assistance an able and successful corps of teachers. Number of pupils enrolled the past year, 309, and the work done is of a most satisfactory character. We are happy to be able to report to our Baptist people in Arkansas, that the College has proved itself eminently worthy of their most hearty support, and none need send their children and wards out of the State for a thorough collegiate education.

REPORT OF THE FINANCIAL SECRETARY FOR YEAR 1889-90.

When we commenced this year's work we were under a debt of \$19,300, and our resources or assets amounted to \$7,407.65. Our debt now is \$13,154 and our assets \$11,712.24, showing that the debt has been decreased \$6,143.00, and at the same time; the assets have been increased \$4,304.69. The total collections this year amount to \$6,680.31, but other means amounting to \$217, have been used which are not counted in the collections. I regard the above as being very encouraging. The work of the year just ending has done much to relieve the embarrassment of the Board, and one more year of such work will put this great work within easy reach. Respectfully,

STATE MISSIONS.

"Go ye into all the world and preach the Gospel to every creature." In this lies the authority for State Missions. Arkansas is no insignificant part of "all the world." That commission will remain unfulfilled so long as any part of our beloved State is destitute of Gospel privilege. That such destitution does exist is not a matter of question or controversy. There are twenty county seats in Arkansas that have no regular and correct preaching of the Gospel. There areother towns where the sound of the Gospel is rarely heard, while many large sections of the State, embracing in some instances, whole counties, where thousands of people never hear preaching the year round. Shall we permit this state of things to exist? There are Baptists enough in Arkansas to see to it that not one soul in all our State shall be lost for lack of Gospel privileges. We profess to be the peculiar people of God. We profess to be the conservators of His truth. Shall we permit ignorance of that truth to abound in our midst, and yet profess that we are Missionary Baptists?

EDUCATION.

Your Committee on Education beg leave to report as follows:

It is evident that there is a constantly growing demand by the people of our State for higher education of the mind and heart. This demand is caused by a better realization of the great results for good that come from intellectual development and heart culture. We know that "knowledge is power," but intellectual and physical without moral development will not produce our ideal of perfect and symmetrical manhood. The heart is ever ready to receive the seeds of evil or error which may in after years germinate and be productive of harvests of untold miseries. Religion and her handmaid, education, must go hand in hand in the great work of progress and civilization. Recognizing this truth, infidels would break the power of Christianity by keeping our children in the woods and streets on Sunday, and from religious instruction during the week. Other denominations would retain their influence by edi catifig their children in their own denominational schools. Shall we as Baptists do less ? Belleving that it is the individual duty of parents to place their children for education where the teachings of home will not be antagonized, your Committee recommend our people to support those institutions built and fostered by Baptists of our own State. We commend the efforts of the brethren of the White River Association to build an institution for Baptists at Mountain Home. We consider Ouachita College as the special property of our people, being originated, built and supported by the Baptists of Arkansas. It has already made its power for good to be felt throughout our State. With its healthful situation, its beautiful location, its moral surroundings, its grand buildings, its full and complete faculty, its thorough work in the past as a guarantee of the future, it is no longer an experiment, but a grand success. Every Baptist in our State should encourage it with influence, with means, with patronage, and thank God for such a power for good, and pray His richest blessing to rest upon those who control it, and upon our children who are to be benefited by it.

BROTHER PRESIDENT AND BRETHREN:—You will remember perhaps that the work of education among the colored Baptists of the State was laid before your honorable body last year, and that the different delegates contributed over thirty dollars to help complete the first building on our college grounds in this city.

I write to inform you that that building will soon be ready for entrance. But we shall owe three hundred dollars or more for desks and windows. We would be glad if your body this session would contribute enough now to pay for one window and one desk, and let the name of the Convention be inscribed on each as memorial gifts to our school. A window will cost fifteen dollars; a desk will cost four dollars.

Our Convention remembered you this year as usual, to the extent of sending a messenger to represent our work in your meetings, but I have been too busy, and am yet too busy to attend. No other delegate having been appointed, we shall be deprived of having a visitor at your session this year. But we trust that you will think of us. We are sure you will encourage us in every good word and work. Whatever you give us or do for us will be highly appreciated by us.

Bro. J. B. Searcy submitted the following report from Committee on Foreign Missions:

REPORT OF COMMITTEE ON FOREIGN MISSIONS.

Your Committee on Foreign Missions would report that we now have Missions in China, Japan, Africa, among Pagan people, who are in the most absolute sense without God and without hope in the world. We also have Missions in Italy, Brazil and Mexico among Papal people who have a form of godliness, but deny the power thereof. The idolatry of Papalism is little, if any, less revolting than that of Paganism.

In all these fields our work has been largely prosperous during the past year. Failing health and overwork for years past has required a number of our missionaries to return home for awhile, but within the last month several of the missionaries have returned. Within the last year more than a score of new missionaties have been sent out. New and inviting fields are continually opening up and scores of worthy men and women, with the fire of missionary zeal from the altar of God, are crying "Here am I, send me." The only obstacle that now stands in the way of large success is the failure of the brethren to furnish the adequate means. Can this obstacle be removed? We think it can. There has been u steady increase of our contributions for the last six years to the amount of about 20 per cent per annum, and we are encouraged; but we need to reach more of our people and interest them in this work. We need more contributors, quite as much as we need more contributions. We are asked to raise \$3,000 this year. We think that we can and ought to raise that amount. The Ankansas Baptist is the principal agency in raising this money. Its columns are expected to speak each week with missionary intelligence, also with receipts of contributions to the work. Every dollar contributed ought to be reported to the Secretary, and through him to the paper. Thus we will provoke each other to this good work. The Foreign Mission Journal is a powerful auxiliary to this work. It costs only fifty cents a year to single subscribers, and thirty-five cents to clubs of ten or more. It is now in pamphlet form and is a splendid monthly. We urge our brethren to read it.

Finally we urge that pastors and other workers would do all they can to increase a missionary zeal among our people, and that collections for this work be taken in all the churches, and that every one be urged to contribute some amount to this work. I. B. SEARCY,

He was chairman of the Convention that organized the Fayetteville Association in 1870, and was moderator of that body successively up to near his death. Aged 78 years.

Elder John H. D. Carlin, of Rector Church, Clay Co., Arki, spent forty-nine years in preaching the Gospel, and died on February 15, 1890, in the "triumphs of a living Faith." He delivered 12,558 sermons and baptised 3,785 converts.

Brother Hazzard Been, of Oak Grove Church, Sebastian Co., Ark., was born in 1815 and died April 14, 1890. Was ordained a Deacon of the church, and lived an active, devoted servant as such for about thirty-six years.

Rev. W. S. Young, of Concord Association, died during the last Conventional year. Was a faithful minister of the Gospel, after having spent many years in the service of Christ.

Brother J. C. Saunders, a member of the Board of Trustees of Ouachita College, and one among the strongest supporters of that Institution, died October 27, 1890.

We would recommend that more consideration and care be given to the memory of our departed brethren and sisters. Respectfully submitted,

W. A. Clark, Chairman of Committee on Sunday Schools, submitted the following:

SUNDAY-SCHOOLS,

The great need of Arkansas is more Sunday-schools and better ones. We should have as many Sunday-schools as we have churches, and these should be the best possible in spiritual, moral and intellectual force. In order to secure these ends, we need no complicated machinery. The Lord's work should be done by simple, direct business methods. "What is everybody's business is nobody's." Therefore this department of our State Convention work should be placed in the hands of an efficient Sunday-school missionary, whose duty shall be to labor personally and constantly to secure the success along these lines.

We also recommend that the manner in which the spirit of this report shall be executed, be left solely to the Executive Board 'of this Convention, with the authority of this Convention to arrange for the immediate inauguration of this work.

We also urge our schools to use Baptist literature, and Baptist song books, of which none are superior to Harvest Bells.
