CADDO RIVER REGULAR BAPTIST ASSOCIATION.

FIRST DAY.

SATURDAY, SEPTEMBER 9, 1882.

The Caddo River Regular Baptist Association met pursuant to adjournment with the Church at New Hope, Pike County. Ark., on Saturday before the second Sunday in September, 1882.

The introductory sermon was preached at 11 o'clock A. M. by the appointee, Elder J. P. Welch, followed by Elder J. J. Hughes. Text: "For without me, ye can do nothing."—St. John 15: 5.

At 2 o'clock P. M., Elder H. M. Wilkinson, Moderator, called the Association to order.

After reading the Scriptures and singing, prayer was offered by the Moderator.

Called for letters from the Churches. Letters read and the names of messengers enrolled. (See Statistical Table).

Called for Petitionary letters, when one was presented from the Church at Tuskawillow and one from the Church at Brushy Creek, Howard County. The letters were read and the messengers received, and the right hand of Associational fellowship extended by the Moderator.

The Association then went into the election of officers, which resulted in the election of H. M. Wilkinson, Moderator; Isaac F. Welch, Clerk, and I. R. Turner, Treasurer.

Visiting ministers were invited to seats in the body, whereupon Elder J. A. McDaniel, of the Southwestern Arkansas Association, presented himself, and was welcomed to a seat with us

The Association met according to appointment. Prayer by J. J. Hughes.

Called for reading of minutes of Saturday Minutes read and adopted.

The Association agreed to open up correspondence with the Southwestern Arka as Association. The Moderator then appointed as corresponding messengers to said Association, Elder W. W. Carson and Asa Cunninghum and C. H. Eddlemon; Elder Carson to write a letter of correspondence.

The Moderator then appointed corresponding messengers to Sister Associations as follows:

To RED RIVER.-J. C. Goss and J. M. Smith; Smith to write.

To Ouacitita. Isaac F. Welch and N. L. Huggins; Welch to write.

To Saling. -A. Nelson, H. M. Wilkinson, A. R. Chitwood and I. R. Turner: Nelson to write.

The following resolutions were read and adopted:

Resolved, 1, That all ministers of this Association are earnestly requested to advocate the cause of Home Missions within their respective charges, and urge upon the brethren to send some specified amount of money by the messengers at the next session of this Association, to be used in employing a missionary in our hounds for the next year.

Resolved, 2, That we, as an Association, use our energies to raise money enough by the next Association to send a missionary to New Mexico for twelve mouths.

Resolved, 3. That we, as an Associatiou, drop the names of all the Churches that fail to represent themselves for three meetings in succession, to take effect at the next meeting of the Association.

Resolved, 4. That the Clerk have as many minutes printed as there is money to pay for after reserving ten dollars for his services as Clerk, and that a few copies be sent to those Churches which have failed to represent themselves this year and which sent money to pay for minutes last year.

Resolved, 5, That we have the Abstract of Faith of this Association printed in the minutes of this session.

Resolved, 6, That we request all the Churches of this body, in sending up their statistics to the Association, to give the names of all the ordained ministers and deacons and licensed ministers in their fellowship and their postoffices. Also, that their letter show who has been their pastor for the Associational year just clusing.

Resolved, 7. That the Association tender her special thanks to the members of the Church at New Hope and the vicinity for their liberal support and friendly hospitality during our stay among them.

Resolved, 8, That the next session of this Association he held with the Church at Forest Hill, Montgomery County, Ark.

The Association then adjourned to meet with the Church at Forest Hill, Montgomery County, Ark., four miles below the Caddo Gap, on the Hot Springs road, on Saturday (at 11 o'clock A. M.) hefore the second Sunday in September, A. D. 1883, peace and harmony prevailing.

ABSTRACT OF FAITH.

(WITH REFERENCES).

ARTICLE 1. We believe in one true and living God, the Father, the Word and the Holy Spirit. (1 John 5: 7; John 1: 1, 2, 3; I Tim. 3: 16.)

ART. 2. We believe that the Scriptures, composing the Old and New Testaments, are the word of God, and the only rule of faith and practice. (2 Tim. 3: 15, 16; 2 Peter 1: 21; Rom. 15: 4.)

ART. 3. We believe in the doctrine of election according to the foreknowledge of God, the Father, through santification of the spirit unto obedience and sprinkling of the blood of Jesus Christ. (1 Peter 1: 1, 2.)

ART. 4 We helieve in the doctrine of original sin by the fall of Adam. (Gen. 3: 6, 7; Ps. 57: 6; Rom. 5: 12-14.)

ART. 5. We believe in man's incapacity by his own free will and ability to recover himself from the fallen state in which he is by nature. (Isa. 1: 5-7; John 6: 44.)

ART. 6. We believe that sinners are justified in the sight of God by the imputed righteousness of Christonly. (Jer. 23: 6; Rom. 22-24; 1 Cor. 1: 30.)

ART. 7. We believe that the saints will be preserved in grace and never fall finally away. (Ps. 89: 31 35; Heb. 8: 10, 11; John 10: 20; John 3: 9.)

ART. 8. We believe that baptism and the Lord's supper are ordinances of Jesus Christ, and that true believers are the only subjects of baptism, and that immersion is the apostolic mode. (Mark 6: 16, and 15: 16; Acts 2: 41, 42; Rom. 6: 3-7; Matt. 20: 26; Acts 2: 42: 1 Cor. 11: 22-26.)

ART. 9. We believe in the resurrection of the dead and that the felicity of the righteous and the punishment of the wicked will be eternal. (John 5: 28, 29; 1 Cor. 15: 22, 23; Rev. 20: 12, 14, 15.)

ART. 10. We believe that no minister has a right to administer the ordinances of the Gospel but one who is regularly baptized, called and comes under the imposition of the hands of a presbytery. (Matt. 28: 19, 20; 1 Tim. 4: 14; Titus 5: 10.)

ART. 11. We believe that none but regular haptized members have a right to commune at the Lord's table. (Acts 2: 42-47.)

VRT. 12. We believe that the Lord's day should be observed as a day of rest and religious devotion. (Ex. 20: 8: Acts 20: 7; Rev. 1: 10.)
