Next session to be held with Corinth Baptist Church, Van Buren County, Ark., commencing on Thursday before the first Sunday in September, 1896, at II A. M.

Rules of Decorum.

1. This Association shall be opened and closed with prayer.

'2. A Moderator and Clerk shall be chosen by the suffrage of the members present, and a majority of votes cast shall elect.

3. The Moderator shall be considered a judge of order, and

shall have the right to call to order at any time.

- 4. Any member not satisfied with the ruling of the Moderator may appeal to the body on the same day, but not afterwards.
- 5. But one member shall speak at a time, who shall rise to his feet and address the Moderator.
- 6. The Moderator, when addressed by a member for permission to speak, shall signify the same by calling the speaker by name.
- 7. No speaker shall be interrupted while speaking unless he departs from the subject or unless words of personal reflection are used.
- 8. Every motion made and seconded must come under the consideration of the body, unless withdrawn by the mover.

9. Every case taken up by this hody shall be decided or

withdrawn before another can be offered.

10. When a question has been taken up, after allowing time for debate, the Moderator shall take the voice of the sody the same by rising to their feet; the negative, by like sign.

11. The Moderator shall pronounce the decision before the

standers resume their seats.

- 12. Any member wishing to retire shall obtain permission of the Moderator.
- 13. No member shall speak more than three times on the same subject without permission of the body, no more than once before every member that wishes to speak shall have spoken.
- 14. The appellation of brother shall be used in the Association by members in addressing one another.

15. The names of the members shall be called as often as the Association may direct.

. 16. No member shall be tolerated in any practice which

tends to interrupt public speaking.

17. The Moderator shall be entitled to the same privilege of speaking as any other member, provided he appoint another to his seat during the time; but he shall not vote on any question unless the Association be equally divided.

18. Any member violating these rules may be reproved by the Moderator at his discretion, but only on the day that the

Articles. of Faith.

Article I. We believe that the Scriptures comprising the Old and New Testaments are the Word of God and the only rule of faith and practice.

Art. II. We believe in the living God, Father, Son and

Holy Ghost.

Art. III. We believe in the doctrine of original sin by the fall of Adam.

Art. IV. We believe that man is in a state of total depravity, by reason of which he is incapacitated to recover himself from the effects thereof.

Art. V. We believe that sinners are justified in the sight

of God alone by the imputed righteousness of Jesus Christ.

Art. VI. We believe in the doctrine of election that God hath from the beginning chosen us unto salvation through justification of the Spirit and belief of the truth.

Art. VII. We believe in the preservation of the saints, and that they who believe shall be finally and eternally saved.

Art. VIII. We believe that baptism is the immersion of a regenerated person in water by a regularly ordained minister of the Gospel.

Art. IX. We believe Church membership to be a prerequi-

site to the Lord's Supper.

Art. X. We believe a Gospel Church is a body of true believers in Christ who have been regularly baptized on a profession of faith in Christ.

Art. XI. We believe in the resurrection of the bodies of all persons and a future and general judgment, and that the happiness of the righteous and the punishment of the wicked will be eternal.

Art. XII. We believe in the work of missions, Home, For-

eign and Domestic.

Proceedings.

LEXINGTON, ARK., August 29, 1895.

The Pee Dee Baptist Association met in its Twelfth Annual Session with Mount Olive Church on Thursday before the first Sunday in September, 1895. The introductory sermon was

Knowing that the greater part of the world is without the true Gospel, and almost without any knowledge of the Bible, or even the existence of the true God, and realizing that we, the Baptists, are the proper custodians of the pure Christian doctrine, and that we for many years have not obeyed the greater commission, "Go ye into all the world and preach the Gospel," to that extent that we realize is our duty to do; therefore, your committee would respectfully urge upon this body to raise all the money possible to aid our brethren who are laboring under the greatest disadvantages in the foreign fields.
