PROCEEDINGS.

Friday Evening, October 25th, 1907.

Grand Prairie Baptist Association met this day at 7:30 P. M., with the Rising Sun Baptist Church, and was called to order by former Moderator, R. F. Routh. After devotional exercises led by Moderator, Bro. J. G. Harris, of Brinkley, Ark., preached Introductory Sermon, from Isaiah 55th chapter, 10th and 11th verses, and Daniel 2nd chapter, 44th verse.

fully say, they would "Seek those things Above" and "set your affection on things above, not on things on the earth," and nearly everybody in the house come forward and gave their hand, praying God to bless their efforts in living a life, "that is hid with Christ in God." EXECUTIVE BOARD REPORT.

We the Executive Board of the Grand Prairie Baptist Association beg leave to report as follows:

Our first Meeting since the last Association was with the Church at DeVall's Bluff, Minutes of which we never received; the other meetings were with the litutgart Church. None of these meetings were largely attended. At the July meeting we found we were about \$100 behind with our Missionary, and motion made and carried, that we borrow money from individual members and pay him, and \$65.00 was borrowed to be paid back when this Association meets.

At each of our meetings the Missionary and Treasurer made their reports which were received and adopted. At our present meeting we find we only owe our Missionary \$8.82, as shown by his report, to be read in connection with this report, which shows the Lord has blessed our efforts greater this year than ever before by the addition of 200 souls to our churches. We recommend we employ a Missionary next year for all his time.

Routh as Missionary for coming year, and he decides to go elsewhere, this Association recommend him to any Association he decides to locate in. Carried.

REPORT ON EDUCATION.

A few years ago, education did not mean so much in the business world as it does to day. Conditions have changed and education is a necessity; but to think of an education from a commercial stand point only, is selfish. God has given us special gifts and talents, and we must develop them or God is not pleased. Education properly acquired broadens the view, strengthens the character, increases the enjoyment of life and better fits men and women for the service of God and their duty toward their fellow beings. We have two excellent Colleges in our state—Ouachita, at Arkadelphia, for young men and young women, and Central, at Conway, for young women only. We urge our people to send their sons and daughters to these Institutions for a College education.

We have read the Constitution looking to the establishment of the Baptist Collegiate Institute at Brinkley, Ark., in co-operation with our Sister Associations, Mt. Vernon and White River Valley, and we most heartly recommend its

adoption by this Association.

In connection with this report, the Constitution was read by Rev. J. G. Harris, and adopted as part of this report:

CONSTITUTION

of the Baptist Collegiate Institute, formerly designated Mount Vernon High School,

The conditions of the establishment, maintenance and perpetuation of which shall be as follows:

- I. We, the Baptist and others, acknowledging, contributing to and fostering the same, propose that said school shall be established and incorporated in the town of Brinkley, Monroe county, Arkansas, to be known and denominated the Baptist Collegiate Institute.
- II. That the same shall be controlled and supervised by a Board of Trustees, selected by the Associations, as follows: Each Association shall select one Trustee for every three hundred members or fraction thereof, to the number of one hundred.
- III. That said Trustees hold office three years, alternately, as designated by their respective Associations.
- IV. At all meetings of the Board of Trustees a vote of a majority of the members present shall govern in all questions, provided that not less than three members of the Board shall constitute a quorum for the transaction of business.
- V. The teacher or teachers of said school shall be members of a Missionary Baptist church or churches, the same to be selected by the Board of Trustees.
- VI. As its name designates, it shall be the purpose of said school to give our boys and girls a thorough Christian education fitting them for the ordinary duties and responsibilities of life. The curriculum of said school to be such as to prepare them for graduation with the A. B. degree in two years from any high class college.
- VII. All property obtained by or for said school shall be deeded to the Board of Trustees and their successors in office, to be held in trust for and in the interest of said school, and is not transferable without the consent of all American in co-operation with said school.
- VIII. In case of abandonment or final dissolution of said school, the Board of Trustees shall legally dispose of the property belonging thereto, and apply or dispurse the proceeds as the vote of said Board may direct, after discharging all obligations of indebtedness, provided the same is in the interest of Baptist denominational education.
- IX. It is understood that this shall go into effect immediately upon its adoption by one or more Associations and they appoint Trustees.

Both report and Constitution were discussed by Eld. J. H. Coleman, Eld. C. F. Kean, Eld. J. G. Harris and Bro. H. J. Kelley, and on motion, both were adopted.

Moved and carried that Moderator appoint 5 trustees from this Association to the college. Adjourned to 6:30.

SUNDAY SCHOOLS.

The report on Sunday Schools was then read and adopted as follows:

The Sunday School is one of the best agencies for spreading the Gospel and bringing the lost to Christ. It is estimated that from 85 to 90 per cent of those converted come from the Sunday Schools. We are glad that so many of our Churches maintain Sunday schools. It is our conviction that each church should have a Baptist Sunday School all through the year. We therefore urge that a greater effort be made by our pastors and churches to this end, and that they urge the members of the church as well as the children to attend, for the study of God's word and the promotion of his cause. We also recommend that Sunday Schools be established in communities where there are no churches as a means of doing effective mission work.

CONSTITUTION.

- ANTICLE 1. This body shall be known by the name of the Grand Prairie Haptist Association, and composed of members chosen by the different churches in the union, who, on producing letters, shall be entitled to seats; also the oriented ministers in good standing, retiring moderator and all committees appoint at one session to report the next.
- ART 2. The motto of this Association shall be: "The truth in its purity, promoted in every section of our bounds."
- ART 8. The letters from the churches must state the number of members builtind, received by letter, restored, dismissed by letter, excluded, the name and postoffice of pastor and clerk.
- ART. 4. The members thus chosen and convened, shall have no power to incling on any of the rights of the churches, but may act as an advisory countries to the common good of all the churches and advancement of the Redeemer's kingdom, and have power to exclude any church from her fellowship which may apart from the gospel of Christ, either in faith or practice.
- ART, 5. Every church composing this Association shall be entitled to three
- ART. 6. Should any church fail to represent herself for two consecutive some, she may be dropped from the list of churches, should a satisfactory reason multiple given.
- Aut 7. New church may be admitted into this body who petition by letter and delegates, if found to be sound in faith and in good order, the reception to be manifested by the the moderator giving the right hand of fellowship to the
- ART 8. This Association shall annually elect a moderator from among themselves whose duty it shall be to see that the Rules of Decorum are observed and take the voice of the Association on all questions properly brought better it; also, a vice Moderator, and a Clerk, whose duty it shall be to keep a record of all the business of the Association; also, a treasuser, to receive all liburato the funds sent up to the Association, as directed by the body, or business and in the same.
- MINUTE the names of all churches admitted to membership, until such are dropted by action of the Association; and in cases of non representation, it shall be

his duty to write: "Not represented," in the proper place opposite their names in the satistical table.

ART. 10. This Association shall in all cases be governed by a majority of the members present, except in the reception and dismission of a church, which shall be unanimous

ART. 11. This Association may correspond with other Associations and Conventions as may be agreed upon while in session.

ART. 12. It shall be the duty of the Association to appoint a minister to preach an Introductory sermon, with an alternate; also one, with an alternate to preach a Missionary sermon at each succeeding session; and to fix the time and place for the next meeting of the body.

ART. 13. The Moderator shall appoint, at each annual session, an Executive board, consisting of at least one member from each church, whose duty it shall be to elect and employ a Missionary or Missionaries, in our bounds; to solicit and collect money, or issue orders on the Treasurer of the Association to pay the same, which orders the Treasurer is hereby authorized to pay out of any money that he may have for this purpose; also to change, during vacation, the time or place, or both, for next meeting of the Association, whenever, in the providence of God, it may be necessary. The officers of the Association shall be considered members of the board.

ART. 14. The Constitution may be altered or amended at any time, by a two-thirds vote of the members present, except that clause in the fourth article which prohibits interference with the internal rights of the churches; which shall forever remain in tact.

ART. 15. The Minutes shall be signed by the Moderator and clerk.
