WYNNE, ARK., OCTOBER 5, 1911

- 12. Upon motion of W. C. Wood of Paragould, it was in like manner ordered that J. H. Kitchens cast the vote of the Association for B. H. Parrish for Secretary. It was so done and be was declared duly elected.

- 21. The report on Literature was read by J. R. Gregson of Jonesboro, who yielded his time to E. J. A. McKinney of The Baptist Ad-

vance. The report was spoken to by E. J. A. McKinney, E. E. Dudley, P. C. Barton, and J. B. Alexander, and then adopted as given herewith.

Religious Literature.

Three things should be sought by us in reading; namely, information, inspiration, and spiritual growth. No man can be informed man without reading; knowledge is the basis of inspiration. Spiritual growth is also essential, and that must be largely a fruit of the devotional in reading.

Of course the Bible comes first in its place as the book for every Christian. Why should it be necessary to urge upon a Baptist—one who makes the Bible the basis of his faith and practice—to read the Bible? And yet we do need to urge this as one of the needs of today.

Then we would urge the reading of good books, hundreds of which come from our own Baptist Press.

As Baptists, too, we are members of a great Baptist family, and we need to know what the brotherhood are doing throughout our own state and the world. Here comes the place of the Baptist newspapers, and in this connection we would urge that our people take and read the Baptist Advance of Little Rock, our State paper, a 16 page weekly, that now comes at \$1.00 a year, cash-in-advance. This paper fosters every denominational interest, whether it be Evangelism, Education, Orphanage, Sunday Schools, B. Y. P. U., or Sunbeam work.

Then we would urge that our people take and read the Foreign Mission Journal, the Home Field, The Orphans' Gem which is now published at Monticello, Ark., in the interest of the Orphanage, and comes at twenty-five cents a year in clubs of ten.

State Missions.

Next to Associational Missions, State Missions is the most important work fostered by our people. Something less than \$10,000 has been collected by our State Mission Secretary up to this date. It will require about \$25,000 more to pay for the work done by our Missionaries.

In order to raise this money, every one of us will have to do his or her part. The question for each of us to decide is what is our part, and then do it.

We recommend that each church in our Association take a collection for State Missions between now and the meeting of the State Convention.

24. The report on Foreign Missions was presented by E. E. Dudley of Jonesboro, and after being discussed by E. E. Dudley W. A. Ramsay, and W. C. Wood, it was adopted.

Foreign Missions.

Never before in the history of our Foreign Mission Board has 3223 baptisms been reported as a partial result of one year's work. In the face of manifold difficulties, our Missionaries have pressed boldly on, and God has greatly honored their sacrifices.

In this report I wish to depart a little from the custom of making general statement relative to the work, and give a brief statement about the work in each field, then to give a summary of the work that we may all have some facts at hand.

Fields of Labor.

Argentina.—Only seven years ago we began Mission work here, with Brother Sowell as Missionary. Now we have fourteen Mission-

aries, six organized churches, and ten outstations, with a membership of 255.

Brazil.—There has been most glorious victory in Brazil during the year past, and 1257 have been baptized. This work only begun in the year 1879, has grown until we now have 109 chnrches with a membership of 7085.

Persecution has been fearful in this Roman Catholic country, but our God is giving the victory.

Italy.—In my judgment our work in Italy has given less apparent return for the amount of labor and money expended than any of our Mission fields. But was not this to be expected under the shadow of the Vatican, and at the beart of the Roman Catholic world? Even here our Missionaries feel that a new day is dawning, and 113 were baptized during the first year. They have 34 courches with a membership of 993 in Italy.

Mexico.—Last year 377 were baptized by our Missionaries in Mexico. They have 47 churches, with a membership of 2000. They have 23 young men in training for the ministry.

Africa.—Here we have a trying climate. Many of nur Missionaries have laid down their lives for the independence of this country. Even on this difficult field, we have 21 churches with a membership of 1098, with 231 baptized last year.

Japan.—We began work twenty years ago in Japan. Our work had blow after blow, as the health of so many of our Missionaries here failed them. We now have 10 churches with a membership of 504. It is thought by our board that we ought to have many more Missionaries on this field at once, for the field is white unto the harvest.

China.—From the organization of the Southern Baptist Convention in 1845, we have been doing Mission work in China. We have now 62 churches with a membership of 7304. During the last year 1106 were baptized.

Our Mission School, our great printing plant and hospital work is telling mightily on this country.

Summary.—On our foreign fields we have 289 churches with 539 out-stations, and a membership of 19,239. We have 207 houses of worship and 218 Sunday Schools with 11,156 scholars. Have 142 day schools with 3771 pupils; 11 boys' boarding schools with 721 students; 12 girls' boarding schools with 610 students.

There are eight woman training schools with 179 students and eight Theological training schools with 200 students.

With these facts before us we must feel that we stand on the

threshold of a new era with great opportunities and mighty responsibilities.

Temperance.

It is with joy and pride that we note the growth of the temperance sentiment in our heloved state, but more especially are we grateful for the growth in our own Associational limits, for during the past year in certain districts, whiskey has been put out in a legal way, and the local officers assure us that there will be no illegal traffic in intoxicants there.

It is necessary, however, for the friends of morality, temperance, religion, and good government, to be ever on the alert, and wide-awake, as the liquor forces are grasping at every opportunity possible to regain the lost ground. Let us work and pray that they may never do so.

We therefore recommend that every Baptist (and we regret the necessity of making this) in this Association, and every friend of the great cause, to abstain from the use of intoxicating liquors, and to seek to create public sentiment against the habit and the traffic, and to vote for the total elimination of both from the state and the na-

RESOLVED, That the Mt. Zion Association give to The Baptist Memorial Hospital located at Memphis, in which enterprise the Baptists of Arkansas are joint owners and share joint responsibility with the Baptists of Mississippi and Tennessee, our hearty approval and endorsement.

- 2. That we recognize the ministry of healing as a vital part of the Savior's service to men, which embraced the works of preaching, and teaching and healing, that He Himself practiced it while living among men, and commanded His disciples after Him.
- 3. That we regard this work not only as a Christian duty and privilege, but as a powerful and effectual agency for evangelization and of building up the Kingdom of God in the world.
- 4. That we appoint a committee, annually, to report on the progress and claims of this institution, and request our pastors and churches to give opportunity for the presentation of its claims before the people.
- That we request our churches to report their contributions to this work annually in their letters to this body.

Education.

There is nothing of greater importance to this and coming generations than Christian Education. In it rests the foundation of the state, the security of our homes, and the promotion and extension of the Gnspel of our Lord.

Every institution in our land which sets forth in its practice and labors always to this end, contributes the most to our land, and the future prosperity of our nation. Every denominational institution which is fulfilling, in the truest sense, its place in teaching and spreading the doctrine and principles of that denomination for which it stands, is the most beneficent agent which that denomination can employ. Denominational institutions of learning are absolutely essential to our times. It is imperative that we provide and maintain such institutions in order that we may properly equip this present generation for the duties and responsibilities which we have for them to discharge.

The Mt. Zion Association is attempting to do this in the establishment and maintenance of Woodland College located at Jonesboro, Arkansas, and we hope that the youth of both sexes, the sons and daughters of Mt. Zion Association, may be persuaded to enjoy the mental and moral training which this institution is prepared and adapted to impart.

It is also the mind of this committee that we recognize the great work of other Baptist Schools in this state, and that we give our loyal service and prayers to all worthy colleges owned by Baptists.

We further recommend that in view of the fact that Woodland College is owned and controlled by Mt. Zion Association, that this institution he made one of the nbjects to which our Association should contribute regularly each year.

Report of Board of Trustees of Woodland College.

We, your Board of Trustees for Woodland College, beg to report that our school opened September 21st, 1910, and closed June 4th, 1911, and had a very successful term, notwithstanding the fact that the patronage was not what we had hoped that it would be.

Under the present management the curriculum has been raised and made equal to that of our best colleges. The school also offers the best advantages in piano and voice culture and business course.

The constant aim of the Board of Trustees has been to provide the very best material to be obtained for our faculty, and so far their efforts have been rewarded with most happy results.

The present faculty consists of C. E. Dicken, President; Mrs. W. B. Anderson, Lady Principal; Prof. Geo. C. Rowlett, Miss Katherine Frazier, and Prof. C. Frederick Ohlenmacher, Director of Music, the splendid qualifications of all of whom are fully set forth in our catalogue for 1911-12.

The Treasurer's report last year showed that our liabilities were \$8568.04 and cash in hand \$600.43, and notes amounting to \$4163.03. Our Treasurer's report for this year shows our present indebtedness to be \$9450.00 with notes and pledges amounting to \$3284.48, thus showing a deficit on running expenses and interest account of \$2042.39. This made it obligatory ou your Board of Trustees to use some of the money collected for the liquidation of the indebtedness of our institution to the payment of running expenses and we ask that this Association ratify this action and authorize a similar privilege for the ensuing year, should same become necessary.

The above deficit occurred, notwithstanding the fact that the school has had wise and economical management in the person of Prof. C. E. Dicken, together with the close co-operation with the Board.

Your Board of Trustees unhesitatingly say that this deficit was due to the lack of interest and hearty support of the members of this Association. The entire eurollment in the literary department last year was only twenty-one. We are glad to say, however, that the enrollment to the present time this year, in the same department, is thirty-three and new pupils being added from time to time.

We feel confident that the enro'lment will be more than double that of last year.

We would recommend that H. W. Graham, whose term expires with this meeting, be re-elected; that W. B. Langford and C. R. French be elected to succeed J. C. Span and W. L. Gage whose terms also expire at this session.

We would further recommend that the Board of Trustees be authorized to put a competent man in the field for the purpose of securing students and to raise at least \$2000.00.

We would also recommend that an offering be taken in this meeting for this cause.

- 37. The Association was called to order, and after singing "Glory to His Name," was led in prayer by J. L. DeArmond.
- 38. The clerk read the record of the session of the two previous days, and the roll of representatives was called.
- 39. The report on Sunday Schools was read by J. R. Gregson who yielded his time to W. A. Ramsey, our State Sunday School man. Bro. Ramsey spoke to the report, at some length, and it was adopted as given below.

Sunday Schools.

We regret to report that the statistics gathered from the Associational letters, show a decrease in the Sunday School interest in Association as a whole. Eight out of forty-two churches show no schools. Two churches, however, report three schools each, hence we find fifteen churches reporting no schools. We are sure that these reports are incorrect, on account of the failure of the clerks to furnish the Sunday School statistics. We would urge the importance of giving more attention to these details in order that the Association may know the real condition of our Sunday Schools.

There is room for great improvement, for with a membership of more than 5,000, the Sunday School enrollment is only 2,000, as shown by the church letters.

We would urge the necessity of teacher training, and of a careful study of Sunday School problems on the part of pastor and laymen. These can best be solved by our Sunday School workers meeting for the purpose of studying and discussing these problems. We need to know the conditions, and to proceed in an intelligent way to improve them.

The problem of the Baptist Sunday School is peculiar, and can only be solved by Baptists, hence we recommend that all churches in this Association join in the organization of one or more Sunday School Conventions for the purpose of improving the condition of the school. We now have aid whereby we may establish Sunday Schools in communities where there are no Baptist schools.

41. The report on Orphans' Home was read by J. N. Robertson. It was spoken to by J. W. Williams, and W. B. Langford, and adopted as given herewith.

Orphans' Home.

The Orphans' Home at Monticello, Arkansas, is one of the most important institutions fostered by the Baptists of Arkansas. It should have the sympathy and hearty co-operation of every Baptist in the state.

This Orphanage is a power for great good, and is perhaps at this time instrumental in leading as many young people to Christ as any one single institution in the state. We had 33 conversions in the home last year.

One year ago there were 110 orphans in the home; this year there are 130. We need more room, for in many instances there are from two to four in one bed, and from eight to twenty-three in one room. One pressing need is a dormitory for the boys. Then we must have food, clothing, and some other necessities are to be provided.

Having no special agent in the field, we recommend that the pastors and members of the various churches consider themselves agents to collect and send money to J. N. Williams, Monticello, Ark. We also urge that our people subscribe for the Orphans' Gem, a monthly paper published at Monticello in the interest of the home.

51. The report on Home Missions was read by T. B. Kitchens, and after being spoken to by T. B. Kitchens, and W. H. Meredith, was adopted.

Report of Committee on Home Missions.

Home Missions sustains the relation to Foreign Missions that the base of supplies sustains to the army on the firing line. Foreign Missions will not long continue without proper Home Mission effort. Home Missions is defensive. We must meet the many foreigners coming to our country with the Gospel ere they meet us with heathenism and error.

We rejoice in the blessing our Lord has given the efforts of Home

Missions this year. Cuba had 22 Missionaries and 12 assistants, with 201 baptisms last year. Panama had 118 baptisms. Our Home Board co-operates with the different State Boards by large sums of money. It also contributes to the colored brethren to assist them in maintaining their work. Twenty-six mountain schools are fostered by the Home Mission Board. Money from the Building and Loan Fund is loaned to churches for building purposes.

Indian Missions come in for a large interest, and work among immigrants is maintained. \$333,534.00 was contributed to Home Missions last year. \$6,612 contributed by Arkansas; \$5,915 less than we gave the year before. This year the Home Board is trying to raise \$400,000. Arkansas is asked to give \$15,000 this year. 49,297 additions were r ported by the Home Board last year.

Brethren, we recognize that Home Missions is a grand and good and great work and herein recommend and urge upon the brethren and churches that we co-operate in Home Missions to our fullest extent.

54. The report on Woman's Work was read by W. G. Mathis, who spoke to this report, and Mrs. J. L. Burns was then called for and responded in an interesting talk on this subject. Adopted.

Woman's Work.

The work of our Baptist Women in our Association is one of great importance, and one upon which we cannot lay too much stress, for it is the purpose of this work to aid our churches in every department of their work. If our women help our churches, they have a right to the endorsement of the churches, and the hearty co-operation of the pastors of the churches.

We find that many of the churches, and especially the churches which stand in the front ranks of the work and are doing the things worthy of themselves, are those churches which have live, active woman's organizations. This being true, how important it is, then, that all our churches have these organizations.

We therefore recommend that each pastor see that the women of his church are organized into these working forces. We also recommend that each society make quarterly reports to our Associational Superintendent, Mrs. J. L. Burns, Jonesboro, Ark. This will greatly assist in keeping her in close touch with the work all over the Association, and enable her to make a complete and correct report of the work each year. Write her for information.

We recommend further that individual members of the different organizations subscribe for The Baptist Advance, The Foreign Mission Journal, The Home Field, and The Orphans' Gem.

We are pleased to note that our Superintendent reports that about one-half of our churches in this Association have Ladies' Societies, though only about one-half of these report to the annual meeting. The report given elsewhere in this minute shows \$2,578.75 raised for all purposes during the year.

Your Board is pleased to report that it employed Elder Otto Mathis as Missionary to do Mission work within the bounds of the Association beginning with December until the close of the Associational year, at a salary of \$1000.00 per year and traveling expenses and we herewith submit the report of Brother Mathis as such Missionary showing 90 professions.

We call sepcial attention to his work in the organization of churches at Marion and Bono, each of which now has pastors and are doing active work. However, we are sorry to note from some unknown cause the church at Marion has failed to represent in this body.

We regret to note that a number of churches that have received aid from your Board have failed to comply with their part of the contract as made in their application for help, to-wit: That they will take regular collections for all objects fostered by our Association and the conventions of our Southern Zion and we ask that this hody say whether or not the incoming Board shall assist churches which refuse or neglect the great commandment, "Go into all the world and preach the Gospel to every creature."

We call special attention to his work in the organization of churches have no pastor and we believe that it would be wise for this Association to recommend that the new Board give especial attention to assisting churches in maintaining pastors wherever such churches are willing and do co-operate thuroughly with our work.

· Report of Missionary.

To the Mt. Zion Association when Assembled at Wynne:

Dear Brethren:—The following is a summary of the visible things which God has done for us within Mt. Zion Association within the last nine months, using your field Missionary as His means:

Being almost constantly engaged during every week this year I have labored 275 days, traveled 2465 miles, delivered 267 sermons and addresses, visited hundreds of homes throughout five counties and interceded for Christ through many personal beart to heart interviews. Of those who have made professions I feel ready to report 90 as genuinely saved. My policy in this respect has ever been, and I trust always will be, a conservative policy. I report only those whom conscience and common sense teach me to believe we shall meet in heaven. I have presided in organizing four new churches, and one Sunday School. One hundred and seventeen have been added to the churches. Forty-five of these have come by baptism.

The expressed plans of your Missionary Board for this year were to have your Missionary to stay in Missionary bounds; that is, on our most needy fie'ds. This I have sincerely tried to do. I must say, out of three years of Missionary work some of my most trying experiences have been in your service here, but thanks be to God, we have come and we have conquered at several of these worst and hardest little fields. We have collected just about half of our salary on the field (\$380.36) and appreciate the hearty co-operation of these strong-

er churches in their supplements to their weaker sisters in meeting the deficiency. If all our nine months' work were obliterated except the two bright, flourishing new churches at Bono and Marion, your investment would be a paying one. In other words, the whole work this year is of a class that will last and we fully expect to see the tracks of 1911 in Mt. Zion Association in years to come.

In the future one Missionary cannot touch side, edge or bottom in this overwhelming field. As the past is gone, my parting greeting to you would be to spur you on to more efficient methods in the future. The conditions are not dreams, but realities and are alarming. It is really now or never for Baptists to have the predominance, as heresies rise ranker and more poisonous in every direction. Lake City, Tyronza, Monette, Parkin, Hickory Ridge are examples from the dozens where every conceivable devilish doctrine of the land is smothering our own fair Zion and the good, old time religion. You need field Missionaries. They are perhaps indispensable, but right now you could use twenty-five Missionary Pastors. The one of you whom God will use as an importer of efficient, consecrated pastors and will provide means and methods to bold them and sustain them on fields where Baptists are in the minority and where Baptist teachings are far below par-this is the man who will be the savior of the day.

Now, Brethren, farewell. As you deliberate in this session of the good, old Mother Mt. Zion Association, I will be bending over my atudies, but my prayers will be with you. May the God of all Grace make this your best and most profitable session.
