The next session of this body will be held with Black Springs Church, Montgomery County, Arkansas, beginning at 11 o'clock a. m. Friday before the third Sunday in September, 1915. The introductory sermon to be preached by Rev. S. W. Sherrod; Rev. Elijah Abee, alternate. Missionary sermon to be preached by Rev. J. W. Hulsey. Sunday at 11 o'clock.

PROCEEDINGS

The fifty-seventh annual session of the Caddo River Missionary Baptist Association assembled with Big Fork Church, Polk County, Arkansas, at 11 o'clock on Saturday before the third Sunday in September, 1914, in harmony with its adjournment at Pleasant Hill Church.

The appointees, Brother J. O. Butler and Brother J. B. Liles being present, Brother Butler preached the introductory sermon from Matt. 1:21, and Brother J. B. Liles, the alternate, concluded the service.

Dismissed to meet at 1:30 p. m.

AFTERNOON SESSION.

At 1:30 the body was called together by singing. The Moderator, Brother J. O. Butler, read the 103rd Psalm. Prayer by Brother Parish.

The Moderator declared the body in regular order, and open for pursuance of business.

The Clerk being absent, the first business to come before the body was the appointment of a Clerk, and H. L. King was appointed Clerk pro-tem.

First-Called for the letters from the churches.

Second---Brethren Parish, Brakefield and Smith were appointed to read the letters.

Seventh---Called for correponding ministers, and on motion seated Brother H. T. Howell from Caddo Valley Association.

Eighth—On motion seated Brother G. H. Wasson as visiting minister from Liberty Church.

Ninth---Motion carried to take a short recess.

Tenth-During recess Brethren W. A Brakefield, R. M. Reece and O. E. Smith, with the deacons of Big Fork Church were appointed a committee on Divine Services, and Brethren S. C. Parish, H. A. Standridge and S. W. Sherrod a committee on Sunday Schools.

The body came together by singing "And Must This Feeble Body Die."

Eleventh—Called for report of Divine Service Committee, with following results: Preaching Saturday night in Methodist Church at Cherry Hill by Brethren H. T. Howell and E. Abee, and at Big Fork Church by Brethren J. B. Liles and Charley Roberts, and Sunday School Rally at 9:00 a. m., Sunday to be led by Brother Parish.

Twelfth—Motion carried to hear from Brethren of Caddo Valley Association, with regard to that of a consolidation of Caddo River Association and Caddo Valley Association, resulting in a very brotherly discussion.

Thirteenth—Motion carried that Caddo River Association hold an adjourned session with Caddo Valley Association which meets at Liberty Church on Friday, September 25, 1914, and extend an arm to the said Caddo Valley Association with the view of receiving it into the Caddo River Association in case it (Caddo Valley Association) so decides.

Fourteenth-Motion carried that a representative delegation be appointed to represent Caddo River Association in the adjourned session with Caddo Valley Association, and O. E. Smith, E Abee, R. M. Reece, G. I. Vandike, H. A. Standridge, with the Moderator and Clerk compose said committee.

Fifteenth---Motion carried to adjourn until Monday morning, the congregation uniting in prayer with Brother E. Abee.

SATURDAY NIGHT SERVICE.

Preaching at Big Fork Church by Brother Charley Roberts from St. John 3:3.

Also at Cherry Hill from St. Luke 11:22 by Brother H T. Howell, and

at the close of the sermon about twenty, in response to an invitation, came forward and asked to be remembered in prayer.

SUNDAY SERVICES.

Moderator conducted devotional service. At 10:00 a.m. the congregation assembled by singing "In the Resurrection Morn." Prayer by Brother Liles.

Motion carried to hear report of the Sunday School Committee, followed by a discussion led by Brother S. C. Parish, with good and visible effects, and by Brethren Sherrod, Standridge, Howell and Roberts. Motion carried unanimously adopting report of Sunday School Committee, which is as follows:

Dear brethren, we your committee on Sunday Schools, submit the following report:

The function of the church as an institution is to teach the Word, win souls to Christ, develop christian character and spread the gospel to those who have it not. The principal function of the Sunday School is to teach. The Sunday School plants, the preacher waters and God gives the increase. The Sunday School strengthens every department of church work. The pastor is the ex-officio, the advisory head of the Sunday School, and should assist in the organization, selection of officers, teachers and literature, and in planning and directing the actions of the school. The Sunday School aids in soul winning, and in the edification of Christian life. This admitted it follows that every church should have a good Sunday School. The letters from the churches of this Association show only a small part of them with Sunday Schools. They are falling short of their highest possibilities. We therefore recommend, urge and plead with our pastors and messengers to take immediate steps toward organizing and maintaining Sunday Schools in all churches that do not now have them; and we urge all members of our churches to become members and active workers in them. We recommend that our Sunday Schools use our convention literature. We further recommend all our pastors to take the Convention Sunday School Training Course. and encourage some of their church workers in doing the same. We further recommend that our Association hereafter devote one day at each Association meeting to Sunday School institute work.

Jones, being present, preached an able missionary sermon from the text, "I am debtor both to the Greeks and the barbarians; both to the wise and to the unwise," to a large and attentive congregation. Brother Howell concluded the service during which time a collection for missions was taken, amounting to cash \$5.55, and a pledge from Mt. Ida Church of \$10.00.

Scripture lesson, Matt. 3rd, prayer by Brother Parish and sermon by Brother
Sherrod, concluding prayer by Brother Roberts.

SUNDAY NIGHT SERVICE.

At Cherry Hill conducted by Brethren J. M. White and E. Abee. At Big Fork Church, a song, prayer, experience and testimony service, followed by sermon from Isiah, 40th chapter, 30th, 31st verses, by Bro. H. T. Howell.

MONDAY MORNING SESSION

Opened by singing "What a Friend We Have in Jesus." Prayer by Brother White.

First—Called for the reading of Saturday's and Sunday's minutes, and after reading and making a necessary correction, motion to adopt carried.

Third--Moderator called for report of committees.

Fifth---Report of Committee on Denominational Schools read and adopted as follows:

Dear brethren, we, your Committee on Denominational Schools, submit the following report:

The tendecy to banish the Bible from our public schools calls for increased emphasis on Christian education. Our denomination should give a larger patronage to our Baptist Colleges at Arkadelphia and Conway, and should give them liberal financial support. We recommend that our young ministers in the country prepare themselves to teach in the public schools, that being more in line with preaching than farming. We request the Ouachita College to lend all possible assistance in training young preachers for such a combination of these vocations.

Sixth-Report of Committee on State of Religion adopted as follows:

We'your Committee on State of Religion, find from the reading of the letters from the different churches, that some of the churches have had a great

We further recommend that our pastors visit the homes of their members and talk and pray in the homes where they go.

Dear brethren, your board would submit the following report; We held our first Fifth Sunday Meeting at Mt. Gilead; members of the board present, O. E. Smith, W. M. Rizley and J. O. Butler. Our next meeting was at Little Hope Church; members present, J. O. Butler. Our third meeting was held at Sweet Home Church; members present, O. E. Smith and J. O. Butler. At the third meeting we employed Brother Charley Roberts to do mission work in our bounds at \$25.00 per month. Brother Roberts reports as follows: Days labored, 37; miles traveled, 72; sermons preached, 52; conversions, 21; baptized, 10; received by letter, 1; total additions, 22; churches organized, 1; addresses, 3; total sermons and addresses, 55; collected on field, \$2.00, for which we paid Brother Roberts \$30.00.

Thirteenth---Foreign Mission's Committee report read, discussed, reread, corrected and adopted as follows:

We, your Committee on Foreign Missions, beg to submit the following report:

The Board conducts work in Italy, Brazil, Mexico, Argentina, Japan, China and Africa. In these countries we have 380 churches, with 833 outstations, 30,000 church members, and 542 Sunday Schools, with 22,000 scholars enrolled. We also have 9,376 students in mission schools, 420 of whom are in the theological seminaries and training schools, seeking specific preparation for Christian work. The present force of workers embraces just 300 home sent missionaries and 635 native workers. 5,252 converts were baptized last year; gifts to the advanced, \$44,000 last year over the previous year. We find that just four of our churches contributed to this work: Black Springs Church, \$13.50; Womble Church, \$1.60; Sulphur Springs Church, \$1.10; Little Missouri Church, .25; total contribution, \$16.45. We urge each church to take some part in this great work which the Lord has enjoined upon us to do.

amount they can to the next assembly of this body, and thereby assist in

CONSTITUTION.

- Article 1. This union shall be known and distinguished by the name of the Caddo River Baptist Association.
- Art. 2. This Association shall be composed of delegates from the churches of the Union. Each church shall be entitled to three delegates, who shall be required to furnish satisfactory evidence of their appointment by the several churches before they take their seats.
- Art. 3. The delegates, when convened, shall organize themselves into a deliberative body by the appointment of a Moderator and Clerk, who shall be chosen by ballot at each annual Association, and continue in office until their successors are chosen.
- Art. 4. This Association shall not interfere with the rights of the churches of which it is composed. It shall regard them as independent in matters of internal government, and shall act as advisory council assuming no authority except what is expressly delegated to it by the churches, or evidently implied by the nature of the compact. It, nevertheless, claims authority over its members, the delegates from the churches, or evidently im-

plied by the nature of the compact. It nevertheless, claims authority over its members, the delegates from the churches, and in justice and propriety, must have power to withdraw from and disown, all churches which departfrom the spirit of this compact by becoming heterodox in faith or disorderly in practices. It should, therefore, regard all churches united under this constitution with a vigilant eye for good. Its principal business shall be to promote the declarative glory of God, by extending the kingdom of grace on earth through the medium of preaching the gospel, and the means in accordance with the gospel to cultivate fellowship and union with all churches of Christ, especially those united in this constitution.

- Art. 5. Newly constituted churches, and churches dismissed from other Associations of the same faith and order, may be admitted into this Union by sending three delegates, their number in fellowship, baptized, received by letter, dismissed, excommunicated, restored and deceased since last session, and all other information which the churches may deem important, which shall be read and minuted.
- Art. 6, This association shall have a fund to be supplied by voluntary contributions of the churches. All the money thus contributed shall be transmitted from the churches and paid over through the committee on finance to the Treasurer, who shall be elected by ballot and hold office during the pleasure of the Association. He shall retain and manage the funds agreeably to the order of the association and present annually for inspection in the minutes a clear and distinct statement of receipts and expenditures.
- Art. 7. This Association shall furnish the churches with the minutes of every session.
- Art. 8. The Association shall take cognizance of no query sent up from the churches unless they have endeavored to solve the same and have failed; nor of any difficulties between the churches unless they have perused the 18th chapter of Matthew and have not been able to settle them; then the Association shall take such matters into consideration and act upon them at its own discretion.
- Art. 9. It shall be the duty of the Clerk of the Association to keep a regular file of the printed minutes of each session of this body and deliver over the same to his successor in office.
- Art. 10. This constitution may be altered or amended at regular meetings of this Association by the concurring voice of two thirds of the members present, provided such alteration or amendment be approved by the churches comprising the Association.

RULES OF DECORUM.

- 1. When the delegates of the several churches shall assemble at the place appointed for the session of the Association, the Moderator shall open business with praise and prayer in person or by proxy. If the former Moderator or Clerk be absent, the Association shall appoint one pro tem.
- Immediately after opening the session the church letters shall be read by persons the Moderator may appoint and the names of the delegates be enrolled by the Clerk.
- 3. When the delegates' names have been enrolled and called by the Clerk, the Association shall elect by ballot a Moderator and Clerk the plurality of votes governing the election.
- 4. All motions and amendments to motions must be seconded before they can be entertained by the Moderator. When motions or amendments to motions are made, the last one made shall be first in order and so on in inverse order, to original motion, but mover may at any time- withdraw his motion.
- 5. Any person wishing to make a motion or speak on any matter before the Association shall rise to his feet and respectfully address the Moderator, and if he be in order, the moderator shall signify it by calling the name of the person; and no one thus in order shall be interupted while speaking unless he departs from the subject, or for personal reflections; nor shall any member speak more than twice on the same subject without leave from the Association or to explain a former remark.
- 6. Whenever sufficient time has been allowed for discussion of any subject before the Association, the Moderator shall take the voice of the Association and declare the result, a plurality governing all cases except those provided for.
- No member may vacate his seat without the consent of the Moderator, while the body is in session.
- 8. When one member shall speak to or of another he shall call him "brother."
- 9. The Moderator shall have the names of the delegates called whenever it is necessary.
- 10. The Moderator may speak on matters of debate as other members by calling some one else to fill his seat while he is speaking; but not until all others have spoken who desire to speak.
- 11. The Moderator may invite visiting members in good order to seats in the council who may speak but not vote.
 - 12. The minutes of the Association may be read as may be necessary.
- 13. The Moderator shall be judge of the order, the objector may appeal to the body, a majority of whom shall determine the point of order.

ARTICLES OF FAITH.

- 1. We believe in a true and living God.
- We believe that the Scriptures, comprising the Old and New Testaments, are the Words of God and the Only Rules of our faith and practice.
- 3. We believe in the Doctrine of Election according to the fore-knowledge of God the Father, through sanctification of the spirit unto obedience and sprinkling of the blood of Jesus Christ.
 - 4. We believe in the doctrine of Original Sin by the fall of Adam.
- 5. We believe in man's inability of his' own free will and ability to recover himself from the fallen state in which he is by nature.
- 6. We believe that the sinners are justified in the sight of God by the imputed righteousness of Christ only.
- 7. We believe that the Saints shall be Preserved in Grace and never fall finally away.
- 8. We believe that Baptism and the Lord's Supper are the ordinances of Christ, and that true believers are the only subjects of Baptism, and that Immersion is the Apostolic mode.
- We believe in the Resurrection of the Dead and in the General Judgment, and that the felicity of the righteous and the punishment of the Wicked shall be Eternal.
- 10. We believe that no minister has any right to administer the ordinances of the Gospel but one who has been regularly Baptized, called and comes under the imposition of the hand of the Presbytery.
- 11. We believe that none except Baptized members have a right to commune at the Lord's Supper.
- 12. We believe that the Lord's Day shall be observed as a day of rest and religious devotion.
