# PROCEEDINGS.

The Friendship regular Baptist Association convened with Mt. Mariah Church, in Desha county, Arkansas, September 13, 1889. Owing to the absence of the Moderator, the former Clerk, called the body to order, and requested Eld. W. C. Golden to proceed with the temporary organization of the body: Whereupon he read the 90th division of the Psalms: and prayer was offered by J. H. W. Overton.

The hour for introductory service having arrived, and the appointee, (Eld. M. A. Gunter) not being present, the stand was filled by Eld. B. N. Hultsman, who preached a most excellent sermon from Jeremiah; xxxi chapter, xxxi verse. After which a recess was taken for refreshments, which were furnished bountifully, upon the ground.

The Committee on Nominations made their report. It was read by the Chairman, discussed, amended by nominating Kingsland and Bethel No. 1. Amendments lost. Adopted as first read. [See Report D.]

Committee on Publications made their report. It was read by the Chairman, discussed and adopted. [See Report E.]

Committee on Education made their report. It was read by the Chairman, discussed and adopted. [See Report F.]

Adjourned for refreshments which were bountifully furnished on the grounds.

Wednesday (7:30 p. m.) before the 3rd Saturday in September, A. D. 1890.

A number of resolutions were read, discussed and adopted, see them in their regular order.

The Clerk was instructed to give the Arkansas Baptist the preference of printing our minutes if they will do it as cheap as other offices.

A motion was made and carried to adjourn until 9 a. m. Saturday.

The body was called together by singing.

The Moderator read Lxxi. division of Psalms.

Prayer by Rev. John R. Searcy.

A motion was made and carried to appoint Eld. J. H. W. Overton agent to collect for this Association a minute of each meeting of this body, and report to this body at its next regular session.

A motion was made and carried to postpone the preaching of the Missionary sermon until 11 a. m. and immediately thereafter to take up a collection for associational missions, and the amount so raised to be paid over to Eld. I. R. Vick for mission work.

Various motions and resolutions introduced relative to the best plan for raising associational mission money. They were extensively discussed and many rejected, but at last the following was adopted.

#### REPORT F.

Your Committee on Education report the following: Brethren in our judgment this question should press itself home to our hearts, we feel that much time has been whiled away in idleness. 1st. Our standard of education is too, low, it ought to be of a higher tone, and of a more general nature that the masses might be educated. 2nd. That we should by all means educate our children. Do all in our power to employ not only competent teachers, but christians to teach our children. No one can fill the place of a teacher properly who is not a christian. It will not do to send to a dissipated man, a profane man or an infidel, for fear our children will partake of his habits. We should see to it that no drunkard should teach in our schools. 3rd. As Baptist we should labor to build up our own school. We now have the Ouachita College located at Arkadelphia in this state, one of the best schools in the south, with a faculty second to none; with all the modern advantages to give entire satisfaction in educating our children. 4th. We feel that our country has lost many good citizens, our churches many workers for Jesus by sending our children to other states, to be educated. And to-day our cause is suffering for the want of well trained men and women, therefore, let us as Baptist see to it, and educate our children at home. Finally brethren do not forget the religious training of your children. Jesus, the great teacher, is pleading for the children. Who will not, who connot send them to the school of Christ.

Jesus said go teach all nations. Go brethren we are simply teachers under the great principal of our moral and spiritual school. We ask the mothers and fathers who read this, to lay the matter to their hearts and consider yourselves assistants, and teach your children whom God has given you and whom you love.

### REPORT I.

Your Executive board beg leave to report: That there is still great destitution in the bounds of this Association, from the increase in population, and increased anxiety for gospel light. Your board has been zealous in trying to induce churches to contribute to the Associational Mission fund, but have failed to attain the usual amount from various causes, two of which we will mention. 1st. dissatisfaction on the part of some of our ministers, as to the work of the board. 2nd. From the change of plan of collecting funds, Reducing the amount from \$286.00 down to \$41.60 paid into the treasury during this associational year. Four applications for assistance In money have been made to the board. Not being willing to encumber this association with debt, and still hoping for an increased contributio, nhe answer of the board to the applications made, was finally made by appropriating the small amount of \$20.00 each to Mt. Mariah and New Prospect with Eld. I. R. Vick, as pastor; and Friendship No. 2 with Eld. W. M. Hopson as pastor. The work of the mis. sionaries has resulted as follows:

Addition to Mount Mariah by letter 2.

New Prospect by letter 2.

" by baptism 8.

Friendship No. 2 by letter 3.

We earnestly recommend that all opposition to the work of the board, shall be made during the setting of this association, and beg the brethren to work together for the Master's cause, and also recommend that some specific plan of raising money for associational missions, be adopted instead of the general plan adopted last association. For many years the Home Board, now located at Atlanta, Ga., has been doing a great work in helping to build up the cause of missions in the southern states. And in nearly all of these states we see the practical results of the work of the board. While we have the help of this board, we should do a great deal more for missions than we have been doing. The home board has been striving to plant the Gospel in every destitute part. About three years ago the Home board went into Cuba, and the Lord has blessed the work beyond our expectation. It is also the work of this board to plant the Gospel in the Indian Territory. While the work has not been what was desired, yet it is very encouraging. We find only \$69.45 paid in, but there is

eight churches that sent nothing for home missions, while we say a great deal about missions we do but little. Brethren let us wake up to the discharge of our duty. We say to the world in words that we are Missionary Baptist. Come one, come all, and let us in the future prove our faith by our works.
