# MINUTES.

### CADRON ASSOCIATION.

FRIDAY, Oct. 9th, 1868.

The introductory sermon was delivered in the absence of the regular appointee, Elder W. T. Box, by Elder T. R. Hall, from Eph. 5:1.

After a short intermission the delegates assembled and were called to order by the former Moderator, Elder J. R. Hall.

1st. The letters from the several Churches were called for, read, and the names of Delegates enrolled. See Table.

2d. The Association then proceeded to the election of officers, which resulted in the election of Elder J. R. Hall, Moderator and J. A. Johnson, Clerk.

3d. Appointed committees:

On Arrangement.—Jones, Parker, Wear, and Moderator and Clerk.

On Preaching.—R. P. Bryant, T. Bryant, Belote, Coperton and Payne.

Sabbath Schools. - Wear and Jones

Domestic Missions.—Ingram and Bryant.

On Temperance.-P. Bryant and Wear.

Ministerial Aid.—Ingram and Johnson.

On Finance.--Coperton and Johnson.

The committee on Preaching reported as follows:

Elder W. M. Lea, to preach this (Friday) night. Elder N. P. Moore at 11 o'clock to-morrow, (Saturday.) Elder J. R. Hall at night, followed by Bro. Marsh. Elder Moore to preach Sabbath at 11 o'clock, a. m., followed by Elder Williams. Elder Williams, at night. J. R. Hall to follow. Elder Williams, Monday at 11 o'clock, followed by Bro. Marsh. Adjourned till to-morrow morning, 9 o'clock.

SATURDAY, 9 o'clock a. m.

Association met pursuant to adjournment.

Prayer by Elder Moore.

4th. Roll called and absentees marked, thus\*

5th. Petitionary letters were called for, whereupon a letter was handed in from Bethel Church, Perry county, by her Messenge I Wells, which was read and Church received, the right hand of fellow ship extended by the Moderator.

6th Invited visiting brethren to seats, when Elders Moore, Williams and others accepted.

7th. Called for report of Committee of Arrangements, accepted

8th. Appointed Ministers and Deacons meetings for the 1st District to be held with Liberty Church, on Friday, before the first Sabbath in August, 1869 Elder Box to preach the introductory sermon.

9th. Appointed Minister's and Deacon's meeting in 2d District to be held with Bethel Church, on Friday before the fourth Sabbath in August, 1869. Elder Bledsoe to preach the introductory sermon.

10th. At the suggestion of the Moderator, it was agreed to send Messengers to the Arkansas State Convention, which meets with the first Church, in Little Rock, November, 1868. Elders, Bearden, Box and Brown, and brethren Parker, Griffith, Wear, Bryant and Jones, were appointed.

11th. On motion it was agreed to ask for correspondence with the Saline Association, Elder Hall, and brethren Parker, Coperton and

Jones, messengers, (Clerk to write.)

12th. Also, that we ask for correspondence with the Dardanelle Association. Elders Beardon and Box, and brethren Wells, Jones Coperton and Johnson, messengers.

13th. On motion, Brethren Box and Jones write the corresponding

letter, and the same be inserted in the Minutes.

Adjourned to 2 o'clock p. m.

14th. Called for reports of various Committees: On Sabbath Schools, See Appendix B.

Miscellaneous business-Queries:

On motion, Parker, Wear and Jones, were appointed a committee to examine the Queries from the Minister's and Deacon's meetings, held the present year, and report such as they deem proper for discussion

1st. The following reported from the 1st District:

"Is it according to scripture, when a member is excluded from a church, to join another without first going to the church from which the party was excluded and making satisfaction?" Answer. It is not

2nd. "If after a person has been divorced from a companion, and

marries again, afterward professes religion and presents themselves to the church for membership, can we consistently with the word of God, receive them?"

Answer. If divorced for a scriptural cause, receive the applicant.

From Second District:

1st "Should a church recognize the administration of a minister as valid, when it is afterwards ascertained that he was not authorized by a Baptist Church so to do. Answer. It should not.

Bro. Wear offered the following Query: "Shall this Association receive the administration of C. W York as valid?" Answer. No.

Adjourned to 8 o'clock, Monday morning.

### SABBATH EXERCISES.

The stand was occupied by Elder N. P. Moore, at 11 a. m., who delivered an interesting discourse on the peculiar tenets of Baptists. During the discourse and the remarks of Elder Williams, much good feeling was manifest, and doubtless lasting impressions were made upon the minds of many present.

Monday Morning, 8 o'clock, A. M.

Association met pursuant to adjournment.

Roll called and absentees marked.

Resumed the discussion of Queries from 2d District.

2d. "Does the New Testament authorize a man to put away his. wife for any cause, and marry again during his lifetime?" Only for the cause of fornication.

3d. "What is the duty of a church towards her members, when it is known that they are patronizing and countenancing an imposter?"

Answer. It is your duty to remonstrate with such members, and if they persist, they should be dealt with."

4th. "Has a man the right to put away his wife for being guilty of lewdness before marriage?" Answer. No.

#### RESOLUTIONS.

WHEREAS, Elder N. P. Moore proposes to commence the publication of the "ARKANSAS BAPTIST." about the 15th November, prox., and having confidence in the Christian integrity, and competency of Bro. Moore, and realizing the necessity and importance of a State Denominational Organ,

Resolved, That we hereby recommend the enterprise, and will do all in our power to extend the circulation of, and sustain said "Arkan-

sas Baptist."

Resolved, That the ministers belonging to the various churches composing this body, be, and are hereby constituted standing delegates to each annual session of this Association, and it is requested that they be in attendence, whenever at all practicable.

The following were unanimously adopted:

WAEREAS, One C. W. York, professing to be a Baptist Minister, came to this county about two years ago last February, settled as pastor over churches, preached and administesed the ordinances of the house of God, and

WHEREAS, Such has been his deportment for some time past, together with satisfactory evidence received from Kentucky, (his residence for some time,) and from Nashville, Tenn., from which place he purports to have imigrated to this county, that we are fully convinced, that he, (said York,) not only never was regularly and scripturally ordained a Baptist minister, but that he is a corrupt man, and

now living in adultery; therefore,

Resolved, That this (Cadron) Association, consider said C. W. York, a vile imposter, as unworthy of a place in the ministry and the confidence of the denomination. And we do hereby solemply adjust the brotherhood, everywhere, that they observe the injunction of Paulin such cases: "Withdraw yourselves from every brother that walk eth disorderly."

DESCRIPTION.—Said York is about six feet high, light complexion is about 45 years of age, has a scar on his throat about where ashirt buttons, has a mole on his chin, and his right thumb has been disjointed, leaving a lump on it. When praying, begins slow and in creases in speech and sound until he grows boisterous. In preaching it is the same. His education is limited, can read and write, but little else.

Be it further Resolved, That the above be published in our Miuutes, and that a copy be forwarded to the "Arkansas Baptist," for publication, and that other papers friendly to the cause be requested to copy.

Resolved, That we recommend to the churches in our bounds, the Library of the "Southern Baptist Sabbath School Union," as a suitable one to be used in their schools, from the fact, that if our princt ples are worth believing, they are worth teaching to our children.

Resolved, That this body request the churches where our sessions shall be held hereafter, to furnish a blank book for the use of the Clerk.

Resolved, That the next session of this body be held with Pleasant Grove Church, Conway county, on Saturday, before the 4th Sabbath in September, 1869.

Resolved, That Elder Bearden preach the next introductory sermon. Elder Hall, alternate; Elder Box to preach the Missionary

ermon. Elder Hall, alternate.

Resolved, That the thanks of this body be tendered the brethren and friends of this vicinity for their hospitality during its session.

On motion, the Minutes being read and approved—all joined in singing one of the songs of Zion, led in prayer by Bro. Bryant, the parting hand was extended, and the Association stood adjourned to meet at the time and place appointed.

Report on Domestic Missions.—Your committee in viewing the ground before us, are pained at the destitution found in the bounds of this Association. There are but four or five ministers belonging to this body, and with so few laborers, the harvest is truly great Many neighborhoods are without a regular Minister. It is our privillege, as well as our duty to labor in the vineyard of the Master. In view of the facts and the necessity of the work, we would respectfully suggest the appointment of a missionary to labor three, six or twelve months, as the case may be, and that his support may be raised by contributions from the churches, in corn. provisions, clothing, money, etc. Having an agent in each church to see to the collection of said articles, and make their report accordingly.

Report on Ministerial Aid.—Your committee ask to submit the following: "When God sees fit to call a man to the work of the ministry, his design is, that he may make his will known to a perishing world; and warn his creatures to flee from the wrath to come.

To perform this labor successfully, a minister must, necessarily consume a vast amount of time in preparing himself, if he makes an efficient minister; besides this, traveling and labor, together with traveling expenses, which losses should be supplied by the community which he serves. Paul says: "If a man preach the gospel, he should live of the gospel." This teaches plainly that a minister should be supported.

As to the manner in which his support is to be raised, Paul says, in 1st Cor. 16: 2, "Upon the first day of the week, let every one of you lay by him in store, as God has prospered him." This plainly teaches systematic benevolence, and your committee would urge upon you such a plan, believing it to be in accordance with the word.

Say, for instauce, you purpose in your hearts to give a certain part of your stock or labor; we think in a little time you will not claim the amount thus set apart, as your own, at all, and God will prosper you in so doing, and many a minister who is now confined to the nlow, would soon be supported amply, and thus enabled to give his whole time to the work.

#### CONSTITUTION.

ARTICLE 1. This Association shall be called and known by the name of Cadron Baptist Association.

ART. 2. The members composing the annual meetings of this Association shall consist of the messengers sent by the churches.

ARY. 3. The messengers sent by the churches to the annual meetings shall not exceed three from each church.

ART. 4. The Association shall meet annually, at such time and place as shall have been previously appointed.

ART. 5. The officers of this Association shall consist of a Modera-

tor, Clerk and Treasurer, who shall be chosen annually at the annual

meetings.

ART. 6. The Association shall have no power or control to regulate the internal affairs or discipline of any church, but it may adopt or recommend all such measures as shall be considered best calculated promote the harmony and prosperity of the churches and advance the Redeemer's kingdom; advise and consult upon such matters at the churches may, at any time present for their consideration and advice, and may receive churches of the same faith and order into the Association, or dismiss churches from the body; enquire into the state of religion in its bounds and suggest measures for its advancement, and be a communion band of union among the churches, but shall not exercise any legitimate power over the churches.

ART. 7. This constitution may be amended at any regular meeting by a vote of two-thirds, provided notice has been given at a previous

meeting.
