TWENTY-FIFTH ANNUAL SESSION.

OFFICERS.

W. H. Bowling, Moderator, - - - Salem, Ark. F. W. Harris, Clerk, - - - - - Union, Ark.

Next Session to be held with Shady Grove Church, six miles West of Salem, Fulton County, Ark., Commencing Thursday before the Fourth Sunday in September, 1899.

PROCEEDINGS.

Big Creek Missionary Baptist Association convened with Macedona church, Byron, Ark., at 11 a. m., Thursday, September 21, 1899. Elder J. H. Soden not being present, Rev. W. H. Bowling preached the annual sermon. Text: 2 Cor., 5th ch., 18, 19 vs.

Adjourned until 1 p. m.

AFTERNOON SESSION.

Pursuant to adjournment, the Association met at 1 p. m.

After singing and prayer the Moderator called the house to order and proceeded with business.

Rev. T. G. Hawkins and J. D. Cochran were appointed reading clerks.

Call for churches. Response by Oak Grove, Diamond Springs, Liberty Hill, Enterprise, Salem, Mt. Zion, Union Hill, whose messengers were received and enrolled.

By motion, all messengers present, knowing themselves to be elected by their churches as messengers to the Association, whose letters had not arrived, were allowed to vote.

A permanent organization was effected by re-electing Rew. W. H. Bowling, Moderator, and F. W. Harris, Clerk.

With a few well-chosen remarks the Moderator assumed the chair.

New churches called for. No response.

· Call for corresponding messengers. No response.

Call for visiting brethren, whereupon Rev. R. T. Farthing, of Rocky Bayou Association, and Rev. J. C. Holman, of White River Association, responded and received the right hand of fellowship by the Moderator and invited to seat with the brethren.

The Association took a recess while the Moderator made out the list of the several committees. The house reassembled by singing and the nounced the following committees:

Upon motion the query from Mt. Zion church was taken up for consideration. Query: Is it constitutional for any one to be a member of the Association who has not been appointed by the churches?

Motion that it was not constitutional carried.

Adjourned with prayer by R. E. Richardson until 9 o'clock Friday morning.

Pursuant to arrangements by the committee on devotional exercises, the audience reassembled at 7 p. m. Rev. J. C. Holman not being present, Rev. R. E. Richardson filled the stand. Concluded by Rev. W. H. Bowling.

FRIDAY MORNING SESSION.

After singing and prayer the Moderator called the house to order and proceeded with business.

Roll call and minutes of preceding day's session read and approved.

Motion to reconsider the action of the Association in regard to query from Mt. Zion, carried.

Call for absent churches. Response by Shady Grove, Pleasant Grove and Liberty.

Renew call for new churches. Response by W. H. McCustian, bearing a petionary letter from Pleasant Ridge church, which was

Renew call for visiting ministers. No response.

Adjourned until 1:30 p. m.

After 5 minutes recess the audience reassembled by singing and devotional exercises were conducted by Rev. J. E. Cargill Text: 1 John, 3-9.

AFTERNOON SESSION.

Pursuant to adjournment the Association reassembled at 1:30 p. m. After singing and prayer the Moderator called the house to order and proceeded with business.

Renew calls for reports of committees.

Response by committee on Temperance. Report adopted as read. See appendix E.

By committee on Orphans' Home. Report adopted as read. See appendix F.

Eld. W. H. Bowling proceeded to take up a collection for said Home and raised \$5.10, which was forwarded at once to the matron of the Home.

Committee on devotional exercises announced that Rev. J. C. Holman would fill the pulpit at 7 p. m.

Renew call for churches not represented. Respondental and Macedona.

Renew call for reports of committees.

Response by committee on State Missions. Report adopted as read. See appendix G.

Report of committee on Finance adopted as submitted, which was \$12.24, turned over to the clerk to pay for the publication of the minutes. See appendix H.

Adjourned until Saturday morning at 9 a. m.

Pursuant to the arrangement of the committee on devotional exercises, the congregation met at 7 p. m. and devotional exercises were conducted by Rev. J. C. Holman. Text: Rom. 1-16.

SATURDAY MORNING SESSION.

After singing and prayer the Moderator called the house to order and proceeded with business.

Roll call and minutes of preceding day's session read and approved.

Renew call for churches not represented. No response.

Renew call for visiting messengers. No response.

Nenew call for corresponding messengers. No response.

Adjourned until 1:30 p. m.

The Association took recess five minutes and reassembled by singing, and devotional exercises were conducted by Rev. D. W. Epley. Text: Rom. 10-14, 15.

AFTERNOON SESSION.

Pursuant to adjournment the Association met at 1:30 p. m.

After singing and prayer the Moderator called the house to order and proceeded with business.

The election of a President, Vice-President and Secretary for the supervision of the Fifth Sunday meetings for the ensuing year resulted in the election of Rev. J. E. Cargill, President, T. G. Hawkins, Vice-President, and H. I. Hiner, Secretary.

Oak Grove was chosen as the place for holding the Fifth Sunday meeting in October.

Shady Grove was chosen as the place for holding the next Association.

Rev. T. G. Hawkins was chosen to preach annual sermon.

Adjourned with prayer by Rev. D. W. Epley, to meet with Shady Grove church on Thursday before the fourth Sunday in September, 1900.

CONSTITUTION.

- ARTICLE 1. This Association shall be known by the name of Big Creek Missionary Baptist Association.
- ART. 2. The members composing the annual meeting of the Association shall consist of the messengers sent by the churches, ordained ministers, and boards connected to this body by reason of appointment. (Original. See Minutes of 1893.)
- ART. 3. The messengers sent by the churches to the annual meetings shall not exceed four from each church.
- ART. 4. The Association shall meet annually at such time and place as shall have previously been appointed.
- ART. 5. The officers of this Association shall consist of a Moderator, Clerk and Treasurer, who shall be chosen by a majority of the messengers, annually, at the annual meeting of the body.
- ART. 6. This Association shall have no power to control or regulate the internal affairs or discipline of any church, but it may adopt or recommend all such measures as shall be considered best calculated to produce the harmony and prosperity of the churches, and advise and consult upon the matters as the churches may at any time present for their consideration and advice. It may receive churches in this Association, or dismiss churches from the body, inquire into the religion in its bounds, and suggest measures for its advancement, and be a common bond of union among the churches, but shall not exercise any legislative power over the churches.
- ART. 7. This constitution may be amended at any regular meeting by a vote of two-thirds of the members present, provided notice has been given at a previous meeting.

RULES OF DECORUM.

1. The Association shall commence with religious exercises and a sermon from some preacher, who shall have been previously appointed, unless the Association shall otherwise direct.

2. The Moderator of the session shall preside, and the former clerk shall act (provided they attend) until the letters from the churches connected with the body shall have been read and a

Moderator and Clerk appointed.

3. It shall be the duty of Moderator to preside over the meetings during its session, and appoint committees (unless the Association shall otherwise direct), preserve order, reprove improprieties (except an appeal is made to the meeting by two members). He shall have a right to speak on all subjects, calling a member to the chair, and examine and correct the minutes if necessary.

4. The Clerk shall keep a correct copy of the proceedings of the meeting, and read the letters and documents, and may call any member to assist him at the close of the meeting. He shall take charge of the papers and documents, unless otherwise directed.

5. The churches shall designate their messengers, and report

their condition by letter.

6. Preachers in good standing in other Baptist churches or Associations with whom we are in fellowship, when attending our annual meeting, shall be invited to a seat as correspondents, and these meetings shall always be opened and closed with prayer.

7. Every member may speak twice on one subject in debate before the meeting, but no more without leave, and when speaking stand and address the Moderator and use decorus and Christian language; and no member shall absent himself from the Association during the session without leave; and any person who shall violate these rules or constitution shall be reproved as the Association shall think proper.

8. These rules may be amended by a majority of the members

present at any regular meeting.

9. The church shall contribute funds for the ordinary expenses of the body, such as printing the minutes and paying the traveling expenses of such members as the Association may send to other bodies.

10. A public collection shall be taken up at each session and applied to such benevolent purposes as the Association may direct.
