# MINUTES

## WEDNESDAY MORNING

In the absence of the moderator, Eld. N. L. Eddy, who was called away on account of a funeral, Eld. W. A. Gilbert took the lead and acted as moderator until the election of officers.

The roll call having been completed, the assembled messengers went into the election of officers.

By motion and second the rules were suspended, and Eld. W. A. Gilbert was unanimously elected moderator.

Nominations for assistant moderator: Eld. Fred Stevenson, Eld. Paul Byers.

A motion to close nominations prevailed.

Eld. Paul Byers was elected assistant moderator by standing vote.

A motion to elect Eld. Fred Stevenson clerk by acclamation carried.

Nominations for treasurer: J. L. Jones, G. M. Barnett, Eld. J. P. Crisp.

Nominations were closed by motion and second.

After a standing vote was taken, Eld. J. P. Crisp was declared elected treasurer by moderator.

Talks were made by the newly elected officers in the following order: Eld. Paul Byers, Eld. Fred Stevenson, Eld. J. P. Crisp, Eld. W. A. Gilbert.

The pastor and deacons of the entertaining church were appointed to act as Divine Service committee.

Visitors were recognized as follows: Eld. Hollis Purtle, state missionary, Nashville, Ark.; Eld. Floyd Hampton, moved from El Dorado to attend Columbia Baptist Bible School, Eld. L. H. Boswell, student and pastor; Bro. O. J. Owens, singer, El Dorado; and the following Bible School students, Eld. A. J. Smith, Eld. J. T. Gilmore, Eld. Victor Matthews, Eld. Gerald Hicks.

There was no response to the call for petitionary letters.

At the call for correspondence from sister associations, Eld. Hollis Purtle extended an invitation to visit Howard County Association, and Eld. A. J. Smith gave an invitation to visit Springhill, La., Association.

A motion prevailed to select the place of meeting for next year. Nominations were Liberty, Shiloh Union, and Antioch West.

After nomination speeches, the vote was taken, and Antioch West was chosen as the entertaining church for the meeting next year.

The time having become late, there was a motion to recess until 9:00 o'clock, Thursday morning.

Announcements.

There was a motion to reconsider the motion to recess.

Eld. Paul Byers was called to the chair.

There was a motion by Eld. W. A. Gilbert that the association assume full responsibility for the publication, "The Baptist Builder," recently begun by Eld. E. B. Jones; that Eld. E. B. Jones be elected indefinitely as editor; and that action on the motion be deferred until Thursday when the matter shall be called up.

A motion to recess until 9:00 o'clock Thursday morning carried.

The closing prayer was led by Eld. L. H. Boswell.

#### THURSDAY MORNING

The song service at 9:00 o'clock A. M. was led by Bro. G. M. Barnett.

Eld. C. T. Taylor was appointed to conduct the devotional.

Prayer was led by Eld. L. H. Boswell.

Bro. Taylor read II Chron. 7:12-22, and commented on verse 14.

Committee on Documents was appointed: Eld. C. T. Taylor, Eld. E. C. Mooney.

Visitors were introduced: Eld. J. E. Cobb, business manager of American Baptist publications and missions; Eld. E. C. Pearrow, treasurer of Arkansas state missions.

Eld. N. L. Eddy, the retiring moderator of the association, was recognized.

Letters were called for and messengers were enrolled:

The Divine Service Committee reported that Eld. J. E. Cobb was appointed to preach at 11:00 A. M. Thursday. This report was adopted.

The report on association missions was read by the clerk.

There was a motion that the report be considered in connection with the report of the missionary.

Eld. W. A. Chisholm, the association missionary, read his report.

The reports were discussed by Eld. W. A. Chisholm, Eld. E. B. Jones, Eld. C. C. Winters, and adopted.

The report on State Missions was submitted by Emerson church, discussed by Bro. W. J. Maloch, Eld. E. C. Pearrow, Eld. Hollis Purtle, Eld. J. G. Murry.

There was a motion to amend the former motion to include an offering for state missions. The motions were adopted.

Eld. J. G. Murry and wife were introduced as visitors.

While the choir sang, Eld. E. C. Pearrow took the collection for state missions. The amount was \$30.00.

Pleasant Hill Church was enrolled—J. R. Rogers.

Eld. Paul Byers was called to the chair of the moderator.

The report on Interstate and Foreign Missions was read by Eld. C. C. Winters.

There was a motion to adopt the report as read with the recommendation that an offering for interstate and foreign missions be taken at the close of the sermon by Eld. J. E. Cobb.

Eld. J. E. Cobb was introduced by the assistant moderator.

The choir sang "There's Not a Friend Like Jesus".

Bro. Cobb came to the stand, announced \$400.00 indebtedness on the interstate mission work, Eld. W. P. Griffin's passage money to Alaska paid, and the foreign missionaries paid in full. He also announced some new publications by the Sunday School Committee.

Bro. Cobb read as his lesson II Cor. 2:14-17.

Prayer was led by Eld. W. A. Gilbert.

The theme for the sermon, based on the above Scripture, was, "Following in the Train of Christ's Triumph".

At the close of a very able sermon, the choir sang, Bro. Cobb was given the handshake of appreciation, and the offering was taken for interstate missions, amounting to \$16.02.

The motion to recess until 1:30 P. M. carried.

Announcements.

The closing prayer was led by Eld. C. T. Taylor.

#### THURSDAY AFTERNOON

The body assembled at 1:30 P. M. with song service led by Bro. Harvey Spain.

Eld. N. L. Eddy led in prayer.

Eld. Paul Byers was called to the chair of the moderator.

Eld. W. A. Gilbert requested that the motion presented Wednesday afternoon concerning the "Baptist Bullder" be withdrawn as being unparliamentary. Bro. Gilbert then read a resolution aiming at the same end as that of the motion.

There was a motion to adopt the resolution.

The motion was discussed by Eld. W. A. Gilbert, Eld. E. B. Jones, Eld. Paul Byers, Eld. Hollis Purtle, Eld. Fred Stevenson, Bro. M. H. Works.

The motion on adoption prevailed.

Eld. E. B. Jones requested that an advisory committee for the paper be elected by the messengers.

A motion carried that the officers of the association and the faculty of the Bible School act as their advisory committee.

By motion, the matter of association missions was taken up.

Eld. J. P. Crisp reported \$30.00 sent by churches for association missions.

There was a motion to take a public collection for association missions.

A motion to amend the former motion to the effect that we take pledges until the amount owed is pledged carried.

The ones pledging and the amounts were: Charlie Wallace, \$2.00; Mrs. Edwards, \$5.00; Kizer, \$5.00; Friendship, \$5.00; McNeil, \$10.00; Macedonia, \$5.00; Pilgrim Rest, \$3.00; Antioch West, \$7.00; Antioch East, \$10.00; River Valley, \$3.00; Magnolia, \$7.00; Waldo, \$20.00.

There was a motion to elect a missionary for the ensuing year.

The choir sang, and prayer was led by Eld. J. G. Murry.

At the call for nominations for association missionary, Eld. W. A. Chisholm was nominated, there was a motion to close nominations and elect Bro. Chisholm by acclamation. The motion carried.

Bro. Chisholm announced that he would accept the mission work.

By motion and second Bro. Chisholm's salary was set at the rate of \$85.00 per month for the summer months and \$12.50 per week-end for the school months for time actually put in, and five cents per mile for travelling expenses.

A motion prevailed that we assume obligation for the salary of the missionary in holding a meeting at Kerlin, which work was not reported, and that the missionary report it in next year's work.

By motion the Bible School report was taken up. Eld. E. B. Jones read the report. It was discussed by him and adopted.

A motion was offered to authorize the trustees of the Bible School to sell the royalty acre owned by the school, at their discretion, for the purpose of raising money to purchase land and build houses for the students. After much discussion the motion was lost.

NOTE: The clerk enters the above item to show the sentiment of the messengers concerning this matter.

There was a motion to re-elect the present Board of Trustees of the Bible School. After an amendment had been lost, the original motion carried.

A motion to confirm the action of the trustees in electing the same faculty as last year carried.

There was a motion that teachers' salaries be set at the same as last year. After discussion by Bro. J. R. Rogers and Eld. E. B. Jones, the motion carried with the interpretation that Eld. Fred Stevenson should receive \$400.00 on the basis of a seven months school term instead of on the basis of an eight months term, and on the same basis the other teachers should receive \$125.00 each.

A motion prevailed to recess until 9:00 o'clock Friday morning.  
Announcements.

The closing prayer was led by Eld. Chester Bullock.

**FRIDAY MORNING**

The body assembled with song service at 9:00 o'clock.

Prayer was led by Eld. E. B. Jones.

The body was called to order by the moderator.

Eld. Fred Stevenson introduced an interpretation of the resolution offered by Eld. W. A. Gilbert on Thursday concerning the fostering of "The Baptist Builder" by the association. After some discussion, the explanation was adopted to follow the resolution in the minutes.

The report on Orphans' Home was read, discussed by several, and adopted with common consent to take an offering for the Texarkana home immediately before noon.

The report on Romanism was read, discussed by Eld. C. C. Winters, Eld. E. B. Jones, and adopted.

There was a motion to select the preacher for the introductory sermon next year.

Nominations were Eld. A. J. Smith and Eld. W. A. Chisholm.

Eld. W. A. Chisholm was elected, and by motion and second, Eld. A. J. Smith was elected alternate.

The Divine Service Committee announced that Eld. J. G. Murry is selected to preach Friday morning at eleven o'clock.

The report on Sunday Schools was read by the clerk and adopted.

The report on Christian Education was read by the clerk and discussed by several.

There was a motion to amend the report to the effect that we recommend the faculty of the Bible School work out and offer to Christian workers special short courses. The amended report was adopted.

A resolution concerning gambling in Arkansas was read by Eld. E. B. Jones, discussed by him, Eld. L. H. Boswell, Eld. C. C. Winters, adopted.

The report on Young Peoples' Work was read by the clerk and adopted.

Eld. Floyd Hampton was introduced as a new student in the Bible School, coming from El Dorado, Ark.

There was a motion that the regular order be suspended and that we go into the eleven o'clock preaching service.

The choir sang.

Eld. J. G. Murry, the selected to preach, was introduced by the assistant moderator.

Bro. Murry read Luke 1:87-90.

Prayer was led by Eld. C. C. Winters.

A special musical number was conducted by Bro. Floyd Formby.

Bro. Murry's text was Luke 1:78; his theme, "Better Things of the Gospel Age".

At the close of an uplifting message, Bro. Murry was given the handshake of appreciation, and the offering for the orphans' home was taken. The amount of the offering was \$20.04.

A motion prevailed to recess until 1:00 o'clock P. M.

## Announcements.

The closing prayer was led by Eld. David Hillier.

## FRIDAY AFTERNOON

The congregation gathered with song service at one o'clock.

Prayer was led by Eld. L. H. Boswell.

The moderator called the messengers to order and called for miscellaneous business.

There was a motion to instruct the clerk to print five hundred copies of minutes, and that the clerk be paid \$25.00 for his services.

By common consent the clerk was instructed to insert only totals of the reports of the missionary and of the treasurer of the Bible school in the minutes.

There was a motion that the messengers approve the action of the new Board of Trustees in electing Miss Naomi Formby to teach music in the Bible School; that we express approval of the step taken by Eld. W. A. Gilbert in raising money to buy land on which to build student houses; and that Eld. F. B. Jones be authorized to purchase the land when the money becomes available. The motion was discussed by Eld. E. B. Jones, Eld. W. A. Gilbert, Bro. M. H. Works and adopted.

Bro. M. H. Works agreed to furnish the money to buy the land immediately.

The choir sang and those present gave Bro. Works and wife the hand of appreciation for his generous offer.

NOTE BY CLERK: While the above was transpiring, the religion of the people was aroused to such a pitch that, if the least thing had gone wrong, there would have been shouting all over the place.

There was a motion that the trustees be authorized to sell the front lots of the land to be purchased at their discretion.

The report on Publications was read and adopted.

The report on Temperance was read by Eld. L. H. Boswell, discussed by him, Eld. E. B. Jones, Bro. W. J. Maloch, Eld. N. L. Eddy, Eld. C. C. Winters, and adopted.

The report on Women's Work was read and adopted.

The report on Lord's Day Observance was read by Bro. Chester Jones, discussed by Eld. N. L. Eddy, and adopted.

The report on Pastoral Support was read by Eld. Fred Stevenson, Eld. W. A. Chisholm, Eld. David Hillier, and adopted.

The report on Church Discipline was read by the clerk, discussed by Eld. J. G. Murry, and adopted.

The assignments to churches of reports to be submitted next year were read by the assistant moderator.

The report on Documents was read by the clerk and adopted.

The report of the Finance Committee was read by Eld. J. P. Crisp and adopted.

The report of the Treasurer was read by Bro. F. A. Formby and adopted.

Eld. J. G. Murry stated that he brings greetings from the Loneoke Association.

There was a motion that the clerk have printed, if finances permit, letter forms to be distributed to the churches for use next year.

There was a motion that the moderator appoint a committee of three to study the Articles of Faith, the Statement of Principles, the Rules of Decorum, and the Order of Business with the idea of devising plans for expediting business.

A motion prevailed that the reading of letters be eliminated next year, and that the moderator appoint a committee on enrollment and digest of letters.

The committee appointed on the second item above are: Eld. Paul Byers, Eld. J. P. Crisp, Eld. N. L. Eddy.

A resolution of thanks for entertainment was read by Eld. E. B. Jones and adopted.

By motion and second the treasurer was allowed his expenses for the past year.

Talks were made by ladies: Mrs. Howard, Pilgrim Rest; Mrs. George Barnett, Antioch East; Mrs. B. F. Booth, Antioch East; Miss Naomi Formby, Antioch West, and others.

By motion and second the body adjourned to meet with Antioch West Church, on Wednesday before the second Sunday in October, 1942, at 10:00 o'clock A. M.

The song, "God Be With You Till We Meet Again," was sung while those present engaged in a general handshaking.

## REPORT ON ROMANISM AND MODERNISM

Modernism is not modern in its origin. It goes back to the Garden of Eden. It has often changed its garb, but underneath it has ever been the same.

#### ORPHANS' HOME

We, the Committee on Orphans' Home, make the following report:

The orphans' home was found in fair condition, having twenty-three children enrolled. There are thirteen girls and ten boys, the oldest, a girl of seventeen and the youngest a boy of six. Twenty-one

of these children are clothed by the churches. This leaves two who must be clothed by the public. These are boys seven and nine years of age.

We recommend especially that the country churches donate such canned goods as peas, beans, kraut, squash, apples, pears, etc., also dried fruit, peas, beans, corn, Irish and sweet potatoes, and syrup. The home has on hand several hundred quarts of berries, peaches, and grapes. On account of a lack of sugar, these cannot be used. We recommend that the town churches take collections to provide for this shortage. There is great need for wash cloths, bed spreads, sheets, and all kinds of dishes.

We further recommend that all the churches that would like to can for the home call for the jars they would like to fill during the canning season for next associational year.

We believe that our superintendent and wife, Bro. and Sister Hoy Crowell, and matron, Sister Jenkins, are taking the best of interest in caring for the children.

We advise that the association take a collection while in session, and that the churches take collections for the support of the children regularly and send same to the treasurer, C. F. Walters, Malvern, Ark.

All the churches should visit the home as often as possible to encourage the work.

#### THE LORD'S DAY OBSERVANCE

We will begin our report, first with the Fourth Commandment, trying to show how we should use the Sabbath: "Remember the Sabbath day to keep it Holy." We also find this in Exodus 20:8. #### TEMPERANCE

One of the worst steps in this direction in the last few decades, is the repeal of the Eighteenth Amendment. I doubt that God will give us victory as long as we make it legal to sin. We all know the evils of liquor; and the churches ought, by the grace of God, to awaken to their duty of disciplining members who indulge in liquor. It is just as much sin to drink beer as to drink any other liquor. The member who drinks beer owes the church an apology. He should refrain thereafter or the church should exclude him. Beer appetites lead to red liquor appetites. The church needs to discipline any member who votes to retain legal liquor. A habitual sot has no more place in a church as a member than has a horse thief. Is he not a robber in effect? He steals and destroys the influence of the church, steals the safety of anyone he meets, especially if he drives a car. He steals food and raiment from his family. He steals the souls of men by leading them into drink, which if followed leads them to procrastinate so long that they become inmates of hell.

We cannot stop the world from drinking, but we can preach the gospel to men. If they receive it they will quit drinking. We cannot make some church members quit drinking, but we can withdraw fellowship from them and announce to the world that we do not approve of drink. Let us resolve as churches to do these things and, in so doing, honor God from whom all blessings flow.

The wrong kind can better enable the wicked man to carry on his evil work. The right kind is not only for the purpose of equipping one to fill a position acceptably but also to live a worthy life.

The responsibility for the right kind of training rests especially on the home and on the church. Through the Sunday Schools and the regular worship periods churches are doing a much needed work in teaching moral and spiritual truths, so vital to the needs of men. Special schools also have been established and maintained, in which the Bible and related subjects are taught.

Realizing the need for a school of this kind, this association has made provision for the teaching of young preachers and other Christian workers, near the A. & M. College.

We recommend that the churches give every encouragement to the teaching of the Bible, and that we support Columbia Baptist Bible School with our prayers and gifts.

#### REPORT OF BOARD OF TRUSTEES OF COLUMBIA BAPTIST BIBLE SCHOOL, YEAR 1940-1941

Again we bring to you a report of the work done by you through the Columbia Baptist Bible School. This is not simply a report of our stewardship as your servants, but a report of your stewardship as you have cooperated together in the work of teaching the Word of the Lord and training those whom the Lord has called to preach His Word and other servants who are called to work in different fields of Christian endeavor.

We are glad to be able to report to you that the school is growing. Last year was by far the best in the history of the institution. There were twenty-eight students enrolled in the Bible School proper and thirty-six students of the A. & M. College who received instructions by a member of the faculty of the Columbia Baptist Bible School. Of this number there were twenty-three preachers. In addition to these students there were more than seventy-five boys in the N. Y. A. camps who received instruction by a teacher in the Bible School.

The financial support was better last year than in any previous year. Only once during the year were we unable to meet the obligations of the school at the end of the month, and this delay was of short duration. The school year ended with a small balance in the treasury. With the monthly checks from our royalty acre and a few regular contributors through the summer we have been able to pay for annual Bulletin which cost \$12.20 and to pay for a \$2,500.00 insurance policy on the building and furnishings, costing \$30.00. Not only have all expenses been paid, but we begin the year with a balance of \$151.46 in the general fund and \$7.00 for student aid. With the money sent to the association and a liberal offering here, we should have about enough money to pay for the first two months of this year's work. Surely with this splendid beginning we should be able to run this year on a strictly cash basis.

We have enrolled ten preachers and two ladies in the school already this year and there will be a number of other preachers in school soon.

The work in the A. & M. College is being done in a different manner this year to the method used in the past. Therefore, we have

not enrolled as yet any of the students in the college. We hope to have a class in the college in the near future as we have had in the past.

The enrollment is a little smaller at this time than one year ago. This is due to two conditions that prevail at present: First, living expenses are much higher than one year ago and some of the preachers who had planned to attend this year have been unable to enter. Second, we have a housing problem that has kept some away. It is difficult to find any kind of house in which to live except those in Magnolia, which are few in number, and the rest in town is prohibitive for preachers who are attending school. In spite of the conditions we confidently believe that the enrollment this year will go beyond any previous year. The type of work being done is equal to any year, and perhaps in some respects the best ever done by the school.

#### OUR NEEDS

The imperative need of the moment is that of houses for our students. The Board of Trustees has already given approval to the proposition of purchasing some land and building some small houses that can be rented at reasonable prices. The plan is to get individuals and churches to furnish money to finance this proposition in the form of a loan. The money to be repaid from rents on the buildings. As soon as the money is repaid the houses will become a source of revenue for support of the school. We request the messengers of this association to give careful consideration to this matter at this time.

The faculty this year is the same as last, namely, Elder E. B. Jones, president; Elder C. C. Winters, dean; Elder Fred Stevenson and Elder J. P. Crisp. The president and dean are also teachers in the school.

The treasurer's report is submitted herewith as our financial report and is self-explanatory.

FOURTH, That we appreciate the stand that our Governor, Homer M. Adkins, has taken against gambling and pledge to him our full support in his efforts to stamp this vicious practice out of our State;

FIFTH, That a copy of these resolutions be furnished the Arkansas Gazette, Little Rock, Arkansas, the Banner-News, Magnolia, the Columbia County Journal, Waldo, and that our religious papers be asked to give publicity to same;

FINALLY, That we pledge our best efforts and our sincere prayers to the end that our great State may soon be freed from the blight of legalized sin in the form of legalized liquor and gambling.

ARTICLES OF FAITH

ARTICLE I.—We believe that the Holy Scriptures of the Old and New Testaments are the inspired Word of God, constituting the only and sufficient rule of faith and practice by which any doctrine or discipline should be determined. (Psa. 19:7; II Tim. 25:17; Petey 1:21; Rev. 22:18-19.)

ARTICLE II.—We believe there is only one true and living God, and He is revealed to us under the personal distinction of Father, Son, or Word, Holy Spirit, but as one divine essence, infinite in every nature and moral excellence. (Deut. 6:13-14; 21:8-22; Matt. 23:19; John 2:16; 2 Cor. 8:14-23; Acts 5:3-4; Rom. 9:5; Cor. 2:16; 2:13-14; I Tim. 3:16; Rev. 1:8.)

ARTICLE III.—We believe that man was created holy, but by a willful violation of the law of his Maker, he fell into a state of sinfulness, and brought death upon his race, who by natural descent in the unholy image of Adam, are children of wrath by nature and without natural or spiritual power to live a holy life, and in a happy state. (Gen. 1:27-28, 31; 2:16-17; 2:1-5; Eccle. 8:20; Jer. 17:9-19; Rom. 6:12-18; Eph. 2:3; 1 John 1:8.)

ARTICLE IV.—We believe that the only way of deliverance from sin and death is by the sacrifice of Jesus Christ, the Eternal Word, who suffered without spot to God, having become incarnate, and suffered the just for the unjust, that He might redeem us to God by the sacrifice of Himself. (Luke 1:26-35; John 1:14; 3:16; Acts 4:12; Rom. 3:18-20; Titus 2:14.)

ARTICLE V.—We believe that God has sent His Son to be the propitiation for the sins of the whole world, and when the Gospel is preached it is the duty of all men to repent and believe in Jesus Christ that they may be saved; that if they do not, their rejection of the

Gospel is occasioned by their love of sin and aversion to holiness. (John 1:12; 3:15-20; Acts 17:30; Rom. 3:26; 1 John 2:2.)

**ARTICLE VI.**—We believe that election is the sovereign exercise of that eternal life by which God hath, according to His Infinite wisdom, chosen His people in Christ before the world was, and hath predestined them unto the adoption of children through sanctification and belief of the truth; doth keep by His power through faith unto salvation. Isa. 14:9-10; John 3:8-16; Rom. 7:29-30; 9:11; 11 Tim. 1:9; 2:10; 1 Peter 1:2; 2:9; Rev. 17:8.)

**ARTICLE VII.**—We believe that there will be a resurrection of the just and unjust; that Christ will come to judge the living and the dead; then those who shall have died or are then living impenitent and unreconciled to God shall be sentenced to endless punishment, according to their works. And those who shall have died or are then living in a state of justification through Jesus Christ, shall be completely delivered from the domination of sin, and adjudged to endless happiness in Heaven. (John 5:28-29; Cor. 5:19; 1 Thes. 4:14-17; Rev. 20:12-15.)

**ARTICLE VIII.**—We believe that a Christian church is a congregation of baptized believers who meet steadily and covenant together to maintain the ordinances, discharge the duties and enjoy the privileges of the New Testament as appertaining to the Church of God. (Acts 2:41-42; Rom. 16:1-4; 11 Cor. 1:1-2; Rev. 2:7.)

**ARTICLE IX.**—We believe that the baptism of believers in the name of the Father, Son and Holy Ghost is a positive institution of Jesus Christ, and is only validly performed when the whole body is immersed in water by an authorized administrator, in good standing with an orderly church. (Matt. 28:18-20; Mark 16:15-16; Acts 2:28-41; 8:38-39; 10:17-48; Rom. 6:3-4; 1 Cor. 2:12; Mark 16:18; Acts 21:41; 1 Cor. 3:11-17; Eph. 2:17-22.)

**ARTICLE X.**—We believe that the Lord's Supper is a positive institution of Jesus Christ, enjoined on all baptized believers who are in fellowship with each other and members of an orderly church; and that such Christians should commune together at the Lord's table, and such only. (Matt. 26:26; Acts 2:41-42; 1 Cor. 2:23-36.)

**ARTICLE XI.**—We believe that each Christian church has the right to receive into its body those persons who give satisfactory evidence of repentance toward God and faith in the Lord Jesus Christ, and willingly submit to baptism or bear sufficient evidence of having been regularly baptized.

**ARTICLE XII.**—We believe that the first day of each week should be observed as the Christian Sabbath, day of rest from common labor or worldly business, and devoted to religious duties. (Luke 4:16-24; Luke 1:8; John 20:19-26; Acts 8:14-16; 20:7; Cor. 16:1-2; 2:16-17; John 1:10.)

#### STATEMENT OF PRINCIPLES

**ARTICLE I.**—This Association is known by the name of Columbia Baptist Association.

**ARTICLE II.**—This Association is composed of churches whose messengers, upon presenting satisfactory evidence of their appointment, are entitled to seats in this body.

**ARTICLE III.**—This Association has no power to legislate for the churches, to pass any resolutions, or to do any act that will violate the rights of individual churches.

**ARTICLE IV.**—Each church belonging to this Association has the right to represent herself at each session with five messengers.

**ARTICLE V.**—It is the duty of the churches to send up to each session of this Association such contributions in money as they may deem necessary to supply the Association with a fund to defray the expenses incurred by it.

**ARTICLE VI.**—Each church has the right to send to each session of the Association such queries as she may choose, asking the advice of the Association upon them; provided, the subject matter of such queries cannot be satisfactorily determined by the church.

**ARTICLE VII.**—A church wishing to join the Association should send a petitionary letter by her messengers, accompanied by satisfactory testimonials of her order and orthodoxy, and any church thus petitioning may be received by an unanimous vote.

**ARTICLE VIII.**—This Association has the power to appoint to any office or service necessary to carry out her inherent rights, any messenger belonging to her body.

**ARTICLE IX.**—This Association has the power to correspond with her sister associations, churches or individuals, as she may deem proper.

**ARTICLE X.**—This Association has the power to withdraw from any church she may deem heterodox or disorderly; and to restore fellowship to any one she may have withdrawn from.

**ARTICLE XI.**—It is the duty of this Association to furnish her churches with such numbers of her minutes as they from time to time desire.

**ARTICLE XII.**—This Association has the power to adjourn at any time and place she may choose.

**ARTICLE XIII.**—Representatives from a majority of the churches form a quorum, but if a majority should at any time absent themselves, it is the duty of those present to appoint the next session and adjourn.

**ARTICLE XIV.**—This Association shall have a fund to be supplied by voluntary contribution of the churches or individuals, which will be subject to the order of the Association.

**ARTICLE XV.**—The officers of this Association are: A Moderator, Clerk and Treasurer, who are chosen by the Association at each session.

**ARTICLE XVI.**—It is the duty of the Moderator to preside over and preserve order in all the acts and deliberations of the Association while in session.

**ARTICLE XVII.**—It is the duty of the Clerk to keep a fair and correct record of all proceedings of the Association which should be read and corrected and signed by the Moderator and Clerk before the Association adjourns.

**ARTICLE XVIII.**—It is the duty of the Treasurer to receive and hold all money paid over to him for the Association, subject to her orders, and to pay it according to her directions.

**ARTICLE XIX.**—This Association has the power to dismiss by letter any church belonging to her body which may apply for dismissal.

**ARTICLE XX.**—Amendments to the Statement of Principles or the Rules of Decorum may be made at any annual meeting of the Association, when a majority of the Messengers present deem it necessary.

But the Abstract of Faith is not to be altered but by the voices of two-thirds of the churches.

#### RULES OF DECORUM

**RULE 1.**—When the Messengers of the several churches shall assemble at the place appointed for the session of the Association, the Moderator shall open the business by praise and prayer, in person or by proxy. If the former Moderator or Clerk be absent, the Association shall appoint one pro tem.

**RULE 2.**—Immediately after the opening of the session the church letters shall be read by persons whom the Moderator shall appoint, and the names of the Messengers enrolled by the clerks.

**RULE 3.**—When the Messengers' names have been enrolled and called by the Clerk, the Association shall then elect a Moderator, Clerk and Treasurer, first by nomination; second, without nomination speeches; third, by ballot—the plurality of votes governing the election.

**RULE 4.**—All motions and amendments to motions must be seconded before they are entertained by the Moderator. When the motion for amendments to motion are made, the last one shall be the first in order, and so on in reverse order to the original motion, but the mover at any time may withdraw his motion.

**RULE 5.**—Any person wishing to make a motion or to speak on any matter before the Association shall rise to his feet and respectfully address the Moderator. If he be in order the Moderator shall signify the same by calling the name of the person so rising, or otherwise; and no one thus in order shall be interrupted while speaking, unless he shall depart from the subject or use personal reflections; nor shall any member speak on the same subject without leave from the Association, except to explain some of his preceding remarks.

**RULE 6.**—Whenever sufficient time has been allowed for the discussion of any subject before the Association, the Moderator shall take the vote of the Association and declare the result, the majority governing in all cases, except those already provided for.

**RULE 7.**—No member may vacate his seat without the consent of the Moderator while the body is sitting.

**RULE 8.**—When one member shall speak to or of another he shall call his "Brother".

**RULE 9.**—The Moderator shall have the names of the Messengers called whenever it may be necessary.

**RULE 10.**—The Moderator may speak in matters of debate as other members, by calling someone to fill his seat while speaking, but not until all others have spoken who desire to speak.

**RULE 11.**—The Moderator may invite visiting members in good order to seats in counsel, who may speak, but not vote.

**RULE 12.**—The minutes of the Association may be read as often as it may think necessary.
