

PROCEEDINGS.

The eighth annual session of the Union Baptist Association was held at Pleasant Grove Church, Nevada county, Arkansas, commencing on Saturday, October 4, A. D., 1879.

The introductory sermon was preached by Elder J. J. Byers. Text, 1 Tim., IV chapter, 15 verse. Theme: the Church the pillar and ground of the truth.

After a recess for refreshments the messengers assembled in the church house and were called to order by Elder J. T. Downs, the former Moderator. Prayer by Elder J. Aaron.

Letters having been called for were presented from the different churches—the same were read and the messengers names enrolled.

Petitionary letters were presented from Shaver Spring and Zion Hill churches, asking for admittance into the body, said letters were read, and, on motion they were received into the body.

The association proceeded to the election of Moderator and Clerk, which resulted in the choice of Elder J. T. Downs, Moderator and Elder J. J. Byers, Clerk.

On motion, adopted the business order of the last session, to govern in business transactions during the present session.

Invited visiting ministers to seats. Elders W. A. Forbes, from the Caroline Association, J. D. Jameson from the Liberty, and B. Hultzman from the Judson, took seats, and their counsel from time to time, during the session was highly appreciated.

The following committees were appointed, viz:

On Preaching: S. F. Snell, T. J. Haynes, J. E. Askew and the messengers from the Pleasant Grove Church.

On Documents: Elders J. Aaron, T. J. Butcher and O. S. Jones.

On Temperance: Elders J. O. Luck, A. Patterson and Brother P. B. Almand.

On Education: J. F. Wallace, L. H. Hill, T. J. Bennett and Elder J. N. Acker.

On Finance: A. B. Luck and D. M. Young.

On Sabbath Schools: Elder J. Aaron, Elder J. J. Byers and B. W. Milwee.

On Destitution: Elder A. J. Cummings, J. J. Haynes and J. M. Smyth.

On Periodicals: Elder T. J. Butcher, H. L. Hurst and J. W. Hudson.

CORRESPONDENCE CALLED FOR.—Bro. J. J. Mayes presented himself, from Red River Association, without a letter, and was invited to a seat.

To Liberty: Elders J. J. Byers, T. J. Butcher.

To Judson: Elders A. M. Tennison and A. Patterson.

On motion, it was agreed to call for contributions on Sabbath, at the close of the forenoon services for the support of foreign missions.

The committee on preaching reported: that Eld. B. Hultzman, would preach Saturday night, Eld. J. Aaron, at 9, and Eld. W. A. Forbes at 11 o'clock, a. m., and that Eld. J. D. Jameson would occupy the stand at the hour of 2 o'clock, p. m., on Sunday.

On motion adjourned until Monday morning 8 o'clock. Prayer by Brother Acker.

EXERCISES ON SABBATH.

The brethren in accordance with the arrangements, preached, at hours specified, to large and attentive congregations. Many realized the fact, that it was good to be there, and we trust that great good was effected in the name of the Holy Child Jesus. Elder J. T. Downs preached Sabbath night.

MONDAY MORNING.—Met pursuant to adjournment. Prayer by Eld. Luck.

On motion the roll was called and the names of absentees erased.

Report on documents read and adopted. (See appendix A.)

Report on periodicals read and adopted. (See appendix B.)

Report on temperance read and adopted. (See appendix C.)

The report on education read and after some discussion, was amended and adopted. (See appendix D.)

Report of committee on finance read and adopted. (See appendix E.)

Report of committee on Sabbath Schools read and adopted. (See appendix F.)

On motion, it was agreed that a Sabbath School convention be appointed to meet at Union Church, on Friday before the 5th Sunday in November next, also that the different churches in the bounds of the association, be requested to represent themselves in said convention.

Report of the domestic missionary board, read and adopted. (See appendix G.)

On motion a recess was given for refreshments.

EVENING SESSION.—The association resumed business at 1 o'clock.

The report of the committee on destitution was read, and on motion was recommitted with instructions, to make certain specifications, after which it had a second reading and was adopted. (See appendix H.)

The treasurer's report was read and adopted. (See appendix I.)

Resolution No. 1, was read and adopted. (See resolutions.)

On motion Brother J. E. Askew was re-elected treasurer.

Reports of district meetings called for.

The next meeting of the 1st District will be held at the Mt. Ol-

Ive Church, commencing on Friday before the 2nd Sabbath in August 1880.

The next meeting of the 2nd District will convene at Harmony Church on Friday before the 3rd Sabbath in August next.

The next annual meeting of the Union Baptist Association will be held at Macedonia Church, commencing on Saturday before the 1st Sabbath in October A. D., 1880.

On motion Elder J. N. Acker was selected to preach the next introductory sermon, and Elder A. J. Cummings alternate.

On motion, the Clerk was appointed to superintend the printing of the minutes, and agreed that he be allowed \$20, for his services. (Resolution No. 2, adopted.)

On motion, the missionary board appointed last year, was re-appointed, to serve in that capacity the ensuing year.

On motion, Eld. T. J. Butcher, by his request, was excused from serving on said board, and Brother J. E. Askew appointed in his stead.

On motion, the churches were requested to specify in their letters to the next annual meeting, the amounts they are willing to pay the subsequent year for home missions.

On motion, Elders J. Aaron, J. T. Downs, J. J. Byers, A. J. Cummings and J. N. Acker, were appointed messengers, to meet with the next Baptist State Convention.

Resolution No. 3, was read and adopted.

On motion, minutes were read and adopted.

Adjourned to meet at time and place before named.

Thus ended another harmonious session of the Union Baptist Association. An appropriate hymn was sung, the parting hand extended, and many left for their homes with glad hearts.

Caney, Riddluga neighborhood, and from Caney neighborhood to the Ouachita River, southeast, also from Shady Grove to Beech Creek, on Little Missouri River, a distance of 20 miles, also from the north line of the association, including Fulton and surrounding country, thence down Red River, to Dooley's Ferry, and Lewisville, a distance of 30 or 40 miles. These, we state, leaving out some minor points.
