

MINUTES, SPRINGTOWN ASSOCIATION.

TEMPERANCE HILL, BENTON Co., ARK., Sept. 17th, 1885.

The Springtown Baptist Association met with the church at Temperance Hill according to previous appointment.

The brethren appointed to preach the Introductory being absent, Elder O. M. Lucas of Little Rock, Ark., was invited and preached from 1st Peter, 1:1.

The Association was then called to order by the former Moderator P. R. Johnson.

Elders A. J. Estes and J. F. Mitchell were appointed to read the letters from the churches and the messengers names were enrolled, (see table.)

Took recess one hour for dinner which was upon the ground, and then resumed business. Elders I. R. Hall and A. J. Maxwell were appointed tellers, the association then went into permanent organization, electing R. C. Gibbs, Moderator, and H. Highfill, Clerk.

Visiting ministers were invited to seats, accepted by Elders O. M. Lucas of Little Rock, who represented the interest of the Arkansas Evangel, and J. F. Mitchell of Springtown.

Called for correspondent messengers, accepted by Elders I. R. Hall, A. J. Maxwell, F. M. Seamster, J. Dunagin, of Bentonville association and J. H. Hogan of Cherokee Nation.

Called for unfinished business. 'The report of the committee that visited the Liberty church was received and made a special order for 9 o'clock A. M., Friday.

The report of the committee that visited Zion Hill was received and adopted. Elder B. F. Cooper was granted leave of absence.

Friday morning—The association met pursuant to adjournment, prayer by Eld. J. H. Hogan who was granted leave of absence.

Called for correspondence, received none. read and approved.

The report of the committee that visited the Liberty church was taken up and indeffinitely tabled and the petition of the Liberty church withdrawn, it was ordered that the report of the committee be spread upon the minutes; adjourned to 11-2 o'clock P. M. Prayer by Elder J. F. Mitchell. Resumed business at 1 1-2 P. M., prayer by G. W. Gordon.

It is ordered that the clerk superintend the printing and distribution of 500 copies of these minutes, and that he have five dollars for his services, if there is that much left when the printer is paid.

OBITUARY SPECIAL

To Elder John Givens Sen., who was born in Hawkin County, Tenn., Dec. 18th, 1806.

Born again in Monroe county, about the year 1835, and united with the Big Creek church and was ordained a Gospel minister in the Baptist church about a year afterward. He moved from Tennessee to Northwest Arkansas in 1855-he died at his home in Benton county, Aug. 22, 1885, in his 79th year. On coming to Benton county in 1855 and finding no Baptist churches in that portion of the country, after riding and searching he tound a few Baptist scattered here and there, whom he constituted into a church, was called to their pastorate and served them for several years, the church enjoying a revival each month for five vears. From that church in a short time several others were organized with Bro. Givens pastor. To Bro. Givens most of the churches in Northwest Arkansas owe their organization. He was known to walk ten and twelve miles to serve these churches when he had no horse to ride. He also organized the first Sabbath School on Butler's Creek at his home church where he was a faithful laborer till death. Bro. Givens was the father of a family of seventeen children, a kind husband and father, faithful minister and pastor. the moderator of the Hiawasa Assooiation in Tennessee for many years, also of the Springtown Association in Arkansas at various times, always filling the office with honor to himself and his association. To him as husband, father and minister, the

claims of duty in all the relations of life were served. His works do follow him. When on his death-bed, he carefully and prayerfully reviewed his life in all its varied scenes and said he had nothing to regret, that he had fought a good fight, he had kept the faith, he had finished his course, flencforth there was laid up a crown of righteousness. All who knew him deplore his death as their common loss but feel it to be his infinite gain. In view of the foregoing history, we, your committee, would therefore report the following:

Whereas God in his wisdom has seen fit to call from the labor of earth to a brighter life and a perfect rest, our beloved brother and father in the ministry, Elder John Givens, the oldest minister of our association, a devoted pastor whose life in general has been a model of Christian meekness and forbearance, who amid the trials and turmoils of life has never faltered in duty to the master's cause, and who by many deeds of kindness and love has endeared himself to all who knew him, and

Whereas, by this dispensation of providence, many are bereaved and sadness is made to fall upon all by this great loss to the church and society, therefore

Resolved, That in his death this association and the church has sustained an irreparable loss—a pillar gone never again to be replaced—a chief stay in the brotherhood whose

place can never be filled.

Resolved further, That though in wisdom he has been taken from us, yet we deplore his loss, and extend to the bereft family our heartfels sympathy in their great misfortune,

ARTICLES OF FAITH.

1st. We believe that the Holy Bible, written by men, divinely inspired and full of unmixed truth, is a perfect rule of faith and practice.

2nd. We believe in one God, Fa-

ther, Son and Holy Ghost.

We believe that man, once holy, fell by voluntary transgression from that happy state, and is now utterly void of holiness.

We believe that sinners are 4th. saved by grace alone.

We believe that men justified by faith in the Lord Jesus Christ.

We believe that salvation is 6th. free to all who will accept the Gospel.

We believe that except a man be renewed by the Holy Spirit he is not qualified or prepared for the Kingdom of Christ on earth or to enjoy his glory hereafter.

Sth. We believe that repentance toward God and faith in the Lord Jesus Christ are the duties of every

one who hears the Gospel.

We believe that election is 9th. the eternal purpose of God by which he graciously regenerates, sanctifies and saves sinners.

10th. We believe that sanctification begun in regeneration and ever progressive is the process by which weare made to partake of God's holiness.

11th. We believe in the preservation of the saints, that they are kept by the power of God through faith unto salvation.

12th. We believe that God's law is the only, the eternal and unchangeable rule of his church and

moral government.

13th. We believe that a church of Christ is a congregation of baptized believers united in the faith and fellowship of the Gospel, observing the ordinances and obeying the laws of Christ; and that its officers are pastors and deacons.

14th. We believe that Christian baptism is the immersion of a believer in water, by a properly qualified administrator into the name of the Father, Son and Holy Ghost.

15th. We believe that only such as have been properly baptized and received into the fellowship of a regularly organized Baptist should partake of the Lord's Supper.

16th. We believe that the Lord's day or Christian Sabbath should be devoutly observed and sacredly devoted to religious services.

17th. We believe that civil government is of divine appointment and that the governor of states and nations should be obeyed, when the laws they seek to enforce are not in conflict with the Gospel.

18th. We believe in the future

resurrection of the dead.

19th. We believe in the final judgment; and that, in that day, the righteous and wicked will be separated forever.

20th. We believe that the righteous will be made happy forever in Heaven and the wicked miserable torever in hell.

RULES OF DECORUM.

1st. The association shall be opened and closed by prayer.

2nd. The medicator and clerk shall be chosen by the suffrages of

the members present.

3d. The moderator shall be deemed a judge of order and shall have a right to call to order at any time.

4th. Any member not satisfied with his decision on any point of order may appeal to the association on the same day; but at no other time.

5th. But one person shall speak ut a time, and he shall rise to his feet and, on obtaining leave, proceed.

6th. The moderator, when addressed for leave of speech, shall signify the same by naming him, or otherwise.

7th. No member shall be interrupted while speaking, unless he depart from from the subject in hand, or use words of personal reflection, and every motion made and seconded shall come under the consideration of the association, except withdrawn by the member who made it.

Sth. Every case taken up by the association shall be decided on, or withdrawn before another is offered.

9th. When anything is taken up by the association, after allowing a reasonable time for debate, the mod-

erator shall take the question and those in favor of the proposition shall rise to their feet and those against it shall keep their seats.

10th. The moderator shall pronounce the decision before the stand-

ers take their seats.

11th. No person shall depart from the service of the association without leave.

12th. The appellation of brother shall be used in addressing one an-

other.

13th. The names of members shall be called as often as the asso-

ciation may direct.

14th. No member shall be countenanced in any prictice that has a tendency to interrupt in times of

public speech.

15th. The moderator shall be entitled to the same privileges of speech as any other member, provided he appoint some other member to his seat while he is speaking, but shall not be allowed to vote unless the association be equally divided.

16th. Any member breaking this decorum shall be reproved at the discretion of the association, but only on the day the breach is made.

CONSTITUTION.

ARTICLE 1st.—This Association shall be composed of messengers, who shall be members of the churchers they represent, (except such as may be invited to a seat by consent of this body,) and shall be styled, the Springtown Baptist Association.

ARTICLE 2nd.—This Association shall meet annually on Friday before the 4th Sabbath in October at the place previously appointed and after public worship and reading the letters from the churches, and acting upon those soliciting membership, a moderator and clerk shall be chosen from the messengers by ballot, both of whom shall hold their offices until others shall be elected.

ARTICLE 3rd.—It shall bethe duty

ARTICLE 5th -- Churches wishing to unite with this association may apply by letter and mesengers and giving satisfactory information of their being sound in doctrine and correct in practice, they may be received by a unanimous vote; in token of which, the moderator shall give their messengers the hand of fellowship in behalf of the association churches, may be dismissed upon application.

ARTICLE 6th. - We acknowledge the independence of the particular churches, and that no authority or jurisdiction is to be exercised over them by this association; nor will the association decide in any controversy that may arise in any church. Nevertheless, they deem it their duty to disown any church belonging to this body which may have essentially departed from the faith.

ARTICLE 7th.-When a church shall neglect making any communication to the association for three years successively, it shall be considered as having withdrawn from us, and shall be dropper from the minutes of the association, unless at least two members request their continuance who shall also engage to inquire into their standing and report at the next meeting of the association.

ARTICLE 8:- This association shall have the right to open and hold minutes,
