Report of Committees

REPORT OF COMMITTEE ON FOREIGN MISSIONS.

Since Foreign Missions is a Divine command, and "the gospel of the kingdom shall be preached in all the world," etc., Matt. 24:14, whereas our Lord and Saviour, Jesus Christ gave us an example and said we should follow Him. Seeing the world in so great sin, God's children should awaken to the fact that many precious souls are being lost in numbers unknown to us, how necessary it is that we should be more zealous than ever as Baptists, to whom the command was given. We should sacrifice greater than ever before for the propagation of the gospel, that our sound go out through all the earth, and we as God's messengers should urge this matter upon the churches, having the assurance that the Holy Spirit is with us, and that My Word shall not return unto me void, saith the Lord.

Work of the Southern Baptist Convention

Last year was the greatest year in Southern Baptist history of Foreign Mission acievement. A total of \$961,970.48 was raised, which included \$180,000 debt, amount contributed to Judson Centennial and to current support. This is the greatest advance ever made by any denomination in the South in contributions to Foreign Missions in a single year.

The above record was made possible both by the large number who contributed and the large gifts of a few who recognized the ex-

treme necessities of our Foreign Mission work.

The expenses of the work were so reduced that 90.7 per cent of the money giver was applied to to the foreign field and only 9.3 per

cent was required to meet all home expenditures.

6,347 converts were baptized, 12,930 students were enrolled in our schools, and missionary doctors treated 67,556 patients. We have at present 458 churches with 47,161 members. 115 of the churches are self-supporting. The members contributed last year \$132,371.05.

There is immediate and urgent need of a large number of missionaries for evangelistic, medical, school and other departments of the work. To meet this need the Board was able to send out but twelve missionaries at its Annual Meeting. This number is not one-fourth of the number needed. Of the 458 churches most of them have inadequate houses of worship, and more than one-half of these have no houses at all.

Obeying the wish of the Convention which met in New Orleans in May, the Board has been compelled to assume obligations which amount to \$165,000 more than Southern Baptists contributed to current surport last year, and this amount leaves more than \$200,000 in

urgent needs unprovided for.

States, associations, churches and individuals are carnestly besought greatly to increase their contributions to this work in order to save it from the peril of growing obligations and enable the Board to enter new fields to which Providence has thrown the doors wide open

and waving harvests invite us.

Some devoted friends are giving the Board Liberty Bonds which they purchased to help their country, and others are investing in the Board's Annuity Bonds which pay good dividends. Such examples are recommended to all our people.

The needs of these Homes are many. This is a labor of love and sacrifice well pleasing to God who surely hears the orphan's cry for mother's love and father's protection

Our scriptural obligation to care for these children is plain and binding. Therefore we urge our churches and organized forces to

give liberally to this great work.

REPORT OF COMMITTEE ON HOME MISSIONS.

The Baptists of Fayetteville Association do Home Mission work through two organizations, the Southern Baptist Convention and the

General Association are undertaking this work at home.

Urgent needs of this work present themselves to every thinking person just at this time. The great world war with its sacrifice of human lives is a challenge to the Lord's people to make sacrifices for our Lord's work Hundreds of thousands of homes are sacrificing the manho of this nation in this great war. Shall we as the Lord's people do less? Our obligations are increased many fold in the giving of our means for the carving on the work in the home land.

The conditions produced at home furnish problems which command the best thinking of our ablest men. These men are grappling with those problems in a way that commands our approval. The results of our work are gratifying, yet not what we might wish. There is need for greater sacrifices in lives given to this work and of money put into it. We recommend:

1. That earnest prayer be made for the work of Home Missions and that our pastors preach at least once a year on this subject.

2. That this Association accept the amounts asked for this important work as carried on by these two bodies, and that churches be asked to contribute to this work as liberally as circumstances will permit.

State Missions in Arkansas is the great task assigned to the Bantists of the State, not only to evangelize, but to enlist and train its thousands who have ben reached by the gospel of Jessu and its

saving influence.

Last year was the greatest year of its history for State Missions in Arkanses The churches co-operating through the State Convennon gave \$25,598 00 to State Missions; had 3,134 conversions; 2,281 aptisms; 3,010 additions. We raised for Home Missions \$16,405,00: for Foreign Missiens, \$23,031.53. The total for Home and Foreign Missiors was \$39,436.53, a gain over last year for the two causes of The present year gives promise of being far better 512,186,28. than last year.

The brethren co-operating with the General Association give the tollowing report of the work done for State Missions last year: Missionaries in the field, 3; sermons preached, 319; additions to churches, 119; Sunday Schools organized, 5; collections, \$1,652.32; missionaries this year. 5. These missionaries are doing good work, but we have but a partial report from them up to this time. So your

committee urges the fellowing:

That every pastor get all possible inforamtion about State Missions to his people and endeavor to secure an offering from every church member.

2. That the pastors and laymen during the meeting of this Association get together and make plans to reach every church in the Association for an offering for State Missions.

3. That the churches of this Association do their best to raise

at leats the amounts asked of them by the Executive Board.

REPORT OF COMMITTEE ON TEMPERANCE.

It is with the profoundest gratitude to Almighty God that we note the rapid strides made by the temperance forces of our country in banishing the liquor traffic from among us. There is now a law which shall go into effect on September 8, the purpose of which is to stop the manufacture of alcoholic liquors from foodstuffs during the continuation of the war. This is attributed to necessities growing out of the food situation in our country. The law was passed, however, because of the large and growing sentiment on the temperance question. Another very gratifying step is the passage by the Senate of a bill which has for its purpose the submission of an amendment to the Federal Constitution to the States. This bill, if passed by the house, will give to the people of our country the opportunity to banish sorever from our nation the greatest curse of our people.

We recommend that our people give great diligence to this work now. We commend the work of the W. C. T. U. and the Anti-Saloon League. Let us watch our law-making bodies and use every opportunity to influence sentiment in favor of Temperance work.

Romanism is false in its teaching of salvation by works and in many other dogmas. This must be met by the doctrine of salvation by grace. The gospel must go to all Catholic countries and be faithfully preached to the Catholic population of our own country. The doctrine of separation of Church and State must be maintained and our influence should be given to guard this sacred Scripture principle. We urge all our pastors and people to remember Paul's injunction to overcome evil with good and so preach and live the true gospel that error will fall away as light banishes the darkness.

CONSTITUTION.

Article I This Association shall be composed of messengers. who shall be members of the churches they represent (except such as may be invited to seats by consent of the body), and shall be styled

the Fayetteville Baptist Association.

Art. II. This Association shall meet annually on Friday before the first Sunday in September, at the place previously appointed, and after public worship, reading the letters from the churches and acting upon those soliciting membership, a Moderator and Clerk shall be chosen from the messengers by the voice through tellers, both of whom shall hold their office until others shall be elected.

Art. III. It shall be the duty of the Clerk to make an accurate record of the proceedings of each meeting of the Association, in a book provided for that purpose. He shall also act as Treasurer.

Art. IV. The churches shall each send not more than three messengers, who shall present the letters certifying their appointment and briefly expressing the state of the churches, their increase and dccrease and their aggregate number. Each church shall send with their letter money for printing the Minutes.

Art. V. Churches wishing to unite with this Association may apply by letter and messengers and upon giving satisfactory information of their being sound in character and correct in practice and faith, they may be received by a unanimous vote, in token of which the Moderator shall give to their messengers the hand of fellowship 'n behalf of the Association. Churches may be dismissed upon application.

Art VI. We acknowledge the independence of the particular churches and that no authority or jurisprudence is to be exercised over them by this Association, nor will the Association decide in any controversy that may arise in any church. Nevertheless they deem it their duty to disown any church belonging to this body which may

have essentially departed from the faith.

Art. VII. When achurch shall neglect making any communication to the Association for three years successively, it shall be considered as having withdrawn from us and shall be dropped from the Minutes of the Association, unless at least two members request their continuance who shall also engage to inquire into their standing and report at the next meeting of the Association.

Article VIII. This Association shall have the right to open and hold correspondence with other Associations as may be deemed expe-

dient.

Art. IX. It shall be the duty of the Association from time to time to suggest to the several churches such measures as may be deemed wise and proper to promote the interest of the Messiah's Kingdom and spread the gospel throughout the world.
