Of the Twenty-Fourth Annual Session of the Fourche Valley
Baptist Association, October 8, 1911.

The Twenty-Fourth Annual session of the Fourche Valley Baptist Association convened with the Bigelow Baptist Church.

The Association was called to order and devotional exercises conducted by Moderator John L. Hill, and Elder T. E. McKinzie addressed the association.

SATURDAY MORNING, OCTOBER 7, 1911.

At 9 a. m. the association was called to order by Moderator H. G. Johnson and devotional exercise led by Elder A. H. Brickey. after which the minutes of the previous day were read and approved.

Report of the committee on ministerial education:

The report of the committee on ministerial education was offered and discussed by J. H. Campbell, H. G. Johnson, John L. Hill and Elder H. N. Hefner and the report was adopted.

We, your committee on ministerial education beg leave to report as follows: Brethren, we have come to the greatest hour the Baptists ever saw. We are facing the greatest opportunity that the world ever offered. Our blessed Redeemer bids us to go and possess the land. And as we go toward the crest of the hill for victory, we need men called of God; trained and equipped and able to stand against the booming cannons of heresy that are flooding the world. In order to do this we must have a better educated ministry, for the whole world is waking up along this line as never before, and it behoovs us, as Baptists, to keep pace with this great move. The best place to educate a Baptist is in a Baptist school; and the best place to train a Baptist preacher is in a Baptist institution. Therefore we recommend the Baptist schools of the state to our people and Ouachita college for our ministry. These are our

institutions—a heritage we ought to be proud of. They are money ments whose peaks point to truth, truth that will triumrh, and whose banners shall one day be unfurled to the world.

## SATURDAY EVENING SESSION

At 1:30 p. m. the association was called to order by Elder H. G. Johnson, prayer by John L. Hill. Ronewed the call for statistical letters and Antioch's letter was received.

Report of committee on Sunday schools.

The report of the committee on Sunday schools was offered and discussed by J. E. Steely, A. H. Brickey, H. G. Johnson and John L. Hill, and was adopted with amendment to the effect that the 5th Sunday meeting have a Sunday school department, as follows:

We, your committee on Sunday schools beg to submit the following: We find that there are five Sunday school reports with a total enrollment of 340 pupils, 31 officers and teachers. We feel this to be a light enrollment; whereas we have several thousand children in this association that should be in Sundays school on

Report of the committe on orphans home

The report of the committee on orphans home was offered and without discussion was adopted as follows:

We, your committee on orphans home submit the following:

We are glad to note the increased interest in this department of our work. We feel that there is no part of our denominational interests that should appeal to our hearts more than our orphanage work; and as we now have no financial agent, it falls upon the churches and brethren to keep constantly in touch with the conditions of the home. We have at present about 140 children in the home and the conditions of the home are comparatively good, and the work is being conducted wisely and economically under the leadership of Brother Williams, yet, as winter is coming on, and winter supplies are going to be needed, we urge our churches to take offerings for the home and send them in to Bro. Williams as early as possible.

We learn from the reports from Houston and Perryville Ladies Aid societies that each have adopted a child in the home and are clothing them, and we heartily recommend that other societies in this association do likewise,

Following the adoption of the report of the committee on an phans home pledges were taken for the support of the home during the year and the following churches made pledges as follows: Perryville, \$5.00; Mulberry Grove, \$5.08; Bigelow, \$6.00, one-sixth to Texarkana home; Houston, \$10.00; Liberty, \$5.00, one-fifth to Texarkana; Casa, \$5.00; Harmony, \$1.00; Antioch, \$5.00 to

Report of committee on associational missions:

The report of the committee on associational missions was offered and discussed by Elder H. N. Hefner, John L. Hill and A. H. Brickey and report adopted, as follows:

We recognize the fact that there is a great need of evangelizing our home country. No part of the state of Arkansas is in greater need of the Gospel than in the bounds of the Fourche Valley Association. Therefore we recommend first of all that we take steps to supply our bounds with the gospel. And, while we recognize the need of our state, home and foreign missions, yet we urge the brethren to make our own association our first care.

We recommend that the churches take regular collections for assolational work.

On motion it was voted to put an associational missionary in the field for three months and ask the state missionary board for \$100.00 to help pay his salary.

Report of the committee on prohibition.

The committee offered their report on prohibition and the same was adopted, as follows:

There has been for years no moral question that demands the attention of God's people more than the whiskey traffic of any country. The day is at hand when the better class of our society must discourage this traffic in every way or find themselves shut out from their rights as citizens. Whiskey is nowhere sold except where the whiskey men control the politics of the locality. The cities are becoming the hiding places of these corrupt forces for overriding the law and trampling under foot good order. We call upon all our membership not only to strive to put the business out of the country but out of the towns and cities, until the traffic has been banished from this great state.

And, we recommend that we assist any courts and men in authority to close the soft drink shops on Sunday, as it is a violation of the law and it is a detriment to the attendance of our churches and Sunday schools.

The report of the committee on home and foreign missions was offered and adopted, as follows:

Whereas, Christ has enjoined upon his churches to preach the gospel to all nations, and believing the Baptist to be the church we recommend that our churches use all diligence to forward this work. We especially recommend that we co-operate with the home and foreign mission board of the Southern Baptist Convention.

Report of the committee on state missions.

The report of the committee on state missions was offered and discussed by H. G. Johnson and John L. Hill and adopted, as follows:

We feel deeply the importance of this branch of our work. The state missionary board is composed of the very best men of our church from all parts of the state who attend the meetings and do the work without remuneration; they simply do the work of their Master because they love him and his cause. This is a work that we are all more or less familiar with, as it is from this board a number of our churches receive financial assistance, besides we get the assistance of some of our very best and most able preachers.

We, therefore, recommend that each and every church contribute all within their power for state missions between now and the meeting of the state conventon, as the board is now largely in debt this having been a very trying year on this branch of the work, since our college debts have seemingly had the right of way the most part of this year. We also ask each pastor to make some special efforts not only in his own churches but do some outside work, and we further recommend that the Sunday schools and ladies aid make an offering to this cause. We not only recommend this but urge and insist on you doing something, as this is a time of greatest need of this board and this branch of the work.

# Constitution.

Article I. This Association shall be called the Fourche Valley Missionary Baptist Association, and shall meet on Saturday before the 2nd Sunday in October of each year at 10:00 o'clock a.m. and remain in session three days.

Art, II. It shall be composed of persons who have been duly elected delegates by the respective churches belonging to this union-

Art. III. The delegates representing the different churches shall, at the opening of each association, present letters specifying appointment and also showing the number baptized, received by letter, dismissed, excluded, restored and died during the year together with the whole number in fellowship.

Art. IV Each church belonging to this body shall be entitled to three delegates until they number fifty members, and one for

each fifty above that number.

Art. V. Churches of this union failing to represent themselves for three successive meetings shall be considered as dropped by this association.

Art. VI. New Churches may be admitted into this body by signifying their wishes by letter and delegates, provided they be deemed orthodox, and are willing to work in fellowship with us.

Art. VII. This body shall have a Moderator, Treasurer and Clerk, who shall be chosen at each annual meeting—by private ballot, as soon as letters from churches are read and delegates names are enrolled.

Art. VIII. This body shall have no power to adopt rules that shall infringe upon the independence and rights of the churches, yet, it may drop such churches as become disorderly, either in doctrine or discipline.

Art. IX. This body shall have a fund for its expenses and the churches may send up funds for domestic or foreign missions or for the Bible cause. This association shall take charge of such

funds and appropriate them as designated by the churches

Art. X. If a church shall have a difficulty with another church we advise her to take the steps laid down in the 18th chapter of Matthew. And no difficulty between churches will be entertained by this body, unless such steps shall have been taken.

Art. XI. When churches of this union shall have gitts there deem worthy of ordination, we advise them to call on sister churches for two or more ministers to set appart such gifts to the work of the good ministery according to the New Testament, and we advise all Presbyteries in the ordination of ministers and deacons and constitution of churches, to be governed by the abstract of principles of this association.

Art. XII. This association will correspond with sister associa-

tions of the same faith and order.

Art. XIII. The minutes of this body shall be read and corrected and signed by the moderator and clerk before the session rises. No session shall adjourn, unless in extraordinary cases, urtil it has finished all its business.

. Art. XIV. The association shall have an executive board, consisting of the treasurer and four other members who shall be chosen annually.

Art. XV. This constitution may be altered or amended at any

meeting by a majority of two-thirds of the members present.





# ARTICLES OF FAITH

#### OF THE SCRIPTURES.

i. We believe that the Holy Bible was written by men divinely inspired. That it is a perfect treasure of heavenly instruction. That it has God for its author, salvation for its end and truth without any mixture of error for its mitter. That it reveals the principles ly which God will judge us and therefore is, and shall remain to the end of the world the unscentre of Christian union and the supreme standard by which human conduct creeds and opinions should be tried

#### OF THE TRUE GOD.

t. We believe that there is one, and only one living and true Ood; an infinite, inclligent wirk, whose name is Jehova, the maker and supreme ruler of heaven and earth, inexpressibly glorious in boliness, and worthy of all possible honor, confidence and love. That is themsity of the God head there are three persons, the Father. Son and Holy Ghost; equal in every divine perfectisg, and executing distinct, but harmonious offices in the great work of redemy ion.

#### OF THE FALL OF MAN-

A. We believe that man was crested in Holiness under the law of his Maker, but by voluntary transgression fell from that Holy and happy state in consequence of which all man, kindary now singers, not by constraint but by choice, being by nature utterly devoid of that Holiness required by the law of God, positively inclined to gyil, and therefore under just condemnation to eternal ruin, without defense or excuse

#### OF THE WAY OF SALVATION.

i. We believe that the salvation of sinners is wholly of grace, through the mediatorial through the mediatorial offices of the Son of God; who, by the appointment of the Father' freely took upon him our nature, yet without sin; honored the Divine law by his personal obelience, and by his death male a full attained; for all sine that having risen from the dead he is now enthrough in heaven; and united in his wonderful person the tenderest symmathies with Divine perfections he is in every way qualified to be a suitable, compassionate and all sufficient Savier.

#### OF JUSTIFICATION,

5. We believe that the great Gospel blessing which Christ sources to such as believe in him is justification, that justification includes the pardon of sin; and the promise of eternal life and principles of righteousness; that it is bestowed, not in equalitration of any works of righteousness which we may have done, but solely through faith in the Redeemer's blood; by virtue of which faith his perfect righteousness is freely imputed to us of Godi that it brings us into a state of most blessed nease and fayor with God and secures every other blessing needful for time and elernity.

#### OF THE FREENESS OF SALTATION.

for We believe that the blessines of salvation are made free to all by the Gospet the is the immediate duty of all to accept them by a cordial, penitent and obedient talk as that nothing prevents the salvation of the greatest somer on earth but his own inherest deprayity and voluntary rejection of the Gospel, which rejection involves him in an are vated condemnation.

#### OF GRACE IN REGENERATION.

7. We believe that in order to be saved, sinners must be regenerated, or born again that regeneration consists in giving a holy disposition to the mind; that it is affected he manner above our comprehension by the power of the Holy Spirit in connection with he vine truth, so as to secare our voluntary obedience to the Gospel; and that its proper endence appears in the boly fruits of repentence, and faith, and newness of life.

#### OF REPENTENCE AND PAITH

8. We believe that repentence and faith are sucred duties, and also inseperable grams wrought in our souls by the regenerating spirit of God; whereby being deely convinced our guilt, danger and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession and supplication for mercy at the same time bearing receiving the Lord Jesus Christ as our Prophet, Priest and King and relying on Him alme as the only and all sufficient Savior.

#### OF GOD'S PURPOSE OF GRACE

9. We believe that election is the eternal purpose of God according to which be graciously regenerates, sanctifies and saves sinners; that being perfectly consistent with the free agency of man, it comprehends all the means in connection with the end; that it is a most glorious display of God's sovereign goodness, being infinitely free, wise, boly and unchangable; that it utterly excludes boosting and promotes humility, love, prayer, praise, t as as God and active imitation of his free mercy; that it encourages the use, of means in the highest degree that it may be ascertained by its effects in all who truly believe the gospet that it is the foundation of christian assurance, and that to ascertain it with regard to surselves demands and deserves the utmost diligence.

#### OF SANCTIFICATION.

10. We believe that sanctification is the process by which, according to the will of God. we are made partakers of his holiness, that it is a progressive work, that it is begun in regeneration and that it is carried on in the hearts of believers by the presence and power of the Holy Spirit, the Healer and Comforter, in the continual use of the appointed means, especially the word of God, self examination, self denial, watchfulness and prayer-

#### OF THE PERSEVERANCE OF SAINTS.

II. We believe that such only are real believers as endure unto the end; that their persevering attachment to Christ is the grand mark which distinguishes them from superficial professors; that a special providence watches over their welfare; and they are kept by the power of God through faith unto salvation.

#### OF THE HARMONY OF THE LAW AND THE GOSPEL.

12. We believe that the law of God is the eternal and unchangable rule of his moral government; that it is Holy, Just and Good, and that the inability which the scriptures ascribe to fallen men to fulfill its precepts arises entirely from their love of sin; to deliver them from which, and to restore them through a Mediator to unfeigned obedience to the Holy Law is the one great end of the Gospel, and of the means of Grace connected with the the establishment of the visible church.

#### OF A GOSPEL CHURCH.

13. We believe that a visible church of Christ is a congregation of baptised believers associated by covenant in the faith and fellowship of the Gospel, observing the ordinan-

es of Christ, governed by his laws, and exercising the gifts, rights and privileges invested in them by His wors. That its only scriptural officers are Hisbops or Pastors, and Descents, whose qualifications, claims and duties are defined in the Epistles to Timothy and Tirus.

#### OF BAPTISM AND THE LORD'S SUPPER.

14. We believe that Christian haptism is the immersion in water of a believer into the name of the Pather. Son and Haly Ghost, to show forth in a solemn and beautiful emblem our tasth in the crucified, buried and risen Savior, with its effect in our death to sin and resurrection to a new life; that it is a prerequisite to the privileges of a church relation; and to the Lord's Supper, in which the members of the church by the sacred use of bread and wine are to commemorate together the dring lave of Christ, preceded always by solomn and examination.

#### OF THE CHRISTIAN SABBATH.

12. We believe that the first day of the we k is the Lord's Day, or Christian Sabbath, and is to be kept sacred to religious purposes, by abstaining from all secular labor, and sinfairecreations, by the devont observance of all the means of Grace both private and public and by preparating for that rest that remaineth for the people of God,

#### OF CIVIL GOVERNMENT.

16. We believe that civil government is of Divine appointment for the interests and good order of human society, and that magistrates are to be prayed for, conscientiously benered and obeyed except only in things opposed to the will of our Lord Jesus Christ who is the only Lord of the conscience and the Prince of Kings of the earth,

#### OF THE RIGHTEOUS AND THE WICKED.

17. We believe that there is a radical and essential difference between the righteous and the wicked that such only as through fail have justified in the name of the Lord Jesus, and sanctified by the Spirit of our God, are truly righteous in his esteem; while all such as continue in impenitance and unbelief are wicked and under the curse, and this distinction holds among men both in and after death.

#### OF THE WORLD TO COME,

18. We believe that the end of the world is approaching that at the last day Christ will descend from heaven, and raise the dead from the grave to find retribution, that a solemn separation will then take place; that the wicked will be adjudged to endless punishment, and the righteous to endless joy and the jimdyment will fix forever the final state of man in heaven or in hell on principles of righteousness.
