The Caroline Baptist Association met in its sixtieth annual session with Landmark Baptist Church, England, Ark., on October 8, 1915, at 10:00 a. m.

## FRIDAY NIGHT.

After singing the Association was called to order by the Moderator.

Prayer was led by E. J. A. McKinney.

Ward Church petitioned for admission into the Association and being found regular in its organization it

was on motion received and Brother C. L. Van Vleet was enrolled as messenger.

Welcome addresses were made by W. A. Crutchfield, pastor of Landmark Church; H. W. Jean, pastor of First Baptist Church; L. E. N. Hundley, pastor of the Methodist Church, and J. E. Hicks, representing the business men of the town.

Pastor S. H. Campbell, of the Second Church, Little Rock, responded on behalf of the Association.

Brother A. L. Aulick led in prayer.

The report of the Executive Board was read by Brother O. E. Williams, Secretary of the Board, as follows:

#### REPORT OF MISSION BOARD OF CAROLINE ASSOCIATION.

The Mission Board of Caroline Association met at the Lonoke Baptist Church December 29, 1914, with the following members present: G. L. Boles, W. P. Fletcher, G. M. Ford, W. P. Fletcher, Jr., O. E. Williams, and Hays Sullivan. R. P. Bain, associational missionary, met with us.

Brothers Bowers, Crutchfield, and Landreth, absent.

An attempt was made to meet about the first of November, but owing to the fact that it takes six to make a quorum and it was impossible at that time to get six members together this meeting failed. The Board was organized by the election of the following officers: Rev. G. L. Boles, Chairman; Rev. G. M. Ford, Vice Chairman; Brother O. E. Williams, Secretary, and Brother W. P. Fletcher, Jr., Treasurer.

It was decided that Brother Bain should continue his work at Cotton Plant as heretofore. We are glad to know that this church has been greatly blessed this year, as the work of Brother Bain has in general, which will be seen from his report.

By reason of the failure of some of our strongest churches to pay their pledges the board was forced to borrow from the Bank of Lonoke, the deficit in Brother Bain's salary from last year, which was \$425.00.

We also planned to have quarterly meetings of the Board during the year and attempted to meet on March 29 and June 29. All members of the Board were notified of the time and place of each of the above meetings, but at neither time were we able to get a quorum and no meeting could be held. The Board met on October 5, 1915, with a bare quorum present. Thus it will be seen that we tried to have five meetings, but had a quorum only twice.

It was also decided at this first meeting to press the holding of fifth Sunday meetings during the year. We had some plans that we hoped would make this work more successful than it has been lately. We divided the Association into four districts and a brother in each district was asked to look after his section and lay plans for meetings and have charge of all the work pertaining to the meeting in his section. The brethren were duly notified but



so far we have heard of only one meeting held under this plan. We think that these meetings are very productive of good to the churches and communities where they are held. They stimulate mission work and serve to keep the people informed and interested in matters pertaining to the kingdom. We recommend that the Association devise some plan that will meet the co-operation of the brethren, so this work may be carried on.

Some appeals have been sent out to the churches this year, but owing to the hard times, we have not sent so many letters as usual. We have had responses from some of the churches and some money has come in, but not many have heeded our appeal and consequently the report of the Treasurer will show that we are far behind with our missionary. We wish we could make the brethren realize how necessary it is to contribute to the salary of the missionary during the entire year. We have before recommended and we repeat it at this time, that in our deliberate judgment, it would be wise for all the churches to adopt some system of giving at different times during the year. We do not recommend any plan in detail but leave that matter entirely with the churches. If we could get these contributions throughout the year it would greatly relieve the burden of the Board and missionary, would be a saving in the interest we pay on borrowed money, and at the same time would be easier on the churches that make the contributions and on the members. We also feel that it is a part of the duty of the missionary to take collections for this work on the field, wherever it meets the approval of the churches.

For a full financial statement we refer you to the report of the Treasurer.

We recommend that the churches decide in regular conference on the amount they will give to Associational Missions each year, and that they state the same in their letters to the Association. If all will do this, we will have a definite sum on which we can depend at the beginning of the year's work, and the Association and Board can lay plans accordingly.

We again recommend that the members of the churches carefully read the Minutes of the Association. We hope the pastors will urge this on the members. By reading the Minutes they will keep informed on the work that we, co-operating together, are undertaking to do for the glory of God in the salvation of lost men and in the spread of the kingdom. We also recommend that the churches contribute more liberally to the Minute fund, so the Minute may be spread more generally over the Association.

May it be the earnest desire and prayer of all the members of all the churches that in the coming year we may lengthen the cords and strengthen the stakes for a greater work; and may it be the unshaken determination of each and every member of our churches, old and young, to have a personal part in this work. If we can give but little, let us do what we can, and the Lord will bless the gift and the giver.

Missionary R. P. Bain read his report, as follows:



## MISSIONARY'S REPORT.

To the Caroline Missionary Baptist Association When Convened with Landmark Missionary Baptist Church, England, in Its Sixtieth Annual Session, October 8, 1915:

Dear Brethren—It is with great joy and gratitude to God for his goodness that permits me to bring you greetings from your mission field, both yours and mine.

Dear Brethren, as your missionary hear me patiently and prayerfully while I tell you the story of the work for this tenth year of my service with you.

Kensett—I reported on this place last year having assisted them in securing a pastor and in speaking to the report I told the Association of the \$253.00 note that myself and three other brethren were on in the bank for the last payment on their new house. This note has been reduced to about \$125.00, interest and all, which was due the 28th of September, but I was so busy I could not get to it at that time, but took the matter up with the bank and got the time extended till October 15.

Cotton Plant—The pews came as indicated in my last report and with all the panic came and it looked for about two months like it would be impossible to get the money to pay for them. Our people did not have it and we couldn't borrow it, though we had \$1,800.00 worth of good new property for security, but at last Brother W. P. Fletcher made a shift and got some money and let us have \$350.00, necessary to cover all the indebtedness, and we intend, if possible, to raise the money during this gathering season and pay out both of these debts. Brother Fletcher refused to take a mortgage on the church and for this reason the membership will go to the limit of their ability to pay it.

We had quite a good meeting at Cotton Plant. Brother T. T. Thompson, of West Helena, assisted us. He brought his wife, who is a fine personal worker and a good musician, and I took Mrs. Bain and my daughter with me, and we had a working force of our own for the first time since I have been going there, and the favorable sentiment for Baptists was greatly increased.

Brethren, these churches are both numerically and financially weak. If the membership of this body who could easily afford to do so would contribute \$1.00 around to these two churches, it would be as worthy and profitable mission money as they ever spent.

Caney Creek—This church has been in a sort of stranded or unsettled condition. I have helped them what I could. We arranged a meeting to begin first Sunday in September and secured the services of Brother C. F. J. Tate in the meeting and the results were glorious. About 60 were baptized and some 20 or more by letter and the church will build a house equal to their needs and continue doing business for the Master.

Grand Prairie—This is a new church that I organized this year located on the Lonoke and Carlisle road about halfway between the two towns. I preached for them two days and three nights, resulting in 10 additions.

Ward—I began a meeting here the first Sunday in July. The results were glorious. I organized a church, had 68 professions and baptized some 25 or more, and left them with about 40 members, and I have heard that some have been added since. The Association would do well to keep close watch over this place, for

they are surrounded by as much false doctrine to the square inch as any place in our bounds.

I have worked for the most part in Lonoke and Pulaski counties this year, as I had given most of the time for two years past to White and Woodruff counties. However, I helped Judsonia to get a pastor and had a good meeting with them. Did some supply work at Kensett till they could get a pastor, and have supplied Cotton Plant once a month.

Brethren, it's hard to speak of our destitution in most of our territory, as many places that are in good working condition this year may be destitute next year on account of a moving population.

I have worked all the 12 months except three weeks and four days that I was sick and not able to work, by reason of which I did not take the month's vacation that you gave me, but I thank you for it just the same, to show you that I am not unmindful of your kindness to me.

I helped Baring Cross, Pleasant Valley, Pleasant Grove, all of Pulaski County, with good results, and tried to start a church at Roland, but the overflow had destroyed two crops for the people and they were so disheartened that I couldn't do much with them. I assisted Pecan Grove and Tomberlin with good results, especially at Tomberlin. Brother Crutchfield's people support the work after a good fashion.

Summary.—Miles, 5,300; sermons, 250; profession of Faith, 215; received for baptism, 141; by letter, 85; deacons ordained, 6; churches organized, 2; prayer meetings attended, 41; prayers in homes, 664; visited homes, 857; B. Y. P. U.'s organized, 1; Sunday Schools organized, 2; Sunday Schools addressed, 26; public schools addressed, 10; collected on field, \$329.93; traveling expenses, \$102.70.

R. P. BAIN, Missionary.

Chairman E. P. Alldredge read the report of the Committee on Associational Missions, as follows:

### ASSOCIATIONAL MISSIONS.

The District Association is the foundation of all organized denominational work among Baptists. To maintain, to strengthen, and to build up the work which devolves upon the 55 District Associations in Arkansas is to magnify every denominational interest and to advance every phase of our distinct work.

We raise the question: Has not the time come when we ought to consider and adopt a definite program looking to the advancement of the work of Caroline Association? Can we not agree upon some things which we can and will undertake to accomplish in this Association? Can we not accomplish more, if we have a definite and well-defined and engaging program of work that appeals to our people? We believe that we can, and that the time has come to work out some such program.

As suggestions to the Executive Board to be considered by them in their working out and putting into operation of some such program as here outlined for this present year we offer the following:

1. That the Association re-elect Brother R. P. Bain, of Lo-



noke, to the work of Associational Missionary, on the same terms and salary as last year.

2. That the Executive Board work out and present to the churches in an attractive printed form, a standard of excellence for the churches in the bounds of the Association and also one for the Association itself.

3. That the Executive Board have printed and presented to churches and pastors of the Association tracts which will set forth the facts as to the needs and opportunities of the work in our Association and seek to get the pastors of our churches to preach two sermons a year—at stated times—on Associational Missions.

4. That the Executive Board and the missionary work out an Association-wide evangelistic campaign for next summer, beginning this task immediately, and arrange, as early as possible, for a sufficient number of pastors and ministerial students to assist the churches as will make it possible to reach every church and every community in the Association where a revival meeting is wanted.

5. That the Executive Board be requested and authorized to appoint a committee of three, including the missionary and two members of the Executive Board, who will constitute a permanent Committee on Pastoral Supply, whose duty it shall be to keep in touch with every church in the bounds of the Association that may become pastorless, for the time, and be ready to recommend good, available men for supply work or pastoral service.

The report on the Mary Fletcher Memorial Foundation Fund was read by Mrs. F. E. Goodbar, Treasurer of the committee, as follows:

## REPORT OF COMMITTEE ON MARY FLETCHER MEMORIAL FOUNDATION FUND.

We, your committee appointed by Caroline Baptist Association, session held with Pleasant Hill Baptist Church, Lonoke County, Arkansas, October 9, 10, and 11, 1914, beg leave to submit our report for the associational year ending October 8, 1915:

Miss Perle Harrison was elected by the Association as Missionary Worker and Organizer, under the direction of this committee. She entered upon the discharge of her duties beginning January, 1915, at a salary of \$40.00 and traveling expenses. There being no funds available to pay her salary, and in order that this work might go forward, Brother W. P. Fletcher agreed to and did advance her salary monthly, based upon the pledges and integrity of the Association. Miss Harrison was on the field nine months. We paid her for this period \$360.00 as salary, and \$75.96 as expenses, making a total of \$435.96. Something over \$200.00 was collected during the year, leaving a balance of over \$200.00, which amount was advanced by and is due Brother W. P.



Fletcher. We ask that the said amount be paid to Brother Fletcher, or any balance that may be due on said advancement, after all the churches and individuals have sent in their pledges.

Miss Harrison resigned without notice on the 25th day of September, 1915. Report of her labors filed herewith and marked "Exhibit A," and we ask that the same be taken as a part of this report. The year's work has not been altogether satisfactory to us, for the reasons—

First. Miss Harrison did not accept the work until January after the Association met in October with Pleasant Hill Church, and her heart was much in the Foreign Mission work, which accounts for her resigning at this time.

Second. That portion of the committee that had charge of this particular work was wholly without experience, therefore, the soliciting and organizing work was not carried on in the direction as contemplated by the Association, and as desired by the committee.

We feel that the foundation has been laid for a great and glorious work for the Master's cause. We ask that this work be assigned to a committee, whose hearts and souls will be so impressed with the importance of this particular work that they will push it to a final successful organization and along the lines contemplated by the gift of the diamond ring, upon which this Foundation Fund is to be built, for the benefit of mission work within bounds of the Caroline Association, with its effects reaching out to the uttermost parts of the earth.

We feel that we will be better prepared for pushing the work more vigorously for another year. We therefore recommend that that work be continued, and that the Association make such recommendations as they may deem proper looking to the raising of funds and the selection of the proper lady missionary, who should be selected with the view of her ability as a more thorough organizer and worker, who will be competent to reach the hearts of our people, especially in the rural districts, as well as the towns and cities.

On account of the lack of necessary data, required by Brother W. P. Fletcher, and on account of his health, which called him from home for some months, we have been unable to prepare and publish the booklet containing the data upon which the design and perpetuity of this Memorial Fund is based. We pledge that this data shall and will be secured and properly compiled and published for the use and benefit of this particular cause.

After remarks by Brethren J. B. Searcy, S. H. Campbell, A. L. Aulick, and E. J. A. McKinney, it was adopted as follows:

### REPORT ON HOME MISSIONS.

Your Committee on Home Missions would report the following:

This department of our work is that which is committed to the Home Mission Board of Atlanta, Georgia. It began its work in 1845, and its receipts was in excess of its expenditures. Many new features have been added to its work since that time. Your committee does not deem it necessary to stress these various departments in detail in this report. Suffice it to say that all the mission work within the bounds of the Southern Baptist Convention is fostered by this board, which includes the work in Cuba,



and Panama Zone. It would be difficult to overstate the importance of the work of this board. We always seek to emphasize the fact that missions is one work, and the spirit of missions includes all, yet it is a fact that Home Missions constitute the base of supply for all our mission work. Practically this work is done by the Home Mission Board collecting large sums in our Eastern border, whose wealth and liberality are being utilized by the Home Mission Board to supply the destitution of the mission points in our South and West territory. Practically the distribution of this immense fund to the needy churches and points is done by the Home Mission Board co-operating with the State Mission Board of each State within the general territory. In this way the spirit of the Scriptures is carried out in that there is equality so that he that has gathered much hath nothing over, and he that gathered little has no lack. We can hardly close this report without emphasizing the great need of the Church Building Department, which is under the general supervision of Dr. Warren. We ask that Caroline Association, which numerically and financially is the leading Association in the State, should lead in this great work. The General Association brethren have several missionaries working in the various sections of the Southwest.

The report on State Missions was read by S. H. Campbell, discussed by him, and adopted, as follows:

### REPORT ON STATE MISSIONS.

"In the beauty of the lilies Christ was born across the sea;  
With a glory in his bosom that transfigures you and me;  
As he died to make men holy, let us live to make men free,  
Our God is marching on."

That, my brethren, is the spirit in which we should prosecute our State Mission work. The purpose of State Missions is to make strong our base of supplies that we may the better prosecute the work of saving men to the uttermost parts of the earth. This is a work which can only be carried on in the spirit of Jesus Christ, when every church is aflame with a passion to win lost men and is eager to contribute in some way, and with some amount, be it great or small, to the carrying out of the great Commission. In the State of Arkansas there are 1,000,000 lost souls and 1,700 Baptist churches who claim Christ, the Great Captain of our Salvation, as their Head, who are called to the task of winning these souls to Jesus. Are we equal to the task? Can we accomplish the work? Can we come off more than conquerors through Him that loved us? Yes, if under the leadership of His Spirit we give ourselves whole-heartedly and unselfishly to the undertaking. There isn't a church, be it ever so weak in numerical strength, but could

carry on a revival in some destitute section near by, at least once each year, in an effort to save souls. There isn't a pastor but could give some weeks of his time to this work every year. There isn't a church but would grow in spiritual power and numerical strength if they would give themselves to this great work. All this ought to be done in addition to our contributions to missions. The Baptist churches of this State are prosecuting the work of State Missions through the Boards of the Baptist State Convention and the General Association. This means that the churches are co-operating in an effort to carry on revival meetings in destitute places, and in weak churches; that they are evangelizing and baptizing, and indoctrinating as they go; that they are helping weak churches by aiding in the support of pastors; that they are caring for orphan children, helping in the support of young ministers in Ouachita College, and prosecuting the work of Christian education so that we may have more efficient leaders in the future. Your committee would welcome any facts or figures that could be given by any brother showing what has been accomplished by any of our churches during the past year to help save this great State of ours, and would gladly embody them in this report, but we can only give here the figures we have at our command. The General Association has eight missionaries in the field, but we have no report in hand to show what has been done.

Here are some facts to show what has been done through the Executive Board of the State Convention for the past year: Missionaries employed, 47; days labored, 10,123; miles traveled, 65,827; appointments, 74; sermons, 5,490; other addresses, 898; total sermons and addresses, 6,388; services in homes, 1,812; conversions, 1,458; baptisms, 1,270; additions, 804; total additions, 2,074; amount raised for State Missions, \$12,262.75.

Last year there was a heavy indebtedness on this Board and hence it will require \$30,000.00 to pay off our missionaries and pay our debts by the time of the Convention at Conway November 18, 1915.

Your committee therefore recommend—

1. That earnest, agonizing prayer be made by all the churches for God to liberate us from the crushing burden of debt.

2. That every pastor gather all possible information about State Missions and present these facts to his people in a burning message that will set them on fire with a passion to win this State to Christ.

3. That the pastors of this Association organize in an effort to get an offering for State Missions from every church in the Association.

4. That the laymen co-operate with the pastors in this great work of reaching each church with an appeal, and try to enlist them in this the greatest work in which any redeemed soul can be engaged.

The Committee on Foreign Missions reported through G. L. Boles, the chairman, and the report was discussed by him, A. L. Aulick, S. H. Campbell, E. P. Alldredge, J. H. Estes, A. E. Dobyns, and adopted as follows:

### REPORT ON FOREIGN MISSIONS.

Our Foreign Mission work is the effort on our part to carry out the last command of our Lord and Master to go into all the world and make disciples of all nations. The conditions of the world today are giving tremendous emphasis to the fact that all men need a simple New Testament religion. The non-Christian nations are awaking in a wonderful way and inquiring for the path of peace and the way of life. The people are more accessible than ever before. The harvest fields are ripe and we should now thrust in the sickle and reap on a scale that will far transcend anything in the past.

The Foreign Mission Board, located at Richmond, Virginia, composed of 18 local members and 18 State members representing each State in co-operation with Southern Baptist Convention, is conducting work in Italy, Brazil, Mexico, Argentina, China, Japan, and Africa. Churches, 382, with 819 out-stations, 33,584 church members, 442 Sunday Schools, with 23,959 scholars, and 8,833 students in mission schools, 384 of whom are in theological seminaries and training schools preparing to preach the gospel to their own people. There are 300 missionaries on the fields, 20 of whom were sent out during the past year, and a total of 651 native workers. Notwithstanding difficult conditions on many fields, caused by the European war and the injury to the work in Mexico from chaotic political conditions in that country, 5,190 baptisms were reported during the year.

Our General Association brethren are also engaged in this great work of carrying the gospel to the lost. We could not secure a full account of their work done in foreign lands, but are glad to report that they have four missionaries at work in the lands of darkness.

The distressing financial conditions throughout the South, created by the war in Europe, caused a falling off in contributions to Foreign Missions last year. This will make it more difficult for us to maintain the work this year, unless God's people meet the situation in a still more heroic spirit. The Convention at Houston asked for an apportionment of \$624.00 for Foreign Missions this year. Every dollar of it is needed to carry on the work successfully.

We recommend—

1. That we as an Association undertake to raise for Foreign Missions our full proportion of the above sum. That we earnestly urge the churches to contribute liberally and systematically to this cause.

2. That each church member take and read the Foreign Missions Journal, thus keeping informed on the progress of the work in foreign lands.

We further recommend that every church in the Association heartily co-operate in the effort to make the Judson Centennial Memorial Fund of \$1,250,000.00 a glorious success, and that we

pledge ourselves to do our best this winter when a week is set apart for the completion of this work to make Arkansas' showing a splendid victory.

We live in an age in which the dissemination of knowledge is great and seemingly there is no end to the making of books and the publication of periodicals of all kinds.

Many of these are not worth the space they occupy on the shelves of libraries. God delights in an intelligent Christian. In every family there should be good religious books whose teachings are in harmony with the doctrines of the Bible. The heads of families should have one or more of our denominational papers which are published weekly, so they and their families may be informed about what we as a denomination are doing for the promotion of the gospel in our own State and throughout the world; and that they also may know what God is doing for us who are His children.

We, your committee, would therefore urge our people to give our denominational papers the financial support which they so justly deserve by subscribing to and paying for these weekly papers.

We, your committee, would also urge that they read and study the Bible that they may know the doctrine and be intelligent Christians.

Report on Christian Education was read by A. L. Aulick, discussed by him, J. W. Conger, J. H. Estes, and adopted as follows:

### REPORT ON CHRISTIAN EDUCATION.

Your Committee on Christian Education would report as below:

Without well-equipped Baptist schools all of our Baptist work would suffer and come to a standstill. We look to our Baptist schools for most of our trained workers in pulpit and pew, as well as on mission fields. Ninety-five out of every hundred of our foreign missionaries come from Baptist schools. The Bible is definitely in favor of Christian education. See Hosea 4:6, Matthew 28:20, Ephesians 4:18. So Christian Education and its support must be put on the same basis with Missions.

Arkansas Baptists have two great Christian colleges, Ouachita, for boys and girls, at Arkadelphia, S. Y. Jameson, D.D., President; Central, for girls, at Conway, J. W. Conger, LL.D., President. Last year Ouachita had about 325 students, and Central had about 200. These schools have rendered a service to the Baptist cause in Arkansas, the value of which can never be estimated. The atmosphere of the schools is religious and reverent, and many students who have gone to them strangers to God have gone forth from them consecrated to God.

We are planning to have three mountain schools soon. One of these, the Ouachita-Maynard Academy at Maynard, W. A. Cummings, A.B., President, is running this year. We must help save north Arkansas by establishing good mountain schools.

The education of preachers is one great object in Christian Education. The denomination that fails to provide for the education of its preachers will die as a denomination. Last year there were 39 young preachers in Ouachita College. They receive free tuition, and some help on other expenses when it is necessary. The Bible Department is arranged with special reference to the preachers, but the classes are open to all, and Bible is required of all who graduate.

Ouachita College has been freed from debt. Central has considerable indebtedness yet. We need annually at least \$10,000.00 to help take care of running expenses at Ouachita, and to pay on the indebtedness of Central.

We recommend—

1. That every Baptist Church in this Association make an offering this year for Christian Education.

2. That no time or effort be spared in an endeavor to turn our Baptist children to our denominational schools.

3. That we insist that our schools and colleges shall continue to conform in spirit and doctrine to well-established Baptist principles.

4. That the churches encourage all men, called of God to the ministry, to obtain, if possible, a college and seminary education.

#### REPORT ON MINISTERIAL EDUCATION.

We, your Committee on Ministerial Education, offer report:

This is an age of specialties, and the ministry must be trained in order to reach the greatest possible degree of efficiency. It is a fact that education does not make, neither can it make, a Baptist preacher. Men may make Pope and priest, but it takes God to make an ideal Baptist preacher.

From every part of the country the people are calling for and demanding that our preachers be trained for their calling. The commercial world is demanding trained men, why not the churches? Our churches will no longer endure a feeble ministry. Every cause dear to our Lord finds expression in the life and leadership of an adequate ministry. Our needs for a capable ministry were never as great as now.

In the matter of ministerial education our minds turn first to Ouachita College. Here we have enrolled about 30 preachers. Many of these boys are glad to endure unspeakable hardships in the hope of acquiring an education. Many of them are living in constant fear that each month may be the last month in school. These boys do not ask for a comfortable support. They ask that they may be permitted to pursue their studies without regard to hardships. Therefore, your committee would recommend:

1. That our churches urge upon the young men whom they believe have been called of God to preach the gospel the necessity of acquiring an education.

2. That our churches contribute liberally of their money for the support of our young preachers at Ouachita College.

3. That the preachers preach at least once on ministerial education during the year, and get the largest possible contribution for them.

We recommend that Brother J. L. Rayburn be adopted as a beneficiary of this Association at Ouachita College.

The report on Woman's Work was read, spoken to by Mrs. E. J. A. McKinney, Mrs. Alice Jones, Mrs. A. L. Aulick, E. P. Alldredge, and adopted as follows:

#### REPORT ON WOMAN'S WORK.

The Woman's Missionary Union auxiliary to the Caroline Association has enjoyed a very profitable two days' meeting at the First Baptist Church during this session of the Association.

The report of our organizer, Miss Perle Harrison, as submitted to the Union, showed 43 societies of various kinds organized. How many of these will become permanent societies we do not know, but every new work will have both its joys and disappointments. We desire to prosecute this work with even a firmer hand during next year, and feel that our past experiences will help us to do better work for the future.

Mrs. A. J. Espy, as Superintendent, reports 16 societies that sent in reports to her. These reports show \$1,453.55 given to Missions and a total of \$6,621.20 raised for all purposes. This is a good showing, but not so great as we want it to be. Our aim is a Woman's Missionary Society, Y. W. A., Royal Ambassador, and Sunbeam Band in every church. In these we hope to increase the knowledge of the Bible and of the world's needy fields. We also hope to impress the right idea of stewardship of talents and possessions on all our people.

To accomplish this work we need to keep a woman worker in the field and hence we ask of the Association that the brethren help us to maintain such a worker the coming year, such worker to be chosen by the Executive Board of the Association and the Executive Board of our Associational Union jointly.

In our meeting we have raised \$138.00 toward the support of the work the coming year.

We more and more appreciate the Mary Fletcher Memorial Fund coming to us through the suggestion of our Moderator through the love he and his brothers and sisters had for their mother and for their appreciation of her love of missions, and we trust that the spirit of the mother in sacrificial giving shall rest more and more upon every child of God in Caroline Association.

## REPORT OF COMMITTEE ON SUNDAY SCHOOLS.

We, your Committee on Sunday Schools, beg leave to submit the following report and urge its adoption:

According to statistics gathered in Caroline Association in 1913, only 54 per cent of the total church membership in the Association attended Baptist Sunday Schools. Your committee assumes that every church member is a member of every service of his church and fails to understand how any Baptist who seeks to teach by either precept or example, could expect to lead his own children or his neighbors' children into the truth as held and taught by Baptists without setting the worthy example of faithful and interested attendance upon every meeting of the Sunday School.

The Sunday School is the teaching service of the church and can be made to count effectively as such only when we are willing to assume the responsibility of teaching others or of being taught. To aid in the solution of some of the problems which menace the prosperity of many of our Sunday Schools in Caroline Association, your committee begs to incorporate in its report, a few wise and timely suggestions offered by your Sunday School Committee in a report made to this body in 1914. The following taken from that report is submitted herewith, in the hope that many of the problems which now seriously hamper Sunday School progress may be speedily overcome:

1. If you have not already done so, proceed at once to take a religious census of the territory tributary to your church, city, town, or country, thus fixing the basis upon which your school should work.

2. Your school should then be graded on the total results of the census thus obtained, and no effort whatever should be spared to reach the last one, young, old, rich, poor, ignorant, learned, all alike.

3. The school building should be equipped with blackboards, maps, tables, chairs for children, and, where separate class rooms are not provided, they may be had in any building by use of curtains or screens.

4. The demand today is for trained teachers also. We would therefore recommend that teachers avail themselves of the Normal Courses for teachers offered by our denominational agencies. This work may be done individually or in classes. Information on Religious Census, Grading, Equipment, Organized



Classes, or any other phases of work may be had free upon request to Doak S. Campbell, 410 Hollenberg Building, Little Rock, Ark.

5. We recommend finally that sound Baptist literature be used in all our Sunday Schools, and that all churches in our Association which are now destitute of Sunday Schools proceed to organize, grade, and equip a Sunday School and maintain same from Association to Association.

## REPORT ON ORPHANS' HOME.

By virtue of the fact that all who are left orphans at an early age are dependent on someone, we would respectfully recommend that the churches of this Association contribute liberally and systematically to the support of those children who have been laid in the lap of the churches of Jesus Christ.

Our Home at Monticello is caring for about 190 children. The Home at Texarkana is caring for 32 children. Substantial improvements have been made at both Homes this year. We are not able to give the amount of the improvements at Monticello or Texarkana either, but from the best information secured there are still improvements needed. We are glad to note the growing interest through the Association in favor of the Home.

We recommend—

1. That all our Sunday Schools give an offering once a month for the support of the orphans, and that the pastors of the churches lay it upon the hearts of their people to do more in the future than they have in the past to supply the needs of those children.

2. That all W. M. U. officers seek to interest and enlist all our women in the work of caring for our orphans.

In former years the Unions were antagonized by older church members, but that has passed away and soldiers for service are being drilled and the future of the Baptist churches grows brighter as the days pass, largely through the B. Y. P. U. work.

We have as Corresponding Secretary of the State B. Y. P. U., Doak S. Campbell, who is second to none in efficiency in the work, and the B. Y. P. U. work is rapidly advancing through his efforts.

We recommend—

1. That a B. Y. P. U. be organized in every church.
2. The group plan of organization, the Standard of Excellence, and the use of the B. Y. P. U. Quarterly for topics.
3. That a representative of each Union be sent to the 1916 Summer Assembly where they will receive an inspiration for better and more efficient work.

## CONSTITUTION

---

Article 1. This Association shall be called the "Caroline Baptist Association," and shall be composed of Baptist churches representing themselves by accredited Messengers. Its objects shall be to provide missions, education, and Sunday Schools.

Art. 2. Every church belonging to the Association shall be entitled to three Messengers, and every church having over one hundred members shall be entitled to an additional Messenger for each additional fifty members over one hundred.

Art. 3. The sessions of this Association shall be annual, at such time and place as shall be appointed by the body.

Art. 4. Any Baptist Church of the same faith and practice may be admitted as a member of this Association upon expressing a desire, through Messengers and letters, to work in fellowship with us.

Art. 5. The officers of the Association shall be a Moderator, Clerk, and Treasurer, who shall be elected by ballot at each annual session, and continue in office until their successors are elected. A majority of all the votes cast shall be necessary to elect.

Art. 6. The Association has no power to control or to in any way interfere with the independence or rights of the churches, but may advise, when asked by a church through its letter to the Association, and it may withdraw its fellowship from any church known to walk disorderly.

Art. 7. This Association may correspond by letter and Messenger with other representative bodies of our denomination.

Art. 8. In the absence of an officer of this Association his place shall be filled pro tempore, by viva voce election.

Art. 9. The Association may from time to time adopt such rules and by-laws for its government as may be expedient, not inconsistent with this Constitution.

Art. 10. This Constitution may be altered or amended at any regular session by the vote of two-thirds of the Messengers present in favor of the proposed amendment.

Amendment No. 1. This Association may provide means to aid in support of their aged, infirm, needy, and superannuated ministers who have devoted their lives to the ministry and have been engaged in their last ministerial work for at least one year within the bounds of the Association. The Association may appoint a board and adopt such by-laws and regulations as will be necessary for carrying out the provisions of this amendment.

## BY-LAWS

---

### For the Direction of the Board on Aid to Superannuated Ministers.

Section 1. The Association shall appoint a Board on Aid to Superannuated Ministers, consisting of three members, which board shall be located in or near the same locality. Said board shall hold office from the time of appointment until the annual session of the Association. Should a vacancy occur on said board the majority may select a member of any Missionary Baptist Church, a member of this Association in good standing, to fill such vacancy. The board shall organize once a year by electing a President, Secretary, and Treasurer. Said board shall provide such stationery as will be necessary for their use as a board, and any other necessary expenses that may be incurred in carrying on the work intrusted to them shall be paid out of the funds in their hands, and they shall be required to make a report to the Association each year of all moneys received and disbursed.

Section 2. The board provided for in Section 1 of these By-laws may raise means through the churches of this Association, or raise contributions from other sources and in such manner as will be legitimate. They may purchase lands, make improvements under direction of this Association. The title to such lands shall be made to the Moderator and his successors in office.

Sec. 3. The Association shall, at its annual meeting, decide who shall be placed upon the list of superannuated ministers and direct what amount of aid shall be furnished by the board, and decide whether or not such beneficiary can labor in the ministry, and if so, to what extent. Provided, that if some ministers, within the bounds of Caroline Association, may, from continued sickness of himself or his family, or for other good and sufficient causes, become a charge on the community in which he may at that time reside, the board may render such aid to such ministers as the circumstances may require or their ability will admit of. Provided further, that for good and sufficient cause the board may determine their aid to such ministers and report the action to the Association at its next session.

Sec. 4. The board provided for in Section 1 of these By-laws shall, in all cases where it is possible, work in harmony with the Missionary Board of this Association in supplying and giving work to such infirm or superannuated ministers as they find such ministers are capable of performing. And in no case will this board be permitted to make pledges beyond their financial ability as such board, nor shall they involve the Association in debt.



Sec. 5. The Board of Ministerial Education shall aid such ministers as are adopted by the Association for education to the extent of the funds in their hands. Loans may be made to ministers and their individual notes taken to the President of the Board of Education and his successors in office, with interest at 6 per cent from due until paid. The board shall not loan more than sufficient funds to meet the actual needs of such beneficiaries, and not more than will be necessary for five months at any one time. They shall divide the funds in their hands in equal proportions as the demands of the beneficiaries may require. And the board shall provide such stationery and printed matter as will be required to carry out the requirements of the Association.

5. We believe that salvation is free to all who will accept the Gospel. Isaiah 55:1; John 7:37; Rev. 21:6; Rev. 22:17.

6. We believe that, except a man be renewed by the Holy Spirit, he is not qualified or prepared for the kingdom of Christ on earth, or to enjoy His glory hereafter. John 3:3-8.

7. We believe that repentance toward God and faith in the Lord Jesus Christ are duties of everyone who hears the Gospel. Matt. 3:2; Acts 18:31.

8. We believe that election is the eternal purpose of God, by which he graciously regenerates, sanctifies, and saves sinners. Rom. 8:30.

9. We believe that sanctification, begun in regeneration and ever progressive, is the process by which we are made to partake of God's holiness. John 3:6; 2 Thes. 2:12.

10. We believe in the preservation of the saints, that they are kept by the power of God through faith unto salvation. 1 Peter 1:5.

11. We believe that God's law is the only, the eternal and unchangeable rule of His church and moral government. 2 Tim. 3:17, 18.

12. We believe that a church of Christ is a congregation of baptized believers united in the faith and fellowship of the Gospel, observing the ordinances and obeying the laws of Christ, and that its officers are pastors and deacons. Acts 2:41-47; 3:28.

13. We believe that Christian baptism is the immersion of a believer in water, by a properly qualified administrator, in the name of Father, Son, and Holy Ghost. Matt. 28:18; Mark 16:16; Rom. 6:3, 4.

14. We believe that only such as have been properly baptized and received into fellowship of a regularly organized Baptist Church should partake of the Lord's Supper. Matt. 26:26, 27; 1 Cor. 11:20-23.

15. We believe that the Lord's Day or Christian Sabbath should be devoutly observed and sacredly devoted to religious services. Mark 16:9; Acts 20:7; 1 Cor. 16:1, 2; Heb. 10:25.

16. We believe that civil government is of divine appointment, and that the governors of States and Nation should be obeyed when the laws they seek to enforce do not conflict with the Gospel.

17. We believe in the future resurrection of the dead. Dan. 12:12; Thes. 4:16.

18. We believe in the final judgment, and that in that day the righteous and the wicked will be separated forever. Acts 17:31; Matt. 25:32, 33.

19. We believe that the righteous will be happy forever in heaven and the wicked miserable forever in hell. Matt. 25:34-46.

### CHURCH COVENANT.

---

Thanking God for the light we have received, and for the revelation of Jesus which we now enjoy, and hoping that God, for Christ's sake, has pardoned our sins, and having been baptized on a profession of our faith in Jesus Christ into the name of the Father, Son, and Holy Ghost, we do this day, before God and the world, and with deep joy and great solemnity, enter into this covenant with one another, as one body in Christ.

We therefore covenant and agree that, by the aid of the Holy Spirit, we will walk together in love and Christian fellowship. We promise to labor for the advancement and final triumph of the church to sustain her worship by attending the house of God and supporting the ministry; guard her ordinances, enforce her discipline and defend her doctrine.

We also pledge ourselves to walk circumspectly in the world; to be honest, just, and faithful in our business relations, and as God may give us help, we promise to live righteous and holy lives.

We further promise to watch over each other in brotherly love; to visit the sick; to pray for each other in the world; to aid the poor and needy, and to perform such other kind offices as may be well pleasing in the sight of God.



RULES OF DECORUM.

---

1. The daily session of the Association shall be opened and closed with religious exercises.

2. All exceptions to the decision of the Moderator shall be by appeal to the body, whose decision, as expressed by a majority of the vote, viva voce given, shall be final.

3. In case of a tie vote the Moderator shall give the casting vote, and shall not be allowed to vote in any other case.

4. The Moderator shall have the same privilege of speaking as other members, but when rising to speak shall call some other member to the chair.

5. No member shall speak but once on the same subject, and not more than twenty minutes at a time, except by leave of the Association, provided the mover shall have the privilege of opening and closing the debate on his motion or resolution.

6. But one member shall speak at a time, and if more than one rises to speak at the same time the Moderator shall decide who is entitled to the floor.

7. Any member desiring to speak shall arise and address the Moderator, and in speaking shall confine himself to the subject under discussion, and no one shall use any disrespectful or discourteous language calculated to wound the feelings of any member, or to disturb the harmony of the body, and the appellation of "brother" shall be used in every reference to a member of the Association.

8. No member of the Association shall absent himself without leave of the chair, and the chair shall grant no such leave except for reasonable cause.

9. It shall be the duty of the Clerk to make and present faithful records of the proceedings of the Association, and to procure and supervise the printing and distribution of the same among the churches.

10. It shall be the duty of the Treasurer to receive all moneys accruing to the Association, to pay out the same upon order of the Clerk, or if Home Mission fund, upon the order of the Secretary of Home Missions, and to report his receipts and disbursements. But the Clerk shall draw no order upon the Treasurer except for appropriations made by the Association.

11. Committees shall be appointed by the chair, unless otherwise ordered by the Association.

### REPORT ON MISSIONS.

The Committee on Orphans' Home reported as follows:

### REPORT ON ORPHANS' HOME.

We, the Committee on Orphans' Home, would respectfully submit the following:

God expects the Baptists of Arkansas to provide for the orphan children who are within reach of us. If we fail adequately to provide for this work we shall fail before God.

We are indeed glad to report that in many ways the past year has been a great one in our Orphanage work. At present we have 190. At one time there were 199, but some died and some left. Five have died the past summer. One of the girls who died was not an inmate of the Home when she died, but was simply visiting the Home. At present the health is splendid. All the children affected with pellagra seem to be entirely well, except two, Sam Tullous and Henry Russell. All are in school except Sam. We feel that God has been good to us in that he has restored so many to health.

The greatest strain on the Home now is the debt. Will we pay it?

At present, Professor and Mrs. J. N. Williams are Superintendent and Matron. They are assisted by Mrs. Evie Jordan and Miss Myrta Daniels. School is in progress, with two teachers, Misses Margaret and Mary Theresa Harris.

We wish to make the following recommendations:

1. The payment of this debt. It is now over \$15,000.00, and we cannot go forward with the constructive work of the Home till it is paid. We must have more money for running expenses. We are behind with our grocery bill. One wholesale house has refused to sell to us. What will we do?

2. That money be raised for steam heat. The steam laundry is already in operation and with a little more expenditure the steam heating plant could be installed.

3. That a printing press be put in. The Home spends two or three hundred dollars a year for printing. Why not eliminate this expense, besides teach the boys and girls to do things.

4. That a carload of produce be sent to the Home from this Association. This would be a great help.

5. That all subscribe for the Orphans' Gem—only 25 cents a year.

We rejoice in the fact that people are more interested in the

Home than ever before, and are giving more to its support than ever before, but, brethren and sisters, remember that the Home is bigger than ever before and calls for more support. Let us all do our whole duty toward the Home and these orphan children.
