We have had very small attendance at all our meetings and we regret the Mission spirit has not been what we would like to have seen it. At our last meeting, the Almyra Church asked a loan of \$40.00 to help pay their Pastor, as the fire at that place delayed some who had contributed, to meet their obligations, and we thought best to refer the matter to your next Executive Board.

We feel the need of emphasizing anew the importance of this subject. The Prosperity and progress of our church depend largely upon the enlightment of the membership. Educated men and women give standing and power to membership, but we should be careful that our young people should not be educated away from Christian work; hence, the importance of Christian education. We have two excellent colleges in our state—Ouachita, at Arkadelphia, for young men and women, and Central at Conway, for young women only, and Bucker College for men and women. We urge our people to send their sons and daughters to these Institutions for a college education.

Report of Board Trustees

of the Baptist Collegiate Institute at Brinkley, Arkansas.

We are glad to report that we now have some 5000 Baptist in sympathy and

co-operation with our school, including three Associations as follows: Mt. Vernon, Grand Prairie and White River Valley. We have made some substantial advance during the year although not what we had hoped to do. We have felt the panic in our work. We now have the following property: a campus of nearly two acres; valuation, \$1000; two lots with a two story dormitory; valuation, \$2500; pledges and building material, \$2500; total, \$6000. We have also adopted plans for our main building, which we hope to have ready for opening school in not later than September, 1909. The building when complete will cost some \$15,-000.

Our financial agent, Rev. J. G. Harris of Brinkley, has worked for us without cost to the board, the Brinkley church allowing him to do this work in connection with his duties as pastor. His expenses have been taken care of without taking it out of the building fund. We are glad to report that he will continue this work.

We recommend the following changes in our constitution, that Sec. II be

changed as follows;

Sec. II. That the same shall be controlled and supervised by a Board of Trustees of fifteen members, elected from the district at large, subject to approval of the Association in co-operation with said school.

That Section III be changed as follows;

Sec. III. One third of the members of said Trustees shall annually be retired from office and others, or the same persons be elected to fill the vacancies.

He often gathered together his disciples and taught them, as in the Sermon on the Mount, Matt. 5-7. The Apostle Paul laid great stress on teaching. So did the early church fathers. Ninety per cent of the conversions comes through the work of the S. S. or teaching service. We regret to know that but eight churches of this Association report Sunday Schools. It is our conviction that each church should have a Baptist S. S., throughout the year.

We further recommend that parents attend the S. S. and discourage the idea that the S. S. is for children only. We further recommend that Sunday

Schools be established where no churches exist.

Report on B. Y. P. U. Work.

The Baptist Young People's Union is no new thing in the religious realm.—
It is as old as the first young individual God laid His hand on for service. It is only new in form. It is not mere machinery. It is more than organization. It has a solid foundation and a magnificent view. The B. Y. P. U. means working and planning and praying. It means preparation, equipment and development larger service in the Kingdom of our Lord. It has a two-fold purpose—the projection and the edification of our young people. Here they are schooled and willed as soldiers to take the place, after awhile, of the veterans who have gone before. It builds up the church in personal work, in evangelistic work, in more for work and surely our young people are never so safe as when they are doing God's work. Surely the possibilities of our young people, co-operating, manued, taught, trained, developed, and armed, are as boundless as the uni-

We note with profuse gratitude that the B. Y. P. U. in Arkansas has taught the spirit of enlargement. More than ever the various churches throughout the little are beginning to realize the absolute necessity of saving, training and util-

izing the mighty army of our young men and young women. New organizations are being formed and many who have hitherto opposed, have become enthusiastic supporters of the work. From the imperfect reports received we learn that last year there were more than seven hundred and fifty engaged in systematic mission study, and the number is increasing week by week.

Beginning January 1st, 1907, and continuing for seven months, Rev. M. E. Hudson, through the aid of the State Mission Board, was kept in the field as a B. Y. P. U. and Sunday School evangelist. His efficient service added many more unions to the number in the State and brought new life to others already formed.

Realizing that the B. Y. P. U. is logically the hardest service in the church to maintain, because it is training work; also that it is a work of such supreme importance and of such splendid possibilities, we therefore recommend:

First. That all our pastors resolve to take a more enthusiastic and working interest in the B. Y. P. U.

Second. In view of the fact that the B. Y. P. U. assembly at Arkadelphia, last July, was so eminently profitable and helpful, that each pastor be urged to secure a large attendance from his church, to the coming assembly, July 10-16, 1909, at Arkadelphia.
