MINUTES.

THURSDAY MORNING.

PROCEEDINGS OF THE UNITED ASSOCIATION, SEPTEMBER 8, 9, 10.

The United Association was called to order in the Baptist church at Antioch on Thursday at II o'clock a. m. by the Moderator. Introductory sermon preached by Elder J. Mayall from Jude i, 3 and 4.

The body adjourned to meet at 2 p. m.

EVENING SESSION.

Body met. Reading and prayer by M. S. Kirkland.

Moderator called for letters from churches. Twenty one presented their letters, and the messengers' names enrolled. See table.

Brethren Daniels and Ledbetter were appointed reading clerks.

The body then went into permanent organization by electing Elder T. Moody, Moderator, Asa Robertson, clerk and E. A. Woolverton, treasurer.

The Moderator appointed a devotional committee consisting of Brethren J. T. Russell, E. A. Woolverton, T. H. Jones and J. K. Broadaway.

Corresponding messengers called. The following brethren reported:

M. S. Kirkland, from Russellville Association; J. P. Pennington, from White River Association; James Denney, from Trace Ridge Association, were received and admitted to seats in the body.

On motion that this body meet at 8 o'clock a. m., adjourn for preaching at 11 o'clock, meet at 2 p. m. each day, and that the hours of 11 and 7 o'clock be set apart for devotional services.

On motion the body adjourned to meet at 7 p. m. for preaching.

FRIDAY.

MORNING SESSION.

Body met, prayer by clerk.
