PROCEEDINGS.

The forty-second annual session of the Crooked Creek Association of Missionary Baptists convened with Valley Springs Church, Thursday morning, October 13th, 1910, at 10 a.m. Devotional service 10 a.m. to 10:30 a.m.

Song, "There is a Fount." Song, "How Firm a Foundation." Prayer, by Elder J. C. Cooper. Song, "Lest Jesus Bear the Cross Alone." Prayer, Elder W B. Collins. Song, "We Praise Thee, O God." Song, "My Savior First of All." Prayer, by Elder R. W. Raley. Song, "Trust and

Obev."

10:30. Elder N. W. Bradley delivered the introductory discourse very forcibly, using for his lesson the third chapter of Paul's letter to the Ephesians. After the reading of the lesson Elder L. R. Capps lead in prayer. Song, "Am I a Soldier." Used 2nd Corinthians 10:4 for his text, brought clearly before the minds of all who heard him the fact of the Bible as the foundation and main pillar of our faith and hope. Explained perpetuity of our church and how our lives or our influence will live long after we are gone.

Elder Capps made an appropriate response at 11:40; meeting closed

to meet in regular session of the Association at 2 o'clock.

Association called to order by moderator at 5 p.m. Devotional service conducted by Elder L. R. Capps. Lesson from Psalms 27. Prayer by Elder L. R. Capps. Letters received from all the churches.

Elder J. H. Klepper and Elder L. R. Capps were appointed reading

Motion carried that Elder W. B. Collins be seated as messenger from Alpena Church, not being duly sent by that body.

REORGANIZATION.

Motion carried that Elder W. S. Trout act as moderator for ensuing year. John Sugg elected by acclamation to act as clerk for ensuing year. Motion carried that Brother E. F. Graham be retained as treasurer. Call for petitionary letters for membership. Letters were received from the

following church: Pleasant Grove Church. Motion with second carried unanimously that Pleasant Grove Church be received into the Association. The right hand of fellowship was given the messengers by the moderator, after which the associational letter was read for them.

3:30 Call for corresponding messengers and letters. Elder C. Hoge, the visiting messenger from White River Association reported, and gavea short literary talk. Elder J. T. Mabry, the visiting minister from P.D.

Association responded but was unable to make any report.

Elder F. P. Turner reported as the visiting member working in the interest of the Orphans' Home at Monticello. Elder J. C. Cooper from the White River Association and Elder N. F. Bradley from Crooked Creek Association were invited to be seated as visiting ministers, with the right to debate and all rights of a regular delegate aside from voting.

Visiting members were invited to seats with the body as follows: W. P. Whitney, Cave Hall Church; John Crowe, Pleasant Grove Church; Troy Eoff, Union Church; E. F. Graham, Prairie View Church; Sister Campwell, Pleasant Grove Church; E. C. Hodge and wife. Harrison Church.

Committee on divine service made partial report as follows:

Eld. R. W. Raley appointed to preach Thursday night 7:30 p. m., Eld. J. H. Klepper to follow. Elder F. P. Turner appointed to conduct services at 11 o'clock a. m. Friday; Elder J. T. Mabry to follow. J. H. Cook, chairman. Motion by Elder Collins carried that the partial report be adopted.

By motion the Association adjourned to meet for devotional service at 1:30 p. m. and to meet in regular business session at 8:30 a. m. on Friday The Association dismissed by prayer from Elder Cooper at 4:30.

Thursday night meeting 7:30. Song, "How Firm a Foundation." Elder L. W. Raley read his lesson from 2nd Timothy 3:1-9. Prayer by Elder J. H. Klepper Song, "Blessed Be the Name of the Lord." Elder Raley took for his text, "Ye are my friends if you do what I command you. If you love me you will keep my commandments." Delivered a very able discourse full of the spirit and power, describing the vital necessity of complete surrender to God to ever be able to accomplish what God intends for us. Song, "Jesus paid it all." Elder J. H. Klepper concluded the service with a very appropriate response admonishing all to a life of Godliness.

The Association met pursuant to adjournment at 8:30 a. m.

To White River Association: Brother George Nichol and Elder W. S. Trout. The Association meets with Hopewell Church via Cotter, Arkansas, on the I. M. Ry. Friday before the 4th Sunday in September.

To Carroll Association: j. F. Pruitt, Elder W. B. Collins, Elder W. S. Troutt and Elder L. R. Capps. The Association meets at Omaha, Arkansas, Wednesday before the second Sunday in October.

To P. D. Association: Elder J. H. Klepper.

Elder I D. Lamb spoke in favor of a committee on Women's work. His talk carried a motion that this committee be appointed and maintained. Elder J. H. Klepper seconded the motion and after some discussion by F. P. Turner and J. H. Klepper the motion carried almost unanimously.

The constitution and rules of decorum were read by the clerk,

After discussion by W. S. Trout, I. D. Lamb, Dock Eagle, F. P. Turner, R. W. Raley and W. P. Collins on the right to strike out of article 1 the word "Delegates" so as to read "Messengers" only. Elder I. D. Lamb made motion to strike out the word "delegate" and insert "messengers" in Article 1. Seconded by J. H. Klepper. The motion was ruled out of order and no vote taken.

Elder W. B. Collins made a motion amending Elder Lamb's motion to read "We your messengers," by majority vote recommend and earnestly desire that you, the churches of the association, amend or embrace the amending of article number 1 of the constitution to read "messengers," leave the word "delegates" entirely out. Second by A. K. Toney. Motion carried 20 for and 10 against. Each church is requested to report in their next letter as to whether or not they favor the change of the constitution as stated.

Letters from Liberty, Oregon and Valley Springs Churches which were received late.

Committee on Association Missions made the following report:— We

your Associational Committee beg to submit the following report:- Realizing the great importance of Associational Missions, we recommend that the Crooked Creek Association Board make an honest, earnest, prayerful effort to employ a missionary for the full year whose duty it shall be to labor in the desolate sections of our Association. First we recommend a mission board of five men, three of whom shall constitute a quorum who have the work at heart, who shall be elected by nomination at such association, whose duty it shall be to render to the next association a complete report of all moneys received and expended, also number of days' work of missionary, number of conversions, number of churches organized, and all the missionary work.

3rd We recommend that a collection be made during this session for associational missions. We further recommend that our board place the importance of this movement on the hearts of the State Board with an effort to obtain a stipulated amount each year for associated missions.

4th. In order to impress this association with the great importance of associational missions, we claim that this movement is the only one which covers every other movement. First, our field is a part of the great State of Arkansas, therefore should receive the favor of the State Missions Many homes are represented in the desolate places of the association, all serving under the same flag, therefore Home Missions should be interested with us. Every church and every member reached in these d solate places are orphans without the comforting guiding hand of a pastor. Therefore the committee on orphan's home should be favorably impressed. We believe, and the reports will bear us out that a greater amount of good and a greater harvest into Christ's kingdom has been acquired through this movement than through any other in proportion to the money expended. Therefore, we, your committee, earnestly request the hearty support, both spiritually and financially of every member in Crooked Creek Association, and further request that every member within the vicinity of a missionary service render their best assistance and co-operation to our missionary.

Call for report from Committee on Orphans Home work. The Committee submitted the following report: Your Committee on Orphanage work respectfully submits the following: Our Orphans Home at Monticello has had another prosperous year. There has been seven or eight

children who have reached the age and gone out for themselves. Four or five have been adopted out into good Christian Homes. The school in the home has been far better than ever before. More than eighty of the children are now in school. The spiritual influence has been excellent. More than twenty-five of the children have professed conversion and have been baptised the past year.

That he is requested to place himself under the jurisdiction of the Association Board for that meeting and

The report is as follows: Believing intemperance to be one of the greatest curses of the human family of the past and present, and unless eradicated it will be the greatest curse of the future, we the Missionary Baptists of the Crooked Creek Association condemn intemperance in every form and that we heartily pledge ourselves to put forth an earnest effort to eradicate the Devil's strongest agency, the Octopus of intemperance whose grasping unyielding arms are even now getting possession of our lawmakers, our business enterprises, mechanics, business men, farmers, doctors and others; further that its deadly grasp reaches out in anticipation of our churches, schools and homes.

We the Baptists here convened believe there is no law or privilege to be found in the Bible-which could be construed to allow one man to sell or even to give his fellowman that which will destroy his health, his home or happiness or cause him to loose his own soul, therefore we condemn the law which licenses the saloon and believe that God condemns it all. We believe that no Christian man can accept a license or be instrumental in granting one either by approval or ballot. We pledge ourselves to discourage the use and abuse of all intoxicants and we further note with pleasure that the Christian people of the United States are rapidly gaining ground on the liquor question, that the prohibition districts are becoming larger and larger while the whisky districts are growing smaller and smaller. We hope and trust and pray that it may soon be entirely eradicated as beverages from this fair land of ours.

We recomend:

First, that every pastor in the Crooked Creek Association make it a part of his obligations to attend Sunday School and take part in the work

Second, noting by experience the handicap over our Sunday School because of the absence of parents, we desire to impress upon the hearts of every father and mother in this Association that their Christian obligation is not fully performed by sending their children to Sunday School but that their duties are performed only when they take their children and their neighbor's children, whose parents are not Christians and do not take any interest in Sunday School work.

Third, that each parent realize that the study of the Sunday School lesson is much more important than day school work and that therefore

True it is that with any highly specialized commercial system there has been a falling off in many cases of the fundamental elements of education, among others the respect for religious ideals. department in Christ's Kingdom.

Second, We recommend that the Moderator be authorized to appoint a superintendent of woman's work who shall have the interest of Christ's cause heavily upon their heart whose duties it shall be to come in touch with every society for women in this Association and make an honest effort to have societies organized in every church.

That the woman's department shall receive credit for all monies paid to pastor's salary, Associational Missions, State Mission, Orphan's Home and every other good movement to which they shall contribute their funds.

That each society recommend a messenger to their church from their society as one of the four delegates of each church to be elected by the church in conference.

That a report be expected from every society and also from their su-

perintendent at the next Association.

Constitution.

We, the Church of Jesus Christ, called the Baptist, being assembled through our delagates at Bellefonte, Boone County, Arkansas on Saturday before the second Sabbath in May. A. D. 1869, agree to form ourselves in an association for the purpose of instruction, edification and promotion of the cause of our Blessed Redeemer.

Article 1. The Association shall be composed of messengers or delegates chosen by the churches of our union, who, on presenting letters cer-

tifying to their appointment, shall be entitled to seats.

Article II. The messengers thus chosen, when convened, shall be known as the "The Crooked Creek Association," who shall be not merely an advisory council, but also for the advancement of the cause and kingdom of our Lord Jesus Christ.

Article III. Each Church in the Association shall be entitled to four delegates, and any church failing to represent herself shall render the reas son to the next Association; failing to do so, she shall be dropped from

the roll of the Association.

Article IV. Letters from the churches shall state the number received by experience, baptism, letters, recomendation or restoration; those dismissed by letter, excommunicated or deceased since the last Association, also the total number of fellowship

Article V. New churcher may be admitted to the Association who petitition by letter, and delegates, adopting or subscribing to our articles of faith, constitution and rules of decorum, the Moderator giving the hand

of fellowship.

Article VI. The Association shall elect a Moderator and Clerk by the

suffrage of the members present.

Article VII. The Association shall have a fund for support which shall be supplied by voluntary contributions of the churches, sent by the hand of their messengers, which shall be at their disposal for Association purposes only

Article VIII. Questions may be sent by churches in their letters or brought in by motion and second, and may, or may not be investigated,

as the Association may determine.

Article IX. The Association shall, in all cases, be governed by a majority of the members, except in the reception of members, which shall be

Article X. The Association shall have power to withdraw her fellowship from any church in her union, who, after due admonition, shall be unsound in her faith and practice.

Article XI. Some of her ministers shall be appointed by the Associ-

ation each session to preach the introductory sermon at the next.

Article XII. She may correspond with any Association which she may determine, while in session.

Article XIII. There shall be a Treasurer appointed by the Association, who shall receive and disburse all funds belonging to her, as she may direct.

Article XIV. The Clerk shall keep a minute of the proceedings, which shall be printed and distributed among the churches according to the contributions.

Article XV. The minutes of the Association shall be read and corrected, if neccessary, and signed by the Moderator and attested by the Clerk, before the Association recess.

Article XVI. Amendments of the Constitution may be made at any

time when two-thirds of the churches may deem it necessary.

Article XVII. The Association shall at each session determine the time and place of the next.

Rules of Decorum.

1. The Moderator shall cause each session to open and close with praver.

2. Ministers present invited to take seats are privileged to speak with

us on all subjects, but vote on none.

3 Those who speak shall rise to their feet and respectfully address the brother Moderator.

4. No motion shall be entertained without a second.

5. If when a motion has been made and seconded, a member oppose its discussion, the Moderator shall put the question. Shall this question be discussed? And if negatived the subject shall be dropped.

6. Motions made and lost shall not be recorded on the minutes unless

ordered at the time.

7. No one shall speak more than three times on any subject without special leave of the Association, and not more than ten minutes.

No member shall absent himself without leave of the moderator,

if so, his name shall be left out of the minutes.

9. The stand shall be supplied with preaching from time to time during the session, only by consent of the Association.

10. The Moderator shall decide by his vote all questions upon which

there is no majority.

11. The Moderator shall state and explain questions before the association, and take the sense of the association in all cases where a vote is taken by ballot.

12. No motion shall be entertained until the one under discussion has been disposed of; except a motion to adjourn, postpone, amend or put the

main question.

- 13. The Moderator shall call to order any member who, while speaking, uses any discourteous language, or departs from the subject under discussion.
- 14. These rules may be amended at any time when the majority of the members may deem it necessary.

Declaration of Faith.

Article I. We believe that the Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction; that it has God for its author, salvation for its end, truth without any mixture of error for its matter; that it reveals the principles by which God will judge us, and therefore is and shall remain to the end of the world the true center of Christian union, and the supreme standard by which all human opinions should be said.

- II. We believe that there is one and only one living and true God, an infinite intelligent spirit, whose name is Jehovah, the Master and Supreme Ruler of Heaven and Earth, inexpressibly glorious in holiness and worthy of all possible honor, confidence and love; that in the unity of the Godhead there are three persons, the Father, the Son and the Holy Ghost equal in every divine perfection, and executing distinct and harmonious offices in the work of the redemption.
- III. We believe that man was created in holiness, under the law of his Maker but by voluntary transgression fell from the holy and happy estate, in consequence of which all mankind now are sinners, not by constraint but by choice, being by nature utterly void of that holiness required by the law of God, positively inclined to evil, and therefore under just condemnation without defense or excuse.
- IV. We believe the salvation of sinners is wholly of grace, through the mediatorial office of the Son of God, who by the appointment of the Father freely took upon himself our nature, yet without sin, honored the divine law by His personal obedience, and by His death made full atonement for our sins; that having risen from the dead, he is now enthroned in Heaven, and uniting in His wonderful person the tender sympathies with Divine perfection, He is in every way qualified to be a suitable, compasionate and all-sufficient Savior.
- V. We believe that the Gospel blessing which Christ secures to such as believe in Him is justification; that justification is the pardon of sinand the promise of eternal life on principles of righteousness that it is bestowed, not in consideration of any work of righteousness which we have done, but solely through faith in the Redeemer's blood, hy virtue of which faith His perfect righteousness is freely imparted to us of God, that it brings us into a stage of most blessed peace and favor with God, and secures every blessing needful for time and eternity.
- VI. We believe that the blessings of salvation are made free to all by the Gospel, and that it is the immediate duty of all to accept them by the cordial, penitent and obedient faith, and nothing prevents the salvation of the greatest sinner on earth but his own determined depravity and voluntary rejection of the Gospel, which rejection involves him in an aggravated condemnation.
- VII. We believe that in order to be saved, sinners must be regenerated or born again; that regeneration consists in giving a holy disposition to the mind, that it is affected in manner above our comprehension by the power of the Holy Spirit in connection with Divine truth, so as to secure our voluntary obedience to the Gospel, and that its proper evidence appears in the holy fruits of repentance and faith and newness of life.
- VIII. We believe that repentance and faith are sacred duties, and also inseparable graces wrought in our souls by the regenerating spirit of God

whereby, being convinced of our guilt, danger and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned, contrition, confession and supplication for mercy at the same time receiving the Lord Jesus Christ as our Prophet, Priest and King, and relying on Him as the only all-sufficient Savior.

- IX. We believe that election is the eternal purpose of God, according to which He graciously regenarates, sanctifies and saves sinners, that being perfectly consistent with the moral agency of man, it comperhends all the means in connection with the end; it is a most glorious display of God's soverign goodness, being infinitely free, wise holy and unchangeable, that it utterly excludes boasting and promotes humility, love, prayer, praise, trust in God, and active imitation of His free mercy, that it encourages the use of means in the highest degree; that it may be ascertained by its effects in all who truly believe in the Gospel; that it is the foundation of Christian assurance, and to ascertain it with regard to ourselves demands and deserves the utmost diligence
- X. We believe that sanctification is the process by which, according to the will of God, we are made partakers of His holiness, and that it is a progressive work, that it is begun in regeneration and that it is carried on in the hearts of believers by the presence and power of the Holy Spirit, the Healer and Comforter, in the continued use of the appointed means—especially the Word of God, self-examination, self-denial, watchfullness and prayer.
- XI. We believe that such only are real believers as endure to the end, and that their persevering attachment to Christ is the grand mark which distinguishes them from the superficial professors, that a special providence watches over their welfare, and they are kept by the power of God through faith unto salvation.
- XII. We believe that the law of God is the eternal and unchangeable rule of His moral government, that it is holy, just and good, and that the inability which the Scriptures ascribe to the fallen man to fulfill its precepts, arises from the love of sin, to deliver them from which; and to restore them through a Mediator to unfeigned odedience to the Holy law, is one great end of the Gospel, and the means of grace, connected with the establishment of the visible church.
- XIII. We believe that a church of Jesus Christ is a congregation of baptised believers associated by covenant in the faith and fellowship of mie Gospel, observing the ordinances of Christ, and exercising the gifts, rights and privileges invested in them by His Word; that its scriptural officers are Bishops, or Pastors, or Deacons, whose qualifications, claims and duties are found in the epistles of Timothy and Titus.
 - XIV. We believe that Christian Baptism is an immersion in water of a believer, into the name of Father, Son and Holy Ghost, administered by a legal administrator to show fourth in a solemn and beautiful emblem, our faith in the crucified buried, and risen Savior, with its effects, in our death to sin and resurrection to a new life; that it is pre-requisite to the

privileges of a church relation and the Lord's Supper, in which the members of the Church, by the sacred use of bread and wine, are to commemorate together the undying love of Christ, preceded always by solemn selfexamination.

XV. We believe that the first day of the week is the Lord's day, or the Christian Sabbath, and is to be kept sacred to religious purposes by abstaining from secular labor and sinful recreations by the, observance of all means of grace, both private and public, and the preparation for the rest that remains for the people of God.

XVI. We believe that the government is of appointment, for the interest and good order of human society, and that magistrates are to be prayed for, conscientiously honored and obeyed, except only in things opposed to the Lord Jesus Christ, who is the only Lord of the conscience and the Prince of the Kings of earth.

XVII. We believe that there is a radical and essential difference between the righteous and wicked; that such only as through faith are justified in the name of the Lord Jesus Christ and sanctified by the Spirit of our God are truly righteous in his esteem; while all such as continue in impenitence and unbelief are in His sight wicked and under the curse, and this distinction holds good among men both in and after death.

XVIII. We believe that the end of the world is approaching; and at the last day Christ will descend from Heaven and raise the dead from their graves for final retribution; that a solemn separation will take place; that the wicked will be adjudged to endless punishment and the righteous to endless joy, and that the judgment will fix forever the final state of man in Heaven or Hell on the principles of righteousness.
