PROCEEDINGS.

The Liberty Baptist Association convened in its fiftyeighth annual session with the Liberty Church at 10:45 a.m., September 26, 1903.

The Moderator, R. A. Faulkner, being absent, the clerk called the Association to order. The brethren engaged in devotional exercises, the clerk reading and commenting on Ps. 133, also Eph. 4:1-16. A. J. Barton led in prayer.

By motion H. T. Hawkins was elected moderator protem.

The annual sermon was preached by W. I. Feazell. Text 2 Cor. 8:23—"The messengers of the churches and the glory of Christ." The preacher showed from the text and context that the early churches co-operated in mission work and made a stong plea for us to imitate their example by uniting our forces for world-wide evangelization. Adjourned for dinner, W. I. Feazell pronouncing the benediction.

AFTERNOON SESSION.

The body assembled at 2:15. Song, "There is a Fountain Filled with Blood." Prayer by C. P. McGraw. J. H. Hughes was appointed to preach in the grove to the "overflow" congregation.

The moderator announced that the association was ready to proceed to permanent organization. By motion of W. I. Feazell, H. T. Hawkins was elected moderator and W. F. Dorris and B. W. Reeves were re-elected clerk and treasurer respectively.

The order of business as appears in the minutes of 1902, was adopted as the order of business for the present session.

Upon a call for petitionary letters, Victoria Church presented her application for membership in our body and was cordially received.

The moderator called for correspondence. J. H. Hughes was enrolled as a corresponding messenger from Everett Association, Louisiana. A. J. Barton, editor of the Baptist Advance, Little Rock, and Frank White, president of Orphans' Home Finding Society, Little Rock, were enrolled as visitors and invited to seats with us.

After a recess of twenty minutes the moderator announced the following committees:

SUNDAY-MORNING SESSION.

The association assembled one hour late. J. H. Hughes led in prayer.

The report on Sunday schools and Colportage was read by F. E. Morgan:

"Your committee finds NINE churches in the association reporting Sunday schools with an enrollment of 616 pupils, not counting officers and teachers. This is exactly 30 per cent of the number of churches represented at this association. If the Sunday school is of divine authority, and we verily believe it is, there is a grave fault somewhere. Is it not possible to locate it? We think so. A consecrated membership

means activity in the Master's cause, and vice versa. It is hardly probable that Sunday schools are ever run for vain glory. It requires too much effort of a sacrificing character to admit of such an idea. A successful Sunday school means consecration and sacrifice which are promptings of the Holy Spirit.

Let us prayerfully consider where this neglect of our churches to organize and maintain Sunday schools lies. If it be a want of consecration to our Master's cause, then let us pray that it may be supplied. If our churches should proceed as above suggested we would arise and go to work.

We recommend co-operation with the Sunday school and Colportage Board of the Arkansas Baptist State convention, to the end that Colportage work be instituted and maintained in our bounds."

Several brethren made earnest talks to the report, which was unanimously adopted.

By motion a collection in cash and pledges was taken for Sunday school and Colportage work as follows:

A. J. Barton, Frank White and C. P. McGraw preached at the time and places mentioned in "report on divine service." The large congregations who heard our beloved brethren were fed with the bread of life, and many are the prayers that shall ascend the "hill of the Lord" for their power and usefulness in our dear Lord's kingdom.

MONDAY-MORNING SESSION.

The association assembled by singing, "What a Friend we have in Jesus." F. E. Morgan led our prayers that God would give us a gracious session of the day.

Minutes of the preceding session read, corrected and approved.

The report on temperance was read by J. D. Crawford.

"Temperance is the ground of the Christian graces as mentioned by the Apostle, when he says 'add temperance to knowledge,' etc. We think temperance should be practiced by the members of all our churches as well as preached by all our ministers, for the reason that intemperance is working so much evil in our country, robbing homes of their loved ones, men of their reason, flooding the world with paupers and criminals and filling hell with drunkards! Perhaps ninetenths of the murders committed in this country are due directly or indirectly to intemperance. With sadness we ask, 'How can we remedy this monster evil?' The answer comes, 'By standing firm against it; using our moral influence to

stamp it out, and then use the ballot box.' No man is worthy the support of moral and christian people who is intemperate, or who is in league with the liquor traffic. We, therefore, recommend that all our members do all in their power to elect such men to county, state and national offices, as are known to be against this nefarious business."

After an earnest discussion the report was unanimously adopted.

The report on obituaries was read by J. P. Crawford.

"It is with regret that we are called upon to report the departure of our beloved brother in the ministry, J. G. McCain, who has been called to his reward since our last meeting. In the death of Bro. McCain we sustain an irreparable loss, but we feel that our loss is his eternal gain. Bro. McCain wrought well and long for the Master's cause, and his labors are ended upon earth and he now enjoys his rich reward which God has promised those who are faithful. He was an able and earnest preacher and a faithful pastor; an exemplary christian. We extend to his bereaved children our deepest sympany."

The report was discussed and unanimously adopted.

The report on orphans' home was read by H. G. P. Williams.

"Brethren, have you ever seriously considered the condition of the helpless orphans, bereft of father, mother and relatives?—left without sympathising friends—neglected and abused—without culture, to grow up in ignorance, and falling victims to all the evils of the world, and surrounded by cesspools of sin and corruption? Such is often the case with orphans.

You have only to compare the above picture with the happy condition of the inmates of our orphans' home at Monticello, founded and presided over by that grand woman, Mrs. Hannah Hyatt Gardner.

We now have 57 of these little parentless children in the home, where they enjoy the motherly care of Sister Gardner, and receive literary and spiritual training to fit them for the battles of life.

This is a work that appeals to the sympathies and substantial aid of all our Baptist people. The donations to this institution have been quite liberal, but the increasing number of its inmates correspondingly increases our obligation to provide for their needs. Everything, so far as we can learn, is carried on in the most economical way possible. No funds needlessly expended. Let us, dear brethren, pray for these precious trusts God has given to us, and give of our means to support this noble work. God will not withhold his blessings if we help the helpless."

After an enthusiastic discussion the report was adopted. By motion a collection was taken in cash and pledges for

the orphans' home as follows:

By motion, the following committee on ministerial relief was appointed: F. E. Morgan, J. T. Hawkins, O. J. Wade.

The committee on state and associational missions made its report as follows:

The history of state mission work in Arkansas has been gratifying. Whatever success has come to the Baptists of Arkansas has depended largely upon the wise conduct of our mission work by those to whom the direction of such work has been committed from year to year.

The report of the State board for last year is exceedingly encouraging. The amount expended in state mission work was \$9,346.68. We note that last year we had the services of 5 general missionaries, 8 associational missionaries and 32 missionary pastors. We note also the following items reported by the board: Conversions, 722; baptisms, 401; received by letter, 379; by restoration, 48; making a total addition to the churches of 828 members.

Though much has been done, there is yet much that must be done. There is scarcely a section in the state where mission work is not needed. But it is especially needed in those new and growing sections into which the unconverted multitudes are pressing. If we, as Baptists, expect to take this state in our Master's name we must do much in these new and rapidly developing sections. We must do this work or others will.

Last year we did nothing in the way of associational mission work. We would urge, with all possible emphasis, that our churches take collections for this work. Your executive board could do nothing last year because of a lack of funds. Let us make all possible effort to enlarge our contributions to state and associational missions. Every dollar spent in this work is an indirect contribution to all phases of our mission work. We must strengthen the stakes at home if we are to succeed in foreign fields. Consecrated men are ready to do the work. Let us contribute our money that they may be able to do it. We suggest that our churches take

collections for this work at the earliest date possible, and that our executive board do all in their power to carry on the work in our own association.

Discussed by several brethren and unanimously adopted.

W. I. Feazell read the report on home and foreign missions.

"Our risen Lord's last command was to preach the gospel to all the world, beginning at Jerusalem. Our Home Board of the Southern Baptist Convention, at Atlanta, Ga., has done, and is still doing, a great work in the southern states, territories and Cuba, and deserves the support of every Baptist. Our Foreign Mission Board at Richmond, Va., has wisely conducted our mission work on the foreign fields. Our work in China, Africa, Japan, Brazil, Italy and Mexico is prospering, and the glorious reports from our missionaries should increase our interest in, and contributions for this work. The fields are white unto harvest; the command of Christ is urgent, and no Baptist or Baptist Church is worthy the name who does not take part in the work.

Believing that our churches are willing to follow the wise leadership of their pastors, we urge them to preach often on missions and take collections for this work."

The report was discussed and unanimously adopted.

Adjourned for dinner. Benediction by B. C. Green.

AFTERNOON SESSION.

The association assembled by singing 'Come Thou Fount.' Prayer by C. P. McGraw.

G. W. Mason read the report on education.

"The Baptists of Arkansas have just right for feeling proud of our schools and of their liberal support. The Ouachita-Central correlated system of colleges and academies has enrolled over one thousand students last year and each school has opened the present session with the most flattering prospects in their history. President J. W. Conger has, by his untiring energy and enthusiasm, made Ouachita College not only the leading college of the state but one of the leading colleges of the south. From this college has gone out to all parts of our country strong men and women whose lives are advancing every cause of the Master.

Central College has met a demand for female education and by devotion and energy of President W. W. Rivers has already taken its place among the best female institutions of our country. Here our daughters receive such training as will fit them properly for life. Already many strong and useful women have gone from this institution and its prospects of usefulness are now the brightest in its history.

The various Baptist academies of our state are doing much good in the cause of christian education. We recommend that a committee of five be appointed to see to locating a Baptist academy in this association. That the duty of this committee shall be to receive bids, take subscriptions and in general to look after locating, building and equipping such academy. That this committee have full power to act in the premises as its judgment may approve.

We heartily recommend these institutions as entirely worthy of our support and believe that all Baptists in this association will do their part in giving their support, influence and prayers to make these christian schools the best in the nation."

After the discussion and adoption of the above report, the following committee was appointed as provided in report: G. W. Mason, O. J. Wade, B. W. Reeves, A. F. Riley, W. F. Dorris and H. T. Hawkins was added.

C. P. McGraw read the report on publications.

"We would unhesitatingly recommend the diligent study

of God's word. Jesus said: 'Search the scriptures, for in them ye think ye have eternal life and they are they that testify of me.' Paul said: 'All scripture is given by inspiration of God and is profitable for doctrine, for reproof, for correction, for instruction in righteousness, that the man of God may be perfect, thoroughly furnished unto all good works.' As a means of spiritual culture we cannot afford to neglect the reading of christian literature, and as Baptists we should keep posted in all matters touching our denominational affairs. We would, therefore, recommend the Southern Baptist Convention series of Sunday school literature.

We furthermore recommend that our people subscribe for and read the *Foreign Mission Journal*, published at Richmond, Va., which tells of our operations as a denomination in foreign fields. We also recommend the *Home Field*, published at Atlanta, Ga., which deals with our operations in the home field, and lastly, we would recommend that our people subscribe for and read our denominational papers."

F. E. Morgan read the report on ministerial relief.

"Your committee would recommend that our pastors take collections in their churches, and all other places they may see proper, for funds to be known as "funds for the relief of aged and infirm ministers," which are to be turned into our treasury, and to be paid out on the order of the executive committee. We recommend that these collections be made at as early a date as possible.

We further recommend that preachers in this association receive the first consideration."

The business of the association being transacted, the moderator made an appropriate address, thanking the brethren for their help in making this so harmonious a session.

The association then adjourned to meet with the El Dorado Church, Saturday before the fourth Sunday in 1904, at 10 a.m. "God be with you," and "Sweet bye and bye," were sung, and the brethren bid each other good bye until we meet again.



CONSTITUTION.

ARTICLE 1. This association shall be composed of members, who, upon producing their credentials, shall be entitled to seats.

ART. 2. The members thus chosen and convened shall be known by the name of the Liberty Baptist Association, which shall usurp no authority over the churches in our union, nor infringe any of their internal rights, but shall merely be considered as an advisory council in all matters relative to their internal concerns. Nevertheless, it becomes necessary in come cases to have a uniform rule of proceedure, namely, if one church commit an offense against another, it shall be the duty of the offended to labor with the offender for satisfaction. If she fail of success, she shall call the aid of two or more churches in our union to assist in laboring for satisfaction; and if final satisfaction, in the opinion of the help thus called, be not obtained, the aggrieved may bring the case before the association, which shall be taken up and decided upon according to its merits. If a serious difference should arise in an individual church, which, upon due labor, cannot be reconciled, she shall call the aid of two or more sister churches to assist in the work, and if a reconciliation be not effected, the help so called, or the church may bring the case before the association, to be acted upon according to its merits; but the association will take cognizance of no such case of the above kind, unless a due course of proceedure shall have been previously pursued according to the economy of the church discipline, found in the 18th chapter of the Gospel by St. Matthew, and other parts of the Scripture which define the nature of offenses and the manner of bringing offenders to trial.

ART. 3. The churches in our union shall transmit to every annual session of the association a written communication, specifying the names of the messengers, their number in fellowship, baptized, received by letter, dismissed, excommunicated, restored and deceased since the last session, which shall be read and minuted accordingly.

ART. 4. Every church in our union shall be entitled to representatives in the following manner, viz: Each church shall be entitled to three messengers for the first fifty members or under, and one for every fifty over. Any church failing to represent herself as above described, shall state her

reasons at the next session.

ART. 5. New churches may be admitted into our union

by messengers bearing petitionary letters. If, upon due examination, they be found orderly and orthodox, the moderator shall manifest their admission by giving their messengers the right hand in token of Christian fellowship.

ART. 6. The association, when convened, shall be governed by a regular, proper decorum, which she is author-

ized to form, and amend, according to her own views.

ART. 7. At every session of the association, a moderator shall be appointed by and from among the messengers present, whose duty it shall be to see that the rules are strictly observed, and to take the voice of the association on all subjects legally introduced. A clerk shall also be appointed, whose duty it shall be to take proper and correct minutes of the proceedings, and record the same in a well bound book kept for that purpose.

ART. 8. The association shall have the power to withdraw from the union of any church that may violate the constitution, or depart from the orthodox principles of the Gospel.

ART. 9. The association shall furnish the churches with

the minutes of every session.

ART. 10. Every query sent by a particular church must be included in her letter, certifying that that she endeavored to reconcile it, but failed. In such cases the association shall take it under consideration, and the voice of the majority shall be considered as an advisory answer, which shall be entered on the minutes.

ART. 11. Queries which immediately concern the general union of the churches, sent by a particular church, or introduced by a proper motion, shall be taken up and decided

as soon as practicable.

ART. 12. The association shall have a fund supplied by the voluntary contribution of the churches, and all money thus contributed shall be transmitted for the churches by their messengers and handed over to the committee on finance. The committee shall be appointed annually, whose duty it shall be to receive in charge the association fund, and dispose of same agreeable to order; and make at every session a fair and substantial report of its proceedings.

ART. 13. It shall be the duty of the clerk of the association to keep a regular file of the minutes of every session of

this body.

ART. 14. The association shall not adjourn until it shall have finished all the business on hand, except in extraordinary cases.

ART. 15. The minutes of the association shall be read

and corrected, if necessary, and signed by the moderator and clerk before the session closes.

ART. 16. In all cases the association shall be governed

by a majority, only when conflicting with the constitution.

ART. 17. Amendments to the constitution may be made by submitting the same at one session of the association, which stand over until the session following, and then be voted upon, requiring two-thirds of the members present voting in the affirmative to affect a change.

ARTICLES OF FAITH.

ARTICLE 1. We believe in one true and living God, the

Father, the Word and the Holy Ghost.

ART. 2. We believe that the Scriptures, composing the Old and New Testaments, are the Word of God, and the only

rule of faith and practice.

- ART. 3. We believe in the doctrine of election as founded in the foreknowledge of God, through sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ.
- ART. 4. We believe in the doctrine of original sin by the fall of Adam.
- ART. 5. We believe in man's incapacity, by his own free will and ability, to recover himself from the fallen state by which he is by nature.

ART. 6. We believe that sinners are justified, in the

sight of God, by the imputed righteousness of Christ only.

ART. 7. We believe that saints shall be preserved in

grace, and never fall finally away.

ART. 8. We believe that baptism and the Lord's supper are ordinances of Jesus Christ, and that true believers are the only subjects of baptism, and that immersion is the Apostolic mode.

ART, 9. We believe in the resurrection of the dead and in the general judgment; and that the felicity of the right-

eous and the punishment of the wicked will be eternal.

ART. 10. We believe that no minister has any right to administer the ordinances of the Gospel but one who is regularly baptized, called and comes under the imposition of the hands of a presbytery.

ART. 11. We believe that none but regular baptized

members have a right to commune at the Lord's table.

ART. 12. We believe that the Lord's day should be observed as a day of rest and religious devotion.

RULES OF DECORUM.

ARTICLE 1. No member shall be interrupted while speaking, unless he depart from the subject, or use words of personal reflection. Every motion made and seconded shall come under the consideration of the association, unless withdrawn by him that made it.

ART. 2. Every case taken up by the association shall be

decided on, or withdrawn, before another shall be offered.

ART. 3. When a question is taken up, after allowing time for debate, the moderator shall take the voice of the association on the subject, and the members of the affirmative side of the question shall signify the same by rising from their seats or otherwise, and those on the negative side shall retain their seats.

ART. 4. The moderator shall announce the decision of

the association.

ART. 5. Any member wishing to retire shall obtain per-

mission of the moderator.

ART. 6. No member shall speak more than once on the same proposition, without permission from the association, nor more than once until every member wishing to speak shall have spoken; nor shall any proposition be made to close the subject until the debates have been carried through.

ART. 7. The appellation of "Brother" shall be used in the association by members in their addresses to one another.

ART. 8. The names of the members shall be called as often as the association may direct.

ART. 9. No member shall be tolerated in any practice

which tends to interrupt public speaking.

ART. 10. The moderator shall be entitled to the same privilege of speaking as any other member, provided he appoints another to his seat during the time, but shall not vote on any question unless the association be equally divided.

ART. 11. Any member violating these rules, shall be reproved by the moderator at discretion, but only on the day

the breach shall have been made.
