ORPHANS HOME -Your Committee on Orphans Home would make the following report: The Home was founded in 1894 by the Arkansas Baptist State Convention and located at Monticello, Arkansas. We began the work with 2 children in a building of 6 rooms. Our family has had a marvelous growth in 18 years, has had more than 300 children. There are now 151 children in the home, six from the bounds of this Association. Brethren our building is full, we have nine beds in some of our rooms. We are receiving applications every week for children to be taken in the home. What must we do? We must enlarge. We must have more room but we cannot do it without your help. We come and appeal to you in this our time of need. Will you fail? God forbid. Our plan is to build a boy's dormitory with 25 rooms. The building and furnishing will cost \$5,000.00 Will ou give the Home a good offering tonight? Brethren when you go home will you lay this work before your Churches and take collections before the next Association. We have a paper, "The Orphan's Gem," published by the children-it is a monthly and costs 25 cents a year It will bring you news from the children and tell you of their needs. All our children that are old enough are members of the Church, and are active Christian workers. May God help us to do our duty to the motherless and fatherless ones Submitted, W. W. GARDNER,

SUNDAY SCHOOLS-"We, your Committee on Sunday Schools, beg to submit the following: Believing the Sunday school to be the principal factor of the Church-that is the source from which we obtain the largest number of converts, we should foster it as a farmer would the richest spot on the farm, or the banker would the very best investment he carries, or the merchant the department from which he gets his greatest profits. We believe that the law of nature (the more exercise, the more strength) proves true with the Sunday school as well as with the human muscles. Therefore we advocate giving the Sunday school plenty of work to do. Believing that a matter of record is an important fector, we urge that every teacher in every school keep as clear a record of each scholar as the day school teacher. We believe that the teachers who are in charge, should consider their presence of as much importance as though they were paid teachers. We believe that a number of the pastors of this Association are neglecting their privileges and duties in the Sunday school, thereby losing the joy of witnessing the conversion of souls that are being lost daily, that may be gained for Christ if appealed to before leaving the Sunday school. We believe that none but Christians should be considered eligible to serve as teachers and officers in the Sunday school As the Sunday school, as well as the Orphans' Home, is principally made up of children, we urge that each Sunday school be instructed to make an offering on the first Sunday of each quarter for the Orphans' Home. We advocate that a man who has the interest of children and Sunday schools at

heart be appointed to represent the Sunday schools throughout the Association, whose duties shall be to visit as many Sunday schools as possible, and organize Sunday schools wherever possible; and report to the coming Association. We believe it is the duty of parents to support the Sunday school as much as possible. Therefore, we urge every parent—not to send, but to bring their children to Sunday school. From experience we have noticed that the active members of the church are to be found in the Sunday school, for 'by their fruits ye shall know them.'

This one was from the Harrison church, which shows that the ladies of said church have done a noble work. They have contributed to the various objects of our work the amount of \$92.60 during this associational year. We consider that the Woman's Work is of great importance, because through the organization of the ladies societies and Woman's Missionary Union opportunities are offered to enlist and develop into usefulness of every female member of our churches. Therefore, we recommend that our pastors emphasise in their respective churches the

need of woman's co-operative work and urge the organization of a woman's society in their churches. Signed by the Committee.

CHRISTIAN EDUCATION.-We your Committee on Christian Education beg to ubmit the following: Whereas, Christian influence is always conductive to the upbuilding of any people and the advancement of God's kingdom in any place, therefore we urge that this body of messengers use their influence, first in their respective districts in advancing the idea of emplo ing Christian teachers where it is practical. Furthermore do we recommend that our schools and colleges in different parts of the state be upheld by our financial support, and that we give them our patronage as far as practical. We desire to impress the fact, that in order to keep up with the times, and promote the cause of our Creator, we must educate our people in His teachings. Christian education is just as important as State Missions or any other general interest of the kingdom, and must be put on the same basis. We therefore recommend that each pastor in the Association preach at least once a year on Christian education and our duty to support Baptist schools. 2nd. That regular collections be taken in every church every year for Christian Education. 3rd. That we patronize our great Baptist college at Quachita for boys and girls, and Central college at Conway for girls for the education of our young people. 4th That earnest and increasing prayer be made for this work.

* CHURCH COVENANT.

Having be n led, as we believe, by the Spirit of God. to receive the Lord Jesus Christ as our Savior, and on the profession of our Faith, having been baptized in the name of the Father, and of the Son, and of the Holy Ghost, we do now in the presence of God, angels and this assembly, most solemnly and joyfully enter into covenant with one another, as one body in Christ. We engage, therefore, by the aid of the Holy Spirit, to walk together in Christian love, to strive for the advancement of this Church; in knowledge, holiness, and comfort; to promote its prosperity and spirituality, to sustain its worship, ordinances, discipline, and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the Church, the relief of the poor, and the spread of the Gospel through all nations. We also engage to maintain family and secret devotion, to religiously educate our children, to seek the salvation of our kindred and acquaintances, to walk circumspectly in the world, to be just in our dealings, faithful in our engagements, and exemplary in our deportment; to avoid all tattling, backbiting and exercise of anger; to abstain from the sale and use of intoxicating drinks as a beverage, and to be zealous in our efforts to advance the Kingdom of our Savior. We further engage to watch over one another in brotherly love, to remember each other in praver, to aid each other in sickness and distress, to cultivate sympathy in feeling and courtesy in speech, to be slow to take offense, but always ready for reconciliation, and mindful of the rules of our Savior to secure it without delay. We moreover engage that if we remove from this place we will, as soon as possible, unite with some other church, where we can carry out the spirit of this covenant and the principles of God's

We, the Church of Jesus Christ, called the Baptists, being assembled, through our messengers at Bellefonte, Boone County, Arkansas, on Saturday before the second Sabbath in May, A. D., 1869, agree to form ourselves in an Association for the purpose of instruction, edification, and promotion of the cause of our Blessed Redeemer.

Article I. The Association shall be composed of messengers, chosen by the churches in our union, who, on presenting letters certifying to their

appointment, shall be entitled to seats

Article II. The messengers thus chosen; when convened, shall be known as the "Crooked Creek Association," who shall be not merely an advisory council, but also for the advancement of the cause and kingdom of our Lord lesus Christ.

Article III. Each church in the Association shall be entitled to four messengers, and any church failing to represent herself shall render the reason to the next Association; failing to do so, she shall be dropped from

the roll of the Association.

Article IV. Letters from the churches shall state the number received by experience, baptism, letters, recommendation or restoration, those dismissed by letter, excommunicated, or deceased since the last Association, also the total number of fellowship

Article V. New churches may be admitted into the Association who petition by letter and messengers, adopting or subscribing to our articles of faith, constitution and rules of decorum, the Moderater giving the hand

of fellowship.

Article VI. The Association shall elect a Moderator and Clerk by the

suffrage of the members present.

Article VII. The Association shall have a fund for support which shall be supplied by voluntary contributions of the churches, sent by the hand of their messengers, which shall be at the disposal for Association purposes

Article VIII. Questions may be sent by churches in their letters, or brought in by motion and second, and may, or may not be investigated,

as the Association may determine.

a from the sale and it a Article IX The Association shall, in all cases, be governed by a majority of the members, except in the reception of members which shall be unanimous.

Article X. The Association shall have power to withdraw her fellowship from any church in her union, who, after due admonition, shall be unsound in her faith and practice.

Article XI. Some of her ministers shall be appointed by the Associ-

ation each session to preach the introductory sermon at the next.

Article XII. She may correspond with any Association which she

may determine; while in session.

Article XIII. There shall be a Treasurer appointed by the Association, who shall recive and disburse all funds belonging to her, as she may

Article XIV. The Clerk shall keep a minute of the proceedings, which shall be printed and distributed among the churches according to contributions.

Article XV. The minutes of the Association shall be read and correct-

ed, if necessary, and signed by the Moderator and attested by the Clerk, before the Association recess.

Article XVI. Amendments of the Constition may be made at any time

when two-thirds of the churches may deem it necessary.

Article XVII. The Association shall at each session determine the time and the place of the next.

RULES OF DECORUM.

1. The Moderator shall cause each session to open and close with prayer.

Ministers present invited to seats are privileged to speak on all

subjects, but vote on none.

- 3. Those who speak shall rise to their feet and respectfully address the brother Moderator.
 - No motion shall be entertained without a second.
- 5. If, when a motion has been made and seconded, a member oppose its discussion, the Moderator shall put the question, "Should this question be discussed?" and if negatived the question shall be dropped.

Motions made and lost shall not be recorded on the minutes unless

ordered at the time.

7. No one shall speak more than three times on any one subject, without special leave of the Association.

No member shall absent himself without leave of the Moderator,

if so his name shall be left off the minutes.

9. The stand shall be supplied with preaching from time to time during the session, only by consent of the Association.

10. The Moderator shall decide by his vote all questions upon which

there is no majority.

11. The Moderator shall state and explain questions before the Association and take the sense of the Association in all cases where a vote is taken, except by ballot.

en. except by ballot. 12. No motion shall be entertained until the one under discussion has been disposed of, except by a motion to adjourn, postpone, amend or put

the main question.

13 The Moderator shall call to order any member who, while speaking uses any discourteous language, or departs from subject under discussion.

14. These rules may be amended at any time when a majority of members deem it necessary.

DECLARATION OF FAITH.

Article 1. We believe that the Bible was written by men divinely inspired, and is a perfect treasure of Heavenly instruction; that it has God for its author, salvation for its end, and truth without any mixture of error for its matter; so that it reveals the principles by which God will judge us and therefore is and shall remain, unto the end of the world, the true center of Christian union, and the supreme standard by which all human conduct and opinions shall be tried.

Art. 2. We believe there is one, and only one, living and true God, an infinite intelligent Spirit, whose name is Jehovah, the maker and supreme ruler of Heaven and Earth, inexpressibly glorious in holiness, and worthy of all possible honor confidence and love; that in the unity of the Godhead there are three persons, the Father, the Son and the Holy Ghost, equal in every divine perfection, and executing distinct and harmonious offices in the great work of the redemption

- Art. 3. We believe man was created in holiness, under the law of his Maker, but by voluntary transgression fell from that holy and happy state, all mankind are now sinners, not by constraint but choice; being by nature utterly void of that holiness required by the law of God, positively inclined to evil, and therefore under just condemnation to eternal ruin, without defense or excuse.
- Art. 4 We believe the salvation of sinners is wholly of grace, through the mediatorial office of the Son of God, who by the appointment of the Father freely took upon himself our nature, yet without sin, honored the divine law by his personal obedience, and by his death made a full atonement for our sins; that being risen from the dead, He is now enthroned in Heaven, and uniting in His wonderful person the tenderest sympathies with divine perfection, He is in every way qualified to be a suitable compassionate and all-sufficient Savior.
- Art. 5. We believe that the great Gospel blessing which Christ secures to such as believe in Him is justification, that justification includes the pardon of sin. and the promise of Eternal Life on principles of righteousness; that is bestowed, not in consideration of any work of righteousness which we have done, but solely through faith in the Redeemer's blood, by virtue of which Faith, His perfect righteousness is freely imputed to us of God that it brings us into a state of most blessed peace and favor with God, and secures every blessing needful for time and eternity.
- Art. 6. We believe that the blessings of salvation are made free to all by the Gospels; that it is the immediate duty of all to accept them by a cordial, penitent and obedient faith, and nothing prevents the salvation of the greatest sinner on earth but his own determined depravity and volundary rejection of the Gospel, which rejection involves him in an aggravated condemnation.
- Art. 7. We believe that in order to be saved, sinners must be regenerated or born again; that the regeneration consists in giving a holy disposition to the mind, and is affected in a manner above our comprehension by the power of the Holy Spirit in connection with divine truth, so as to secure our voluntary obedience to the gospel, and that its proper evidence appears in the holy fruit of repentance, faith and newness of life.
- Art. 8 We believe that repentance and faith are sacred duties, and also inseparable graces wrought in our souls by the regenerating spirits of God, whereby being deeply convinced of our guilt. danger and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession and supplication for mercy; at the same time heartily receiving the Lord Jesus Christ as our Prophet, Priest and King, and relying on him as the all-sufficient Savior.
- Art. 9 We believe that election is the eternal purpose of God, according to which he graciously regenerates, sanctifies and saves sinners; that being perfectly consistent with the moral agency of man, it comprehends

all the means in connection with the end; that it is a most glorious displan of God's sovereign goodness, being infinitely free, wise, holy and unchangeable; that it utterly excludes boasting and promotes humility, love, prayer, praise, trust in God and active imitation of his free mercy; that it encourages the use of means in the highest degree, that it may be ascertained by its effect on all who truly believe in the gospel, that it is the foundation of Christian assurance, and that to ascertain it with regard to ourselves demands and deserves the utmost diligence.

Art. 10. We believe that sanctification is the process by which, according to the will of God, we are made partakers of His holiness; that it is a progressive work, that it is begun in regeneration and that it is carried on in the hearts of believers by the presence and power of the Holy Spirit, the healer and comforter in the continued use of the appointed means—especially the word of God, self examination, self-denial, watch-
