Glades church which was adopted.

The committee on nominations made its report,

At 11:00 o'clock Bro. George Young preached upon the subject of "Death and the Resurection." Text, 1 Cor.

An invitation was extended to the unsaved; one came forward.

A resolution was offered by Mrs. J. A. Phillips which was adopted.

The treasurer made his report which was adopted. By motion the Association re-elected J. G. McLane, Frank Meredith and J. F. Pitts, as members of the Associational board for the ensuing year.

A call for the next session of the Association was made. Buckville was chosen as the next meeting place.

The Association voted to have 350 copies of the minutes printed and after paying for same the clerk might retain any money that might be left to the credit of minute fund for his service; a collection of \$15.00 was taken to supplement this amount.

The minutes were read and adopted.

Report of Committee on Christian Education:

Every good Baptist in Arkansas rejoices over the properity of our educational institutions.

Ouachita College, at Arkadelphia, has property values in buildings, grounds, and equipment worth about \$250,000.00. The endowment is about \$112,000.00. New buildings to cost about \$250,000.00 are now in course of construction.

In Central College, at Conway, we have property worth about \$125,000.\$\$ and new buildings to cost about \$100,000.00 are to be constructed right away.

In Mountain Home College, at Mountain Home, our junior college, we have property valued at \$60,000.00 or more.

The property values of our academies at Maynard, Blue Eye and Hagarville average about \$12,000.00 for each school.

A Baptist college is to be built at Jonesboro soon and Baptist academies will hold their first sessions this fall in Montgomery and Union counties.

Let us pray for our schools and support them.

#### CONSTITUTION.

Article I. This union of churches of God shall be known as the Buckyille Missionary Baptist Association.

Art. II. The Association shall be composed of messengers from the churches in this union. Each church with less than 50 members be entitled to three messengers, and each church with over 50 members be allowed one additional messenger for each 50 members of fraction thereof. When any church has not its muota of messengers any member in good standing may be seated as a messenger.

Art. III. Messengers, when convened, may organize them-selves into a deliberative body, by the appointment of Moderator and Clerk, who shall be chosen by ballot at each annual session,

and shall continue in office until their successors are elected.

Art. IV. The Association shall not interfere with the rights

of the churches of which it is composed.

It shall regard them as independent bodies in all matters of internal government, and shall act only as an advisory council, assuming no authority except what is implied by the very nature of the compact.

It nevertheless claims authority over its own members, the messengers from the churches, and in justice and propriety must retain the right to withdraw from all churches which may depart from the faith of this compact by becoming heterodox in faith or disorderly in practice.

It should, therefore, regard all churches united under this Constitution with vigilant eye, as its principal object shall be to promote the truth of the Gospel and advance the kingdom of God in our bounds and to all the ends of the earth.

Art. V. Newly constituted churches, or churches having letters of dismission from other Associations of like faith and order may be admitted to membership in this Association at any regular annual session of the body, provided they send messengers

with a petitionary letter.

Art. VI. The churches of this Association shall transmit to each annual session a written or printed communication, signed by the Moderator and Clerk of the church, specifying the names of their messengers and the statistics of the church, showing the progress of the church since the last session of this body, which shall be read and filed with the Clerk of this body accordingly.

Art. VII. He shall present annually to the Association for insertion in the minutes, a clear statement of all receipts.

Art. VIII. This Association shall furnish the churches with printed copies of the minutes of each session.

Art. IX. This Association shall take cognizance of no query sent up from the churches, unless it appears that the churches sending them have used due diligence to solve them first; and shall not undertake to settle individual differences between the members of the churches, unless it appears that the individuals or the churches to which they belong, have taken, or caused to have taken, Gospel steps for the adjustment of the trouble.

Art. X. This Constitution may be altered or amended at any

regular meeting of this Association, by a vote of two-thirds of the members present, provided, further, that Article IV of this Constitution shall not be altered or amended.

#### ARTICLES OF FAITH.

Article I. We believe in one only true and living God, the Father, Son, and Holy Spirit.

We believe the Scriptures of the Old and New Tes-

tament is our only rule of faith and practice.

Art. III. We believe in the doctrine of election as founded in the foreknowledge of God, through the sanctification of the soul unto obedience and sprinkling of the blood of Jesus Christ.

Art. IV. We believe in original sin by the fall of Adam. Art. V. We believe in man's incapacity, by his own free will and ability, to rescue himself from the fallen state in which he is by nature.

Art. VI. We believe the saints are justified in the sight of

God by the imputed righteousness of Christ only.

We believe the saints will be preserved in grace

and never fall finally away.

Art, VIII. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ; that believers are the only proper subjects of baptism, and that immersion is the apostolic mode.

Art. IX. We believe in the resurrection of the dead, and

general judgment, and that the reward of the righteous and

punishment of the wicked will be eternal.

Art. X. We believe that no minister has a right to administer the ordinances of the Gospel but one who has been regularly immersed, and that is called and comes under the hands of a scriptural presbytery.
