CONSTITUTION

(As Amended at 1933, 1943, 1948, 1950, 1951, 1953, 1954,
1956 and 1957 Sessions)

ARTICLE I—NAME

The name of this body shall be the Pulaski County Baptist Association, Incorporated.

ARTICLE II—PURPOSE

The purpose of this Association shall be to awaken and stimulate among the churches of the Association, the greatest possible activity in Evangelism, Christian Education, Missions and Benevolences, throughout the bounds of the Association; to cultivate closer co-operation among the churches and to promote concert of action in advancing all the interest of the Kingdom of God.

ARTICLE III—MEMBERSHIP

Section 1. This Association shall be composed of Messengers from regular co-operating churches, which are in sympathy with the principles and purposes of this Constitution and desire to co-operate with this Association, who shall be entitled to seats upon presentation of letters from their churches or other satisfactory evidence of their appointment.

Section 2. Each church shall be entitled to a minimum of three messengers. One additional messenger shall be allowed for every 50 resident church members above 100. No church, however, may have more than 10 messengers.

Section 3. Messengers from churches desiring to affiliate with this Association shall present to the Association in Annual Meeting, Petitionary Letters or evidence, setting forth the Articles of Faith on which the church was organized, together with satisfactory evidence of the regularity of their organization. They shall be received into the Association by receiving two-thirds of the votes cast.

ARTICLE IV—AUTHORITY

This Association shall never exercise any authority, legislative or ecclesiastical, over any church. Nor shall it in any way interfere with the rights and absolute independence of any church.

ARTICLE V—OFFICERS

Section 1. The officers of this Association shall be Moderator, Vice-Moderator, Clerk, and Treasurer, who shall be elected the first session of the second day and who shall take office the closing

session of the last day of the annual Associational meeting. Said officers to be elected by a majority vote cast at such meeting. The Moderator shall not be eligible to serve more than two successive terms. The Clerk and the Treasurer may be the same person.

Section 2. The Moderator shall preside at all sessions of the Association; or request the Vice-Moderator to preside. The Vice-Moderator will also preside in the absence of the Moderator. The Moderator shall exercise the same privilege of discussion as any other member of the body.

Section 3. The Clerk shall keep a correct record of the Proceedings of the Association in annual meeting, the Executive Board in regular or called meetings, and the Missions Committee in regular or called meetings. He shall be responsible for the printing and distribution of the proceedings of the annual meeting; the taking and preserving of the minutes of all Executive Board and Missions Committee meetings as the Association may direct.

Section 4. The Treasurer shall receive all funds of every kind entrusted to him and shall disburse the same upon the order of the Executive Board and shall make an itemized statement of receipts and disbursements monthly to the Executive Board and an annual statement to the Association in annual session. The Treasurer shall be bonded by the Association, at the Association's expense. An annual audit shall be made of his books by a reputable accountant. This fee shall be paid by the Association.

ARTICLE VI—EXECUTIVE BOARD

Section 1. The Executive Board of the Association shall be composed of one lay member, elected by each co-operating church, together with the pastor of each co-operating church and the officers of the Association. FIFTEEN members of said Board shall constitute a quorum.

Section 2. The Executive Board shall meet one time each month in regular meeting, time and place to be determined by the Board. In case of special meetings written notice must be given to each Board member. The Moderator and Clerk of the Association shall be the officers of the Executive Board.

Section 3. The Executive Board shall receive reports, in the monthly meetings, from the following:

Treasurer's Report.

Associational Missionary.

Superintendent of Associational Sunday School.

Director of Associational Training Union.

Chairman of Evangelism.

President of the Associational Brotherhood.
Superintendent of the Associational W.M.U.
Director of Associational Music Program.
Director of Student Union Work in the Association.
Library Committee.
Recommendations of the Missions Committee.

Section 4. The Executive Board shall be constituted and empowered by the Association as its legal agent to administer all business committed to it by the Association and to employ such paid agents as it may deem necessary in carrying on the Missionary, Education, Benevolent and Financial work of the Association.

Section 5. The Executive Board shall render to the Association in Annual meeting a summary statement of all the business for the year. Same to be printed in the minutes.

ARTICLE VII—STANDING COMMITTEES

I. Missions Committee

Section 1. The Association in Annual meeting, through the Nominating Committee, shall elect a standing committee known as the Missions Committee. This committee shall be composed of twelve members. Members of the Missions Committee shall serve for a term of three years. Each year four members shall complete their terms and shall not be eligible for re-election for a period of at least one year.

Section 2. The Officers of the Association and the elected Associational Organization leaders, shall be ex-officio members of the Committee with all rights of discussion and voting.

Section 3. The Missions Committee shall have the responsibility of selecting and nominating the Associational Missionary or any other paid agents of the Association, and to recommend their employment to the Executive Board in regular meetings, or properly called special meetings.

Section 4. The duties of the Missions Committee shall be as follows:

- (1.) To serve as a nominating committee for any paid officer or worker of the Association. These nominations are to be brought to the Executive Board.
- (2.) To plan a program of mission work for the Association. This is to be an active and aggressive program of planning. This committee should present a challenging and progressive program of work.

- (3.) To see that the plans for Associational work are promoted effectively.
- (4.) To plan a program of benevolences. This should be a well thought out program including all such needs. Plans for promoting the activities should be initiated by this committee.
- (5.) To plan a comprehensive program with regard to Christian Education. This committee should ascertain the needed projects, set the emphases, and actively promote the work.
- (6.) To correlate the activities and projects of the Association with the adopted cooperative program. This committee should actively work toward the end of keeping all of our Baptist program under direct supervision in co-operation with the cooperative program plan. These projects should be clearly thought through and planned in connection with the budget committee each year.
- (7.) To work toward the establishment of new units of mission work in the Association. To facilitate this phase of the work the Chairman of the Missions Committee shall appoint a special committee of three from the membership of the Missions Committee. This shall be known as the Missions and Survey Committee. The duties of the committee shall be:
 - (a) To survey the entire Association to determine the areas where new churches or missions should be established, and to locate property in such areas suitable for building sites.
 - (b) To recommend to the Missions Committee expenditures from the Missions Expansion Fund toward securing such property. The Mission Committee will then study their findings and recommendations and bring to the Executive Board for final action those projects they endorse.
 - (c) To solicit the assistance of sponsoring churches in establishing work in areas which have been approved by the Executive Board.
 - (d) To assist and advise all groups desiring to establish Baptist Churches and Missions in the territorial limits of Pulaski County to the end that all such works may secure the most desirable and strategic locations to serve the people of this association.
 - (e) To survey the areas to be served by each proposed new work and recommend to the Missions Committee the nature and extent of any assistance that the Association should provide in each case. The Missions Committee would in turn study their recommendation and

submit to the Executive Board a final recommendation in each instance.

- (f) To recommend to the Missions Committee all salary supplements to pastor's of missions and needy churches. Commitments for supplements shall be made for periods not to exceed one year. They may be renewed by recommendation of the Committee in deserving cases.
- (8.) This Committee shall never exercise any authority over the churches. Its sole function shall be that of advising the local congregation, desiring to establish a new work, in the matter of securing the most strategic location and assist them in securing the sponsorship of a mother church, if desirable. Any group desiring associational assistance in securing property and for pastor's salary supplements would be expected to counsel with this committee in locating their work. If a church forms spontaneously or a local church establishes a new mission without counselling with the Missions and Survey Committee, no attempt will be made to tell them they cannot do so. The Association must then decide whether or not to welcome the new church into the fellowship.
- (9.) The Missions Committee should correlate the activity of the Associational organizations. Plans should be made together so as to avoid conflicts.
- (10.) The Chairman of the Missions Committee will appoint committees within the committee when such are needed to carry out the duties of the Missions Committee with regard to the above items.

II. Committee on Order of Business

- 1. The Committee on Order of Business shall consist of the Moderator and Clerk of the Association, Host Pastor, Associational Missionary and the elected leaders of the Associational Organizations.
- 2. This committee shall be charged with making the Annual meetings as spiritual, inspirational and informational, as is possible to do so. Preaching shall have a prominent place in the meetings.
- 3. This committee shall publish a tentative order of business for distribution at the first session of the Annual meeting.

III. Nominating Committee

- 1. This committee shall be composed of five members elected by the messengers during the first day's session of the annual Associational meeting. This committee shall be elected as follows:

- a. The chairman of the Executive Board of the Association shall appoint a committee of five executive board members to serve as a special nominating committee to nominate members of the Standing Nominating Committee.
 - b. This duly appointed special nominating committee will present nominations for the five members of the standing nominating committee during the first day's session of the annual Associational meeting.
 - c. The right of nominations from the floor shall not be abridged.
2. The duties of the Standing Nominating Committee shall be as follows:
 - a. They shall name the standing committees of the Association, except those otherwise provided for in this Constitution, and they shall nominate the membership of such committees which shall report at the Annual meeting.
 - b. They shall nominate the leaders of the Associational Organizations.
 - c. They shall nominate the members of the Missions Committee as provided in Article VII, Section 1, paragraph 1.
 - d. This committee shall make any necessary nominations to fill vacancies which occur during the year in these committees or offices. These nominations shall be submitted to the Executive Board in regular or called meetings.

ARTICLE VIII—MEETINGS

Section 1. The Association shall meet annually on a date designated at each Annual meeting. If no date is set, the Executive Board will designate one.

ARTICLE IX—ASSOCIATIONAL ORGANIZATIONS

Section 1. The Associational Organizations shall be: Sunday School, Training Union, Woman's Missionary Union, Baptist Brotherhood, Music, Library, Student Work and Evangelism.

Section 2. Leaders of these organizations shall be elected as provided in Article VII, Section 3 (paragraph (2) b.).

Section 3. The Associational Organizations shall correlate their activities through the Missions Committee. A Calendar of Activities shall be planned and followed. Said organizations, through their

leaders, will make monthly reports to the Executive Board of work done and work proposed.

ARTICLE X—HOW AMENDED

This Constitution may be amended at any Annual meeting of the Association by a TWO-THIRDS VOTE of the Messengers present and voting, provided that the substance of Article IV shall not be abrogated.

RULES OF ORDER

Roberts Rules of Order shall be the standard in deciding questions of parliamentary practice.

MISSIONARY'S ANNUAL REPORT

During the past twelve months I have preached in 50 of the seventy-five churches in the association, and visited services in six others. Eight revival meetings were conducted in as many churches with 53 professions of faith and 24 additions by letter. I assisted 19 churches in their search for pastors, and arranged for an average of four supply preachers every week, or a total of 200 plus during the year. I assisted with the ordination of 11 deacons in

5 churches and 6 preachers. I spoke in 26 denominational meetings other than Pulaski County, and attended the Southern Baptist Convention in Chicago and Home Missions Week at Ridgecrest. In doing all this, I traveled approximately 16,000 miles.

As I look back and try to list the accomplishments of the past year, I am not at all flattered, but there are some solid gains from which I feel we will begin to realize the benefits more this coming year than we did last. To list a few:

1. More of our churches adopted the percentage plan of support for the Associational Budget. The churches actually gave \$3,058.00 more this year than last.
2. Our pastors have been drawn into a closer spirit of unity concerning the Associational program. Pastors Conferences and Executive Board meetings have been well attended.
3. The Missions and Survey Committee has pin pointed certain areas where we ought to begin new churches as soon as funds are available.
4. The New Church Foundation has been introduced. This plan, if accepted and utilized, can help us purchase property in these strategic areas.
5. We have had better planning and coordination by the associational organizations, which I trust will result in improved programs for all our meetings.
6. All promotion materials for the meetings of our organizations have been prepared and mailed from the associational office.
7. An accurate system of budget control has been installed enabling every organization to know the funds available every month. I believe that our system of reporting the gifts from the churches, both to the association and the cooperative program, are a real asset to every pastor and treasurer.
8. I believe I can truthfully say that the associational office has become a real service center for our organizational officers, the pastors, and the churches.

It is my hope and prayer that one year hence I may be able to report that we have established several new missions and churches; that we have purchased property for future church sites; and that we have aided many of our smaller churches in securing loans to expand. I also want us to promote Mission Vacation Bible Schools and Revivals next summer.

12. MISSIONS COMMITTEES: The report was read by Carl Overton, and spoken to briefly by him. He explained that the Missions Committee was a part of the Executive Board and that all action of any importance to the Association was carried to the Executive Board and was adopted by same. Hence this report covered the work of the Executive Board. The report was adopted.

REPORT OF THE MISSIONS COMMITTEE AND EXECUTIVE BOARD

The Missions Committee held 12 regular meetings during the year.

Most of the action taken by the Committee was in the form of recommendations to the Executive Board. A few matters such as the election of officers, etc. did not necessitate Board action.

Elected the following officers for the year: Carl Overton, Chairman, Nolan P. Howington, Vice-Chairman.

The Missions and Survey Committee was appointed as required by the Constitution. W. Harold Hicks, Chairman, R. L. South, and R. W. McMillan.

Recommended that we pay all remaining commitments made to the Broadmoor Baptist Church out of the Revolv-

ing Loan Funds, and that all liabilities and assets of said fund be transferred to the NEW CHURCH AND MISSIONS EXPANSION FUND.

Recommended that we take steps to secure property in the Wakefield Village area for a future church site.

Recommended that we approve the work of the Pulaski County Library Council and that we make it a unit of work in our program along with Training Union, Brotherhood, B. S. U., etc.

Recommended that we establish a CHURCH BUILDING FOUNDATION, and authorize its promotion through all the churches of the Association.

Recommended that we make plans for a Training Union Clinic to be held September 29-October 3, 1958, and that we finance this project to the amount of \$500.00.

Recommended that we help the Bellevue Church to meet some pressing payments on her property, and to secure a pastor, and that we ask the State Missions Department to join us in this effort.

Recommended that we cooperate in a simultaneous revival effort in 1959, and that the date for this be set as April 12-26.

Recommended that the Executive Board set up an advisory committee to study the feasibility of establishing a Seminary Extension Plan for in Service Training. The Board approved this recommendation and named the following committee: W. O. Vaught, R. H. Dorris, Bunyan Wallace.

Recommended that we request a larger amount of help from the Home Mission Board for our work in Pulaski County Association.

Took under advisement a plan to place a set of the Baptist Encyclopedia in the high school libraries of Pulaski County.

Recommended that we authorize our missionary to place all monies received as honorariums from the churches

of the association, in the CHURCH EXPANSION FUND, beginning, October 1, 1957.

The above named recommendations were made to the Executive Board and were all approved by the Board. This report, therefore, includes the action of the Board and suffices as a report of the Board.

REPORT ON BENEVOLENCES
(Abbreviated for Printing)

ARKANSAS BAPTIST HOSPITAL

Since Arkansas Baptist churches are interested in the growth of their institutions, the following facts over a ten-year period 1946-1956, of the Arkansas Baptist Hospital growth are here given: Bed patients including new-born babies from 12,047 to 18,634; out patients from 2,010 to 6,349; new babies from 1,159 to 2,064; cost per day from \$2,500 to \$7,000 plus; student nurses from 150 to 250; registered nurses employed from 30 to 130; people employed from 300 to 700. Support from our Baptist churches has grown from nothing to approximately \$100,000 per year—\$25,000 for charity \$30,000 for the School of Nursing and \$45,000 for capital needs. Capital needs will be met if a full budget is reached or collected for the present year. Charity obligations have grown from \$57,626.09 in 1946 to \$175,327.95 in 1956. Therefore the churches are contributing enough to take care of one seventh of the charity done by the hospital. During the year thus far in 1957, some allocations have been received from the Ford Foundation and the Bottoms' will. This extra money has given the hospital opportunity to increase the efficiency of the hospital by replacing walls and ceilings of the old part of the building and installing an elevator in the center of the building.

At our regular State Convention this year, the Executive Board will recommend that the Hospital be allowed to borrow approximately \$300,000 in order to have enough money to build a surgical building. The total cost will be \$700,000. The building will include an emergency room, medical records department, an out-patient clinic, doctor's dressing rooms, 14 major operating rooms and a large X-Ray Department. These modern facilities are a necessity for a hospital of our size and that does as many surgical cases each day as we are required to do.

Mr. J. A. Gilbreath has been the Administrator since 1946.

19. WORSHIP: Thurman Watson led in singing two hymns, "Have Faith in God", and "Count Your Blessings", after which W. O. Taylor led in prayer. Mr. Watson then sang as a solo, "A Wayfaring Stranger". D. David Garland, the appointee to preach the Doctrinal Sermon, read as a text Phil. 2:5-10, and preached on the subject, "The Cross—Its Meaning".

Ben L. Bridges led in prayer after which the body adjourned until 1:30.

TUESDAY AFTERNOON, OCTOBER 15, 1957

20. DEVOTIONAL: Hymns "Am I a Soldier of the Cross?", and "Our Best", were led by Thurman Watson, after which W. Harold Hicks read scripture (I Cor. 13) and led in prayer.

21. The Clerk read the journal of the morning's proceedings.

22. EVANGELISM: This report was made by Bunyan Wallace and was adopted without discussion.

23. CIVIC RIGHTEOUSNESS: C. Gordon Bayless presented this report. After a few remarks he moved the adoption of the report and it was seconded. Mr. Clyde C. Coulter, Superintendent of Temperance League of Arkansas, spoke on the evils of intoxicating drinks and the liquor traffic. Report adopted.

24. INTER-RACIAL COMMISSION: This report was made by Clyde Hart. It was in written form, and after motion and second to adopt it, he spoke briefly to it. It was adopted.

INTER-RACIAL REPORT

One major development in our work with Negroes in the state of Arkansas, was the very successful simultaneous revival conducted in the Pulaski County Association in which forty-four White and fifteen Negro churches participated. This was a new and happy experience. Wonderful fellowship and high inspiration marked the breakfast meetings in which the Negro and White pastors, evangelists, and singers participated.

This year, special emphasis has been placed on trying to help save and strengthen Arkansas Baptist College, the only Negro Baptist College in Arkansas. We spent \$10,000 on repairs on the main building which had been condemned. This

\$10,000 was matched by \$12,000 from the Negro Convention. We had another \$10,000 in our budget this year for the operating expenses of the school given on a money matching basis. The college is facing a crisis, laboring under a large debt, with building after building being condemned as unsafe and with insufficient revenue with which to pay the operational expenses of the college. In the light of this need, our Convention (White) voted to set aside Sunday, June 9, 1957, to raise \$100,000. At this writing, about \$54,000 has been received at Baptist Headquarters office and the money is still coming in. Reports indicated that the offering from the churches will reach \$60,000 to \$70,000 with additional big gifts coming from non-church sources (conditioned upon our churches raising at least \$60,000). We hope to reach our \$100,000 goal.

Our Convention gives \$2,000 per year to Morris-Booker College at Dermott.

The churches of Pulaski Association have given \$9,518.76 to this offering to date. Other churches will take an offering before the end of the year.

All in all, we believe our program of work with Negroes is making good progress throughout the state.

REPORT OF LIBRARY COMMITTEE

The Church Library is a selection of books—a collection of rare gems from many sources, brought together to become a ministry to the whole church.

We now have 23 church Libraries in the Pulaski County Association. Three of these being established this year.

The Library Council of the Association has two traveling libraries, composed of 50 books each, to be loaned to churches without a library, for a period of three months each. When a library is started with 15 approved books the Sunday School Board donates 10 books to the library. The Library Council will donate two new books to each church beginning a library.

The Executive Library Committee meets monthly and the church Library Council meets quarterly.

Goals for 1958 are for 10 new libraries and 5 reactivated libraries in the Association.

**SUNDAY SCHOOL ANNUAL REPORT
FOR 1956-1957**

Pulaski County Association has a full corps of officers for 1956-1957.

Three associational rallies were held at First Church, North Little Rock, Gaines Street, and Pulaski Heights. The associational group training schools held in six different churches in October, 1956, took the place of the quarterly associational rally for that month.

A total attendance at the quarterly associational rallies for the year was 994. Four associational group rallies were held during the year in each of the five associational groups. The total attendance at these group rallies was 862.

Attendance at the eight Vacation Bible School Clinics totaled 317.

Pulaski County has ranked high among the Associations of the Southern Baptist Convention for the last two years. Last year our association was 13th in number of awards and this year ranks 15th among the 1,072 associations. One church in the association, Immanuel Baptist Church, ranked 13th in the Southern Baptist Convention during the year.

For the first time in history, Pulaski County Sunday School Association attained Standard recognition. Our growth in Standard Sunday schools for the past four years has increased from none in 1953-54 to a total of 22 in 1956-57. This has been due to the capable leadership of Mr. J. V. Sanders, the associate superintendent of our association in charge of standards. There are 66 standard Sunday schools in Arkansas for this year, and 22 of them are from Pulaski County.

Pulaski County Sunday schools have had a net gain of 8,201 in Sunday school enrollment over the past five year period. The enrollment in 1951 was 19,342. This has increased to 27,543 in 1956.

TRAINING UNION REPORT

In the Pulaski County Association at the end of the 1957 year we have 75 Baptist Churches. Of these churches, 74 have during the associational year, carried out a Training Union program on Sunday evening. These same 74 churches on September 30, 1956, show an enrollment in Training Union of 11,600.

"M" Night was observed on December 3, 1956, with a meeting at the Baring Cross Baptist Church, North Little Rock. The attendance records show 1,388 present with more than 200 unable to enter the building because of lack of space. There were 49 churches represented with 33 of the local pastors present.

Forty-seven churches of the seventy-five in Pulaski County had 354 present at the second associational meeting of the 1957 year. Attendance banners were awarded to three churches for high attendance, Trinity Baptist, Gaines Street, and Immanuel.

The Park Hill Church was host to the Associational Training Union Meeting on this evening. Twenty churches in the Association took part with 195 present. Attendance banners were awarded to Trinity Church with 35 present; to the Park Hill Church with 13 present; and to the Immanuel Church with 43 present.

The program on September 16 was around the theme of "Enlargement to Meet the Needs of our People." The Associational Training Union workers presented the churches of Pulaski County Association with \$250.00 worth of visual aid equipment for use in their local churches. A film library was started that churches can borrow from for use in the 75 churches of our Association.

During the meeting at the Second Church several of the new film strips that are now in the associational office for use were shown. The last meeting of the year was closed with the announcement that "M" Night would be held with the Immanuel Church of Little Rock on December 2. The

Association was challenged with a goal of 2,000 present for the meeting.
