SUNDAY MORNING.

At 11 a. m., by request of the appointee, Eld. John Winham, Eld. J. L. Whittle preached the missionary sermon. Collection for associational missions, \$18.80.

Met in business meeting. Sister E. C. Moore, of Belton Female College, Belton, Tex., was announced present and was invited to address the body in the interest of her work in the cottage home annex at Belton Female College.

(Note) The cottage home is being built by Sister Moore, that those unable to pay regular board and tuition may receive board in the cottage home family at a nominal price. Those desiring so to do can address her at Belton, Texas. Collection for cottage home, \$10.25.

Reports of Committees.

ASSOCIATIONAL MISSIONS.

We, your committee, submit the following report: Bros. T. L. Fulbright and J. B. Lumbly have given part of their time during the past year at Dolby Springs. Bro, Winham gave about forty days to the work; received \$35 from the field and paid out Bro. Martin went one Sunday each month, from April to-October, in the northwest part of Bowie county, receiving fourteen by baptism and otherwise. Beside this, little has been done. There is great destitution in the northwest part of Bowie county, and also in the southeastern portion of same. The want of the spirit of missions among our people in the Association is seen in the small amount of funds in the letters from the different churches. We urge the pastors to lay the responsibility of complying with our Saviour's commission upon the hearts and consciences of our churches. Our baptisms last year only numbered We beg that every pastor resolve to make it many times more than this during our next associational year. also recommend that Bro. Windham be employed for three-fourths of his time. Submitted. W. A. FREEMAN, Chairman,

FOREIGN MISSIONS.

We, your committee, would suggest that the mission of the church of Jesus Christ is to be preached the gospel to the world. Beginning at home, we should seek to carry the glad tidings wherever man is found. The great commission is to go into all the world and preach the gospel to every creature. We are not commanded to be successful, but we are commanded to be faithful to our Master. Paul says: "Now if any man has not the spirit of Christ he is none of His." May we not truly say that if any church has not the spirit of Christ that such a church is not the church of Christ? The spirit of Christ is the spirit of missions. The churches in the association have given for foreign missions during last year \$50.45. There are twenty churches reported this year. Five gave \$50.45; fifteen gave nothing.

There are nearly 1,400 Baptists in this association, and to carry out the great commission we have averaged about three and one-half cents to each member. Is this the spirit of Christ? We recommend that the pastors take at least one collection this year for this work.

STATE MISSIONS.

Your committee begs to report that never before in the history of the State has greater success attended the efforts of the denomination in mission work. One hundred and twenty missionaries have been employed in preaching the gospel last year to 311 neighborhoods, laboring 23 511 days, preaching 12 334 sermons. Gf these sermons over one thousand were missionary sermons, The denomination has paid \$2,200 to this work. The State is being flooded with foreign immigration from many nationalities. thus the Macedonian cry is coming to us from other nations through our own great State, and it is our duty to meet them with the open Bible. This we have been trying to do in the face of difficulties in our State mission work. We, therefore, recommend the co-operation of the churches of this association with the State Convention. The board begins this year out of debt and about \$3,000 in the treasury. But the board is expecting to enlarge the work for another year, and in order to do this, must have cooperation from the churches. We, therefore, recommend all of our churches and pastors to take collection and send to J. B. Grambell, Dallas, Tex., for this work.

EDUCATION.

We, your committee, submit the following: This is a progressive age and there are institutions of learning all over this great country. It was founded by our fathers, so that young ministers might have advantage of theological training. Let us stand by this great school and support it with prayer and money.

The recent statistics show that there is more money spent in the United States for beer and whiskey than there is for bread; and that today nine-tenths of the crimes are traceable to strong drink. Thousands of men are annually going to drunkard's graves, hundreds of innocent women and children are suffering for the necessaries of life, all on account of strong drink, and to the shame of Baptists it has been said by saloon men that but for the Baptist vote, they would have to close their business, and the strange thing to your committee is, that men can come before God in prayer asking Him to save the young and at the same time go to the ballot box and by their vote legalize that which is distracting more young men than all other vices of the day. We therefore recommend that the Baptists of the Texarkana Association vote as they pray, remembering that our blessed Lord has said that "Faith without works is dead," and again, "Show me thy faith without thy works and I will show you my faith by my works."

ARTIGLES OF FAITH.

ARTCLE I. We believe that the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction; that it has God for its author, salvation for its end, and truth without any mixture of error for its matter; that it reveals the principles by which God will judge us, and therefore is the true center of Christian niuon and the supreme standard by which all human conduct, creeds and opinions should be tried.

ART, 2. We believe there is one, and only one, living and true God, an infinite, intelligent spirit, whose name is Jehovah, the maker and supreme ruler of heaven and earth, inexpressibly glorious in holiness, and worthy of all possible honor confidence and love; that in the unity of the God-head there are three persons-the Father, the Son and the Holy Ghost, equal in every divine perfection, and executing distinct but harmonious offices

in the great work of redemption.

ART. 3. We believe that man was created in holiness under the law of his Maker, but by voluntary transgression fell from that holy and happy state, in consequence of which all mankind are now sinners, not by constraint, but choice, being utterly void of that holiness acquired by the law of God, positively inclined to evil, and therefore under just condemnation to eternal ruin without defense or excuse.

ART. 4. We believe that the salvation of sinners is wholly of grace, through the mediatorial offices of the Son of God, who by appointment of the Father freely took upon him our nature, yet without sin, honored the divine law by his obedience and by his death made a full atonement for our sins; that having risen from the dead he is now enthroned in heaven, and uniting in his wonderful person the tenderest sympathies with divine perfections he is in every way qualified to be a suitable, a compassionate and all sufficient Savior.

ART. 5. We believe the great gospel blessing which Christ secures to such as believe in Him is justification, and justification includes the pardon of sin and promise of eternal life on principle of righteourness; that it is bestowed not in consideration of any works of righteousness which we have done, but solely through faith in the Redeemer's blood, by virtue of which faith his perfect righteousness is freely imputed to us of God; that it brings us into a state of most blessed peace and favor with God and secures every other blessing needful for time and eternity.

ART, 6. We believe that the blessings of salvation are made

free to all by the gospel; that it is the immediate duty of all to accept them by a cordial, penitent and obedient faith; and that nothing prevents the salvation of the greatest sinner on earth, but his own inherent depravity and voluntary rejection of the gospel, which rejection involves him in an aggravated condemnation.

- ART. 7. We believe that in order to be saved sinners must be regenerated or born again; that regeneration consists in giving a holy disposition to the mind; is affected in a manner above our comprehension by the power of the Holy Spirit, in connection with divine truth so as to secure our voluntary obedience to the gospel, and that its proper evidence appears in the holy fruits of repentance, and faith, and newness of life.
- ART. 8. We believe that repentance and faith are sacred duties, and also inseparable graces wrought in our souls by the regenerating spirit of God, whereby being deeply convicted of our guilt, danger, and helplessness; and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession and supplication for mercy, at the same time heartily receiving the Lord Jesus Christ as our prophet, priest and king, and relying on him alone as the only and all sufficient Savior.
- ART 9. We believe that election is the eternal purpose of God, according to which he graciously regenerates, sanctifies and saves sinners, that being perfectly consistent with the free agency of man it comprehends all the means in connection with the end; that it is a most glorious display of God's sovereign goodness, being infinitely free, wise, holy and unchangeable; that it utterly excludes boasting and promotes humility, love, prayer, praise, trust in God and active imitation of his free mercy, that it encourages the use of means in the highest degree, that it may be ascertained by its effects in all who truly believe the gospel; that it is the foundation of Christian assurance, and that to ascertain it with regard to ourselves demands and deserves the utmost diligence.
- ART. 10. We believe that sanctification is the process by which, according to the will of God, we are made partakers of his holiness; that it is a progressive work; that it is begun in regeneration, and that it is carried on in the hearts of believers by the presence and power of the Holy Spirit, the sealer and the comforter, in the continual use of the appointed means—especially the Word of God, self examination, self-denial, watchfulness and prayer.
- ART. 11. We believe that such only are real believers as endure unto the end; the persevering attachment to Christ is the grand mark which distinguishes them from superficial professors;

that a special Providence watches over their welfare, and they are

kept by the power God through faith unto salvation.

ART. 22. We believe that the law of God is the eternal and unchangeable rule of his moral government; that it is holy, just and good, and that the inability [which the Scriptures ascribe to fallen men to fulfill its precepts, arises entirely from their love of sin, to deliver them from which, and to restore them through a mediator to unfeigned obedience to the holy law, is one great end of the Gospel and of the means of grace connected with the establishment of the visible church.

ART. 13. We believe that a visible church of Christ is a congregation of baptized believers associated by covenant in the faith and fellowship of the gospel, observing the ordinances of Christ, governed by his laws, and exercising the gifts, rights and privileges invested in them by his word; that its only Scriptural officers are bishops or pastors and deacons, whose qualifications, claims and duties are defined in the Epistles to Timothy and Titus.

ART. 14. We believe that Christian baptism is immersion in water of a believer, into the name of Father, and Son, and the Holy Ghost, to show forth in a solemn and beautiful emblem our faith in the crucified, buried and risen Savior, with its effect, in our death to sin and resurrection to a new life; that it is prerequisite to the privileges of a church relation and to the Lord's Supper, in which the members of the church, by the use of bread and wine, are to commemorate together the dying love of Christ, preceded always by solemn self-examination.

ART. 15. We believe that the first day of the week is the Lord's day or Christian Sabbath, and is to be kept sacred to religious purposes by abstaining from all secular labor and sinful recreation; by the devout observance of all the means of grace, both private and public, and by preparation for that rest that re-

maineth for the people of God.

ART. 16. We believe that civil government is of divine appointment for the interest and good order of human society, and that magistrates are to be prayed for, conscientiously honored and obeyed, except only in things opposed to the will of our Lord Jesus Christ, who is the only Lord of conscience and the prince of the kings of the earth.

ART. 17. We believe there is a radical and essential difference between the righteous and the wicked; that such only as through faith are justified in the name of the Lord Jesus and sanctified by the spirit of our God are truly righteous in his estrem; while all such as continue in impenitence and unbelief are in his sight wicked and under the curse, and this distinction holds among men both in and after death.

ART. 18. We believe that the end of this world is approaching; that at the last day Christ will descend from heaven and raise the dead from the grave for final retribution; that a solemn separation will then take place; that the wicked will be adjudged to endless punishment and the righteous to endless joy, and that this judgment will fix forever the final state of men in heaven or hell on principles of righteousness

Constitution.

We, the Missionary Baptist Churches of Christ in the States of Texas and Arkansas, having been baptized upon a profession of our faith in Christ, are convinced of the necessity of a combination of churches in order to perpetuate a union amongst us and preserve and maintain a correspondence with each other. We, therefore, propose to maintain and keep the order and rules of an association according to the following plan:

1. The association shall be composed of members chosen by different churches in our association who, on producing letters from their respective churches certifying their appointment, shall

be entitled to seats.

2. The letters from the different churches are to express their members in full fellowship, those baptized, received by letter, dismissed, excluded, restored and dead since last association; also inscribe upon the backs of their letters the name of church.

postoffice, delegates, pastor and clerk.

3. The members thus chosen and convened shall be known as the Texarkana Missionary Baptist Association, who shall have no power to lord it over God's heritage or to infringe on any of the eternal rights of churches in the association, but shall be considered an advisory council in matters respecting their internal concerns, for the benefit of all such churches; but the association shall have power to exclude any church from its body who shall violate or deviate from the rules of the orthodox principles of the Gospel.

4. Every church in this association shall be entitled to three delegates or messengers, and should any church fail to represent herself she shall state her reasons in her letter to the next

association.

5. New churches may be admitted into this association, who shall petition by letter and delegates, and, upon examination, if found orthodox and orderly, shall be received by the association, and the reception thereof manifested by the moderator giving the right hand of fellowship.

6. This association, when convened, shall be governed by

regular and popular rules which they are authorized to form for themselves.

7. The association shall elect a moderator from among themselves by ballot, whose duty it shall be to see that the Rules of Decorum be attended to, and take the vote of the association in all questions properly brought before it and to organize the next association; also a clerk, whose duty it shall be to take proper and correct minutes of the proceedings; also a treasurer, whose duty it shall be to receive and disburse all money coming into his hands as directed by the association, giving and taking receipts for the same, and make a report of the same to the association.

8. The association shall in all cases be governed by a majority of members present except in the reception of new

churches, which shall require a unanimous vote.

9. Every query sent by a particular church must be included in her letter, certifying that she has endeavored to settle it, but could not; in which case the association shall take it under consideration and give its advice.

10. Business which immediately concerns the association at large, when sent by a particular church as from it or handed in by a member shall be taken up and decided as soon as an oppor-

tunity will admit,

11. The association shall correspond with other associations

as may be agreed upon when in session.

12. The association shall elect one or their ministers to preach the introductory sermon and his alternate at the next association.

13. The association shall endeavor to furnish the churches

with minutes of her proceedings.

14 Amendments to this constitution may be made at any time when two thirds of the churches composing the association deem it necessary.

15. The minutes of the association shall be read and corrected (if necessary) and signed by the moderator and attested

by the clerk before the association adjourns.

16. The association shall at each annual session appoint a Missionary Board, which shall choose its own officers, which shall consist of a president, vice-president, clerk and treasurer. Said board is required to report at each session of the association.
