MINUTES.

The White River Missionary Baptist Association met pursuant to adjournment with the Hopewell Baptist Church, Mountain Home, Ark., on Friday, September 1, 1911 at 10 o'clock a.m., the Moderator and Clerk being present. The meeting was called to order by singing.

Elder J. H. Marler preached the Introductory Sermon, after which the Moderator called for the letters from the different churches. Bro. J. L. Paul and W. R. On motion the committee to write the history of this Association was requested to report at our next session. The committee is as follows:—W. D. White, W. R. Jones, T. O. Horn, J. H. Marler and J. M. Casey.

Motion and second that we adjourn to meet with the Pleasant Hill Baptist Church at Bruno, Marion County on Friday at 10 a. m. before the first Sunday in September, 1912.

The parting hand was taken, followed by a prayer from the Moderator.

REPORTS.

1.—We, your Committee on deceased ministers, beg leave to submit the following: We find that God in his providence has seen fit to take from our midst our dear brother, H. H. Hilton, one of the pioneer ministers of the White River Association, and while we regret to give him up, but believing that God does all things well let us bow in humble submission to His will.

2.—We, your Committee on state missions, respectfully sub mit the following report:

State missions is a vital part of our denominational work. The great unit from which all mission work is launched must forever be the local church. And the local churches of Jesus Christ must forever be left free to carry on God's missionary work as they see fit and proper, so long as they do no violence to New Testament principles. If the local church desires to send forth one or more missionaries to proclaim the gospel to a lost world, it has the perfect right to do so. If two or more churches decide to affiliate themselves together into an associational capacity, they also have the right to send forth as many missionaries as they see proper for the purpose of extending the boundaries of God's Kingdom, and of carrying out the great commission. For the true local churches compose the "household" of Jesus Christ. He is the head, not of one only, but of them all collectively.

For the same reason; if two or more churches desire to affiliate together for the purpose of widening their missionary effort, and of covering a whole state, they have the same right to do that. In fact, it is not only the right of the churches to extend their missionary efforts to the furthest bounds of the state in which they are situated, but it is their duty as well. All the states in the world must be converted to the religion of Jesus Christ before he can be said to truly rule over the earth.

In the choice of executives for the purpose of carrying on state mission work the matter is entirely in the hands of the thurches affiliating themselves together. They are sovereign in this matter and no association, convention or any other body of momengers fraternizing together, shall say them nay. Each local church must be left entirely free in this matter.

But we feel that it is the duty of every church to take an interest in the great work of saving the State of Arkansas for Jesus Christ, and we recommend that each church not only send messengers to some state gathering this fall, but that it contribute to apprying on state mission work as well. At the present there are two mediums through which the Missionary Baptists of this state are carrying on state mission work. One is designated as the Mate Convention. The other the State Association. Each of these are simply the executives of the will of the local churches, affiliating together. Then there is a third plan of doing state mission work—that is for the church to endorse the missionary and for the contributions to be sent direct to said missionary in the field.

Your committee regrets that we can not all agree to the same plan of doing state mission work, and earnestly urge the brethren to investigate the different methods of carrying on God's work in our state.

But in the meantime we recommend that each church, and each individual of every church, be urged to support one of the plans of carrying on state mission work, leaving the method to be pursued to the best light the church may have on the subject, and to the honest Baptist hearts composing the church membership.

We recommend that this great work be carried on in a spirit of love and not of strife.

We recommend that all money collected for the purpose of carrying on state mission work through the Executive Board of the State Convention be sent to Eld. John T. Christain, Little Rock, and that all money collected for the purpose of doing state mission work through the Committee of the State Association be sent to O. H. Echols, Ft. Smith.

Trusting that God will, at his own proper time, lead us into a perfect spirit of unity, we are respectfully.

3.—We your committee on foreign missions report as follows: We realize the sad state of affairs in regard to foreign missions in our Association. But few churches are giving anything to this cause. We want to urge our brethren to think more on this cause and do more in propagating the gospel in heathen lands. Christ's command: Go into all the world, is as urgent today as it was in the past.

We would ask that every church take a collection for foreign missions some time during the year and forward it to the foreign mission field and thus be a helper in the worlds redemption.

4.—We your committee on destitution beg leave to report as follows:—We realize that there is still great destitution within the bounds of this Association, and we recommend that the pastors and deacons of the various churches do all in their power to raise means for the support of such missionary. 5.—We your committee on baptist literature beg leave to moke the following report:—First, we recommend the reading and careful study of the Bible. Second, we recommend the reading of all sound Baptist literature.

6.—We your committee on associational missions would respectfully submit the following: Whereas there is great destitution in in our bounds we therefore recommend that the Moderator appoint a committee consisting of five brethren to solicit funds from any legitimate source that they may choose and employ one man for full time or two men for half time as missionaries to preach in the bounds of the Association. We urge upon all our

minutelies to contribute liberally for the support of this work.

We your committee on woman's work wish to submit the following: Realizing the great influence for good wielded by the women of our country and knowing the great things being accommitted by them along financial, moral and spiritual lines, request that the brethren of this Association help the women in all of their modesvors for the uplifting of their fellow man and forwarding the cause of Christ.

We your committee on orphan's homes, beg leave to submit the following report: We now have two Baptist orphan longs in Arkansas—one at Monticello and the other at Texarkana. The home at Monticello is under the management of the Stat Connection; the one at Texarkana is under the management of the line Association. There are about 150 orphan children in the long at Monticello and about 20 in the home at Texarkana. Bro. N. Williams is superintendent and his wife is matron at Monticello. Bro. Carter is superintendent and his wife is matron at Texarkana. Both of these institutions are sadly in need of money take care of the children.

We recommend therefore that this Association take an offering in cash and pledges for the orphans and that each individual and church be requested to give or pledge to the Home of his choice.

We further recommend that our churches and Sunday achools take a public offering for the orphans some time during the next Associational year and at the earliest date possible.

We further recommend the hearty financial support of our Baptist institutions by our entire brotherhood.

WINISTERS, WESSENGERS AND DIERWE

CONSTITUTION.

ARTICLE 1.—This Association shall be called and known by the name of the "White River Baptist Association."

ARTICLE II.—The members composing the annual meetings of the Association shall consist of the messengers sent by the churches.

ARTICLE III.—The messengers sent by the churches to the annual meetings shall not exceed four from each church.

ARTICLE IV.—The Association shall meet annually at such time and place as shall have been previously appointed.

ARTICLE V.—The officers of the Association shall consist of a moderator, clerk and treasurer, who shall be chosen by a majority of the messengers annually at the annual meetings of the body.

ARTICLE VI.—This Association will have no power to control or regulate the internal affairs or discipline of any church, but it may adopt and recommend all such measures as shall be considered best calculated to produce the harmony and prosperity of the churches, and to advance the Redeemer's kingdom, and advise and consult upon such matters as the churches may at any time present for their consideration and advice. And it may receive churches into this Association or dismiss churches from the body, inquire into the state of religion in its bounds, and suggest measures for its advancement, and be a common bond of union among the churches, but shall not exercise any legislative power over the churches.

ARTICLE VII.—This constitution may be amended at any regular meeting by a vote of two-thirds of the members present, provided notice has been given at a previous meeting.

DECLARATION OF FAITH.

1. We believe the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction; that it has God for its author, salvation for its end, and truth without any mixture of error for its matter, that it reveales the principles by which God will judge us; and therefore is, and shall remain to the end of the world, the true center of Christian union and the su-

prome standard by which all human conduct, creeds and opinions about be tried.

- We believe that there is one, and only one, living and true that, and infinite, intelligent Spirit, whose name is Jehova, the Maker and Supreme ruler of heaven and earth; inexpressibly doubles in holiness, and worthy of all possible honor, confidence and love; that in the unity of the God-head there are three persons, the Father, the Son, and the Holy Spirit; equal in every divine prection; and executing distinct but harmonious offices in the areat work of redemption.
- 8. We believe that man was created in holiness, under the law of his Maker; but by voluntary transgression fell from that looly and happy state, in consequence of which all mankind are now almers, not by constraint, but choice; being by nature utterly vold of that holiness required by the law of God, postively inclined to evil, and therefore under just condemnation to eternal ruin witnout defence or excuse.
- 4—We believe that the salvation of sinners is wholly of grace, through the mediatorial offices of the Son of God, who by the appointment of the Father, freely took upon him our nature, yet without sin; honored the divine law by his personal obedience, and by his death made a full atonement for our sins; having risen from the dead, he is now enthroned in heaven, and uniting in his wonderful person the tenderest sympathies with divine perfections he is every way qualified to be an all-sufficient Savior.
- 5. We believe that the great gospel blessing which Christ secures to such as believe in Him is justification; that justification includes the pardon of sin and the promise of eternal life on principles of righteousness; that is bestowed, not in consideration of any work of righteousness which we have done, but solely through faith in the Redeemers blood, by virtue of which faith his perfect righteousness is freely imputed to us of God; that brings us into a state of most blessed peace and favor with God and secures every other blessing needful for time and eternity.
- 6. We believe that the blessings of salvation are made free to all by the gospel; that it is the immediate duty of all to accept them by a cordial, penitent and obedient faith, and that nothing prevents the salvation of the greatest sinner on earth but his own

determined depravity and voluntary rejection of the gospel, which rejection involves him in an aggravated condemnation.

- 7. We believe that, in order to be saved, sinners must be regenerated, or be born again; that regeneration consists in giving a holy disposition to the mind; that it is affected in a manner above our comprehension by the power of the Holy Spirit, in connection with the divine truth, so as to secure our voluntary obedience to the gospel, and that its proper evidence appears in the holy fruits of repentance, faith and newness of life.
- 8. We repeat that repentance and faith are sacred duties and inseparable graces, wrought in our souls by the regenerating Spirit of God; whereby being deeply convinced of our guilt, danger and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession and supplication for mercy, at the same time heartily receiving the Lord Jesus Christ as our Prophet, Priest and King, and relying on Him alone as the only all-sufficient Savior.
- 9. We believe that election is the eternal purpose of God, according to which he graciously regenerates, sanctifies and saven sinners, that doing perfectly consistent with the free agents of man, it comprehends all the means in connection with the end, that it is a most glorious display of God's soverign goodness, being perfectly free, wise, holy and unchangeable; that it utterly excludes boasting, and promotes humility, love prayer, praise, trust in God and active imitation of his free mercy, that it discourages the use of means in the highest degree; that it may be ascertained by its affects in all who truly believe the gospel; that it is the foundation of Christian assurance, and that to ascertain it with regard to ourselves demand and deserves the utmost diligence.
- 10. We believe that sanctification is the process by which according to the will of God, we are made partakers of his holiness; that it is a progressive work; that it is begun in regeneration, and that it is carried on in the hearts of believers by the presence and power of the Holy Spirit, the Healer and Comfortor, in the continual use of the appointed means—especially the Word of God, self-examination, self-denial, watchfulnesss and prayer.

11. We believe that such only are true believers as endure

to the end; that their reserving attachment to Christ is the grand mark which distinguishes them from superficial professors; that a special providence watches over their welfare, and they are kept by the power of God through faith into salvation.

- 12. We believe that the law of God is the eternal and unlanguable rule of his moral government; that it is holy, just and mod, and that the inability which scriptures ascribe to fallen men to fulfill its precepts arises entirely from their love of sin, to deliver them from which and to restore them through a mediator to infolgred obedience to the holy law is one great end of the gospel and the means of grace connected with the establishment of the table church.
- 18. We believe that a visible church of Christ is a congregation of baptized believers, associated by covenant in the faith and followship of the gospel, observing the ordinance of Christ, governed by his laws and exercising the gifts and privileges invested in them by His word; that its only scriptural officers are bishops or pastors and deacons, whose qualifications and claims and duties are defined in the epistles of Timothy and Titus.
- 14. We believe that Christian baptism is the immersion in water of a believer into the name of the Father and Son and Holy Spirit, to show forth in a solemn and beautiful emblem, our faith in the crucified, buried and risen Savior with its effect, in our death to sin and resurrection to a new life; that is a prerequisite to the privileges of a church relation and to the Lord's Supper, in which the members of the church by the sacred use of bread and wine are to commemorate together the dying love of Christ preseded always by solemn self-examination.
- 15. We believe that the first day in the week is the Lord's Day or Christian Sabbath, and is to be kept sacred to religious purposes by abstaining from all secular labor and sinful recreation, by the devout observance of all the means of grace, both of private and public, and by preparation for that rest that remaineth for the people of God.
- 16. We believe that civil government is of divine appointment, for the interest and good order of human society; and that magistrates are to be prayed for, concientiously honored and

obeyed, except in things opposed by the will of our Lord Jesus Christ, who is the only Lord of the conscience and the prince of the kings of the earth.

at the last day Christ shall descend from heaven and raise the dead from the grave to final retribution; that a solemn separation will then take place; that the wicked will be judged to endless punishment, and the righteous to endless joy; and that this judgment will fix forever the final state of men in heaven or hell on principles of righteousness.

RULES OF DECORUM.

- 1. The Association shall commence with religious exercises and a sermon from some preacher, who shall have been previously appointed, unless the Association shall otherwise direct.
- 2. The Moderator of the session shall preside, and the former Clerk shall act (provided they attend) until the letters from the churches connected with the body shall have been read and a Moderator and Clerk appointed.
- 3. It shall be the duty of the Moderator to preside over the meeting during its session and appoint committees (unless the Association shall otherwise direct), preserve order, reprove improprieties (except an appeal is made to the meeting by two members). He shall have a right to speak on all subjects, calling a member to the chair, and examine and correct the minutes if necessary.
- 4. The Clerk shall keep a correct copy of the proceedings of the meeting, read the letters and documents, and call any member to assist him at the close of the meeting. He shall take charge of the papers and documents unless otherwise directed.
- 5. The churches shall designate their messengers and report their condition by letter.
- 6. Preachers in good standing in other Baptist churches or Associations with whom we are in fellowship, when attending our annual meeting, shall be invited to a seat as correspondents, and these meetings shall always be opened with a prayer and closed in a similiar manner.

- 7. Every member may speak twice on any one subject in delimite before the meeting, but not more without leave; and when punking shall stand and address the Moderator and use decorous and Christian language; and no member shall absent himself from the Association during the session without leave; and any person who shall violate these rules, or the constitution, shall be reproved in the Association shall think proper.
- These rules may be amended by a majority of the mem-
- 9. The churches shall contribute funds for the ordinary expenses of the body, such as printing the minutes and paying the traveling expenses of such members as the Association may send to other bodies.
- 10. A public collection shall be taken by the Moderator at much session and applied to such benevolent purposes as the Association may direct.

- 15. Appoint place for next meeting of Association.
- 16. Appoint some one to preach the Introductory Sermon.
- 17. Adjournment.
