

CONSTITUTION

As Amended at 1933, 1943, 1948, and 1950 Sessions

Article I.-NAME

The name of this body shall be Pulaski County Baptist Association.

Article II.—OBJECT

The object of this Association shall be to aid the churches in their divinely appointed work of spreading the Kingdom of God throughout the whole world by every Scriptural means.

Article III.—MEMBERSHIP

- Section 1. This Association shall be composed of messengers from regular Baptist churches, which are in sympathy with the principles and purposes of this Constitution and desire to co-operate with this Association, who shall be entitled to seats upon the presentation of letters from their churches or other satisfactory evidence of their appointment.
- Section 2. Each church shall be entitled to three messengers, with one additional member for every fifty members or major fraction thereof above one hundred.
- Section 3. Messengers from churches desiring to affiliate with this Association shall present to the Association petitionary letters or other evidence setting forth the Articles of Faith on which the churches were organized together with satisfactory evidence of the regularity of their organization. They shall be received into the Association only by unanimous vote as cast by the body.

Article IV.—AUTHORITY

This Association shall never exercise any legislative or ecclesiastical authority over any church, nor shall it in any way interfere with the rights and absolute independence of the churches of Christ.

Article V.-OFFICERS

- Section 1. The officers of this Association shall be a Moderator, Vice-Moderator, Clerk and Treasurer, who shall he elected at the last session of each Annual Meeting by a majority of all the votes cast at such meeting. Provided, however, that the Moderator shall not be eligible to serve more than one term.
- Section 2. The Moderator shall preside at all sessions of the Association or call some one to occupy the chair temporarily in his

absence, and may exercise the same privilege of discussion as any other member of the Association.

Section 3. The Clerk shall keep a correct record of all the proceedings of the Association and shall superintend the printing and distribution of the Minutes of each session as he may be directed by the Association.

Section 4. The Treasurer shall receive all funds of every kind entrusted to his care, and shall disburse the same upon order of the Association and shall make an itemized report of all such funds to the Association before the close of each annual session.

Article VI.—ASSOCIATIONAL BOARD

Section 1. The Associational Board shall be composed of one lay member, elected by each co-operating church, together with the pastors of such churches, and the officers of the Association and the Superintendents of W. M. U. work. Seven members of said Board shall constitute a quorum to transact business, after notice has been given all members of the Board of such meeting.

Section 2. This Board shall co-operate with the churches in this Association in informing and arousing the churches in gathering and disbursing of funds for all of the causes fostered by this Association and shall transact all of the business of the Association in the interim of the annual meeting of the Association.

Article VII.-MISSION COMMITTEE

The Mission Committee shall be elected by the Association in three groups, as follows: Group 3, to serve for three years; Group 2, to serve for two years; and Group 1, to serve for one year, thus retaining six members of the committee each year and only electing three new ones to take the place of the Group retiring.

The Moderator, Clerk, and Treasurer of the Association and the five elected officers of the associational organizations known as the Sunday School, Training Union, Brotherhood, W. M. U., and Music become ex-officio members of that committee, thus making the total membership seventeen and this committee shall provide the program and calendar of activities for the Association.

The Mission Committee shall elect its own chairman, who shall be required to report monthly to the meeting of the Associational Board and an annual report to the annual meeting of the Association.

The Mission Committee shall have the responsibility of the selection of the Superintendent of Associational Missions, subject to the approval of the Executive Board of the Association, and shall have as its duty in co-operation with that officer the planning and practical promotion of the Program of Associational Missions for Pulaski County Baptist Association.

ARTICLE VIII-MEETING

This Association shall meet annually on Monday night after the second Sunday in October at 7:00 o'clock, and day session Tuesday, adjourning Tuesday night. That four sermons be placed on the program, consisting of the Annual Sermon; the Annual Doctrinal Sermon; a sermon on Stewardship; and a sermon on Missions.

Article IX.

This Constitution may be amended at any annual session of the Association by a two-thirds vote of the messengers present at any annual meeting, provided that the substance of Article IV shall never be abrogated.

RULES OF ORDER (BY-LAWS)

As Amended at 1933 and 1947 Sessions

- I. The following committees shall be appointed six weeks in advance of the Associational meeting:
- (1) Associational Missions; (2) State Missions; (3) Home Missions; (4) Foreign Missions; (5) Colleges and Schools; (6) Religious Literature; (7) Bible (Sunday) Schools; (8) Ministerial Education; (9) Orphan's Homes; (10) Christian Stewardship; (11) Hospitals; (12) Woman's Work; (13) Young People's Work; (14) Digest of Letters; (15) Obituaries; (16) Resolutions; (17) Finance; (18) Temperance; (19) Nominations.
 - II. Each session shall be opened and closed with prayer.
 - III. The following shall be the order of business:
 - The Body called to order by the Moderator, or, in his absence, by brethren in the following order of precedence: Vice-Moderator, Clerk, Treasurer, Pastor of entertaining church.
 - 2. Devotional Service.
 - 3. Presentation of letters and enrollment of Messengers.
 - 4. Permanent organization,
 - 5. Introductory Sermon.
 - 6. Petitionary Letters.
 - Reception of visitors, corresponding messengers from other bodies and introduction of new pastors.

- Appointment of program committee which shall recommend a schedule for all reports and other matters to come before the body, subject to the Association's approval.
- IV. Every speaker shall rise and address the Moderator. In discussion all personalities shall be avoided. No one shall speak more than twice on the same subject, without special permission from the Association.
- V. Mell's Parliamentary Law shall be the standard in deciding questions of parliamentary practice.
- VI. The minutes of the preceding session shall be read and approved at the meeting of each session and at close of the Association meeting.
- VII. Such offerings may be taken at the annual meeting of the Association as the body may direct.
- VIII. These by-laws may be amended at any regular meeting by a two-thirds vote of those present, or suspended by a unanimous vote.
- IX. The Associational Board shall meet monthly at such time and place as the Board itself may determine.
- X. A doctrinal sermon shall be preached during each annual session at such an hour as each program committee shall provide.

PETITIONARY LETTERS

7. Petitionary Letters were called for by the Moderator. Letters were presented by the following churches: Davis Chapel Baptist Church, and Calvary Baptist Church of Rose City.

The letters were referred to the Committee on Petitionary Letters and upon motion the churches were voted into the Association, and the pastors of the two churches were recognized and officially welcomed by the Moderator.

8. New pastors were introduced by Dr. E. A. Ingram, and were officially welcomed by the Moderator, H. W. Ryan.

CHRISTIAN EDUCATION

9. Lucian Coleman, Sr., spoke on Christian Education. A motion was made that report as drawn up by Dr. K. Owen White, on Christian Education, be adopted. Motion carried.

Christian and Ministerial Education

If any denomination is to maintain its place and give effective witness to Christ in a changing world it must give careful consideration to its responsibility in the field of Christian Education. The emphasis must rest upon the word Christian. If our schools, colleges and seminaries do not make a contribution beyond that of the secular schools they have no excuse for existence.

The "faith once delivered to the saints" must be preached and taught with intelligent understanding as well as with fire and vigor. People do not usually go far beyond their leaders. A consecrated, well trained leadership with unshaken faith in God's Word is essential to the program and progress of all of our work.

We shall do well to "lengthen our cords and strengthen our stakes" in our whole program of Christian Education. Let us maintain great schools and insist that they have a clear, ringing testimony for Christ in the classroom and on the campus.

OUR COLLEGES

Ouachita

Ouachita College is now in its 65th annual program of Christian Education. A few years ago a foremost Baptist leader of the South ranked Ouachita second among the Baptist colleges in worth to our Baptist Program.

The distinctiveness of Ouachita College lies in its program of Christian education, namely, Christian men and women on the faculty who are active in the work of the churches and interpret knowledge in all studies in the light of Biblical truth; the almost 100% Christian group of students on the campus; the close associations between the college and the local Baptist churches, the Arkansas Baptist and Southern Baptist programs; the many organizations and activities on the campus promoting Christian training, fellowship and service.

700 regular students were enrolled in the fall term 1949-50; 632 in the second term and 300 in 1950 summer school. More than 150 Ministerial students have been enrolled this past year. The faculty is composed of 40 fine Christian men and women, the most of them active Baptist people.

Ouachita College is a big institution for Arkansas Baptists. The College has 16 main brick buildings, 75 apartments, cottages, and trailers; an athletic field and stadium, and a 167 acre farm. This year the college has a budget of \$513,000. Approximately 500 students take their meals at the college cafeteria. Utilities—water, electricity, gas and telephone service—average \$1,700 per month the year round. Insurance and maintenance of buildings is no little item.

The fiscal year, 1949-50, the college will receive \$65,000 or \$70,000 from the Cooperative Program. Because of rising costs and standards, and lower income, it is increasingly difficult to operate an accredited school on such income.

Two new buildings will be completed in the summer of 1950, a library and science hall. At the present time, however, the college has no source of funds to equip the science building. It will take a minimum of \$75,000 for this.

The extreme emergency now is in the matter of operation—paying salaries, bills, etc. Over a period of a few years the college has been running farther and farther behind until now we are facing a critical operating deficit. The college has a backlog of more than \$70,000 in unpaid bills and must have help and lots of it.

Southern

Southern Baptist College continues to grow and offer her unique service to multitudes in Northeast Arkansas. The College had a total enrolment during the winter session of 905. The first summer term of 1950 showed an enrolment of approximately 600. Not counting duplicates, the college has enrolled during the twelve months period between 1,150 and 1,200 individuals.

In the enrolment this year, Southern had approximately 100 Ministerial Students and some 35 other religious trainees. The College now is one of the largest Baptist Colleges in the South and continues to attract a large number of students from all the states of the South. Southern is offering the regular Liberal Arts College training, as found in all of our Baptist schools; the special course for rural ministers, as found in no other school in America, and vocational training for many students who wish to train for some particular vocation in life. Having this type of training makes Southern one of the most popular Baptist schools in the South.

Gross revenues and expenditures of the college this year were well over \$400,000. Our State Convention continues to assist in the operation of the School.

Baptist School of Nursing, Arkansas Baptist Hospital

Our Baptist Hospital, located in Little Rock, reports another good year during which some 207 young women have received special training in the field of nursing.

A class of 58 was graduated in June.

A deeply spiritual atmosphere pervades the school. Courses in Bible are included in the regular course of training and a vigorous B. S. U. program is sponsored continuously. Student revivals, religious focus week and a special chapel service all contribute to the religious atmosphere.

SEMINARIES

Southern Seminary, Louisville, Kentucky

Southern Baptist Seminary reports that it reached its highest enrolment this year with 854 preachers, 52 in Music School, and 114 Training School Students and 83 preachers' wives attending classes.

The faculty has been increased to 22 with 7 teaching assistants.

The beautiful new chapel seating 1,700 people was completed and dedicated at the Pastor's Conference March 20-24.

A new million dollar apartment building for married students is under construction.

Southwestern, Fort Worth, Texas

Southwestern Seminary also reports its peak attendance with an enrolment of 1,704 of which 914 were in the school of Theology. Thirty-nine states, the District of Columbia, Hawaii and seven foreign countries were represented.

A number of new members have been added to the faculty.

The Seminary rejoices in the completion of the Scarborough-Truett-Fleming Administration Library Building and the J. M. Price Hall.

New Orleans Seminary

The enrolment last session was 543, as compared with the previous all time record of 394. Eighty-six of these graduated. Students came from 27 states and 3 foreign countries. Of these, 360 are college graduates, 62 have had some college work, and 121 are without college credit. They are the highest calibre in fitness for Christian service.

The Seminary offers Theological degrees only to college graduates, awarding the Bachelor of Divinity, Master of Theology, and Doctor of Theology degrees. The Bachelor of Religious Education, and the Master of Religious Education degrees are offered in that field.

On September 1, 1949, the four new apartment buildings on the new 75 acre Gentilly campus were occupied by students.

The Seminary has no debts, and contemplates none. The building program depends on the "capital funds" from the Cooperative Program and gifts from generous friends. They need \$1,000,000 for buildings.

Two New Seminaries

The Southern Baptist Convention has now committed itself to the support of two additional seminaries—Golden Gate Seminary, Berkeley, California, and an Eastern Seminary to be located at the original site of Wake Forrest College. The Golden Gate Seminary is already in operation and the Eastern Seminary hopes to begin operating in the fall of 1951. Southern Baptists are on the march in the field of education. There is need for an awakened interest and much more adequate support for all our schools.

COOPERATIVE PROGRAM

11. Dr. B. L. Bridges and Dr. J. D. Freeman spoke on the Cooperative Program.

The Cooperative Program is our denominational lifeline in that it provides a way for all the churches to support all the causes fostered by the denomination. Also it enables every church to minister in the evangelistic, education and benevolent work of the Gospel even out to the end of the earth.

The Cooperative Program is scriptural in that it includes in its scope the things Jesus commanded His churches to do: preaching, baptizing, and teaching believers. The Mission Boards, the hospitals, the schools and the churches carry forward these things. And they are Baptist in what they believe and what they do. The Bihle is their guide.

Now Baptist churches being independent need some program linking them in their significant responsibility of Missions. They certainly are missionary in spirit and purpose. Therefore a link that will pool their strength and direct their effort in missionary endeavor is a mighty boon to the Baptist cause. This the Cooperative Program is!

Being of such nature and Baptists being of such need, the Cooperative Program is for them right and must be in their mind and heart as an instrument of God given them to carry out His program. Simple in design it is merely every church sharing of its income with every other church in the program of its state Convention. And every state Convention sharing of its income with the Southern Baptist Convention.

The amount we give should receive our careful consideration. No church should allow itself to spend all its funds at home. The matter of our world mission witness should guide us to the ideal that our responsibility is world wide, and dividing of our income in order that the lost everywhere will hear the Gospel will certainly receive Christ's blessing.

We do not hesitate to call every pastor and church to prayer concerning this vital matter. The life and development of our denomination is at stake here. Colleges, Orphanages, Hospitals, Old Ministers, the Mission Boards, Seminaries, all eat from this missionary table. Let us not take this as merely ordinary. This is primary, fundamental.

Let every church have worthy part. Put it definitely in budget for a worthy share. We feel that the ideal is a fiftyfifty division. Earnestly implore that we strive for this goal. God certainly blesses sacrificial, Christ-honoring missionary spirit.

Tuesday, October 10, 1950

Morning Session-10:00 A. M.

16. The morning session of the annual meeting began at 10 a. m., Tuesday, October 10, 1950, with the Moderator, H. W. Ryan, presiding. The messengers and visitors were led in the opening prayer by pastor Daniel Taulbee.

- 17. Mrs. Marcella Simmons led the congregation in singing "Love Divine All Loves Excelling."
- 18. Pastor Vernon Wycliffe read the thirteenth chapter of First Corinthians and led in prayer.
- 19. The Journal for the previous evening was read by the clerk.

BAPTIST HOSPITAL

20. Dr. J. F. Queen made the Hospital Report. Motion that report be adopted. Carried.

Arkansas Baptists and Hospitals

There are three hospitals in which Arkansas Baptists are interested, organically or financially. First, we have the Southern Baptist Hospital in New Orleans. Dr. Frank Tripp is the Administrator. We help to support this hospital through the Cooperative Program for South-wide Causes. Second, we have a part in the operation of the Baptist Memorial Hospital in Memphis, by electing annually memhers from Arkansas who serve on the Board. Dr. Frank Groner is the Administrator. Third, the Arkansas Baptist Hospital, Little Rock, has Mr. John A. Gilbreath as Administrator. This hospital is owned and operated by Arkansas Baptists.

The purpose of these institutions is to render spiritual care as well as to attend to the physical needs of those who call upon them. All three have full time chaplains who are constantly visiting the patients, encouraging them and praying with them, leading the lost to Christ and counseling with the hospital personnel and in public relations. The chaplains are: Frederick P. Laman, Baptist Memorial; W. W. Hamilton, Southern Baptist, and J. F. Queen, Arkansas Baptist.

All three hospitals have schools of nursing. More than 700 young women attend these schools every year. All have student secretaries who lead in Y. W. A. and B. S. U. work. Chapel services are conducted by the chaplains for students and others who desire to attend. Chaplain Hamilton has a public address system over which he gives a devotional daily for 15 minutes for all patients who are able to listen.

Expansion programs are being visualized by all three hospitals. Usually all have a waiting list of patients because of the lack of beds. If our work is to continue to grow and our influence is to continue to increase it will be necessary for us to make additional room to all our hospital plants. South-

ern Baptist Hospital is constructing now another wing at a cost of \$1,600,000 to increase capacity to 550 beds, plus 80 bassinetts. In addition to an allocation from the Southwide Cooperative Program for Charity, \$150,000 was allocated for capital needs which is being used on the wing now under construction. The Arkansas Baptist Hospital is constructing a Doctor's office building at a cost of \$500,000. This is to be paid for from rents on rooms to doctors, rents on drug store, cafe, and shops on the first floor. Then the huilding will serve as an endowment for the hospital. The next great need for the Arkansas Baptist Hospital is a new dormitory for the school of nursing to take care of 300 students. At present we can care for only 200. If this building could be constructed we could add 100 or more beds to the hospital with the wing the girls occupy now. That would give us a 400 bed hospital.

The amount of charity done by these hospitals the past year was above \$600,000. The Baptist Memorial Hospital did the biggest part of this. In fact they did more than all the other Southren Baptist Hospitals put together. They do it without the help of any denominational funds. Rents on buildings and other concessions help in a large way for this to be made possible. Arkansas Baptist Hospital is limited on income to subsidize its charity program. Its only resources of help outside the hospital is the Mother's Day Offering which amounted to \$3,983.61 this year. Since an allocation of \$35,000 was made to help support the Arkansas Baptist Hospital School of Nursing at our last convention it has lightened the burden of the hospital in caring for the school.

As these three hospitals take care of approximately 50,000 bed patients annually it should increase our belief in the great ministry of healing in a Christian atmosphere, and a consideration of making wills and memorial gifts to them. Prayers of all who hear this report are earnestly solicited.

RELIGIOUS LITERATURE

22. Pastor W. H. Hicks read the report on Religious Literature. Motion that report be adopted. Carried.

"If reading makes the man" and if "the pen is mightier than the sword" Baptists would do well to re-examine regularly and plan prayerfully the production and distribution of good literature. Reading and writing have been the twin handmaidens of progress and the forward march of civilization. The kingdom of our Lord has a life's hlood kinship with what men of olden times wrote under Divine inspiration. The story of Jesus was handed down for a time by word of mouth but ere long, in the providence of God, the word that had become flesh became a recorded story that men might read. The power of the inspired Word with its instruction, its comfort and its condemnation of evil, is continually demonstrated in the lives of people.

Southern Baptists recognized early in their history the imperative to place good literature in the hands and homes of its constituency. The Sunday School Board produces an astonishing amount of printed matter. The quality of our denominational literature is as high as the best in present day journalism. Its doctrinal content is the expression of our historic Baptist position of implicit faith in the Word of God.

Churches would do well to consider wider and more thorough use of such Sunday School Board publications as "The Sunday School Builder", "The Training Union Magazine" and "Home Life Magazine". The foreign mission magazine "The Commission", and the home board "Southern Baptist Home Missions", bring a constant stream of missionary information and inspiration to readers.

Arkansas Baptists have reason to be proud of our own "Arkansas Baptist". We have been blessed with exceptional line of fine editors and Dr. B. H. Duncan is a keen student of religious life, a fine writer and good administrator. "The Baptist" has reached a circulation of about 36,000 issues per week; it should be and has been placed in a rapidly growing number of church budgets at a cost of \$1.32 per year. It gives every department of our state work a worthy and fitting amount of its production space. The total program of Southern and Arkansas Baptists is spread before our minds on its pages. Every church should consider placing "The Baptist" in its budget.

Baptists of Pulaski County are fortunate to have in Little Rock one of the stores operated by the Sunday School Board. It carries an immense inventory of religious literature and church supplies. It should also be remembered that such a store operated by our denomination adds greatly to the impact of the Gospel as proclaimed by our Baptist Churches.

TEMPERANCE

23. Pastor W. O. Vaught, Jr., gave the report on Temperance and brought a very timely and helpful message on the evil of drink. Motion made that report be adopted. Carried.

Social Service Report

Although our Social Service Report usually covers other vices than the liquor traffic, because of the importance of our state election in Arkansas this coming November we are confining our report to the liquor traffic. More than 53,000 individuals in Arkansas signed petitions asking that Arkansas vote on the sale of legalized liquor in this state. This issue will be on the ballot in November and all the friends of righteousness in Arkansas will have an opportunity to help vote legalized liquor out of our state. Only 19,000 signatures were necessary in order to submit this matter to a vote of the people, but 53,000 signatures were secured. Therefore on November 7th we will determine the future of the sale of legalized liquor in Arkansas.

Pay Poll Tax Now

Every person who votes in the November 7th election this fall must pay their poll tax before October 1st, 1950. The poll tax which entitled the voter to sign the petition to submit this issue to a vote of the people is not the poll tax which will give them the right to vote in the November election this fall. Therefore it is IMPERATIVE that all of our Christian people throughout Arkansas will pay their poll tax and be ready to vote on November 7th. Church groups throughout Arkansas are urged to see to it that every Christian throughout the state pays a poll tax this year so they can vote in November. A line at the Bottom of the 1950 poll tax receipt reads as follows: "If paid on or before October 1, 1950 will entitle taxpayer, if otherwise qualified, to vote in any election held in this state between October 2, 1950, and October 1, 1951, inclusive." Therefore we must see to it that all our people pay their poll tax and be ready to vote on this issue in November.

The Bill We Vote On

If we vote this statewide prohibition act we will make it unlawful to manufacture, sell, barter, loan or give away intoxicating liquor within the State of Arkansas. All beverages containing more than ½ of 1% of alcohol are considered as intoxicating liquor by this proposed bill. If this bill is passed every liquor store and beer joint in Arkansas will be closed.

We will put an end to the sale of legalized liquor in this state.

Let Us Look at Some Facts!

- (1) AMERICA'S LIQUOR BILL FOR 1949: Americans spent for "legal" liquors in 1949—one year—\$8,550,000,000.00. It has been approximately ONE MILLION MINUTES since Christ was born. America's liquor bill last year was equal to more than \$8.50 for each minute since Jesus was born. It was equal to ONE MILLION DOLLARS PER YEAR since six-thousand, five-hundred years before Christ was born.
 - (2) ARKANSAS' LIQUOR BILL for 1949.

 Spent for liquors \$41,625,000.00

 Crime bill caused by liquors last year 30,700,000.00

 Auto Accidents and deaths caused by liquors 3,537,000.00

Total \$75,862,000.00

- (3) ARKANSAS "REVENUE" FROM LIQUOR TRAF-FIC in 1949: \$5,251,000.00. Each \$1.00 of "revenue" cost the people above \$14.00!
- (4) IN ARKANSAS: Surveys have shown repeatedly that there is more bootlegging in WET areas than in DRY areas. One survey revealed SIXTY boot-leggers with FEDERAL PERMITS IN THIRTY-EIGHT DRY COUNTIES, and THREE-HUNDRED NINETY-FOUR of them in THIRTY-SEVEN WET COUNTIES. In Mid-January, 1950, there were nine "legal" WHOLESALE liquor dealers in Arkansas, and at the same time, there were EIGHTEEN WHOLESALE BOOTLEGGERS in Arkansas, with FEDERAL permits. Twice as many wholesale bootleggers as legal wholesalers.

A Deplorable Situation

The brewer's contributions to their anti-prohibition propaganda are ruled by the U. S. Bureau of Internal Revenue to be deductible as "necessary business expenses." But, contributions to the Temperance organizations are not deductible. This is one more reason why we must "roll up our sleeves" and get into this fight against this liquor traffic.

We Are In To Win!

We are in this campaign with other self-respecting, lawabiding and Christian friends to win—To drive out from our state the cheating, deceiving, soul-destroying liquor traffic. There is clear and increased evidence throughout Arkansas that the people are disgusted with the entire booze traffic and want to get rid of it—to drive it out.

BROTHERHOOD

37. Nelson Tull gave a very inspiring report on the work of the Brotherhood. Motion that report be adopted. Carried.

1950 has been a year of Brotherhood expansion both in Arkansas and throughout the area of the Southern Baptist Convention. The development of new promotional materials, plus the growing momentum of Brotherhood endeavor, have together contributed to the organization of many new church and associational Brotherhoods.

Many churches which once tried Brotherhood on a SO-CIAL basis, (a sort of men's club where the men come, eat a banquet meal and then sit back to hear a good message), are organizing their Brotherhoods again on a SERVICE basis. (Men at WORK!) Men at work at the tasks of their churches and denomination—that's Brotherhood. Baptist men organized to work, undertaking and carrying through particular items of work, all for the advancement of the Kingdom of God through their church and denomination—that's Brotherhood.

Unused manpower is lost manpower. Lost manpower means a church operating at less than capacity, less than efficiency. The utilization of Baptist manpower is a fundamental necessity for the advancement of our churches and our denomination.

There are Two hundred and fifty-six Brotherhoods of record in churches of the Arkansas Baptist State Convention. Thirty-nine of our forty-two associations have one or more church Brotherhoods. Twenty-six of our associations have associational Brotherhood organizations.

We believe that every church should have a functioning Brotherhood, and that every association should set up and maintain an associational Brotherhood.

BOTTOMS BAPTIST ORPHANAGE

38. H. C. Seefeldt, Superintendent of the Bottoms Orphans' Home gave the report on the work of the orphanage. Motion that report be adopted. Carried.

The Bottoms Baptist Orphanage is maintained by Arkansas Baptists and is located in Monticello, Arkansas. The state, fraternal Organizations, Civic Organizations, and many others have caught the spirit of Christianity in an endeavor to help in the care of helpless needy children. Careful study of God's Word will reveal that all through the Scriptures He takes a special interest in widows and orphans. Not as a means of salvation, but as an evidence of the new birth and redemption from sin, do we find the child of God demonstrating the spirit of Christ in a vital interest in child care. James 1:27 places it along with other acts of influence in Christian living as marks of pure religion. The work of your orphanage is unselfish service to those who need it most and is not limited to just the field of benevolence, but also to missions, Christian education and the whole program of Christ.

The Orphanage is a part of the Arkansas Baptist Institutional family and is supported partly through the Cooperative Program and partly through the Annual Thanksgiving Offering and other special designated gifts of money, food, elothing and equipment. Although the amount to the Orphanage in the state budget was increased last year, the total budget was so much larger than the previous year, that the percentage to the Orphanage was smaller and resulted in the Orphanage receiving less the first five months of this year over last year. The month of June, however, of this year, was better than last year the same month.

Many churches have not understood that the Orphanage was placed in our state budget for only a part, or one-third of its support. The remaining two-thirds of the amount we receive to be raised in special offerings, as above indicated, is as definite a part of the Arkansas Baptist Program as the Cooperative Program itself. When we planned to do away with so many special offerings it was understood that the Thanksgiving offering for the Orphanage would be the main exception and would continue. Therefore churches who do not participate in a special offering for the Orphanage have only a small part in carrying on this work we consider so near to the heart of the Savior. We need to either triple the amount we have in our state budget for the Orphanage, or all of the churches recognize the special offering, especially at Thanksgiving and Christmas, as a part of the Arkansas Baptist Program.

Last year we went as far as we could on the money received. A detailed statement of all receipts is provided for our Little Rock office each month and also a monthly statement is made showing receipts, disbursements and balances. We are doing our best to operate within our income, whatever that amount is.

Last year 114 children were cared for, although 68 at one has been our capacity, making a total family average around 85. Even though it is generally known that your orphanage is always full, we cannot begin to take care of the many, many, applications that come to us. The only way we can take on another child is when we can work out a satisfactory program for a child now in the home. In spite of this 7 children made profession of faith last year and 5 came into our church by letter.

The Home is active in the program of the First Baptist Church in all of its organizations. Through the kindness of friends in Arkansas Baptist Churches and others, our children have been able to enjoy many of the blessings of our state programs, such as the Training Union Convention, Siloam Springs Assembly, R. A. and G. A. Camps, etc.

All of the children in the Home will be in school this fall. One graduated from High School last May and plans

to enter Southern College this fall. There will be three seniors this year. The children participate in all school activities. Some are in the band and several are taking private piano lessons. One boy was selected to go to Boys State, and one boy went from Drew County to Little Rock and then on to Chicago in stock judging.

The farm is made up of 240 acres and is largely pasture land. We now have some 75 head of cows and calves, 45 pigs and hogs, and around 300 chickens. The boys do the milking and are active in 4-H club work. We participate in the local County Fair program and sent one steer to the Pine Bluff Stock Show, which sold for nearly \$300.00.

A limited space has been provided for sick children. Our Baptist Hospital in Little Rock has been most gracious to our children. Our local doctors continue to be very kind and considerate. Thanks to God, our children are generally a healthy group!

We acknowledge with sincere appreciation the new car provided by the Convention last year, the truck by Caroline Association, the Movie projector by the Ministerial Association of Ouachita College, a deep freeze, hay baler, several pianos, floor and table lamps, floor coverings, sewing machines, tables and so many other things, too numerous to mention, showing Christian love and thoughtfulness.

The Home has gotten by with a septic tank overflowing through other people's property but the city has recently voted a bond issue to extend sewerage and although we are out of the city limits, connection will be made possible which the Board of Health will demand. This will cost between five and six thousand dollars.

"Bangs" disease showed up in our cows during the past year. The Board of Health requires milk to be pasteurized. A small pasteurizing plant will cost some \$2,500.00.

We need more space for children. We need to provide barn space for more feed and shelter. We need another small tractor. We need a good mimeograph machine, a new typewriter, a good camera to take pictures through the year, etc.

We plan to place Birthday Banks in all of the churches, with one for each department and class, where acceptable. (Oklahoma Baptists receive about \$1,000.00 per month from this source.)

We have had a moving picture made of the Home and some of the activities, which we would like to show to the churches and Associational and State meetings, so as to better acquaint our people with the Home. We have employed a Field man, (Rev. W. A. Herring) who is experienced in this type of work and we would like for him to be able to visit the churches, showing the movie and informing our people of the work we are endeavoring to do. Superintendent Seefeldt would also appreciate opportunities to supply pulpits and other occasions to tell of the work.

We urge all churches to get behind the Thanksgiving Offering for the Orphanage, emphasizing again the "One day's pay" plan. We will continue to use the truck, but you were so gracious last year that we urge the emphasis be placed on a "Money Offering." Any amount received over actual operating needs will go to capital needs. The truck will run by Associations, as last year, and pick up such contributions of feed, food, and clothing as you may provide.

Please continue to pray for us and visit your home for Homeless Children, if at all possible.

That Article VII—Mission Committee, be amended in the second paragraph to read as follows:

"The Moderator, Clerk, and Treasurer of the Association and the five elected officers of the associational organizations known as Sunday School, Training Union, Brotherhood, W. M. U., and Music become ex-officio members of that committee, thus making the total membership seventeen and this committee shall provide the program and calendar of activities for the Association."

ASSOCIATIONAL SUNDAY SCHOOL WORK

58. Frank Shamburger gave report on Associational Sunday school work. Motion that report be adopted. Carried.

The Associational Sunday School organization held only two meetings during the 1949-50 Sunday School year. Each of these meetings was attended by approximately 150 people. One was held at Baring Cross, the other at First Church, Little Rock.

Without knowing the progress shown by any of our Sunday Schools, I checked 14 churches (9 city and 5 rural) and found that 11 of these had shown an increase in enrolment during the year of more than 600, while three had shown a decrease in enrolment.

Our program for 1950-51 should emphasize the importance of the larger church helping the smaller ones. The programs should be so designed that they will be of greatest assistance to the rural church.

Reverend Earl Herrington was elected associational Sunday School Superintendent and we feel sure that we will make real progress this year.

ASSOCIATIONAL TRAINING UNION WORK

59. Ed Markert read the Associational Training Union Report. Motion that report be adopted. Carried.

According to the 1949 minutes of the Association, there were 55 churches reporting Training Unions. There were 432 individual unions with an enrolment of 7,337, which is an increase of 1,785 over the previous year.

I. Activities

A Central Leadership School was held January 30-February 3, 1950 with the First Baptist Church, Little Rock. The enrolment was 439 with 25 churches represented.

Promotion of the Junior Memory Drill, Intermediate Sword Drill, and Young People's Speakers Tournament. Associational Elimination Contest was held February 20, 1950 at Second Church, Little Rock. Miss Nancy Long, Pulaski Heights Church, represented our Association in the State Junior Memory Drill. Miss Martha Jane Wilson of First Church, Little Rock, represented us in the State Intermediate Sword Drill.

II. Awards

2,587 Study Course Awards were issued to 46 churches and missions in this Association from October 1, 1949 to October 1, 1950.

III. Recommendations '

- 1. That the Associational Training Union Director set up a complete organization for the promotion of the work in all the churches, this to include the following workers: Associate Director, Secretary-Treasurer, Chorister, Pianist, Pastor-Advisor, and a Leader for each of these departments, Adult, Young People, Intermediate, Junior, Story Hour; a cabinet meeting to be held at least once a quarter.
- 2. That this organization be charged with the responsibility of getting a good attendance at the Associational and Zone meetings, assisting in the organization of new Training Unions in the Association and assuming the leadership of department conferences to be held at the meetings of the Training Union Association.
- 3. That we co-operate with the Aunual State Planning Meeting for Associational Training Union officers to be held at First Church, Little Rock, Monday, October 30, 1950.
- 4. That "M Night" (Mobilization Night) be observed on Monday, December 4, 1950, as suggested by the Training Union Department, Nashville.
- 5. That every Training Union actively support Church Development Week planned by our State Training Union Director for January 29-February 2, 1951 at Immanuel Church, Little Rock.
- That one or more Training Union Study Courses be conducted in every church during the ensuing year.
- 7. That each Training Union promote the sending of members to the State Baptist Assembly at Siloam Springs and the Southwide Training Union Assembly next Summer.
- 8. That every Training Uniou join in the crusade for daily Bible reading and family worship and prayer meeting attendance, as well as the Stewardship program of our churches this year.

ASSOCIATIONAL MUSIC WORK

60. M. O. Kelley read the report on the Associational Music Work for the year. Mr. Kelley recognized Mrs. W. B.

Nininger, who spoke to the report. Motion that report be adopted. Carried.

The past associational year has been a very joyful year for me. The response of the churches has been most gratifying. We have contacted about every church in the association and some of them on three or four different occasions. We have conducted Hymn-Sings in the following places:

South Zone: Geyer Springs, 2; East End, 2; Pleasant Hill, (Central Association) 1; Ironton, 2; Pine Grove, 2.

South West Zone: Crystal Hill, 2; Plainview, 2; Douglassville First, 2; Martindale, 2.

West Zone: Pleasant Grove, 1; Attended, 1; Hebron, 1.
North West Zone: Graves Memorial, 2; Amboy Mission,
2; Pike Avenue, 2

North Zone: Zion Hill, 2; Harmony, 1; Stanfill, 2; Friendship, 1.

In all of these thirty-one Hymn-Sings there were from 50 to 275 present and from 5 to 12 churches represented. There were two to five special musical numbers presented each time, either choir, quartette, or trio. Another inspiring thing about the Hymn-Sing was the many pastors, choir directors, and pianists present.

I want to thank the following musicians who have been very helpful to me and to the churches where they have gone: our State Director, Mrs. B. W. Nininger is always ready to help and has gone and spoken to the people on church music and directed some of these Hymn-Sings. Others who have helped are Mrs. Perry Parsons, Music Director at First Church, Park Hill; Mr. John A. Gilbreath of the Baptist Hospital, Mr. Bob Hall, Music Director at Amboy Mission. I also want to thank our associational missionary who has helped in my work in many ways.

I have led the singing for four Revival Meetings this year: North Point, Crystal Hill, Vimy Ridge, and Pine Grove.

In Greater Little Rock, three Music Rallies were held during the year—at Calvary, Reynolds Memorial, and First Church, North Little Rock. The outstanding feature of this program is the formation of a singing body known as The Baptist Choral Club. Made up of choir members from all the Baptist Churches this group is endeavoring to serve in a closer fellowship of music ministry, presenting at least once a year an outstanding service of song. On May 28 under the leadership of Miss Marcella Johnson, now Mrs. Joe Simmons, the group sang four beautiful selections at the Quarterly Music Rally.

On Thanksgiving Morning, November 30, 10:00 a.m. in the Immanuel Baptist Church at the joint worship service of all Baptist Churches of Greater Little Rock, the Baptist Choral Club will again be presented in anthems of praise and Thanksgiving, Hatcher Hoyt conducting.

In addition to the Quarterly Hymn-Sings, the goal for 1951 is to have a School of Church Music taught in every church in the association. Two books are highly recommended for this purpose: "Growing a Musical Church" (Nininger) and "Practical Music Lessons" (Harrison McKinney). In some cases several churches in a zone will want to come together for the music school. Others promote it for their own church membership. I will be available to teach some of these schools under the supervision of the State Music Director, who will provide others to assist in this work. An honorarium of \$35 a week is the custom for such service. It is suggested that request be made to me immediately for dates of your music school so that a working schedule may be prepared.

ASSOCIATIONAL W. M. U. WORK

61. Mrs. J. D. Yerby read the report on the Associational W. M. U. Work. Mrs. E. A. Ingram, field worker for the Association, was introduced and spoke to the report. Motion made that report be adopted. Carried.

I am happy to bring my first report as Superintendent of Pulaski County Baptist Association Woman's Missionary Union.

The year of 1949-50 has presented many privileges and opportunities of work for the women of Pulaski County Baptist churches. We have truly endeavored "To lengthen the cords and strengthen the stakes."

I have the privilege of reporting fifty-four active missionary societies with an average attendance of nine hundred and fifty at the missionary programs which are rendered each month. Nine hundred tithers have been reported and our women have given \$31,143.57 to the Cooperative Program. Twenty-two societies observed the Foreign Mission season of prayer and gave a Lottie Moon Christmas offering of \$17,205.97. The Home Mission season of prayer in March was observed by twenty-three societies with \$3,211.55 being given to the Annie Armstrong home mission cause.

We do not have a complete report of the State Mission Season of Prayer just observed in September. The Pulaski County Federation of business women's circles reported three new churches having organized circles for business women bringing six new circles into their organization.

The business women of Pulaski County have contributed to the purchase of a station wagon for Miss Evelyn Standard, a missionary in Louisiana. The first state wide encampment for Business women was held the first week in September with fourteen in attendance from Pulaski County.

Mrs. J. W. Hall, mission study chairman, planned and conducted a mission institute last February in Calvary Baptist Church with fifty mission study teachers taking advantage of that study.

The Woman's Missionary Union of Pulaski County in session July 27, 1950, voted to contribute \$30.00 per month to the support of Miss Chico Sato, already enrolled in Ouachita College and plans to return to her own country to teach in the elementary grade school. She has surrendered her life to serve where God leads her and asks for the prayers of this group that she may find God's will for her life.

Mrs. W. J. Mooney, Community Missions Chairman, led an association prayer meeting in First Baptist Church, Little Rock, preceding the simultaneous revivals in April.

A schedule is sent each quarter for director of Community Missions for each society in the association. Mrs. W. F. Miller, Young People's Director for Pulaski County Baptist Association, reports ninety-one auxiliaries for young people. Mrs. Harvey Elledge, Y. W. A. counselor, reports twelve organizations. Mrs. John Hinkson and Mrs. C. A. Riley, Intermediate and Jr. G. A. Counselors, supervise the work of forty-five organizations. Eleven Royal Ambassador chapters are led by Mr. Francis Rowe. Mrs. R. E. Freeman directs the work of twenty-three Sunbeam Organizations. Quarterly rallies are held for each organization in the different churches. New organizations for young people have been organized as follows. Two new Y. W. A., one Royal Ambassador chapter, one Jr. G. A. and one Intermediate G. A. Total gifts reported from Young People's work amounts to \$3,422.53.

Much credit for the promotional work done by Pulaski County W. M. U. goes to Mrs. E. A. Ingram, Field Worker, employed by the Pulaski County Baptist Association. Mrs. Ingram is one of the busiest people we know of. She has covered Pulaski County majoring on mission study. She has taught forty-seven mission study books in different churches, taught twelve classes in the W. M. U. Manual and made one hundred and seventy-three talks on mission study and stew-

ardship besides the many other activities she leads. She reports five new organizations and the work has been revived in many places. Woman's Missionary Union of Pulaski County is thankful for such a consecrated, zealous worker as Mrs. Ingram.

Our goal this year is a missionary society and young people's auxiliary in each church in Pulaski County Association. Please keep the Associational W. M. U. on your prayer calendar.

ASSOCIATIONAL BUDGET

64. Due to the expected expansion of the Associational Program a motion was made that the Budget be referred to the Executive Board of the Association. Motion carried.

STATE MISSIONS

65. Dr. C. W. Caldwell read the report on State Missions. Motion that report be adopted. Carried.

The Mission Department of the Arkansas Baptist State Convention gives an account of its stewardship for six months of 1950 as follows:

- 1. The State-Wide Evangelistic Conference in January which laid the foundation and stimulated interest in the program of evangelism as sponsored by the Southern Baptist Convention.
- 2. The Department promoted the Simultaneous Evangelistic Crusade which resulted in thirty-five associations cooperating, with 522 churches engaged in revivals at the same time. There were 5,003 people added to the churches by baptism and a total number of 6,936 additions.
- 3. A Missionary Retreat was held for the associational missionaries at Hot Springs for the purpose of discussing plans and policies of mission work throughout the state.
- 4. A Rural Church Conference was sponsored at Central College which was the first to be held in the state. It was primarily for pastors of rural churches and was the largest attended of any such conference in the southland.

To summarize the work of the Missions Department during the six months period of 1950 reveals the fact that the missionaries connected with the Department of Missions have won 1,079 people to Christ and have held 128 revivals. There have been twelve churches helped on their building programs and fifty churches given aid on the pastors' salaries.

Two Negro colleges have been aided financially through State Mission funds. During the six months period a total of \$41,730.89 has been spent for state mission work.

The Mission Department plans to continue its work of supplementing associational missionaries' salaries, salaries of pastors in weak churches, aiding churches on their building program, and maintaining chaplain at Booneville Sanatorium. Evangelism will continually be stressed and three full time evangelists will continue their service with the Mission Department. The Department will continue the promotion of conferences in the interest of missions, both rural and city. A State-Wide Conference in the interest of local mission stations will be held in December and three leadership conferences for pastors and leaders of Negro churches next February.

Many places of destitution are being surveyed with hope of establishing missions and churches within the near future. Liberal support of the Cooperative Program will help in all of this work.

HOME MISSIONS

66. Miss Nancy Cooper read the report on Home Missions. Motion that report be adopted. Carried.

The annual report of the Home Missions Board for 1949 magnifies the fruits of evangelism. We think rightfully so. In Simultaneous Evangelistic Crusades, led by three workers in the Department of Evangelism of the Home Mission Board, 7,780 baptisms were reported with 11,875 additions to the churches participating in crusades. Southern Baptists reported a total of 334,862 baptisms for the year, which brings joy to all our hearts. Baptist Chaplains reported 4,893 professions of faith. Not counting the above reports, Home Missionaries reported 35,913 conversions.

Figures included in the annual report show 165 new churches constituted and 577 new missions opened. Fifty new buildings were either completed or were under construction. Fifty-four pieces of home mission property were improved.

A total of 779 regular missionaries served the Home Mission Board during the year and 251 summer student workers gave ten weeks of mission service, making a grand total of 1,030 workers. Missionaries contacted 177,139 in personal work, delivered 81,039 sermons and addresses, taught 22,987 classes, conducted 1,817 revivals, distributed 57,419 Bibles and Gospels, and made 258,818 religious visits. They worked in

1,541 vacation Bible Schools. There are 44 kindergartens in operation.

Few Southern Baptists really know of the tremendous task the Home Mission Board faces in the homeland, and the mighty work the Board is doing to meet the demands at our own doors. The great western area—New Mexico, Arizona, Kansas, California, Washington and Oregon—contains more people and more needs than the original South held when the Home Mission Board was established more than 100 years ago. There are more people in our present area above nine years of age who are lost and wholly unchurched than the total population in the South when the Board began its ministry.

As indicated above, great things are being done by Home Missionaries. New churches being organized by them at the rate of two each week. Dead or very weak churches are often revived and made strong. A great work of occupying urban areas is being done through the department of City Missions, and rural work is developing rapidly under the Rural Church program.

Our work among the Indians is the most productive we have ever had, and we are aiding in a large way to prepare ministers for the Negro churches of the land. A great work is being done among the foreign language groups. Many capable workers are being won and trained so that they may go to their native lands as workers when the way is open again. In New Orleans and other cities Good Will Centers and Rescue Missions are bearing a rich harvest. Thus, the Home Board is doing a valuable mission work.

Never before was there so great a need for the Home Mission Board as there now is. It is our greatest unifying agency; it is our only means of reaching vast fields of spiritual destitution, such as are found in Maryland and California where Baptists are few and the needs are enormous. It is our means of reaching Cuba, Panama, Alaska, Hawaii and other parts of our nation not connected with the United States proper.

Your committee cannot stress too much the value of the work Home Missions is doing. We do heartily recommend, therefore:

- 1. That our churches seek to learn about the Home Mission Board and its ministry.
- That Baptist homes everywhere subscribe for the Southern Baptist Home Missions magazine and learn from this monthly paper what Home Missions is doing.

3. That the churches make extra liberal offerings for Home Missions next March through the W. M. U. and Sunday School special offerings.

FOREIGN MISSIONS

67. W. C. Burnett led the congregation in singing "The Kingdom Is Coming", after which Dr. E. A. Ingram made the motion that report on Foreign Missions be adopted. Motion carried.

A rehearsal of the facts makes a thrilling report on Foreign Missions. The following paragraphs are a digest of the report Dr. M. Theron Rankin, Executive Secretary of the Foreign Mission Board, gave to the Southern Baptist Convention in Chicago:

"During the year 1948 the Foreign Mission Board had under appointment over 700 missionaries serving in 24 different countries of the world. Sixty-seven new missionaries were appointed during the year, 19 to Africa, Europe and the Near East, 16 to Japan and Hawaii and 32 to Latin America. Included in the total 700 are 231 ordained ministers, their wives and 190 single women. (Already during 1950 enough new missionaries have been appointed to bring the total to 753.) The Board hopes to appoint a total of 100 new missionaries in 1950, 125 in 1951, increasing 25 each year until 1954 when they hope to appoint 200.

"The Board's total receipts for the year, exclusive of world relief funds amounting to \$120,354.15 reached a grand total of \$5,319,261.04. This represents a gain over 1948 of \$465,313.77.

In Africa during August 1950, the Southern Baptist Foreign Mission Board will celebrate its 100th anniversary of work in Nigeria. There are now 492 churches in Nigeria with 20,065 members. 2,044 new converts were baptized in 1949.

"In Europe work is maintained in Spain where three new churches were organized during the year and in Italy where within the last twelve months work has made great progress despite persecution. Two student evaneglists were jailed for preaching the Gospel. Also, an international European Theological Seminary is maintained at Zurich, Switzerland with 28 students representing 13 countries and 15 nationalities.

"In the Near East work is conducted in Lebanon, Arabia and Israel.

"In Latin America new work has been opened in Costa Rica, Venexuela and among the Russians of Paraguay. Other work has been planned for Ecuador and Peru. This leaves only a very few of the Central and South American countries without Baptist witnesses. Medical work is rapidly expanding with physicians at labor in Paraguay, Mexico and Columbia. The first Baptist hospital in South America is under construction in Asuncion, Paraguay.

"In the Orient Baptists had at the end of 1949, 57 missionaries in communist China, six in Macao, seven in Hongkong, two in Formosa, four in Bangkok, and 16 in the Philippines, a total of 92 still working with the Chinese people. There are 40 missionaries in Japan with 60 more needed immediately.

"The Foreign Mission Board maintains a mission magazine, The Commission, with a circulation of 93,131; an audio visual aids department in active production of film strips and movies and a literature department for production of books and tracts."

Behind the facts here recited we see millions of men lost in sin, doomed to spend eternity in Hell unless the Savior of men is brought to them. This our faithful missionaries are trying to do, but the line is too thin. We require missionaries and money for their support to bolster the line.

- 68. Dr. E. A. Ingram introduced Dr. John Mein, of Brazil, who brought a message on the work there. He used the words of the Apostle Paul, "A great door and effectual is opened unto me."
- 69. Motion was made to adjourn until next regular meeting. Carried.
