### PROCEEDINGS

#### SATURDAY-MORNING SESSION

The Forty-second annual session of Friendship Baptist Association convened with Bethlehem Baptist church in Lincoln county, Arkansas, Saturday, September 19, 1914, at 10 o'clock A. M.

On account of the death of Moderator J. H. W. Overton, the Clerk, W. A. Fish, called the Association together. Bro. Will Winston conducted devotional exercises, after which Bro. W. L. Compere was called to act as temporary moderator.

Bro. Eugene Winston was nominated to preach the introductory sermon, provided, the original nominee did not.

#### REPORT ON SUNDAY SCHOOLS

"We your Committee on Sunday Schools make the following report: We find by examination of the church letters 19 schools reported. Number of pupils in said schools 1,528; number of officers and teacher 122; number of baptisms 77; number of churches which have no schools 9. We are glad to find this much done along the line of Sunday school work. But we have not yet reached the goal. We, therefore, recommend that each church which has no school to organize and maintain one.

#### REPORT ON SABBATH BREAKING

We, your Committee on Sabbath Breaking, beg leave to say we are taught in the Bible to "Remember the Sabbath day to keep it holy." We recommend that our pastors and our churches do all in their power to set aside the playing of ball on Sunday. Sad to say, a great many members of our churches, both brethren and sisters, are witnesses of this desecration. This ought not to be. The only remedy we can see for this evil is for our churches to be more interested in Sunday schools, as it seems to be more prevalent where there is no school. It was a wonderful provision of God to set aside a day in which to refrain from secular labor and pleasure and to serve Him. How sweet to spend the day in God's service, but he who stays at home and reads his paper or visits his farm, works hunts or goes visiting in preference to God's service, fails to keep it holy. May God help us to preserve our christian sabbath.

#### REPORT ON CONDITION OF CHURCHES

We, your Committee on Condition of Churches, find from the reports that there are 34 churches on the roll of which eight are not represented at this meeting. We also find that 16 churches have had no pastors. But most of those represented have had very good meetings and seem to be in a very good spiritual condition. We urge that all our churches endeavor to have pastors the coming year. We find on examination of letters that there has been an increase of 263 of which 163 were by experience and baptism. A decrease of 126 shows that we have had a net increase of 137. We are grateful for the increased condition of our churches and urge that we press forward to more spirituality and consecration to our master's cause.

REPORT ON HOME MISSIONS

We, your Committee on Home Missions, submit the following report: The time has come when we have been made to realize that not only foreign missions work is important but that home missions should have a good deal of attention. There is great destitution in the bounds of our home-land. There are many churches that have not houses of worship and many places where the gospel in not preached at all. Great progress, however, has been made in the past few years. Their are about 1,200 missionaries employed by the Board who last year reported about 35,000 baptisms. The only way for this

work to be continued is for us to give of our means to the support of this great work. The General Association has been working in the same territory and has done a great deal of good work and is fast carrying the gospel to the destitute places. But the work is not yet done. Each year we see a greater task before us. Let us as brethren and as pastors push the work, and let every church not fail to take collections for Home Missions. #### REPORT ON CHRISTIAN EDUCATION

Your Committee on Education submits the following report: We all know the importance of education. The generation that boasted of illiteracy has passed. Not only do we see the need of education along general lines, but of christian education. Christian education has to do with the training and developing of men and women in such a way as to bring out the powers latent within them, and direct them for the greatest possible usefulness in this service and the benefit of humanity in general. As has been said, the churches are demanding an educated ministry and yet many of our churches are not willing to help in this cause. Not only are the ministers to come from these schools but all of our leaders in religious work must come from them as well. If we depend on secular schools and state institutions for our preachers and religious leaders, we may expect their spiritual life to be of a lower order, not only this but we cannot expect to have as many leaders as we need.

The Baptists of Arkansas have two great christian colleges, Ouachita (co-educational) at Arkadelphia and Central, for girls, 'at Conway. These schools, because of the high order of the work that they are doing, deserve our support. This is a critical time for Ouachita. We have at the head a noble, earnest, consecrated man of God who is doing his best, but who cannot make a school unless Arkansas Baptists help. We must pay the debt of \$20,000 or lose the college. Brethren, if you hav'nt done anything for this cause do it at once.

Report on Orphans' Home read by H. L. Atkinson, discussed and adopted REPORT ON ORPHANS' HOME.

We, your Committee on Orphans' Homes submit the following report: At the last Convention the Monticello Home raised about ten thousand dollars in pledges for the improvement of the property and the building of a dormitory. This three-story concrete building has been completed, the work being largely done by the boys in the home. We understand all the pledges have not yet been paid and this together with the current expenses make a pressing need that should be presented in all the churches to the end that the 186 children now being cared for there shall receive the necessaries of life.

The Texarkana Home was burned in the latter part of the winter. which misfortune greatly crippled them in the work this year. The debt had all been paid on this building, but having to rebuild leaves them with a debt of about \$15,000. They are now caring for about 41 children in the new home and should receive our hearty support.

Brethren, let us remember these institutions in our prayers and give liberally of our means to support them Fraternally submitted, H. L. Atkinson.

#### REPORT OF EXECUTIVE BOARD

Your board was unable to secure for the whole year such a man as we understood the Association wanted. We employed Bro. Sam Grumbles to hold meetings two months, agreeing to pay him \$75.00 per month, or \$100.00 per month if he collected it. He collected as follows: Enon, \$16.63; Bethlehem, \$32.90; Florence, \$11.01; Pleasant Springs, \$9.01; Hickory Grove, \$22.06; Holly Springs, \$18.30; Lone Grove, \$10.37; Cornerville, \$20.00; Star City, \$18.00; First church

Pine Bluff, \$24.25; total, \$182.53.

He reports: Miles 500, days 60, sermons 116, Baptisms 16, conversions 26, joined by letter 11, by statement 3, by restoration 3, homes visited 102. Sunday schools organized as result of meetings 3.

He says of his work: "While the visible results are not great, I hope the work which cannot be separated is great. The main object of our hasty campaign was to strengthen the churches and to get individual christians to consecrate themselves to God. I am sorry to say that many of our churches are in a low state spiritually, and church membership means very little. The time has come when we must lay greater stress on personal consecration to God."

Bro. Grumbles worked faithfully, and we recommend that he be

paid the \$17.47 which he lacked of collecting \$200.00.

We feel the need of a larger Board, but a quornm should be located at one place. During this year the membership of our Board was cut down to three, Bro. Wood having moved out of our bounds and our veteran, Bro. Overton, having passed to his eternal reward.

We recommend that the Association instruct the Board as to whether or not it shall accept help from the State Convention Mission Board.

#### AMENDMENT TO THE CONSTITUTION

ARTICLE 15. Five members elected by the Association, and one member selected by each church composing the Association any five of whom shall be a quorum; shall constitute the Executive Board, whose duty shall be to devise means to carry forward the benevolent object of the Association. The officers of this Association shall be ex-officio members of the Board.

Proposed for adoption and ordered printed in the minutes.

#### RESOLUTIONS

No 1. Resolved, that the board of this Association be requested to hold a meeting for its work in connection with our Fifth Sunday meeting.

Resolved, that we request each church of this body to elect some one of its members to attend each Fifth Sunday meeting as an advisory counsel to this Board of this Association.

Resolved, that pledges be made here to Associational Missions and that the Board endeavor to put a man in the field for as much

time as can be done.

Resolved, that mission work be done in places of real destitution; such as weak, pastorless churches and places where no Baptist preaching is being done.

Adopted.

- No. 2. Be it resolved, that the Association extend thanks to the Bethlehem church and community for the delightful hospitality in our entertainment. Adopted.
- No. 3. Be it resolved, that the Clerk of the Association be allowed \$20.00 for his services, and the remainder of the minute fund be used in printing and distributing the minutes. Adopted.

On motion the Association adjourned to meet with Pleasant Ridge Baptist church in Cleveland county, Arkansas, on Saturday before the Third Sunday in September, 1915.

## CONSTITUTION

1. This confederation of churches shall be known by the name of

"Friendship Regular Baptist Association.

2. The object of this association shall be to promote the glory of God on earth by the preaching of the Gospei of His Son, Jesus Christ, our Savior; by aiding in the support of missionaries who first have been called or God to preach the Gospel, and who feel impressed of the Spirit to do mission work and have been set apart to that work of the church to which they belong, (Acts 13:2-2); and by the universal spread of the Bible, the word of the true and living God, and by other and appropriate means in keeping with the Scripture.

3. The association shall consist of messengers from the churches now forming this union, and such other Baptist churches as may

hereafter be received as constituant members thereof.

4. Every church shall be entitled to three representatives without regard to the number of their members respectively; and to an additional one for every fifty members exceeding fifty, provided: that no church shall ever be entitled to more than five. A certificate of appointment or letter from their respective churches shall be evidence

that they have been so delegated.

5. The officers of this body shall be a Moderator and a Clerk, who shall be ex-officio Treasurer, who shall be elected annually by ballot by a majority of the members present, immediately after the names of the delegates are enrolled; which officers shall perform all the duties usually devolving on such officers, and to continue to exercise their respective functions until they shall be superseded by a subsequent election. Provided: No person shall be elected and serve as Moderator of this association more than two years in succession.

6 The clerk shall preserve a regular record of the association and have it present at the meeting of the body, and when he vacates the office, deliver the same with all other books and papers relative

to said office to his successor.

7. The association shall regard the churches as independent bodies in all internal affairs and to exercise no ecclesiastical jurisdiction or claim any legislative or judicial prerogative over them. Neverthe-

the association may exercise authority over its own members, the representatives of the churches, and have power to withdraw from and disown all churches which may depart from the gespel as understood and held by this body; by becoming either hetrodoxy in faith or disorderly in practice; and should, therefore, regard all the churches united in this association with a vigilant eye for good; and may give at its own discretion, and in its own way, advice or information when sought, to any church connected with it.

8. The association shall hold annual sessions, to convene on Saturday before the thir. Sunday in September in each year and not to adjourn until all the business shall have been regularly finished except circumstances imperiously demand. The place of meeting shall be determined at each previous session and published in the minutes.

9. Baptist churches not before united in this association may be admitted as members into this union on application by a written petition or letter presented by one or more messengers duly appointed by such church or churches; provided, that they give satisfactory ev-

idence that they are orthodox in faith and practice.

10. Every minister of the gospel, either ordained or licentitate whose membership is in or who may be a pastor of any church belonging to this association shall be ex-officio a member of this body with the privilege of offering resolutions and speaking but not voting unless specially delegated by the church of which he is a member.

11. When in session the association shall be governed by such

rules of decorum as it may adopt itself.

12. It shall be the duty of the churches, respectively, to report to the association their general condition, the number of members in fellowship, the number baptized, received by letter, dismissed, excommunicated, restored, dead, amount paid pastor in value during the year, and the names and each office address of all Ministers, whether ordained or licensed, designating each, and, also the name and address of their clerks. They shall also report on any special matters required, and send up contributions as they may willingly contribute to aid the body to disseminate more widely the truth as contained in the Holy Scriptures, and the establishment of the Redeemer's kingdom on the earth.

13. The neglect or failure of a church to be represented by a messenger or messengers in this association for three consecutive years shall be cause to withdraw from the church at the discretion of

the association.

14. This association may correspond by letter or messenger with

any other religious body of the same faith and order.

15. A board consisting of five members, any three of whom to constitute a quorum, shall be elected at each annual meeting, whose duty it shall be to devise means to carry forward the benevolent objects of the association, and the officers of this association shall be ex-officio members of the board.

16. The minutes of the association shall be publicly read and corrected, if necessary, and then signed by the moderator and clerk be-

fore the association adjourns.

17. Any amendment may be made to this constitution at any meeting of the association by a vote of two-thirds of the members resent; provided, the same shall have been published in the minutes of the preceding year.
