of the Forty-Eighth Annual Session of the Gainsville Missionary Baptist Association.

The Gainsville Missionary Baptist Association convened in its 48th annual session with Rock Hill Baptist church, Paragould, R. F. D., 10 o'clock a. m., Oct. 24, 25 and 26th, 1917. The moderator of the last session, Bro. J. D. J. Faulkner, and clerk. Bro. R. L. Lewis and pastor of Rock Hill church being absent, the association was called to order by Bro. W. R. McEwen, who entertained a motion for nominations for temporary moderator and clerk. Bro. L. J. Covington was elected moderator and W. O. Heath clerk. After singing by the association, Bro. W. R. McEwen conducted devotional exercise. The moderator then called for the church letters and appointed Brothers W. R. McEwen and G. R. Tyler to read them. The letters were presented and the messengars enrolled.

The next item on the program was the preaching of the annual sermon, Bro, A. Floyd Crittenden, selected for that purpose being absent, and also the alternate, Bro. H. E. Peters, Bro. L. D. Summers, of Blytheville, was selected, and he announced his text Matthew, 28:19-20. It was grand, -delivered with power and the lesson found a home in the hearts of many.

A committee on the order of business was appointed composed of Brothers Walden, Bishop and Standfield. After announcements were made, the body adjourned to 1:30 p.m.

FIRST DAY-afternoon session.

The association re-assembled at 1:30 p.m.

After singing by the association, motion made by Brother G. C. Jernigan that the association dispense with the regular order of business and elect a permanent moderator and clerk. Motion carried, and G. O. Light, of Paragould, and L. G. Covington, of Rector, were placed in nomination, and on a standing vote, the clerk announced: G. O. Light, 22 votes; L. J. Covington, 27 votes. Whereupon Brother Covington was declared elected moderator.

Motion that W. O. Heath, of Piggott, be elected clerk, by acclamation. Carried, and the said Heath declared elected.

Brother J. B. Walden was elected treasurer by acclamation.

Motion made and adopted that a committee be appointed to make a report on stewardship, and Bros. W. R. McEwen and W. K. Neeley were selected.

Report on associational mission duty read by Bro. G. C. Jernigan, secretary and treasurer of the associational missions, and approved. ASSOCIATIONAL MISSIONS.

We, your Executive Board, beg leave to make the following report:

After having studied very carefully the situation of the Gainsville Association, we found that to do our Master's duty, a missionary must be employed for full time This decision having been prayerfully made, Bro. L. J. Covington, of Mayfield, Ky., was elected on Dec. 31st, 1916, at a salary of \$75.00 per month, beginning Feb. 1st, 1917, and to continue until the meeting of the association.

In doing this, we fully realize that we have in some ways at least transgressed from the proceedings of the past, but we have at all times put the salvation of lost men and women as our first duty, remembering our Savior's words in Matthew 28: 19-20, when He said: "Go ye therefore and teach all nations, baptizing them in the name of the Father and the Son and the Holy Ghost, teaching them to observe all things what-so-ever I have commanded you; and lo I am with you allways even to the end of the world."

So strongly did your board believe this promise that the expenditure of money, which in so many instances retards the Lord's work, has not been in our way, and in doing what we felt He would have us do, we believed that He, through the Gainsville Association and the State Convention would stand squarely behind us in this work, and I am glad to say that He has, in that we can come to you to day and report the conversion of 60 lost souls, established one church, fifty baptisms, five additions by letter, over \$2000.00 having been collected for various purposes and the gospel having been preached in places where it was never preached before.

In saying that we have not let finances hinder us, I do not mean to sav that we have had in our posession all the money that we needed, but whenever Bro. Covington came to us for help, we made a note immediately and borrowed the money, and in this way the cause has not been hindered.

The Baptist State Convention has, indeed, been very kind to the Gainsville Association, in that it allowed \$30.00 per month on Bro. Covington's salary, for which this association should feel duly greateful.

It would be unkind of the board, perhaps, not to mention the

fact that some of the churches have not only stood behind us with their prayers, but their money as well, while others, I presume, have only remembered us with their prayers, if at all.

Bro. Covington, has, indeed, labored hard and in many instances and places, having met with almost every opposition that could confront a missionary on such a field, still he has driven constantly and patiently on until the dawn of a brighter day for this work is clearly seen.

Before closing this report, there is a matter relative to some claims which were presented to the board, to which I wish to call your attention.

The first claim was from Bro. J. R. Hall, for \$85.17; the next was from Bro. Merridth for \$25.00, and the last was from Bro. W. L. Pinkston for \$50.00, making a total of \$160.17. This was a matter that gave the board no little worry from at least three reasons. First, we took the work with not one penny in the treasury; second, that the report of the association showed that the association was free of debt and these claims were all for work done previous to the meeting of the association, third, we had all on our hands that we were able to carry to keep the work going with Bro. Covington.

From the fact that Bro. Hall had labored as a missionary on this field last year, and that his age would also demand our attention, we allowed his claim, and are glad to say that Marmaduke church paid \$55.00 of this amt.

The other claims were not allowed, and it was unanimously agreed that they should be presented to the association at its next regular meeting.

To the new board we could not do otherwise than to commend our present missionary to you in the very higest terms, and feel safe in saying that so long as he is on the field as a missionary our association will be carefully looked after.

SECOND DAY-Morning Session:

After song service, devotional exercises were conducted by Bro. L. J. Covington, and prayer lead by Bro. Robt. F. Liddell.

The Minutes of yesterday's session was read, corrected and adopted.

The Roll of the Messengers was called and revised.

The Report on Stewardship was presented by Bro. W. R. McEwen. REPORT ON STEWARDSHIP

Every human being of sound mind is a steward. The things that we possess are not our own. They belong to God; they are to be used according to God's will and for his glory; and to God each one must give an account of his stewardship. Whether the accounting shall be joyous or filled with disappointment depends on whether or not we have been good stewards. We are born into the

world as stewards. We may deny that we are stewards, but that does not change the fact just as it would not change the fact for us to deny that we are children of our parents.

This doctrine is as old as the human race, and the Bible is full of it. It applies to every single thing that we possess and to everything that we do. "What hast thou that thou didst not receive?" "A man can receive nothing exceqt it has been given him from heaven."—1 Cor. 4:7 & John 3:27. We are to administer all that we have "as good stewards of the manifold grace of God." -1 Peter 4:10.

We recommend and urge

That pastors preach often on stewardship, taking pains to 1 to teach the people what the Bible says on this subject.

2. That classes be organized in all our churches to study this vitally important doctrine. Books can be had for such classess free of cost, from J. S. Compere, 410 Donaghey Bldg., Little Rock, Ark.

That literature on stewardship and tithing be circulated and 3. read everywhere.

4. That every member of every church in this association strive to be a "good steward of the manifold grace of God."

Foreign Missions, and Sister G. L. Burns, of Jonesboro, on Committe on Woman's work.

Report on State Mission was presented by Bro. W. R. McEwen, STATE MISSIONS

Belief in missions is fundamental to Christianity. No organization can be a true church of Jesus Christ and not have the missionary spirit and not be engaged in the missionary effort. Just as a belief in Foreign Missions is the key to a belief in all missions, so activity in State Missions is the key to activity in all missions. The way for a Baptist church to become, "glorious, not having spot or wrinkle, or any such thing," is for it to be intensely missionary in both doctrine and practice.

State Missions is the united effort of Arkansas Baptists to win the people of Arkansas to Christ, and into Baptist churches. Both these things are fundamental and necessary: The first, to salvation; the second, to well rounded Christian life. In Arkansas the worth of a church to the Kingdom is very laregly expressed in attitude toward, and activity in State Missions.

It is a trite saying, but there is great destitution in all parts of the state. Just how great this destitution is, none but those best informed know, even approximately. It is safe to say that six-teen thousand souls go from Arkansas to hell every year. Thous-ands of these may be saved if we will but do our duty by State Many of them will never be reached through any other Missions. channell.

Reports for last year show the following interesting items.

Workers engaged, 65; conversions, 3,134; baptisms, 2,281; additions, 3,010; raised for State Mission, \$25,598. About seven hundred churches co-operated with our State Convention last year, and the total contributions were \$87,786.96, which about 6 per cent was used in expenses.

For this year there are more workers and the prospects are for a great increase along all lines of state work. To go to the Convention out of debt we must raise not less then \$30 000.00, and to meet some most pressing needs we want to raise lot less than \$40,000.00 by the first of next December.

In order that Gainsville Association come up to all expectations, your committee urges the adoption of the following recommandations:

-1- That every preacher and other Christian worker get, and be sure to disseminate all possible information on State Missions.

-2- That a strong committee be appointed to plan and put on and every church canvass on State Missions between now and the first of December 1917.

-3- That all the churches be asked to co-operate with this com mittee most heartily, and if at all expedient, put on an every member canvass, and thus make a determined effort to raise the amounts asked.

The report was discussed by Brethren W. R. McEwen, L. D. Summers, and Dallas Faulkner, and a request was made by the Moderator that every pastor. messenger, and member do all they can to raise the amount asked for in the report, by Dec. 5th, at which time the State Association will convene at Jonesboro, Ark. Report adopted.

Motion made that the moderator of this association appoint others to assist him in the collection of state missions. Motion adopted, and the moderator appointed Bros. J. R. Stanfield and A. M. Hall.

The sermon at 11 o'clock was delivered by Bro. J. S. Rogers, of Little Rock, state secretary. Song, Reading of the 1st chapter of Paul's letter to the Phillipians. Prayer, by Bro. Crocker. Song: "There is a Fountain." Text: Phillipian, 1, -1.27. The sermon was very instructive and inspiring. At the close of the sermon an offering was taken for state missions, and \$261.90 cash was raised, beside pledges that were made to be paid later. The association adjourned until 2 o'clock p. m.

AFTERNOON SESSION-second day

Song service, by the association. Prayer, by Bro. Hunter. Short talk by Bro. L. D. Summers on the Liberty Loan question.

Report on associational missions presented by Bro. E. G. Ward. Bro. L. J. Covington, as associational missionary, presented his report, together with report on associational missions.

REPORT ON ASSOCIATIONAL MISSIONS.

In as much as Jesus Christ said: "Go into all the world and preach the gospel to every creature," we believe that included Gainsville Association. Your committee is giad to report the good work on this field, but we realize that there is still a great work to be done. Your committee would offer the following recommendations: First: that each church and pastor co-operate with the associational board in their gifts and prayers. Second: that these gifts be sent to the treasurer of the board each month. Third: that each church have a workers institute some time during the year. Fourth: that the churches and pastors pray for and assist the missionary, whoever he may be, in all of his work.

We want to commend the board for its noble work, in that it has reported the board free of debt.

ASSOCIATIONAL MISSION BOARD:

Report of the aspociational board, by Bro. W. K. Neeley. Reported that the board had recently held a meeting and elected Bro. L. J. Covington as associational missionary for twelve months, at a salary of one hundred dollars per month. A vote was taken on the action of the associational board, and their report adopted.

Report of Missions presented by Bro. L. D. Summers, which is as follows:

Our Home Mission Board at Atlanta, Georgia, has the distinction of reporting yearly more converts and baptisms through the work of its missionaries

than have ever been reported by another Home Mission Board in America, though several of these expend more money than our Board does.

Our Board last year reported 37,724 baptisms, 22,945 of which were creditable directly to Home Missions, while the rest were creditable to co-operative agencies. Last year the total receipts of the Board for all objects were \$474,792, while the administrative costs were \$22,638, or only 4.7 percent. This suggests great economy in administration. While we applaud a wise economy, we must not forget that efficiency in secular business has nearly always required considerably larger administrative costs than this.

Our Board must not only wisely expend money; it must aid in nurturing and instructing the sources of its supply, which are among nearly 3,000,000 Baptists, most of whom belong to churches with only once a month preaching by absentee pastors. To do this service with any real effectiveness will necessitate some expense We would encourage our Board in incurring expenses required for efficiency.

The great world war is a challenge to every moral and spiritual resource in America. Hundreds of thousands of homes will experience a new soul-hunger, a new sense of need, in the giving of their sons to fight in the nation's armies for justice and democracy. The American farmer must feed the world. The farmer's church, already in need of inspiration and new methods that it may serve a new rural world, must be the center from which the farmer shall 'gain added understanding and courage to do his part for God and for country. Southern Baptists must do their full share to save and to serve the religious reeds of our American boys in the camps, and to protect them from the foul birds of prey that gather in the wake of every army.

Realizing that new and heavier burdens must in this crisis be borne by Baptists of the South in the Home Mission Field, the Southern Baptist Convention at New Orleans instructed the Board to pursue its work on the basis of an apportionment of \$505,193, and the annual meeting of the Board in June planned the year's work on that basis. It is the first time Southern Baptists have undertaken to raise half a million for Home Missions, but the abounding needs and opportunities call for it. Our Baptist people are prosperous. They can enjoy their prosperity without moral deterioration only by serving God and country and men with their substance. Patriotism and true religion call us to a large support of Home Missions.

In Evangelism and Church Building and Enlistment, in Cuba and Panama and the Southern Highlands, among Foreigners and Negroes and Indians, through co-operative missions in such needy States as New Mexico and Arkansas and Oklahoma and Louisiana and Florida, in cities and towns and countryside, our Board has a great work, and the pressing needs which grow out of the war are in addition.

We recommend-

1. That earnest prayer be made for the work of the Home Mission Board and that our pastors be asked to preach at least once during the year upon Home Missions.

2. That this Association approve of the action of the Southern Baptist Convention, which increases the apportionment for Home Missions by approximately 25 per cent, and put our apportionment at \$200.00 for the present fiscal year.

fiscal year. 3. That we apportion this amount among our churches and publish the apportionment in our minutes.

4. That our churches be encouraged to form mission study classes in "Baptist Missions in the South" and "Country Church in the South," the two unusually popular mission study books of the Home Board. Also that our churches order and make a larger use of the full and interesting lot of tracts about each phase of the work of the Board. The tracts are free on application. The books are, each, cloth 60 cents, paper 40 cents. All orders for literature or books should be directed to Publicity Department, Baptist Home Mission Borad, Atlanta, Georgia.

REPORT OF ORPHANS' HOMES.

Report adopted

The Pledges secured by Bro. W. T. Dorris the first day of the Association is hereto show in connection with the report of the Committee on Orphans' Home, as follows.

REPORT ON ORPHANS' HOME.

God, who is a 'Father to the fatherless'', has provided for the orphans. Visiting the widows and orphans in their affliction is declared to be 'pure and undefiled religion," In accord with God's plan we have been caring for the orphans at the Monticello Home for 22 years. More than 600 of these unfortunate children have shared a place in our Home.

Since January 1, 1916, we have securned homes in good families for more than 160 of these children. We now have 65 children in the Home. We are hoping to reduce the number to 50 by the Convention in December.

The debt on the Home July 1, 1917, was \$12,500. Our campaign to pay the debt by the Convention gives good promise of success. All of the current expenses of the Home amount to about \$750 a month.

The present management of the Home is entirely satisfactory; the farm has been well worked and a fine crop has been produced; the premises are clean and sanitary; and the children are, with probably the fewest exceptions in the history of the Home, well and happy. A strong religious sentiment prevails. Most of the children are Christians, a number of them having been received into the church the past year. We recommend: (1) Regulur monthly offerings in every Sunday School, and the amount forwarded promptly to J. S. Rogers, General Secretary, 410 Donaghey Building, Little Rock.

(2) That every church take as large an offering as possible and forward it to Brother Rogers.

(3) That every Woman's Missionary Society join in this debt-paying campaign and send their offerings in promptly to the general office.

Your committee on temperance submits this report. Realizing the importance of temperance we earnestly urge our people to give it a more careful study. During the last few decades we have been gaining victories over the liquor traffic. We have studied it out, prayed it out and voted it out, and knocked it out in a thousand places, until to-day 75 per cent of the population is in dry territory. Arkansas Baptists have always been in the front rank of battle. When we put our money in churches and schools and put our children in training for better citizenship, we will have a better and happier people. September 8th, 1917, was a great day for our cause, — liquor being outlawed in the nation. The way was thus paved for a complete victory. The abolition of liquor may come out of the war that is now being waged by people of the earth. We recommend that this association put itself on record against tobacco, and the undertaking of discouraging its use. thank God for the victories of the past, and earnestly pray that the day may speedily come when we can have peace and happiness, prohibition and plenty.

Report on Foreign Missions presented by Bro. G. R. Tyler. **REPORT OF FOREIGN MISSIONS**

Motion to recieve the report, Discussion, W. R. McEwen, L. D. Summers, W. K. Brunson, L. J. Covingtion. Report adopted. REPORT ON FOREIGN MISSIONS.

We your committee on Foreign Missions beg leave to report as follows:-Last year was the greatest year in Southern Baptist history of Foreign Mission achievement. A total of \$961,970.48 was raised, which included \$180,000 debt, amount contributed to Judson Centennial and to current support. This is the greatest advance ever made by any denomination in the South in contributions to Foreign Missions in a single year.

The expenses of the work was reduced by nearly \$10,000. 90.7 per cent of the money given was applied to the foreign field and only 9.3 per cent was required to meet all home expenditures. This should be satisfactory and gratifying.

6,347 converts were baptized, 12,930 students were enrolled in our schools, and missionary doctors treated 67,556 patients. We have at present 458 churches with 47,161 members. 115 of the churches are self-supporting. The members contributed last year \$132.371.05.

There is immediate and urgent need of a large number of missionaries for evangelistic, medical, school and other men-tal work. To meet this need the Board was able to send tal work. out but twelve missionaries at its Annual Meeting. This number is not one-fourth of the number needed. Of the 458 churches most of them have inadequate houses of worship, and more than onehalf of these have no houses at all.

Some devoted friends are giving the Board Liberty Bonds which they purchased to help their country, and others are investing in the Board's Annuity Bonds which pay good dividends. Such examples are recommended to all our people.

Truly all cannot make great contributions of money or buy Liberty Bonds, but every one can do as his or her bit by giving according as the Lord has prospered.

So brethern and sisters of this Association: let us rise from our knees of devotion with our hearts full of love and our hands full of blessings with onr souls aflame with an undying passion for lost souls, and go forth prsenting the great commission to carry the gospel to all the world from which obligation no follower of Christ is excused.

We earnestly hope that some influence shall be brought to bear upon the membership of our churches who are now indifferent to the importance of the Sunday schools, that they are as much responsible for the success of their church through the Sunday schools as any member. The matter of individual responsibility must be stressed tremendously in order to achieve the greatest efficiency as Christian workers.

We recommend that every Sunday school in our association establish a course in their school.

The great commission was to make disciples and "Teach them all things" and we earnestly recommend to every church that they support in heroic fashion their Sunday school and make it truly a teaching force in their church.
