OPENING SESSION, THURSDAY 7:30 P. M.

After a season of songs and touching prayers by many brethren of the Association, the Forty-Third Session of the Grand Prairie Association was convened by Moderator Brother H. B. Dudley, who, after devotional service introduced Brother L. H. Dodson, who had been appointed to preach the Introductory Sermon. Brother Dodson read the 23d Psalm, called Brother C. W. Fox to lead in prayer. Text: I. John 4:8. After a short and helpful sermon by Brother Dodson, the Moderator appointed a

which consisted of Rev. J. T. Fowlkes, the deacons of the DeVall's Bluff church, Brethren C. W. Fox, and W. H. Gregory. Said committee reported that Rev. G. W. Bray of Almyra, would preach Friday 11 a. m., and Rev. H. Y. Morris of Hazen, to preach at night. It was then moved and carried that the Association adjourn till 9 a. m. Friday morning. Benediction by Rev. Carl Sager of Gillett.

FRIDAY MORNING SESSION. 9:00 A. M.

The Association was re-convened at 9 a.m. by singing "Jesus Lover of My Soul;" prayer by Brother LaCotter, visiting from Tennessee. A committee on

Bray of Almyra preached an able and inspiring sermon, reading Is. 53, and a few verses from Heb. 12th chapter, taking for his text Mark 2:5.

AFTERNOON SESSION.

The Association was re-convened by songs, and prayer by Rev. R. P. Bain.

ELECTION OF OFFICERS.

Moderator – By a brief introductory, Rev. J. T. Fowlkes moved to suspend the rules and that the Clerk be instructed to cast the vote of the body for Brother W. H. Gregory of Hazen; motion carried, and the vote was cast. Brother Gregory was then introduced, and after a brief acceptance, took the chair.

Vice Moderator—Motion by J. T. Fowlkes to suspend the rules and ask the Clerk to cast the vote of the body for Rev. H. Y. Morris for Vice Moderator was carried, and the Clerk cast a unanimous vote for Brother Morris.

Clerk—It was moved by Brother Fowlkes to suspend the rules and the Moderator cast the vote of the body for W. G. Mathis for Clerk; motion carried, and the vote was cast.

Treasurer—It was then moved by Brother H. B. Dudley, and motion carried, to suspend the rules, and the clerk cast the vote of the body for brother J. H. Rounsavall for Treasurer.

REPORT ON CHRISTIAN EDUCATION.

The Committee on Christian Education asked to report, and report spoken to by Dr. J. W. Conger, and E. J. A. McKinney, both making strong speeches. Motion prevailed to adopt the report as read. Report follows:

Your Committee on Christian Education would report as follows:
Without well equipped schools all our Baptist work would suffer
and come to a standstill. We look to our Baptist schools for most of
our trained workers in pulpit and pew, as well as on mission fields.
Ninety-five out of every hundred of our foreign missionaries came from
Baptist schools. So Christian Education and its support must be put
on the same basis with missions.

Arkansas Baptists have two great Christian Colleges—Ouachita, for boys and girls, at Arkadelphia, C. E. Dicken, President; Central, for girls, at Conway, J. W. Conger, President. Last year Ouachita had 287 students, and Central had 205. These schools have rendered a service to the Baptists in Arkansas, the value of which can never be estimated.

We now have two mountain schools. One at Maynard, with W. A. Cummings as Principal, and the other at Mountain Home, with H.

F. Vermillion as Principal.

The education of preachers is one great object in Christian Education. The denomination that fails to provide for the education of its preachers will die as a denomination. Last year there were forty young preachers in Ouachita College, and several in the Mountain Home and Maynard schools. They receive free tuition, and some help on other expenses when it is necessary. The Bible is required of all who graduate of both colleges.

This committee recommends that all of our preachers preach often each year on the needs and benefits of Baptist schools, that every church in the Association will make a good offering for our schools and for the education of young preachers this year, and give to the Loan Fund for our girls in Central College, and that our people

will send their children to our Baptist schools.

TEMPERANCE.

The report on Temperance was read by Brother J. L. Brown, and

spoken to by himself. Report adopted, and follows:

We, your Committee on Prohibition, submit the following as our report. We are glad to say that the Baptists as a people have always stood against the whiskey traffic, and have had no small part in the fight that has been waged against it through the years that have gone, and that we as a people rejoice in the fact that after the long drawn-out battle—the serpent—the whiskey traffic—with his trail of slime and death, has been driven from both our State and Nation. No longer can the black-winged Vulture of hell—the saloon traffic—roost, or build its nest beside our American Eagle with the Stars and Stripes of Old Glory floating over it for protection.

With prayers and shout We've driven it out, From both our state and nation; No more can rum in ruin come With licensed regulation.

In conclusion we recommend that this Association of Baptist churches petition President Wilson to do all in his power to prevent the manufacture and sale of all intoxicants during this war.

EVENING SESSION

Convened at 7:15 by singing, "Count Your Blessings," and prayer by E. J. A. McKinney. Rev. D. A. Gregory, Pastor of Stuttgart church, was then introduced and acknowledged a member of the Association.

Request by Brother Morris, that he be excused from preaching at this hour, and that Rev. J. L. Brown be appointed to that place, request was granted, and Brother Brown was introduced, and read the 13th chapter of First Cor., and used for his text the 13th verse, and preached a very strong sermon.

The report on Associational Missions was then called for, and was read by W. G. Mathis, and spoken to by himself, and Brother R. P. Bain. It was then moved and seconded to amend the report by inserting a resolution of the Executive Board, read by the Clerk, removing the restrictions on the Missionary which did not allow him to go to the churches of the Association, except where such were pastorless. The amendment was never called up, and the vote was not taken on the amendment.

The Divine Service Committee announced at this time the Rev. E. J. A. McKinney should preach at the 11:00 o'clock hour Saturday morning.

ASSOCIATIONAL MISSIONS REPORT.

We, your Committee on Associational Missions, beg to submit our report. Associational Missions is doing mission work in the bounds of a given Association. The cause for Associational Missions is destitution. Until we reach that point when there is a Baptist church in every community in the bounds of Grand Prairie Association, and every church has a pastor, then and not until then should we consider letting up on Associational Missions.

Our destitution is great. We have our great waving rice fields, our cotton and corn acrages, and the various well developed enterprises which are prospering to a remarkable degree; the various other denominations of our district are prospering, and many of them are rapidly spreading their doctrines over our bounds; but we, as Baptists, are doing less according to our ability and advantages for our Master

than many of them.

We need and recommend the employment of an efficient missionary for full time. We need co-operation of the churches and preachers in forwarding the doctrines of Christ as taught by Baptists. We recommend also, that each pastor preach regularly on Associational Missions, and appeal to their churches to pray for and pay to this work. We further recommend that each church insert in their letters to the Association just what amount they can be depended on to give to Associational Missions for another year.

ORPHANAGE REPORT.

This report was read by Brother H. B. Dudley, and spoken to by H. B. Dudley, J. T. Fowlkes, W. G. Mathis, Mrs. Emma Ketchum, J. L. Brown, E. J. A. McKinney, W. H. Gregory, Mrs. Nicholson, and Brother LaCotter. Report adopted and follows:

God, who is a "Father to the fatherless," has provided for the care of the orphans. "Visiting the widows and the orphans in their afflictions" is declaired to be "Pure and undefiled religion." In accord with God's plan we have been caring for the orphans at the Montecello Home for 22 years. More than 600 of these unfortunate children have shared a place in this Home while a large number of others have been cared for in the Texarkana Home.

Since January 1, 1916, there have been secured homes in good families for more than 160 of these children from the Montecello Home, and there are now 65 children in the Home. It is hoped to reduce this to 50 by the meeting of the Convention in December. In the Texarkana Home there are some 40 children now.

The debt on the Montecello Home July 1, 1917, was \$12,000. The campaign to pay the debt by the Convention gives promise of success. All of the current expenses of this Home amounts to about \$750 per month. About \$2,000 is needed by January 1, in order to pay all debts on the Texarkana Home, besides current

expenses.

The present management of the Montecello Home is entirely satisfactory; the farm has been well worked and a fine crop has been produced; the premises are clean and sanitary; and the children are, with probably the fewest exceptions in the history of the Home, well and happy. A strong religious sentiment prevails. Most of the children are Christians, a number of them having been received into the church last year. At Texarkana the children are reported to be in excellent health and well cared for in every way. We recommend,

(1). Regular monthly offerings in every Sunday school, and the amount for-

(1). Regular monthly offerings in every Sunday school, and the amount forwarded promptly to J. S. Rogers, General Secretary, 410 Donaghey Building, Little Rock, for the Montecello Home, and to J. W. Sims, Marvel, Ark., for the Texar-

kana Home.

(2). That every church take as large an offering as possible and forward it as

per the wishes of the donor.

(3). That every Woman's Missionary Society join in this debt-paying campaign and send their offerings in promptly to the proper authorities.

(4). That offerings be taken in every church for this purpose. Every Baptist is expected to do his part for the orphans.

As servants of our Lord each of us needs to know all he possibly can about the work of our people so as to wisely use our means and energy to the highest glory of our Lord. In Arkansas we have two State wide bodies doing mission work, and each has its own State paper.

Those desiring to know about the work of the State Association, the Baptist and Commoner is printed at Little Rock at the price of \$1.50 per year. The Baptist Advance represents the work of the Arkansas Baptist State Convention, and is published at Little Rock, also at the the price of \$1.50 per year. The Baptist and Commoner also carries a stock of Bibles and books, while the Baptist Book House, owned and controlled by the Arkansas Baptist Convention with the Baptist Advance carries a full line of Books and Bibles. We would urge the patronizing of our own book houses and Sunday school literature.

AFTERNOON SESSION. 1:30 P. M.

In the absence from town of Moderator Gregory, we were reconvened with J. T. Fowlkes in the chair. The letters of New Hope and Humphrey were then read, having arrived since last reading, and messengers seated, and appear in the list of churches and messengers. Later Corinth, by letter.

HOME MISSIONS.

Report read by E. J. A. McKinney, and spoken to by himself, and J. T. Fowlkes. Report adopted as read. Report follows:

Our Home Mission Board at Atlanta, Ga., has the distinction of reporting more converts and baptisms through the work of its missionaries than any other Home Mission Board in America, though several

of these expend more money than our Board does.

This Board last year reported 37,724 baptisms, 22,945 of which were creditable directly to Home Missions, while the rest were creditable to co-operative agencies. Last year the total receipts of the Board or all objects were \$474,792, while the administrative costs were \$22,-338, or only 4.7 per cent. This suggests great economy in administration.

The great world war is a challenge to every moral and spiritual resource in America. Hundreds of thousands of homes will experience a new soul-hunger, a new sense of need, in giving of their sons to fight in the nation's armies for justice and democracy. Southern Baptists must do their full share to save and serve the religious needs of our American boys in the camps, and to protect them from the temptations that gather in the wake of every army.

Realizing that new and heavier burdens must in this crisis be corne by Baptists of the South in the Home Mission Field, the Southern Baptist Convention at New Orleans instructed the Board to persue its work on the basis of an apportionment of \$505,193, and the annual meeting of the Board in June planned the year's work on that basis. Our Baptist people are prosperous. They can enjoy their prosperity without deterioration only by serving God and men with their substance. Patriotism and true religion call us to a larger support of Home Missions.

In Evangelism and Church Building and Enlistment, in Cuba and Panama and the Southern Highlands, among Foreigners and Negroes and Indians, through co-operative Missions in needy States, in cities and towns and countryside, our Board has done a great work, and the pressing needs which grow out of the war are in addition. We recommend:

(1). That earnest prayer be made for the work of the Home Missions, and that pastors be asked to preach at least once a year

upon Home Missions.

(2) That this Association approve the action of the Southern Baptist Convention, which increases the apportionment for Home Missions by approximately 25 per cent, and do our part toward raising it.

3). That we urge every church to contribute to Home Missions.

(4). That our churches be encouraged to form Mission study classes in "Baptist Missions in the South," and "Country Church in the South," also, that our churches order and make a larger use of tracts telling of each phase of Home Missions. The tracts are free on application. The books are, each, cloth 60 cents, paper 40 cents. All orders for literature or books should be directed to Baptist Mission Rooms at Little Rock, or C. C. Winters. The State Association has several Home Missionaries. Funds for its Home Mission work should be sent to C. C. Winters, Treasurer; McNeill, Ark.

OBITUARY OF BROTHER R. H. PARKER.

Brother R. H. Parker was born in Talbert County, Ga., April 13. 1839, and moved to Arkansas while a young man and settled in Arkansas County, lived there and raised his family on what is now known as the Parker Place. He donated or gave the ground for the Big LaGrue Baptist Church, on which it now stands.

He was a consecrated Christian, and was Moderator of the Association for 12 or 15 years in which he lived. In his last days he refused to be Moderator and asked that the Association elect another

in his place.

He was a beloved citizen in his county, both in moral, political. social and religious life. He has served his county, as Representative: he has served his county as Judge; he never missed the attending of Grand Prairie Association while he lived but once, then he was County Judge, and County Court was in session. The church to which he belonged was Big LaGrue. The church has lost a consecrated working member; the county in which he lived was Arkansas, and it has lost an honorable, noble citizen; the community in which he lived has lost a man much beloved, a friend that has been much regretted. If he had an enemy it was because his life out-shown theirs. "Owls and bats don't like the rising sun." Brother Parker is gone but not forgotten.

"Blessed are the dead which die in the Lord, from henceforth vea saith the Spirit, that they may rest from their labors, and their works do follow them."

STATE MISSIONS.

The report on State Missions was read and adopted, and discussed by Brothers L. H. Dodson, J. L. Brown, R. P. Bain, W. J. Johnson, Sister H. B. Dudley, W. G. Mathis and J. T. Fowlkes. Report follows:

We, your committee on State Missions, submit the following report: By State Missions we mean the mission work carried on by our two Baptist State bodies, the State Convention, and the State Association. It is the purpose of these two hodies of Baptists to supply all the destitute parts of our State with Baptist

preaching. To do so they must have the co-operation of our Baptist churches throughout the State. Every Baptist is a freeman, and as such has a right to put his money where he thinks it will accomplish the most good; and no man or set of men has any right to tell him not to do so. Therefore we recommend every Baptist embraced within this Association to do all they can to push forward the State work of evangelization until the communities now manteld with darkness may see the light of Baptist truth. All funds contributed to the State Convention, send to J. S. Rogers, 410 Donaghey Bldg., Little Rock. All funds contributed for the State Association, Brother J. A. Smith, Little Rock.

After a warm yet friendly discussion of State Missions, it was moved by Brother W. J. Johnson that we take a collection for the soldier boys at Camp Pike; motion carried, and a collection was taken. amounting to \$25.00, and the Treasurer was instructed to send same to J. S. Rogers, Little Rock.

It was then moved and carried that we offer a special prayer for the soldiers at Camp Pike, and for the Nation. A season of warm-

hearted prayers followed.

FOREIGN MISSIONS.

The report on Foreign Missions was then read by Brother B. F. House, and spoken to by Brother R. P. Bain and Sister J. T. Fowlkes. Report adopted as read and follows:

We, your committee on Foreign Missions, submit the following report: The Southern Baptist Convention and the General Association are both engaged in Foreign Mission work and both report progress in their work. For full information concerning their work, we refer you to the Minutes of these two bodies. No man can believe and obey the Commission of our Risen Lord without taking part in sending the Gospel to the nations of the earth. Therefore, we recommend, the churches of this Association to aid in supporting by prayers and contribution the Gospel in foreign fields.

CONSTITUTION.

ARTICLE 1.—This body shall be known by the name of the Grand Prairie Baptist Association, and composed of members chosen by the different churches in the union, who, on producing letters, shall be entitled to seats; also the ordained ministers in good standing, retiring Moderator and all Committees appointed at one session to report the next.

ARTICLE 2.—The motto of this Association shall be: "The truth in its

purity, preached in every section of our bounds."

ARTICLE 3.—The letters from the churches must state the number of members baptized, received by letter, restored, dismissed by letter, excluded, the name

and postoffice of pastor and clerk.

ARTICLE 4.—The members thus chosen and convened shall have no power to infringe on any of the rights of the churches, but may act as an advisory council for the common good of all the churches and advancement of the Redeemer's Kingdom, and have power to exclude any church from her fellowship which may depart from the gospel of Christ, either in faith or practice.

ARTICLE 5.—Every church composing this Association shall be entitled to

three delegates.

ARTICLE 6. Should any church fail to represent herself for two consecutive years, she may be dropped from the list of churches, should a satisfactory reason be not given.

ARTICLE 7.—New churches may be admitted into this body who petition by letter and delegates, if found to be sound in faith and in good order, the reception to be manifested by the Moderator giving the right hand of fellowship to the messengers,

ARTICLE 8.—This Association shall annually elect a Moderator from among nemselves whose duty it shall be to see that the Rules of Decorum are observed, ad take the voice of the Association on all questions properly brought before it; so, a Vice Moderator, and a Clerk, whose duty it shall be to keep a correct re-rd of all the business of the Association; also a Treasurer, to receive and disirse the funds sent up to the Association, as directed by the body, or churches nding the same.

ARTICLE 9.-It shall be the duty of the Clerk of this Association to retain the Minutes the names of all churches admitted to membership, until such are opped by action of the Association; and in cases of non-representation; it shall his duty to write: "Not Represented," in the proper place opposite their

mes in the statistical table.

ARTICLE 10.—This Association shall in all cases be governed by a majority the members present, except in the reception and dismission of a church, which all be unanimous.

ARTICLE 11.—This Association may correspond with other Associations and

onventions as may be agreed upon while in session.

ARTICLE 12.—It shall be the duty of the Association to appoint a minister preach an introductory sermon, with an alternate; also one with an alternate to each a missionary sermon at each succeeding session; and to fix the time and ace for the next meeting of the body.

ARTICLE 13.—The messengers assembled shall elect the missionary, and the oderator shall appoint, at each session, an Executive Board, consisting of at st one member from each church, whose duty it shall be in case a vacancy ocrs between the sittings of the Association, to elect and employ a missionary or ssionaries.

ARTICLE 14.—This Constitution may be altered or amended at any time, by a two-thirds vote of the members present, except that clause in the fourth article which prohibits interference with the internal rights of the churches, which shall forever remain intact.

ARTICLE 15.—The Minutes shall be signed by the Moderator and Clerk.

RULES OF DECORUM.

ARTICLE 1.—The Association shall be opened by singing and prayer. ARTICLE 2.—The Moderator, Vice Moderator, Clerk and Treasurer shall be elected by ballot by the members present.

ARTICLE 3. - The Moderator shall be considered the judge of order, but any

member not satisfied with his decision may appeal to the body.

ARTICLE 4.—The Moderator shall be entitled to the privilege of speaking as

other members, but not to vote, unless it is a tie.

ARTICLE 5.-All questions shall be introduced by motion, and if seconded, shall be open for discussion, unless withdrawn by the mover or his second. When a subject has been discussed a reasonable time, the Moderator shall, when the question is called for, proceed to take it by calling for the yeas and nays, and if a call for a division is made, he shall call for a standing vote.

ARTICLE 6 .-- Any member wishing to speak shall rise and address the Moderator. Only one shall speak at the same time, and shall not be interrupted while

speaking unless he depart from the subject or make personal reflections.

ARTICLE 7.—No person shall speak more than once upon any subject until all who wish to speak have had an opportunity, nor more than twice without per-

ARTICLE 8.—Every subject introduced for discussion shall be decided before another is offered, unless it be laid over by motion, with the consent of the mover

and the Association.

ARTICLE 9.- The names of messengers shall be called whenever the Association shall direct, and absentees marked. Any member wishing to retire shall obtain permission from the Moderator.

ARTICLE 10.—The appellation of "brother" shall be used in addressing each

other.

ARTICLE 11.—Any member violating the rules shall be subject to reproof by the Moderator.

ARTICLE 12.—Amendments or alterations may be made to these rules when

a majority may deem it necessary.

ARTICLE 13.—Any case coming before the Association not provided for in these rules shall be governed by general parliamentary rules.
