Rules of Decorum.

1. The Association shall open and close with prayer.

2. The introductory sermon shall be preached by a minister chosen by ballot at the preceding association. In case of absence or failure, the sermon to be preached by an alternate chosen at the same time and in the same way. Some brother shall also be chosen to deliver a temperance address.

3. A committee of arrangements, consisting of five members, besides the moderator and clerk, who shall be ex-officio members, shall be appointed by the moderator to arrange and report the order of business.

4. Visiting brethren who are in good standing may be invited to seats but not to vote.

5. A member not satisfied with any decision of the moderator may make an appeal to the Association on the same day, but at no other time.

6. But one member shall speak at a time, who shall rise, address the moderator, and upon obtaining leave, shall proceed.

7. No member shall be interrupted while speaking, unless he depart from the subject or use words of personal reflection, and then by the moderator.

8. Every motion made and seconded shall come under consideration of the Association by yea and nay or otherwise.

9. A member wishing to retire shall obtain permission from the moderator.

10. No member shall speak more than twice on one subject without permission from the moderator.

11. The appellation of "brother" shall be used in the Association by the members in their addresses one to the other. Titles that are unknown to the Scripture, such as "Reverend," "Parson," and the like, shall not be employed nor appear upon the minutes.

12. The names of the members shall be called as often as the Association may direct.

) 13. The moderator shall be entitled to the same privilege of speaking as any other member, provided he appoints another to his seat during the time, but shall not vote on any question unless the Association is equally divided.

14. Any person violatingthese rules may be reproved by the moderator at discretion, but only on the day the breach shall have been made.

15. These rules may be amended or altered at any regular meeting of this Association by a majority vote of the members present.

Constitution.

Article I. This Association shall be known as the Concord Association. Article II. It shall be composed of Messengers from Baptist churches known to be in good standing. Each church with fifty members or less shall be entitled to three Messengers.. Each additional fifty shall entitle the church to one additional Messenger.

Article III. The officers shall be Moderator, Vice-Moderator, Clerk, and Treasurer, who shall be chosen by ballot at each annual session and shall continue in office until their successors are chosen.

Article IV. Section 1. It shall be the duty of the Moderator to preside over the body according to parliamentary usage, and in absence of Moderator, Vice-Moderator to assume said duties.

Sec. 2. The Clerk shall keep a correct record of the proceedings, attend to the publication and distribution of the minutes, keep a regular file of the printed minutes of the body and deliver the same to his successor in office.

Sec. 3. The Treasurer shall take charge of the funds of the Association, or its Executive Committee, and render account of the same to the annual session of this body.

Article V. The object of the Association shall be to promote fellowship among the churches; to secure unanimity of faith; to encourage concert in operation, and especially to cultivate the piety of the churches; and to aid in this last object, several minutes of each session shall be spent in devotional exercises.

Article VI. Section 1. This Association shall in no case interfere with the internal regulations of the churches, but will act as advisory counsel whenever it shall be necessary.

Sec. 2. It, however, claims authority overity own members, the Messsengers from the churches, and will withdraw-from and disown all churches that depart from the principles of this compact by becoming heterodox in faith or disorderly in practice:

Article VII. Newly-organized churches, or churches dismissed from other Associations may be admitted into this body upon application, by letter and Messenger at our annual meeting, and subscribing by our Messengers to the abstract of principles herewith published.

Article VIII. Churches may be dismissed from the Association, upon application at the annual meeting for the purpose of joining other Association, but any church departing from us without being regularly dismissed, shall be regarded as disorderly.

Article IX. Section 1. There shall be an Executive Committee, consisting of the officers of the body with five members chosen by the Association at each annual meeting. The duty of the committee shall be to superintend the missionary operations of the Association, and represent it in all ratiers requiring their attention when the Association is not in session. Three members of said committee shall contitute a quorum for the transaction of business. Upon appointment, said committee shall come together and arrange their meeting and take such other steps as may be to the best interests of the cause of Christ.

Sec. 2. The regular committees of this Association shall be as follows: Foreign Missions, Home Missions, State Missions, Associational Missions, Sunday School Missions, Educational, Ministerial Support, Prohibition, Religious Literature, Digest of Letters, Nominations, Queries, Finance, Order of

Business Woman's Work, Orphans' Home and Obituaries.

Article X. It shall be the privilege of the Association, through its executive committee, in addition to the power already granted, to conduct missionary operations within its limits, and for this purpose to choose a missionary or missionaries as means may allow, and designate the field of labor and pay them monthly through its Treasurer out of any funds in its hands, except the money sent for publishing the minutes of every annual meeting.

Article XI. The annual meeting of Association shall begin at 10 o'clock a. m. on Thursday before the fourth Lord's Day in September. The introductory sermon shall be preached at 11 a. m. on the same day. On each succeeding day the Association shall adjourn at 11 o'clock for preaching.

Article XII. This Constitution may be altered or amended, except as to Article VI, Section 1, at any regular meeting of the Association by a twothirds vote of the members who are in attendance.

Amendments to Constitution.

1. No person shall serve as Moderator of this body more than two terms in succession. Adopted 1882.

2. The Constitution shall be published annually in the minutes of the Association. Adopted 1893.

3. Missionary sermon is placed in the hands of the Committee on Divine Service. Adopted 1894.

4. Each church is expected to send to each annual meetingof the Association, by the hands of its Messengers, a sum of money to be used for printing minutes. Adopted 1395.

5. All moneys collected by the Association during its several sessions shall be under the control of this Association.

6. The introductory sermon shall be preached at 11 o'clock on the first day of the annual session. Adopted 1910.

7. It shall be composed of Messengers from Baptist churches known to be in good standing. Each church with fifty members or less shall be entitled to three Messengers; and all ordained ministers belonging to said churches are Messengers without election. Each additional fifty members shall entitle the church to one additional Messenger. Adopted 1905.

8. That there be appointed a Committee on B. Y. P. U. Work. Adopted 1914.

9. The preaching services on Monday at 11 o'clock be dispensed with. Adopted 1914.

10. Created office of Vice-Moderator.: Adopted 1920.

11. Changed meeting to 10 o'clock, a. m., Thursday before the fourth Lord's Day in September.

Articles of Faith.

1. We believe there is one and only one true and living God, Jehovah, and that in unity of the God-head there are three persons, the Father, the Son and the Holy Spirit.

2. We believe that the scriptures of the Old and New Testament are the words of God, constituting the only all-sufficient standard of Faith, Dostrine, Discipline and Practice.

3. We believe that election is the sovereign exercise of the eternal love by which God has, according to His infinite wisdom, chosen His people in Christ before the word was, and has predestined them unto the adoption of the children through sanctification of the Spirit and belief of the truth, and doth keep them by His power through faith unto salvation.

4. We believe that man was created holy, but by wilful violation of the law of his Maker, he fell into a state of sinfulness and brought death upon his race, who being by natural descent in the unholy image of Adam, are children of wrath by nature, and without matural or spiritual power to live a holy life or attain to a happy state.

5. We believe that sinners are saved by grace through faith in Jesus' Christ and in no other way.

6. We believe that in order to be saved sinners must be regenerated or born again, that regeneration is affected by the power of the Holy Spirit, in connction with divine truth and the conditions thereof are repentance and faith, the evidence thereof love to the brethren.

7. We believe that such only are believers as endure unto the end in holiness of life, and are kept by the power of God through faith unto salvation.

8. We believe the scriptures teach that repentance and faith are sacred duties and also inseparable graces wrought in our souls by the regenerating spirit of God.

9. A Christian church is a congregation of immersed believers who meet statedly and have covenanted together to maintain the ordinances of Christ, discharge the duties and enjoy the privileges of the New Testament appertaining to the church of Jesus Christ.

10. The only and proper offices of Christian churches are bishops (or pastors) and deacons.

11. Christian baptism is the immersion of a believer in the name of the Father, Son and Holy Spirit by a regularly ordained Baptist minister in good order.

12: The Lord's Supper isapo sitive and commemorative ordinance of Jesus Christ, to be observed in the church as such inremembrance of Christ and to show forth His death until He comes.

13. The first day of the week is the Lord's Day, and should be observed as a day of rest from common labor and all worldly business and devoted to religious duties.

14. We believe in the resurretion of the dead and in a general judgment, and that the felicity of the righteous and the punishment of the wicked shall be etornal.

Constitution and By-Laws of the Woman's Missionary Union Auxiliary to the Concord Association.

Article I-Name. This organization shall be known as the Woman's Missionary Union Auxiliary to the Concord Baptist Association.

Article II-Object. The three-fold object of the Woman's Missionary Union shall be:

1. To distribute Missionary information and stimulate effort through the local societies.

2. To secure the earnest, sympathetic co-operation of women and young people in collecting and raising money for missions.

3. To encourage organized and definite personal service.

Article 111-Officers. Section 1. The officers shall be the Superintendent, First Vice-Superintendent, Second Vice-Superintendent, and a Secretary-Treasurer.

Sec. 2. The Executive Committee shall be composed of the officers of the Union and the President of each society or her substitute.

Sec. 3. The Superintendent and Vice-Superintendents shall be the Program Committee.

Article IV—Annual Meeting. The annual meeting for the election of officers, transaction of business, and the rendering of the annual program shall be held each year at such time and place as may be determined at the previous annual meeting or by the Executive Committee.

Article V—Representatives at the Annual Meeting. The officers of the W. M. U. and delegates duly elected by the local societies shall be entitled to vote. Each society shall be entitled to five delegates and one additional for each organization fostered by the local society.

Article VI-Conduct of Meetings. Every session of the W. M. U. shall be opened and closed with devotional services.

Article VII—Amendments. The Constitution may be altered or amended by a two-thirds majority vote, at any annual meeting, a month's previous hotice having been sent through the Secretary to each local society.

BY-LAWS.

Articlel—Superintendent. The Superintendent shall preside at the annual meeting of the W. M. U. and at all meetings of the Executive Committee; shall appoint all committees not otherwise provided for. She may, through the Secretary, call special meetings of the Executive Committee, when in her judgment needful or at the request of five members of the Committee. It shall be her duty to keep in close touch with all societies by letter, or otherwise, and do all in her power to promote the work of the kingdom in the Association. All reports shall be sent to her from the societies and she shall report quarterly and annually to the State Secretary of the W. M. U. In her absence the First Vice-Superintendent shall preside in her place.

Article II-First Vice-Superintendent. The First Vice-Superintendent shall preside at all meetings in the absence of the Superintendent; shall be

expected to attend the annual meetings of this body. It shall be her specific duty to do the field work and enlistment work of the Association.

Article 111—Second Vice-Superintendent. The Second Vice-Superintendent shall preside at all meetings in the absence of the Superintendent and First Vice-Superintendent. She shall be expected to attend the annual meeting of this body. She shall be Superintendent of the Young People's Work in this Association:

Article IV—Secretary-Treasurer. The Secretary-Treasurer shall receive all funds paid into the Association for expenses; shall keep accurate records of the annual and special meetings of the W. M. U. and Executive Committee. She shall perform the other duties usual to her office.

Article V—Nominating Committee. The Nominating Committee, composed of five members, shall be elected from the floor at the beginning of each annual meeting. Only one member of this committee shall be allowed from any society.

Article VI—Amendments. The By-Laws may be altered or amended by a two-thirds majority vote at the annual meeting, one month's previous notice having been sent through the Secretary to the local societies.

PROCEEDINGS

Charleston, Ark., Sept. 26, 1920.

The fiftleth session of Concord Baptist Association of Arkansas met with Charleston Baptist Church, September 26, 27, 28. Called to order at 10 a. m. by Moderator W. J. Hinsley of Booneville.

Devotional services were led by E. Rawlings of the Clear Creek Association.

The order of business submitted by B. V. Ferguson was adopted and the Association organized by electing the following officers: B. V. Ferguson, Moderator; E. A. Spiller, Vice Moderator; W. A. Booker, Clerk; and C. F. Spiller, Treasurer.

W. J. Hinesley delivered a forceful address upon the breaking down of the Inter-Church Movement, and the glorious achievement of the 75 Million , Campaign.

By appointment, Brother Wilkins presented the new Moderator, B. V. Ferguson, who addressed the Association in his usual forceful way, impressing the churches that they expected to put the most into the next year's work. They would earnestly and faithfully strive to advance the Lord's work throughout the bounds of Concord Association.

Called	0 order by Moderator

After invocations by W. A. Booker-and D. W. Bryan, devotional services were conducted by B. V. Ferguson.

Moderator extended greetings to the following visitors: E. Rawlins, Ciear Creek Association; Robert Rennic, Dardanelle Association.

Dice Moderator E. A. Spiller was called to the chair, and B. V. Ferguson and other Messengers spoke on the subject of the petitionary letter from Hackett Baptist Church, transferring that church from the Buckner to this Association.

Motion to receive the Hackett Church and seat Messenger, J. W. Comer, was unanimously adopted.

After spirited discussion of the proposed organization of a new association in Sebastian County by the following Messengers: B. V. Ferguson, D. W. Eryan, J. W. Comer, W. J. Hinsley, W. A. Booker, P. C. Mays and O. O. Davis, the following resolution, offered by B. V. Ferguson, was unanimously adopted:

"Whereas, There has been an effort to form a county association in Sebasilan County; and,

"Whereas, The churches in Sebastian County have been urged to withdraw from the Concord Association for the purpose of forming the said Association; be it

'Resolved. That we urge all the churches in the Concord Association to remain with the Association and hold our present work intact. That we deem the movement to organize the Sebastian County Association untimely, inexpedient and impractical."

Passed unanimously by the Association in session at Charleston.

After motion prevailed, a committee, consisting of W. J. Hinsley, B. V. Ferguson and O. O. Davis, was instructed to write all churches within the bounds of Concord Association not represented in this session, asking that they affiliate with Concord Association.

REPORTS.

Woman's Work.

• After discussion by Mrs. C. W. Hall, Mrs. B. V. Ferguson, W J. Hińsley, H. M. Wells, D. W. Bryan, the following amended report on Woman's Work was adopted:

The Committee on Woman's Work submits the following report:

The Concord W. M. U. Auxiliary to the Concord Association is composed of thirteen societies, two Young Woman's Auxiliaries, one Royal Ambassadors, cne Girls' Auxiliary and four Sunbeam Bands.

The total contributions this year are \$13,126.15, a gain of \$5,208.00 over that of last year.

During the past year in these thirteen woman's societies there have been held twenty-five mission study classes. Practically all of these societies have regular/Bible study. Under the leadership of our personal service superintendent the personal service work has greatly increased.

Our Key Women in the four districts have brought us in closer touch with the churches in our Association, and their needs are brought more clearly before us.

Our churches need a consecrated woman giving her full time in enlisting and developing our women. We recommend, therefore:

1. That as soon as expedient a trained woman be employed to work with our associational missionary among our women and young people, organizing and training them.

2. The expense of this year be paid by the Association instead of being prorated among the societies.

Prohibition.

Report on prohibition was discussed by H. M. Wells, P. C. Mays and J. S. Compere, and adopted as follows:

We, your Committee on Prohibition, beg leave to submit the following report:

Whereas, The results of our State prohibition laws are becoming more ... manifest to all sound-thinking and God-fearing Baptists each day, it, therefore, becomes the duty of all Christians to, on every occasion, raise their voice against any lack of law enforcement against bootlegging and other lilegal means of disposing of the harmful liquors.

We therefore, recommend that all our churches keep constantly before their people the fact that the battle is only half fought in the passage of the Eighteenth Amendment unless we demand the rigid enforcement of laws.

Orphans' Home.

Orphans' Home report adopted, after being discussed by P. C. Mays and J. G. Lyle.

We, your Committee on Orphans' Home, beg leave to report as follows:

We have two Orphans' Home, one at Monticello and one at Texarkana. The Home at Monticello has cared for about 1,000 children. Many of these have gone our into various walks of life, and are making useful men and women, who, but for the kindnesses, might have become a menace to society and the state. At present there are about sixty children in the home. There have been no deaths in the Homes this year, and health of the children has been remarkably good. The children are received into the Home at any age up to 13, and keep none after 18 years of age. The financial condition is good.

We recommend that our churches and Sunday schools contribute more liberally to the support of cur Orphans' Home.

We have no data for our Texarkana Home.

The matter of changing the time for annual meeting was discussed at length by W. J. Hinsley, W. A. Booker, P. C. Mays, B. V. Ferguson and others, and final vote of 46 to 10 prevailed, changing date of meeting to 10 o'clock a. m. on Thursday before the fourth Lord's Day in September.

Old Ministers' Relief.

J. S. Compere made a thorough explanation concerning the 75 Million. Movement as it relates to old ministers' relief, and, after further discussion by P.C. Mays and L. G. Lyle, report was adopted as follows:

By taking offering for their needs we have long neglected these dependent soldiers of the Cross; we, therefore, recommend That this is an additional reason that all Baptists should be prompt in the payment of their 75 Million Campaign pledges, because, under the present, plan, the old minister receives his relief from this fund.

Ministerial relief should be looked upon in the light of duty and not charity. We find ample proof in the New Testament that the men who preached the unscarchable riches of Christ and ministered unto the people in spiritual things, were highly esteemed by New Testament churches.

SATURDAY EVENING SESSION

Devotional services were conducted by E. A. Spiller, after which Moderator called Association to order.

REPORTS.

Religious Literature.

Discussions were made by J. S. Compere, Roy Bryant, W. J. Hinsley and W. J. Hamor. Report was adopted as follows:

It is hardly possible to over-estimate the importance of getting and using the right sort of reading matter. For many years we have been saying that this is a reading age. It becomes more and more so every year. The great war whetted the people's appetites for the printed page, and the reading habit is bound to grow.

The future belongs to the people who produce and read the best literatture and the most of it. The country is being sowed down with literature, and a great deal of it is hurtful in the extreme. A very large per cent of the literature that our young people read is shot through with vulgar and profane suggestions as well as infidel teaching. The most senseless and unreateanable heresies are widely advertised in the literature that is being read on all sides. It is not possible to overcome the bad effects of such literature except by circulating the right sort.

The Bible holds first place in our literature. When we know what the Bible teaches on any subject that settles it. There is not the slightest excuse for our people to be in ignorance of the teachings of the Bible. We urge regular, systematic Bible study by all our people, and that parents teach the Bible to their children.

But people are going to read other things besides the Bible. We believe that every home should have a good supply of the best books, including books on subjects of general interest as well as books on religious subjects, and especially on Baptist doctrines. Such boods can be had from the Baptist Book House, 405 Donaghey Building, Little Rock, Ark.

Another matter of the very greatest importance is to see that every Baptist home has a Baptist paper. It is estimated that 600,000 Baptist homes in the South are without a Baptist paper. In Arkansas among the Baptists who are in sympathy with the Convention there are not less than 16,000, or possibly 18,000, such homes without a Baptist paper. If the Baptist Advance could be pu^{*} in all such homes it would be a mighty help to our cause.

A special effort is being made all over the South to put a Baptist paper in every Baptist home. This campaign was approved by the Southern Baptist Convention and it was recommended by 75 Million Commission in its report to the Convention. It is strongly urged by the Conservation Commission that was appointed to go on with the work of the campaign. We believe that it we are to go on through the five years of the 75 Million Campaign with success we must get Baptist papers into the homes of our people.

- The Baptist Advance is the property of the Baptist State Convention. It is our paper. It promotes all the work in which we are engaged. It ought to go to every Baptist home in the State. We recommend that special effort be made by pastors and churches to see that every family represented in their resident membership gets the Advance.

On the first of September the Advance had about 9,000 regular subscribers. This number ought to be doubled in a short time.

Also Home and Foreign Fields, published by the Baptist Sunday School Board, Nashville, Tenn., and Royal Service, published by the Southern Baptist W. M. U., Baltimore Md. are of very great value and we recommend that our people subscribe for and read them.

SUNDAY MORNING SESSION

Song service was conducted by A. B. Kirkpatrick of Lavaca.

J. S. Compere, editor of the Baptist Advance, discussed the 75 Million Campaign, after relating incidents of his early life at his birthplace on the hill near the present meeting place of the Association.

A free-will offering was taken for State Missions.

At. 10:15 a .m. the Charleston Sunday school assembled to make class records, and then gave way to work of the Association.

Vice-Moderator E. A. Spiller called the meeting to order, and prayer was offered by W. A. Mayfield of Branch, Ark.

REPORTS.

Sunday School Reports.

Report was adopted after interesting discussion, by Missionary C. F. Wilkins, featuring Baptist literature and Baptist teachers. Discussions were

also made by W. A. Booker, W. J. Hinsley, J. W. Comer and State Sunday School Secretary J. B. Mosley. The latter giving splendid description of the work in the State, and calling for 1,000 volunteers for Sunday school extension work.

The Sunday school is the teaching service of the church-teaching is pre-eminent. It is truly the church studying and teaching God's Word.

Baptist have ever been in the forefront in the making of Sunday school history. Just a few facts connected with what they have done in the past and are now doing:

William Fox, a Baptist deacon, organized the first Sunday school for the study of the Bible.

William Gourney, a Baptist, started voluntary teaching in the Sunday school.

Joseph Hughes, a Baptist, organized the work of Sunday school tracts and literature.

Miss Harriet Bishop, a Baptist, organized the first Sunday school in the great Northwest of our own American territory.

B. J. Jacobs, a Baptist, gave birth to the uniform lesson system.

The world never needed to hear the voice of God so much as today. Before we can understand His message, we must learn to abide in His Word. There is a general and growing neglect in Bible study among professed Christians. The home is neglecting to lead the child in Bible study; the public schools can't teach the Bible, hence it is left for the church school to do this work. If our children ever know or appreciate the truths of God's Word, then how important that every church maintain a strong Bible school. How important that every pastor be faithfully engaged in training members of his congregation to do efficient Bible teaching.

There is great need of more effort on the part of the leaders of church work to extend this important kingdom work. Every church should have a Sunday school, and every member of the church should become members of some department of the church school. Let us all work and pray to this end.

We find in our Association:

1. There are several churches without and Sunday school organization.

2. There are many churches maintaining a Sunday school for not more than six months in the year.

3. There are some churches using other than Baptist literature and employing other than Baptists for teachers.

4. That 70 per cent of the reported baptisms for the past year came from our schools.

Your committee would recommend:

1. That every church in the Association maintain a Sunday school twelve months in the year.

2. That only Baptist literature be used and that we connect ourselves with and encourage only Baptist Sunday school organizations.

3. That all possible effort be made to make every Sunday school in the Association a standard school, and that our Sunday school workers attend all Sunday school conferences and institutes that they can in order that they may be efficient workers. Organize a class in the Convention Normal Manual right away. God bless our Sunday school.

B. Y. P. U.

After brief discussion, report on B. Y. P. U. work was adopted as follows:

Just as the Sunday school is the teaching force, just so the B. Y. P. U. belongs to the training department of our kingdom work. The outcome of the B. Y. P. U. participation in the recent 75 Million Campaign demonstrated the value of training such as B. Y. P. U. gives. The purpose of the campaign was enlistment, and enlistment is the keynote of B. Y. P. U. They seek to enlist every member into some activity of the Union, chiefly in taking part in the programs, in reading the Bible daily, in singing, and in systematic and proportionate giving. It is a well-known fact in B. Y. P. U. circles that all A-1 Unions are 90 per cent and up in giving. Many of them reach 100 per cent in giving. The reports of the campaigners from all the States show that the B. Y. P. U. members gave, and gave gladly.

It is gratifying to report a large increase in B. Y. P. U. membership during the past year. We have six B. Y. P. U. organizations in our Association, and onlyone in a rural church. May the day soon come when a B. Y. P. U. will be maintained in every rural church, upon which the growth of our work largely depends.

We recommend: First, That our associational missionaries devote a part of their time in organizing and enlisting our young people. Second, That a B. Y. P. U. be organized in every church as soon as it is expedient. Third, That representatives bo sent to the summer assembly at Arkadelphia, July 5th to 10th. Fourth, That we call upon our D. Y. P. U. workers to assist in institutes and training schools.

Resolution.

After a spirited disucssion a resolution, offered by W. J. Hinsley, relative. to separate bathing places in the river at Arkadelphia during B. Y. P. U. assembly, was adopted as follows:

"Since there seems to be a growing tendency to moral lackness in society, and since we believe that the practice of mixed bathing is hurtful to our Christian influence, and tends to immorality; therefore, be it

"Resolved, That we ask the authorities at our B. Y. P. U. assembly to arrange separate bathing places for our young people.

"That a copy of this resolution be presented to the Secretary of our Young People's Work, Bro. J. B. Mosley, and also a copy be sent the Baptist Advance.

"That we feel impelled to withdraw our support of the assembly unless this practice of mixed bathing is discontinued."

At 11 o'clock Sunday morning, Rev. J. S. Compere of Little Rock addressed the Association, using the first chapter of Revelations as a text. Brother Compere's sermon was inspiring to the Messengers and large number of visitors.

SUNDAY AFTERNOON SESSION

The meeting was opened by singing "How Firm a Foundation," and devotional exercises held by J. W. Comer, who read the eighteenth chapter of Luke.

REPORTS.

Ministerial Education.

Report adopted as follows:

Approximately one-third of the Baptist churches in Arkansas are pastorless at this time, and yet there are many idle preache.s. The demand for educated pastors never was so great. In many villages and country churches preference seems to be given to no pastor at all unless educated. This day of good schools and enlightened communities marks a definite call for educated ministry.

Ouachita College, when free tuition and other courtesies are extended to ambitious young preachers, only forty were enrolled last year, and our Mountain schools had about thirty in attendance.

We recommend that each church in the Association lend'all the encouragement and assistance possible to young men who are called to preach, and work out definite plans for those already in the ministry to complete their college and seminary training.

Christian Education.

Report on Christian Education was adopted after discussion by C. F. Spiller, P. C. Mays, W. J. Hinsley, J. G. Lyle and H. G. Thomason. This discussion proved to be one of the most interesting of the Association. Brother Hinsley's plea was for the child, while Brother Thomason discussed Christian education from a standpoint of the country's good, recommending secondary schools and denominational schools for training of teachers injecting into his remarks a bit of prophecy and warning to Christian parents that our denominational schools be given heartier support.

The following was adopted:

We are what we are very largely, almost entirely, because of the teaching we have had. If we had been brought up in homes of infidels and taught by infidel parents and infidel teachers, not many of us would now be serving the Lord Jesus Christ. In every school in the land we should have Christian teachers. If we are concerned about the spiritual welfare of our children, if it is our purpose to helpour young people to become useful Christian men and women, we must stand loyally for our Baptist schools and support them with our means and our patronage.

Every good Baptist in Arkansas rejoicés over the prosperity of our educational institutions.

Ouachita College, at Arkadelphía, has property values in buildings, grounds and equipment, worth about \$250,000. The endowment is about \$112,000. New buildings to cost about \$250,000 are now in course of construction.

In Central College, at Conway, we have property worth about \$125,000, and new buildings to cost about \$100,000 are to be constructed right away.

In Mountain Home College, at Mountain Home, our junior college, we have property worth about \$60.000 or more.

The property values of our academies at Maynard, Blue Eye, and Hagarville, average about \$12,000 for each school.

A Baptist college is to be built at Jonesboro soon, and Baptist academies open their first sessions this Fall in Montgomery and Union Counties.

Our colleges and schools are all well patronized, so well that additional buildings are absolutely necessary, and yet only a very small per cent of our boys and girls are attending Baptist schools. We urge upon our people the duty of sending their children to our own schools and colleges.

Never has there been greater need for an educated ministry. Young preachers are given free tuition and additional financial help in Ouachita College ad in our mountain schools. Let us call out the called and encourage them and help them to attend college. To fail in this means ruin. Several good friends have recently remembered Ounchita College in their wills-a splendid way to bless mankind.

The most hopeful sign of progress in all our work is the prosperity of cur Baptist schools and colleges, and the ever-increasing interest of our broherhood in this work, manifested by the enlarged patronage and the liberal contributions through the 75 Million Campaign.

Let us pray for our schools and support them.

Of all the departments of the Kingdom work, Foreign Missions is the part where the least element can enter. The salvation of our own family, friends or community, is a great incentive to do mission work at home. But in the work of foreign mission it is far different. God calls us to be interested in the salvation of a people whom we, perhaps, never saw, or among a people whom we have regarded as our national enemies, yet the commission of our Lord is to take the message of salvation to the uttermost parts of the earth. In order for us to do most effective work in this large field, we must focus our efforts together.

Our Foreign Mission Board, located at Richmond, Va., affords just such opportunity for every church and every member in those churches to unite their efforts in this great heaven-sent gigantic enterprise. The success of our 75 Million Drive made it possible for August 28, 1920, to be one of the great days in Baptist foreign mission work.

Seventy-five new missionaries sailed that day on one vessel, the largest number that ever sailed at one time in the history of missionary activities. Seven thousand of our young people volunteered for special work in October, 1919. Many of them are preparing for foreign work. There is no excuse for any Baptist anywhere not to have some part in this glorious work. With our well established schools, hospitals and preaching stations on foreign fields, affords ample opportunity to push forward the work of the Kingdom everywhere. Prompt and regular payment of our pledges to the 75 Million Campaign will insure the financial success of our foreign work.

SUNDAY EVENING SESSION

Devotional exercises were conducted by Vice-Moderator E. A. Spiller.

REPORTS.

Home Missions.

Chairman J. W. Comer yielded his time for the discussion of Home Missions to Dr. W. S. Wiley, field secretary of the Sunday School Board, Nashville, Tenn. Dr. Wiley gave an interesting history of the new Baptist institute in New Orleans, La., showing its growth in the last few years. This institution now having fourteen buildings valued at more than \$1,000,000. Four hundred men and women matriculated at this institute for the study of mission work last year. All languages are taught at this institute, and a

splendid work has been done for home missions. Dr. Wiley also described the million dollar sanitorium at Mt. McKinley, and told of the great educational work being done in Cuba.

The following report on Home Missions was adopted:

Following the World War and in the midst of reconstruction problems. thousands of our people have made a new dedication of themselves to this Christian Americanism, and in no section more than in the South, where the largest proportion of nativo Americans reside. They purpose to safeguard American liberties by safeguarding that faith which alone made those liberties possible, and to keep lighted in America a beacon of liberty which shall shine out across the seas to cheer and bless meoples who grope in darkness.

In 1919 the missionaries of our Board baptized one convert for every three received into our churches. Regularly they baptize from twenty to twenty-five per cent as many converts as the entire number who enter our churches. For fifteen years its Evangelists have averaged 450 baptisms per year per worker, a record far out-stripping that of any other similar agency. Its system of Mountain Schools is larger than any other and is the acknowledged standard in adaptability. Its Enlistment work is rapidly bringing a more adequate standard of spiritual instruction and effectiveness in hundreds of churches. Its Church Extension work has grown from infancy to lusty strength in a period of only a few years.

Every loyal Bapilst will rejoice in the admirable efforts of our Board to meet the crucial needs of these days by enlarging its work. At its annual meeting in Atlanta in June, after long and painstaking efforts to reduce the appropriations as far as possible, the brethren of the Board found that \$2,875,000 was necessary for work of the present year.

We commend to our people the admirable Mission Study Books of the Home Board, through which a true view is presented of the large problems we confront, and recommend that-pastors, superintendents, mission society leaders and others write often for the large and splendid assortment of free tracts about its work and the needs, which our Home Board gladly furnishes on request. We urge the churches to pay up on the 75 Million Campaign. \mathcal{T}

There is a cause for each effect. What is the cause of so many pastorless churches? We do know that many of our pastors are paid on a minimum living scale, and even some are not paid a living wage. The growing demands for better preachers, and increased costs of living compel us to see that our pastors are paid salaries that will keep them in the service. The scarcity of preachers is co-relative to the scarcity of school teachers. We must pay preachers enough to justify necessary preparation, or else God's cause will suffer.

State Missions.

State Mission report was adopted after being discussed by E. A. Spiller, W. J. Hinsley and others.

W. J. Hinsley and others. With Arkansas Baptists one supreme expression of their missionary faith and zeal is found in State Missions. The object of State Missions is to bring all the affairs of all the people of the state under the control of Christ. Our purpose in this work is to get everybody in the state saved and into the Baptist churches and then get them to give proper support to all enterprises of the Kingdom of God, both for Arkansas and all the world. We believe the great Commission was given to Baptist churches.

The work of State Missions is carried on by the churches through the Executive Board of the Baptist State Convention. The report of this Board to the Convention last year showed the following results: Workers employed for full or part time, 120; days labored, 21,870; sermons and addresses, 15,253; baptisms, 2,281; additions, 3,902; subscriptions to the Baptist Advance, 995; money raised by missionaries, \$50,005.

Surely these wonderful reports set out facts and figures that will stir the churches in our Association to pay up subscriptions to the 75 Million Campaign in order that State Missions may have all obligations paid Decembor 1st. All over the state there is sore destitution. If the destitute sections are to be cared for next year by State Mission workers, if associational boards are to be aided in paying their missionaries, and if weak churches are to be helped in paying their pastors, we must take care of our State Mission obligations. The Association urges all our pastors and churches to do their utmost.
