As to what we as Baptists should not read, we should not read novels of any type, nor such papers as "Appeal to Reason," for such things tend to destroy our religious liberty, and drift toward anarchy and infidelity.

Temperance.

Your committee on Temperance beg leave to submit the following report:

The word Temperance as defined by the lexicographers in its primary meaning is, Habitual moderation in regard to the indulgence of the natural appetites and passions; restrained or moderate indulgence; moderation; as, temperance in eating and drinking; temperance in joy or mirth.

While it has grown to be the custom to consider only the saloon question in reports on temperance, we think it of the highest moment that the Christian should exemplify the full import of the word temperance in their daily lives.

Herbert has said: "To put on the profound humility and exact temperance of our Lord Jesus Christ, and to keep them on in the sunshine and noon of prosperity, is as necessary and as difficult, at least, as to be clothed with perfect patience and truce christian fortitude in the cold midnight storms of persecution and adversity." Yet without this we cannot hope to build high christian character; and without such character, we cannot hope to impress ourselves on the world for good. So we must add to our knowledge temperance.

Outside of the moral aspect of the subject, it has a sanitary bearing that cannot be neglected. Benjamin Franklin said, Be sober and temperate and you will be healthy. But we will leave that field for the medical fraternity to occupy.

We believe the Christian man who is immoderate in his habits, and that means intemperance, cannot be a highly efficient worker. The man who eats intemperately, or labors intemperately with body or mind, or exercises any of the passions intemperately is not in normal state, and loses efficiency.

We believe the indulghnce of unnatural appetites, though moderately, is close kin to intemperance, and is only a little less harmful. This of course hits the tobacco habit squarely in the face; and we believe it is high time the Christian world,

especially the ministry, were becoming examples of abstinence in this particular. Let us study more carefully and imitate more zealously the life of perfect equipoise, perfect sobriety, perfect temperance, and perfect simplicity of our great Leader.

This report of course would be a disappointment if concluded without some mention of the liquor question. The church sustains two general relations to this burning question of the day.

First, the church should be a great training school in conjunction with the fireside instructors, where a thorough abhorrence of the liquor habit and of the liquor traffic should be ingrained in the very nature of the young.

Secondly, the church should use its power to shape the legislation of our country, both state and national, so the people may, when a majority speak against whiskey by their ballots, have their will enforced.

Our state is fast becoming dry. The prohibition sentiment has, through the influence of the church, made wonderful strides in our state, till a very large majority of the counties have voted drymore than sixty.

The last legislature passed one of the best temperance laws that has been enacted in many years. The bill so amended the statutes that the distilleries cannot sell in five gallon lots or in any quantity in counties that have voted against license. The greatest need now is a law by the National Congress prohibiting transportation companies or individuals from transporting intoxicantainto dry territory in the states. Until this is done our prohibition laws will lack greatly in effectiveness.

The people of the state have adopted the Initiative and Referendum amendment to the Constitution, and the last legislature passed an enabling act, rendering the amendment operative. Therefore the people of the state can initiate and enact any laws on the temperance question they may like. So the work becomes almost wholly a work of building public sentiment on this question.

We will conclude by stating that the money waste caused by the use of drink is appalling. It has been estimated that the drink bill of the American people yearly is \$440,000,000, a sum sufficient to build and fortify the Panama canal. It is our opinion that the church people of America spend enough money for tobacco and drink annually to maintain and promote our church work on a scale far greater than is now done.

ARTICLES OF FAITH.

I. We believe that the Holy Bible was divinely inspired and is a perfect treasure of heavenly instruction; that it has God for its author, salvation for its end and truth without any mixture of error for its matter, that it reveals the principles by which God will judge us, and therefore, is and shall remain to the end of the world, the true center of Christian union and the supreme standard by which all human conduct, creeds and opinions should be tried.

II. We believe that there is one, and only one, living and true God, an infinite, intelligent Spirit, whose name is Jehovah the Maker and Supreme Ruler of Heaven and earth; inexpressibly glorious in holiness, and worthy of all possible honor, confidence and love; that in the unity the Godhead there are three persons, the Father, the Son and the Holy Ghost, equal in every divine perfection, and executing distinct but harmonious offices in the great work of redemption.

III. We believe that man was created in holiness, under the law of his maker, but by voluntary transgression fell from that holy and happy state; in consequence of which all mankind are now sinners, not by constraint, but choice; being by nature utterly void of that holiness required by the law of God, positively inclined the evil, and therefore under just condemnation to eternal ruin, without defense or excuse.

IV. We believe that the salvation of sinners is wholly of grace, through the meditorial offices of the Son of God, who by the appointment of the Father, freely took upon him our nature, yet without sin; thus having arisen from

the dead he is now enthroned in heaven; and uniting in his wonderful person the tenderest sympathies with divine perfection, he is in every way qualified to be a suitable, compassionate and all sufficient Saviour.

V. We believe that the great Gospel blessing which Christ secures to such as believe in Him is justification; that justification includes the pardon of sin and the promise of eternal life on principles of righteousness; that it is bestowed, not in consideration of any work of righteousness which we have done, but solely through faith in the Redeemer's blood; by virtue of which faith his perfect righteousness is freely imputed to us of God, that it brings us into a state of most blessed peace with God and secures every other blessing needed for time and eternity.

VI. We believe that the blessings of salvation are made free for all by the Gospel; that it is the immediate duty of all to accept them by a cordial, penitent and obedient faith, and that nothing prevents the salvation of the greatest sinner on earth but his own inherent depravity and voluntary rejection of the Gospel, which rejection involves him in an aggravated condemnation.

VII, We believe that in order to be saved, sinners must be regenerated or born again; that regeneration consists in giving a holy disposition to the mind; that it is affected in a manner above our comprehension by the power of the Holy Spirit in connection with divine truth, so as to secure our voluntary obedience to the Gospel; and that its proper evidence appears in holy fruits of repentance and

faith and newness of life.

VIII. We believe that repentance and faith are sacred duties and also inseparable graces wrought in our souls by the regenerating spirit of God; whereby, being deeply convicted of our guilt, danger and helplessnes, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession and supplication for mercy; at the same time heartly receiving the Lord Jesus Christ as our Prophet, Priest and King, and relying on him alone as the only and all sufficient Saviour.

IX. We believe that election is the eternal purpose of God, according to which he graciously regenerates, sanctifles and saves sinners, that being per-fectly consistent with the free agency of man, it comprehends all the means in connection with the end; that it is a most glorious display of God's sovereign goodness, being infinitely free, wise, holy and unchangeable; that it utterly exboasting, and promotes love, cludes prayer, praise, trust in God and active imitation of his free mercy; that it encourages the use of means in the highest degree, that it may be ascertained by its effect in all who truly believe the gospel; that it is the foundation of Christian assurance, and that to ascertain it with regard to ourselves demands and deserves the utmost diligence.

X. We believe that sanctification is the process by which according to the will of God, we are made partakers of holiness; that it is a progressive work; that it is begun in regeneration, and that it is carried on in the heart of believers by the presence and power of the Holy Spirit, the Sealer and Comforter in the continued use of the appointed means, especially the Word of God, self examination, self denial, watchfulness and prayer.

XI We believe that such only are real believers as endure unto the end, that their persevering attachments to Christ is the grand mark which distinguishes them from superficial professors, that a special providence watches over their welfare, and that they are kept by the power of God through faith unto salvation.

XII. We believe that the law of God is the eternal and unchangeable rule of his moral government; that it is holy, just and good; and that the inabilities which the Scriptures ascribe to fallen men to fulfill its precepts arise entirely from their love of sin, to deliver them

from which and to restore them through a Mediator to an unfeigned obedience to the holy law, is one great end of the Gospel, and of the means of grace connected with the establishment of the visible church.

XIII. We believe that a visible church of Christ is a congregation of baptized believers, associated by covenant, in the faith and fellowship of the Gospel, observing the ordinances of Christ, governed by his laws, and exercising the gifts, rights and privileges invested in them by his word; that its only spiritual officers are bishops or pastors, and deacons, whose qualifications, claims and duties are defined in the epistles of Timothy and Titus.

XIV We believe that Christiam baptism is the immersion in water of a believer, unto the name of the Father, Son, and Holy Ghost; to show forth in a solemn and beautiful emblem our faith in the crucified, buried and risen Saviour, with its effect in our death to sin and resurrection to a new life; that it is prerequisite to the privileges of church relations, and to the Lord's Supper in which the members of the church, by the sacred use of bread and wine, are to commemorate the dying love of Christ, preceded always by solemn self-examination.

XV. We believe that the first day of the week is the Lord's Day or Christian Sabbath, and is to be kept sacred to religious purposes, by abstaining from all secular labor and sinful recreation, by the devout observance of all the means of grace, both private and public, and by preparation for the rest that remaineth for the people of God.

XVI. We believe that civil government is of divine appointment, for the interest and good order of human society; and that magistrates are to be prayed for, conscientiously honored and obeyed; except only in things opposed to the will of our Lord Jesus Christ, who is the only Lord of the conscience, and the Prince of the kings of the earth.

XVII. We believe that there is a radical essential difference between the righteous and the wicked; that such only as through faith are justified in the name of the Lord Jesus and sanctified by the spirit of our God, are truly righteous in his esteem; while all such as continue in impenitence and unbelief are in His sight wicked and under the curse; and this distinction holds among men both in

and after death.

XVIII. We believe that the end of this world is approaching; that at the last day Christ will descend from heaven and raise the dead from the grave to final retribution; that a solemn separation will then take place; that the wicked will be adjudged to endless punishment, and the righteous to endless joy; and that this judgment will fix forever the final state of men in heaven or hell, on principles of righteousness.

CONSTITUTION.

Article 1.—This Association shall be composed of messengers, who shall be members of the churches they represent (except such as may be invited to a seat by censent of the body) and shall be styled, "The Benton County Baptist Association."

Art. II. This Association shall meet annually on Wednesday before the Fourth Sunday in October, at the place previously appointed; and after public worship, and reading the letters from the churches, a moderator and clerk shall be chosen from the messengers by ballot, both of whom shall hold their offices until others shall be elected.

Art. III. It shall be the duty of the clerk to make an accurate record of the proceedings of each meeting of the Association, in a book provided for the purpose. He shall also act as treasurer.

Art. IV. Each church may send three messengers. The messengers shall present letters certifying their appointment and briefly expressing the state of the churches, their increase and decrease, and their aggregate number. Each church shall send with the letter money

for printing the minutes.

Article V. Churches wishing to unite with the Association may apply by letters and messengers, and giving satisfactory information of their being sound in doctrine and correct in practice, they may be received by unanimous vote, in token of which the moderator shall give to their messengers the right hand of fellowship in behalf of the Association. Churches may be dismissed upon application.

Art. VI. We acknowledge the independence of the particular churches, and that no authority or jurisdiction is to be exercised over them by this Association, nor will the Association decide in any controversy that may arise in any church. Nevertheless they deem it

their duty to disown any church belonging to this body which may have essentially departed from the faith.

Art. VII. When a church shall neglect making any communications to the Association for three years successively, it shall be considered as having withdrawn from us, and shall be dropped from the minutes of the Association unless at least two members request their continuance, who shall engage to inquire into their standing and report at the next meeting of the Association.

Art. VIII. This Association shall have the right to open and hold correspondence with other Associations, as may be

deemed expedient.

Art. IX. It shall be the duty of the Association, from time to time, to suggest to the several churches such measures as may be wise and proper to promote the interest of the Messiah's kingdom, and spread the Gospel throughout the world.

Art. X. This constitution may be amended at any regular meeting of the Association by a two-third vote of all

members present.

A FORM OF CHURCH COVENANT.

Thanking God for the light we have received, and for the revelation of Jesus which we now enjoy; and hoping, that God, for Christ's sake, has pardoned our sins; and having been baptized on a profession of our faith in Christ Jesus into the name of the Father, Son, and Holy Ghost, we do this day before God and the world, with deep joy and great solemnity, enter into covenant with one another, as one body in Christ.

We therefore covenant and agree, that, by the aid of the Holy Spirit, we will walk together in love and Christian fellowship. We promise to labor for the advancement and final triumph of the church; to sustain her worship by attending the house of God and supporting the ministry; to guard her ordinances, enforce her discipline, and defend her

doctrine.

We also pledge ourselves to walk circumspectly in the world; to be honest, just and faithful in our business relations; and, as God may give us help, we promise to live righteous and holy lives.

We further promise to watch over each other in brotherly love, to visit the sick; to pray for each other and the world; to aid the poor and needy; and to perform such other kind offices as may be well pleasing in the sight of God.
