PROCEEDINGS

Pulaski County Baptist Association met in its fourth annual session with the First Baptist Church, England, Ark., on Tuesday, October 7, 1919, at 10 o'clock a. m. In the absence of the former Moderator, A. H. Autrey, the Clerk, E. J. A. McKinney, called the body to order.

Eld. J. B. Searcy was elected Moderator pro tem.

STEWARDSHIP.

"Ye are bought with a price, ye are not your own; therefore glorify God in your bodies and in your spirits, which are His."

If professing Christians acknowledge the above as true relative to their lives; then we must adhere to the doctrine of Stewardship. To be an honest steward, a real steward, one must of necessity administer relative to that over which he has been made steward, whether it be money, property, trust, or talent.

Gratifying progress is being made in this doctrine among our Baptist hosts. Some are, indeed, good stewards, but we have only begun. If our lives are God's, if we belong to Him, then all that we have should be at His disposal, and under His direction. The \$75,000,000 could be raised by Arkansas Baptists alone if we administered as stewards ought.

Your committee urges that the churches with their several organizations continue aggressively to wage the fight all along the line for this doctrine of the Old and New Testament.

The report of Committee on Colleges and Schools was read by Prof. J. G. Lile and motion was made to adopt as follows:

CHRISTIAN EDUCATION.

Our Baptist schools and colleges are all filled with students. Ouachita and Central have had to turn away many young women because of lack of room in the dormitories.

We are pleased with the fact that our schools and colleges are well attended, but we recognize the need of greatly increased numbers of properly trained men and women and we know that facilities sufficient to take care of the increasing patronage ought to be provided at once.

Ouachita now has a productive endowment of \$103,000. This must be increased to \$300,000.

We urge that our people support our Baptist educational institutions by liberal contributions, that we patronize them by sending to them our sons and daughters, that we urge others to patronize them, that we especially do all we can towards sending our young preachers to our Baptist schools, and that we pray for these institutions.

The report on State Missions was read by G. D. Faulkner and motion made to adopt as follows:

STATE MISSIONS.

The greatest expression of missionary faith and zeal from the Baptists of Arkansas is found in State Missions. The object of State Missions is to reach the yet-unreached element, to bring as large a number of souls as possible to Christ and as far as possible to bring all the affairs of all the people of the entire State under the control of Christ.

\$700,000 of Arkansas' \$3,200,000 of the \$75,000,000 Campaign is to go for State Missions, making \$140,000 each year for the next five years. This of course will give opportunity for a larger corps of workers, if they can be had. But since there is scarcity of preachers and missionary workers, it behoves us to pray for the Lord to put more men into the ministry and more of other workers into His service.

Both State and Associational Missions have been greatly enlarged during the last few years. The number of State and Associational workers being about 225 for this year. It is hoped that by this increased means we may be able to take the State for Christ.

A. M. Rodgers then spoke on Stewardship and 75 Million Campaign.

Report on Foreign Missions was read by J. T. Walters and motion was made to adopt as follows:

FOREIGN MISSIONS.

The Southern Baptist Convention at Atlanta, Ga., last May launched a 75 Million Dollar Campaign, which asks that Southern Baptists give four and one-half millions dollars to Foreign Missions before the next meeting of the Convention. Compared with Southern Baptist numbers and wealth this amount is small. God's blessings are upon Foreign Missions. Even the war has helped this great enterprise. We had some 6,000 baptisms last year. We have now 505 churches, on all the fields of which 143 have assumed self support. We have a church membership of some 50,000 with 760 Sunday Schools, enrolling more than 36,000 scholars. In other schools we have enrolled 15,722 scholars. We are conducting theological schools in Japan, China, Africa, Italy, Mexico and South America. We have 28 American and native doctors who treated 129,000 cases last year. Several new missionaries were appointed last summer. We have 303 church houses and 72 residences owned by the Board. We have some 320 American and near 800 native missionaries and helpers. Also have some 480 schools, over 400 of these being elementary, kindergarten, etc., and 10 theological. We recommend that every church in our Association do its utmost in the great Campaign between this and December 7th toward Arkansas' goal of \$120,000. We recommend that every church work earnestly toward putting Baptist Advance and Home and Foreign Fields in every home. Many fine free tracts may be had from our Foreign Mission Board at Richmond, Va.

ASSOCIATIONAL MISSIONS.

Your committee reports as follows:

That Bro. J. H. Reynolds, who was elected to fill the unexpired term of Bro. Howell, has been serving as missionary for six and one-half months and has done most excellent work, especially when we consider the late hour and other unfavorable conditions under which he entered the work.

We are glad to report that notwithstanding the long lapse we had with no missionary on the field and the considerable debt that had accumulated, the Association, it seems, will pay out of debt. Therefore, we recommend:

1. That the Association refer the election of new missionary for the ensuing year to the Executive Committee.
2. That the committee be instructed to consider the advisability of employing two missionaries for the year, and if necessary and deemed wise, to have more than two missionaries for as much time as might seem fit.
3. That the Executive Committee be advised to confer with the State Board and to ask for such financial help as necessary to carry out the above recommendations.
4. That the Executive Committee be instructed to meet at the earliest date possible for the transaction of this business.

The report on Woman's Work was read by Mrs. W. S. Farmer and motion was made to adopt as follows:

W. M. U. REPORT.

We, the women of Pulaski County Baptist Association, beg leave to submit the following report. Never before, since the birth of our Lord and Savior, have so many things come into the hearts and lives of our people to make them feel the very presence of the Master, as during the past year. First, came the signing of the armistice. This came in answer, we believe, to the earnest, united prayer of God's people. Then, before we were quite over this, our Southern Baptist Convention met and decided to undertake the raising of \$75,000,000. But, sisters, let us forget the money side of the question—let us try to realize that we are Christ's children bought with the price of His precious blood and let us go to work to enlist every woman belonging to our churches. Then raise it, we will. We are sorry indeed that our Superintendent, Mrs. W. I. Moody, did not get her report in. But still we know from the reports read in our women's meeting some of the work that has been done. The Wednesday luncheon of the Business Women's Circle and the programs at Camp Pike of the Second Baptist Church; and the programs of the Immanuel women at the Reform School and much of the other personal service work, and let us give especial mention of Immanuel's Home Department. Then we know that the First Church, Tabernacle Church, Pulaski Heights Church, First Church, North Little Rock, and First Church, England, have accomplished much good work along many lines. Let us pray that our women in every church in Pulaski County will wake up and organize and do the work that the Lord meant for them to do.

REPORT OF ASSOCIATIONAL MISSIONARY J. A. REYNOLDS.

To the Pulaski County Baptist Association.

Brethren: I have served as your Missionary six months and 18 days. During that time I have assisted in revival meetings in the following churches, namely: Maple Street and Emerson's Chapel, Little Rock; Baring Cross and First Church, North Little Rock, Jacksonville, Vimy Ridge and McAlmont. Organized two new churches, one at Plain View school house, one at Marche, in Pulaski county.

I have preached every Sunday morning but one at the State Hospital which has largely taken the place of the weekly dance and Dr. Kirk and his faculty, which includes the other physicians and attendants both male and female, have shown me every courtesy and often speak of the good results therefrom and have shown their appreciation not only in words but with a contribution of \$5.00 per Sunday. This I deliver at 9 a. m. At 11 a. m. I would often be miles away in a meeting.

I spent six days working in the interest of the 75 Million Campaign in Cleveland county. Have visited, held prayer services and preached at a number of other places.

Visible results: Sermons 183, professions 136, added to churches 112, of this number 66 were baptized; 40 backsliders made happy, traveled 2877 miles, made 976 visits, phone calls 160, letters written 75, prayer services in homes and churches 160, worked on car 51 hours, assisted in licensing of one preacher and two others have heard the call and one of them preached two messages, conducted five funerals, officiated in two marriages, collected on the field \$291.64.

CONSTITUTION

Article I.—Name.

The name of this body shall be Pulaski County Baptist Association.

Article II.—Object.

The object of this Association shall be to aid the churches in their divinely appointed work of spreading the Kingdom of God throughout the whole world by every scriptural means.

Article III.—Membership.

Section 1. This Association shall be composed of messengers from regular Baptist Churches, which are in sympathy with the principles and purposes of this Constitution and desire to co-operate with this Association, and shall be entitled to seats upon the presentation of letters from their churches, or other satisfactory evidence of their appointment.

Sec. 2. Each church shall be entitled to three messengers and one additional messenger for each one hundred members or major fractional part thereof.

Sec. 3. Messengers from any church desiring to become affiliated with this Association may do so by the presentation of a petitionary letter indicating the desire of the church, the standard of faith which the church holds, and the messengers appointed to represent the church in the Association.

Article IV.—Authority.

This Association shall never exercise any legislative or ecclesiastical authority over any church, nor shall it in any way interfere with the rights and absolute independence of the churches of Christ.

Article V.—Officers.

Section 1. The officers of this Association shall be a Moderator, Clerk, and Treasurer, who shall be elected at the opening of each annual session by a majority of all the votes cast at such meeting. Provided, however, that the Moderator shall not be eligible to serve more than two consecutive terms.

Sec. 2. The Moderator shall preside at all sessions of the Association or call some one to occupy the chair temporarily in his absence, and may exercise the same privilege of discussion as any other member of the Association.

Sec. 3. The Clerk shall keep a correct record of all the proceedings of the Association and shall superintend the printing and distribution of the Minutes of each session as he may be directed by the Association.

Sec. 4. The Treasurer shall receive all funds of every kind

entrusted to his care, and shall disburse the same upon the order of the Association and shall make an itemized report of all such funds to the Association before the close of each annual session.

Article VI.—Association Board.

Section 1. The Associational Board shall be composed of one member from each church co-operating with the Association (to be elected by the churches), and five additional members to be elected from the Association at large at each annual session of the Association, seven of the whole number constituting a quorum after due notice has been given to all the members of the Board.

Sec. 2. This Board shall co-operate with the churches in this Association in informing and arousing the churches, in gathering and disbursing of funds for all the objects fostered by this Association and shall transact all of the business of the Association in the interim of the annual meetings of the Association.

Article VII.—Meeting.

This Association shall meet annually on first Tuesday morning at 10:00 o'clock, in October, at such place as the Association may determine.

Article VIII.—Amendment

This Constitution may be amended at any annual session of the Association by a two-thirds vote of the messengers present at any annual meeting, provided that the substance of Article IV shall never be abrogated.

BY-LAWS.

I. Each anniversary of the Association shall be opened with appropriate religious services under the direction of the Moderator, or in his absence by the next officer in rank present, or if all the officers are absent, by the pastor of the entertaining church.

II. The following shall be the order of exercises:

1. Religious services as above.
2. Call to order by the presiding officer.
3. In case of the absence of all officers, election of temporary Chairman and Clerk.
4. Introductory sermon.
5. Appointment of Program Committee to report to each hour of adjournment.
6. Appointment of Committee on Enrollment.
7. Reading of Articles Three, Four, Five and Seven of the Constitution by the Clerik.

8. Introduction of visitors.

III. All committees shall be appointed by the chair, and confirmed by the Association, unless otherwise ordered.

IV. There shall be appointed at each annual session, the following committee, to report to the Association in session:

1. Associational Missions.
2. State Missions.
3. Home Missions.
4. Foreign Missions.
5. Colleges and Schools.
6. Religious Literature.
7. Bible Schools.
8. Ministerial Education.
9. Orphans' Home.
10. Christian Education.
11. Woman's Work.
12. Young People's Work.
13. Digest of Letters.
14. Obituaries.
15. Resolutions.
16. Finance.
17. Temperance.
18. Nominations.

V. Each session shall be opened and closed with prayer.

VI. Visiting brethren and sisters may be invited to seats in the Association and allowed all privileges of the session except to vote.

VII. Every speaker shall rise and address the Moderator. In discussion all personalities shall be avoided. No one shall speak more than twice on the same question, without special permission from the Association.

VIII. Mell's Parliamentary Law shall be the standard in deciding questions of parliamentary practice.

IX. The minutes of the preceding day shall be read and approved at the opening of each morning session.

X. Such offerings may be taken at the annual meeting of the Association as the body may direct.

XI. These By-laws may be amended at any regular meeting by a two-thirds vote of those present, or suspended by unanimous vote.

XII. The Associational Board shall meet monthly at such time and place as the Board itself may determine.

ARTICLES OF FAITH.

Abridged from Pendleton's Church Manual.

1. We believe that the Holy Bible, written by men divinely inspired, and full of unmixed truth, is a perfect rule of faith and practice. II Tim. 3:16.

2. We believe in one God—Father, Son, and Holy Ghost. Gen. 1:16; II Cor. 13:14.

3. We believe that man, once holy, fell by voluntary transgression from the happy state, and is now utterly void of holiness. Gen. 1:26, 3:17.

4. We believe that sinners are saved by grace alone. Eph. 2:8, 9.

5. We believe that salvation is free to all who will accept the Gospel. Isaiah 55:1; John 7:37; Rev. 21:6; Rev. 22:17.

6. We believe that, except a man be renewed by the Holy Spirit, he is not qualified or prepared for the kingdom of Christ on earth, or to enjoy His glory hereafter. John 3:3-8.

7. We believe that repentance toward God and faith in the Lord Jesus Christ are duties of everyone who hears the Gospel. Matt. 3:2; Acts 18:31.

8. We believe that election is the eternal purpose of God, by which he graciously regenerates, sanctifies, and saves sinners. Rom. 8:30.

9. We believe that sanctification, begun in regeneration and ever progressive, is the process by which we are made to partake of God's holiness. John 3:6; II Thes. 2:12.

10. We believe in the perseverance of the saints, that they are kept by the power of God through faith unto salvation. I Peter 1:5.

11. We believe that God's law is the only, the eternal and unchangeable rule of His church and moral government. II Tim. 3:17, 18.

12. We believe that a church of Christ is a congregation of baptized believers united in the faith and fellowship of the Gospel, observing the ordinances and obeying the laws of Christ, and that its officers are pastors and deacons. Acts. 2:41-47; 3:28.

13. We believe that Christian baptism is the immersion of a believer in water, by a properly qualified administrator, in the name of Father, Son, and Holy Ghost. Matt. 28:18; Mark 16:16; Rom. 6:3, 4.

14. We believe that only such as have been properly baptized and received into fellowship of a regularly organized Baptist Church should partake of the Lord's Supper. Matt. 26:26, 27; I Cor. 11:20-23.

15. We believe that the Lord's Day or Christian Sabbath

should be devoutly observed and sacredly devoted to religious services. Mark 16:9; Acts 20:7; I Cor. 16:1, 2; Heb. 10:25.

16. We believe that civil government is of divine appointment, and that the governors of States and Nations should be obeyed when the laws they seek to enforce do not conflict with the Gospel.

17. We believe in the future resurrection of the dead. Dan. 12:12; Thes. 4:16.

18. We believe in the final judgment, and that in that day the righteous and the wicked will be separated forever. Acts 17:31; Matt. 25:32, 33.

19. We believe that the righteous will be happy forever in heaven and the wicked miserable forever in hell. Matt. 25:34-46.

CHURCH COVENANT.

Thanking God for the light we have received, and for the revelation of Jesus which we now enjoy, and hoping that God, for Christ's sake, has pardoned our sins, and having been baptized on a profession of our faith in Jesus Christ into the name of the Father, Son, and Holy Ghost, we do this day, before God and the world, and with deep joy and great solemnity, enter into this covenant with one another, as one body in Christ.

We therefore covenant and agree that, by the aid of the Holy Spirit, we will walk together in love and Christian fellowship. We promise to labor for the advancement and final triumph of the church, to sustain her worship by attending the house of God and supporting the ministry; guard her ordinances, enforce her discipline and defend her doctrine.

We also pledge ourselves to walk circumspectly in the world; to be honest, just, and faithful in our business, relations, and as God may give us help, we promise to live righteous and holy lives.

We further promise to watch over each other in brotherly love; to visit the sick; to pray for each other in the world; to aid the poor and needy, and to perform such other kind offices as may be well pleasing in the sight of God.

CONSTITUTION OF WOMEN'S MISSIONARY UNION, AUXILIARY TO PULASKI COUNTY ASSOCIATION.

Preamble.

We, the women of the Missionary Baptist Churches of Pulaski County Baptist Association, desirous of simulating a missionary spirit and cultivating the grace of giving among the women and young people of all the Churches within the bounds of this Association, do organize and adopt the following:

CONSTITUTION.

Article 1.—Name.

This organization shall be known as the Woman's Missionary Union of Pulaski County Baptist Association and shall be composed of Woman's Missionary and Aid Societies, Young Woman's Auxiliaries, Young Peoples' Bands co-operating with the State Women's Missionary Union.

Article 2.—Object.

The object of this Union shall be: To distribute Missionary information and to secure, if possible, the organization of Woman's Missionary and Aid Societies, and Young People's Bands in every church; to inspire a deeper interest in the study of God's word in its bearing upon world-wide missions, by the organization of definite Bible and Mission Study Classes and to encourage the adoption of the tithing plan of securing offerings of money and service after the pattern laid down in the New Testament.

Article 3.—Officers.

The officers shall be a President, Superintendent, First Vice President, Second Vice President, Secretary and a Treasurer, who shall be elected annually by ballot. No officer shall succeed herself more than once.

Article 4.—Religious Exercises.

Every session of the Union shall be opened and closed with religious exercises.

Article 5.—Dues.

Each society enrolled in the Union is expected to contribute quarterly toward the expense attached to the organization of new societies and furnishing literature for same.

Article 6.—Representation.

This body shall be composed of regularly accredited messengers elected by the Woman's Missionary and Aid Societies, Young Woman's Auxiliaries and Young People's Bands as fol-

lows: Woman's Missionary and Aid Societies, 5; Young Woman's Auxiliaries, 3, one of which shall be the leader; Sunbeam Band, Royal Ambassadors, Junior Union and Definite Personal Service Committee, one adult representative each.

Article 7.—Executive Committee.

The Executive Committee shall be composed of the officers of the Union, and one representative from each Society. Seven members shall constitute a quorum. The Executive Committee shall meet once every quarter.

Article 8.—Amendment.

This Constitution may be amended or altered by a two-thirds majority vote at any annual meeting.

BY-LAWS.

Duties of Officers.

Section 1. The President shall preside at annual and all Executive Committee meetings; shall appoint all committees not otherwise provided for.

Sec. 2. Vice Presidents.—The Vice Presidents shall perform the duties of the President in her absence, and shall aid so far as possible in the development of the Union's work.

Sec. 3. Superintendent.—The Superintendent shall have a general supervision of all the work of the Union. She shall keep in touch with Societies by visiting, correspondence, and by sending literature; shall endeavor, with the aid of her associates, to organize a Woman's Missionary Society, Young Woman's Auxiliary, Junior Union, Definite Personal Service Committee, Order of Royal Ambassadors or Sunbeam Band in every church of the Association. She shall submit an annual report to the Associational Union, shall send a quarterly report to State Corresponding Secretary, shall present a report at the annual meeting of the State Executive Board, and shall prepare a comprehensive report of the year's work for the annual meeting of the Pulaski County Baptist Association and for the Annual Woman's Missionary Union. She shall attend, if possible, the conference of Superintendents held in connection with the annual Woman's Missionary Union.

Sec. 4. Secretary.—The Secretary shall keep a record of annual and Executive Committee meetings; shall notify committees of their appointment. She shall send a copy of minutes of the Annual Meeting to the Clerk of the Pulaski County Baptist Association.

Sec. 5. Treasurer.—The Treasurer shall keep all receipts and an accurate account of all moneys passing through her hands; shall tabulate, giving only sum totals, the financial report of Societies; shall send all contributions, except for expenses,

to the State Woman's Missionary Union Treasurer, and shall make an annual report to Associational Union.

Sec. 6. Temporary Committees—At the first meeting a nominating committee of five shall be elected from the floor. The President shall appoint all other committees not otherwise provided for.

Sec. 7. Standing Committees—The following standing committees shall be appointed by the President, at her convenience to report to the next annual meeting:

1. Committee on Program.
2. Committee on Woman's Work.
3. Committee on Literature.
4. Committee on Obituaries.

Sec. 8. Delegates to the Woman's Missionary Union—The President shall represent the Union at the Annual Woman's Missionary Union.
