FRIDAY, OCTOBER 19, 1900.

Pursuant to adjournment the Mt. Vernon Baptist Association met with the Helena Baptist Church, Helena, Ark, Oct. 19th, 1900, at 10 a.m., and was called to order by former Moderator, Major S. H. King.

After reading letters the association proceeded to elect officers for the ensuing year.

A motion was made and carried, that on account of the feeble health of our Brother S. H. King, who has served Mt. Vernon Association long and faithfully as its honored Moderator, be elected Moderator and that an Assistant Moderator also be elected.

Slaughter. A. Flora and L. P. Anderson were appointed as tellers. G. R. Robuck was appointed to assist the tellers in counting the vote, which resulted in a tie; whereupon a second vote was ordered to be taken, and Deacon Lon. Slaughter was declared elected to the office of Assistant Moderator. Bro. W. H. Allison nominated L. P. Anderson for Clerk. A. N. Couch nominated J. A. Smith; J. B. Wise nominated L. J. Wilkes; The nominations of J. A. Smith; and L. J. Wilkes being withdrawn, the Clerk was instructed by a unanimous vote of the body to cast its vote for L. P. Anderson as Clerk. At this point a letter from Raymond Church was read and H. W. Graves curolled as a messenger.

Committee on Orphaus' Home made their report per Chairman H. C. Rosamond:

Since our last report to you we have made some progress. Our future is hopeful. We have now thirty children in the Home. Ten have been baptized, and are faithful church members. We have a good school taught in the building. The larger-boys cultivate the farm. Our main building is enclosed but not finished on the inside. Two associations have agreed to finish and furnish one room each at a cost of \$80.00 per room. Will Mt. Vernon join hands with them? We feel that this body should not be behind in grand works. Our noble Matran has made sacrifices that ought to inspire all hearts to stand by her. We recommend that all our churches take collections for this work. The Master left us the poor as a lagitage. These children must be trained for Christ. Every dollar, we put into the care and training of orphan children is treasure laid up in Heaven.

man T. M. Oldham:

Your Committee would respectfully submit for your consideration the following:—That there is a disposition on the part of professing Christians to cover up the great Hydraheadel

monster evil, the use of intoxicants of any and all names as beverages in the general term of temperance. But we believe that effects of any intoxicant are of such a nature that they can not be used even temperately with any degree of safety, and we further believe that the Baptist who uses it disgraces his profession and wounds the very cause he professes to love. We further believe that the churches are too slack in the disciplining of members who use intoxicants and are thereby retarded in growth and usefulness, and are to a very great extent responsible for at least the general traffic and consequent evil growing out of the use of intoxicants, and believing these things we offer the following resolution, to-wit:

Resolved, That we favor the extermination of liquor traffic for beverage purposes and that as citizens, and especially as Baptists, we use our influence to that end by such means as

L. J. Wilkes made the report on education. It was discussed by L. J. Wilkes, W. W. Rivers, Dr. Clark and Elder Peay, the reportswas adopted as follows:

Webster's definition of education is "the bringing up as of a child, instructions, formation of manners." It comprehends all that series of instruction and discipline which enlightens the understanding, corrects the temper, and shapes the manners and habits of youth for future usefulness. To give children a good education in the arts and sciences is important; to give them a religious education is indispensable. An immensoresponsibility rests on parents and guardians who neglect the proper training of children. Webster includes in his definition, "moral and religious knowledge in faith and practice." God has endowed man with a physical and spiritual nature, and in His wisdom has left us the means for the development of each. The idiot has neither physical or moral responsibility, but sane man is under great responsibilities, both to his fellow-men and to his God; and hence as these powers of mind, body and soul are educated in like proportion is he able to discharge the duties

of correct citizenship. Developing the mind makes better citizens, makes us more capable of properly enjoying the social life; but this would be an education in part only. The highest education is of the heart, which means spiritual developmen and consecration to God, and in order to have it we must have proper facilities. Thanks to a kind Benefactor we have them

We would recommend as a suitable place to get the above described training said development, our own Mt. Vernon High School at Trenton, which has begun its first year under most favorable auspices, to Mountain Home College, Central and

As Southern Baptists we feel that the Southern Baptist series of Sunday school literature should be used as long as it remains in orthodox lines.

The importance of having an educated ministry is felt by all Baptists. Great issues are to be met. The distinctive doctrines of the Bible are to be explained. In fact preachers have the largest and most responsible work to be done by any set of men under heaven. This being true they ought to have

the best preparation possible.

Ouachita College is offering excellent opportunity to all young preachers who wish better preparation for the work to which God has called them, by giving them free tuition, and aiding those who need help to pay their board. The board of printsterial education of Ouachita College ask the Baptists of Maansas each year for a sum of money sufficient to carry on this work. If enough money to help pay the board of all who need help is not given, some must go away from school. There are about twenty young ministers now in school at Ougedinas several of whom need help. Brethren let us help them. For several years this Association has been giving one bundled dollars a year to this great work.

You're committee recommend that the churches of this Association be now asked to pledge at least one hundred dollars

for undsterial education in Ouachita College.

There are about forty-four churches in this Association, and our instructors tell us the Sunday School is a work of the church—then why not report your school to this body, so that we can see what you are doing? We take no pleasure in making the foregoing observation, only as we hope to make your plain duty more keenly felt so that you will give us a full report of your Sunday School work at our next annual meeting.

Report of the trustees of Mt. Vernon High School, per J. Wilkes:

We, the undersigned trustees of Mt. Vernon Associational High School, located at Trenton, Ark., would beg to make

the following report:

At a session of the above association, held at Poplar Grove Church, in St. Francis County, Oct., 1898, that body appointed a board of trustees and instructed them to locate. build and operate said school, and report to this body. following persons were appointed, viz: S. L. Holloway, G. R. Robuck, Lon. Slaughter, L. J. Wilkes, Wm Allison, Alex Tebleman, S. H. King, Ira Gorum and M.J. Manning. Pursuant to the above instructions the trustees held their first meeting at Treaton, Ark., Feb. 13, 1900, the following members being present: S. L. Holloway, Lon Slaughter, Alex. Tebelman, Wm. Allison and L. J. Wilkes. S. L. Holloway was elected Chairman and L. J. Wilkes Secretary and Dr. J. W. Besin Treasurer. After prayerful consideration the board decided to accept the two acres of and generously offered by Mrs. Virginia Kendall of Trenton, and to creet a suitable building the reon. S. L. Holloway, Dr. J. W. Bean, W. H. Allison, were elected the Building Committee. The building has been crected and paid for and we desire to present it to the Association with the deed. The board elected Prof. L. P. Anderson, A. M., from Roanoke College, Va., Principal for this year, he to take charge of same and operate it, his compensation to be the receipts therefrom. The school opened on Sept. 10, 1900, with 29 pupils. The progress and prospects are very satisfactory to the board. Size of building, 50x30, two storties. The second story is divided into two rooms for classes, and a library room; the lower story is arranged for an audiforium; two large-porches; with a front and a rear stairway. All material used is first class. Value of building, furnishings and ground \$2,500 00. All liabilities paid, except about 8200 00 on furnishing. Chapel exercises held every morning. The inoral and religious training a prominent feature of the school. As the terms of six of the trustees have expired it will be necessary for this body to elect their successors. Frustees named herein whose time has expired, as follows: Lan, Slaughter, S. L. Hollowny, G. R. Robnek, L. J. Wilkes, Mox Tebelman and S. H. King. Special mention is due Dr. LW. Bean for his untiring energy and interest in the building of the school. We recommend, First-That a cash collegtion be taken and personal pledges be made for the payment of the debt now due. Second-That all the pastors of our Association lend their prayers, their influence and in any way they can foster the interest of this school in paying up its debt

on furnishings and in securing boys and girls for same Third -That the Clerk of this Association be instructed to advertise this school in the minutes of this Association.

Since there is some dissatisfaction in regard to the present plans of the board we recommend that we express our-confidence in their integrity, faithfulness and devotion to the Master, in their planning and work entrusted to their hands. That the state be divided into two or more districts and evangelists be employed who shall be required to devote their whole time in traveling and preaching to the poor and destitute of our state, and that if this or a similar policy is adopted we pledge ourselves to increase our contributions as the exigencies may demand.

ARTICLE 8. Every subject introduced for discussion shall be decided before another is offered, unless it be laid over by

ARTICLE 10. The appellation of "Brother" shall be used in addressing each other.

Abrican 12. Amendments or alterations may be made to these rules when a majority may deem it necessary.

ARTICER 13. Any case coming before the Association, not provided for in these rules shall be governed by general parliamentary rules.

CONSTITUTION.

1... This confederation of churches shall be called by the name of "Mount Vernon Baptist Association."

2. The object of this Association shall be to promote the

- glory of God on earth by the preaching of the gospel of His Son, Jesus Christ, our Saviour; the universal spread of the
- Bible, the word of the true and living God, and by other appropriate means.

 3. This Association shall consist of messengers from the
- churches now forming this union, and such other Baptist churches as may hereafter be received as constituent members thereof.
- 4. Every church shall be entitled to three representatives without regard to the number of their members, respectively, and to an additional one for every fifty members exceeding fifty; provided, That no church shall ever be entitled to more than five. A certificate of appointment or letter from their respective churches shall be evidence that they have been so
- 5. The officers of this Association shall, be a Moderator, a Clerk or clerks, a Corresponding Secretary and a Treasurer, who shall be elected annually by ballot, by a majority of the members present, immediately after the names of the delegates

delegated.

ure enrolled, which officers shall perform all duties, respectively, isually devolved on such officers, and continue to exercise heir respective functions until they shall be superseded by a

sulmequent election.

- 6. The Clerk shall preserve a regular record of the Association and have it present at the meeting of the body, and when they vacate their offices deliver the same, with all other books and papers relative to said office to their successors.
- 7/ The Association shall regard the churches as independent bodies in all their internal affairs and exercise no ecclesiastical jurisdiction, or claim any legislative or judicial prerogative over them; nevertheless, the Association may exercise authority over its own members, the representatives of the churches, and power to withdraw from all churches which may depart from the gospel as understood and held by this body by becoming either heterodox in faith or disorderly in practice, and should therefore regard the churches united in the Association with a vigilant eye for good and may give at its own discretion, and in its own way, advice or information when sought to any church connected with it.
 - 8. It shall be the duty of the Association to ascertain the general condition of its constituent churches; devise means to promote their harmony and increase their spirituality and efficiency, to promote the cause of truth and righteousness.
 - 9. The Association shall hold annual sessions, to convene on Thursday before the first Lord's Day, in October, in each year, and not adjourn until all the business shall have been regularly finished, except when circumstances imperiously demand. The place of meeting shall be determined at each previous session and published in the minutes.
 - 10. Baptist churches not before united in the Association, or those dismissed from other associations, may be admitted as members into this union on application by a written petition or letter, presented by one or more messengers duly appointed by such church or churches, provided they give satisfactory evidence that they are orthodox in faith and correct in the practice of the gospel ordinances.

11. Every minister of the gospel (either ordained or

licentiate) whose membership is in or who may be a pastor of any church belonging to this body, shall be ex-officio a member of the Association, with the privilege of offering resolutions and speaking, but not of voting unless specially delegated by some church.

- 12. When in session the Association will be governed by such rules of decorum as it may adopt for itself.
- 13. It shall be the duty of the churches, respectively, annually to report to the Association their general condition; the number of members in fellowship; the number baptised, received by letter, dismissed, excluded, restored, and dead during the year, and the names and postoffice addresses of all ministers (whether ordained or licensed), designating each, and also the name and address of their clerks. They shall also report on any special matter required, and send up such contributions as they may willingly contribute to aid the body to disseminate more widely the truth as contained in Holy Scriptures and the establishment of the Redeemer's kingdom on earth.
- 14. The neglect or failure of a church to be represented by a messenger, on messengers, in the Association for three consecutive years shall be cause to withdraw from such church at the discretion of the Association.
- 15. This Association may correspond by letter or messenger with any other religious body of the same faith or order.
- 16. A board consisting of five members, any three of whom shall constitute a quorum, shall be elected at each annual meeting, whose duty it shall be to devise means to carry forward the benevolent objects of the Association, and the officers of this Association shall be ex-officio members of the board:
- 17. The minutes of the Association shall be publicly read and corrected, if necessary, and then signed by the Moderator and Clerk before the Association adjourns.
 - 18. Any amendment may be made to this constitution at

any meeting of the Association by a vote of two-thirds of the members present, provided the same shall have been published in the minutes of the preceding year.
