PROCEEDINGS.

Saturday, September 5th, 1858-11 A. M.

Elder P. S. G. Watson, who had been chosen to preach the Introductory, and Elder J. M. Cox. alternate, not arriving in time, the service was performed by Elder W. H. Barksdale, of Helena. Text: John xiii, \$4.

An intermission of about thirty minutes was given, and then the Messengers were convened by Elder T. S. N. King, the former Moderator. The former Clerk at the table. Same appropriate remarks were made by the Chairman, a hymn sung, and the Moderator led in prayer.

Letters were then read from nine Churches, and the messen-

gers' names enrolled as follows:

No other delegates arrived on Saturday.

The above enrolment being made, an election was held to elect Associational Officers for the ensuing year. Upon counting the votes Spence Hall was found chosen Moderator; P. S. G. Watson, Clerk; John H. Hicks, Corresponding Secretary; and J. C. McCrary, Treasurer.

The Moderator took the Chair, addressed the Association in a few brief and appropriate remarks, then read the Rules of De-

corum.

Business as follows:

1. The Moderator invited any persons desiring the admission of new Churches, to come forward. A letter was handed in

from the Clarendon Church, but as no messenger was present." the subject was laid over till Monday.

3. All ministers of the Baptist denomination present were invited to sit with us .. Accepted by T. S. N. King and Nathan McKeean.

3. Reports read and disposed of as below:

RESOLUTIONS ADOPTED.

- 1. That the 9th article of the Constitution of this Association be so altered as to fix the time for the beginning of the Annual Meetings (after 1859) on Thursday before the first Sunday in October.
- 2. That the next Annual Meeting be held with the Liberty Church, Phillips county, Arkansas, beginning on Saturday before the first Sabbath in September, 1859. Distance from Helena, twenty miles north-west, near the St. Francis road.

3. That the Clerk have six hundred copies of the Minutes

printed, that he hold twenty-five for general correspondence, and that he have ten dollars for his services.

4. That the list of Ministers names, &c., be again printed as

part of these Minutes.

5. That the Board of Missions for last year be continued, except R. J. Koonee, who will shortly leave our Associational limits, and that W. C. Chastain fill his place.

6. That the Missionary Agents of the past year be continued, and that new Churches be requested to appoint one in every

Church.

7. That we heartily approve of the movement to publish Baptist Sunday School Books, and that we have full confidence in the wisdom, honesty, and entire competency of all the persons, engaged in the enterprise.

8. That we feel the need of a College in our own State, and highly favor the purpose of the State Convention to establish

one.

2. That we daily experience inconvenience for want of a Denominational State Paper; and further, that as soon as a sufficient number of subscribers shall have been obtained, we recommend that the paper be published.

10. That J. M. Cox be our messenger to the Caroline Associ-

ation.

11. That the first meeting of the Educational Board be held on the first Wednesday in November next, at Big Creek Post Office, in the Little Rock road, twenty miles west of Helena.

12. That the Clerk send the Minutes by mail, unpaid, to the

several Churches.

. 13. That the thanks of this Association are due, and are hereby tendered to the Oak Grove Church and to the citizens of its vicinity, for the hospitable and pleasant manner with which they have entertained this body.

14. That we now adjourn to meet with the Liberty Church, Phillips county, Ark., on Saturday before the first Sabbath in

September, 1859.

ON DOMESTIC MISSIONS.

Your Committee, to whom was referred the subject of Domes-

tic Missions, beg leave to report :

Your Association has an area of at least fifty miles square. Within this district, as your Minutes show, there are sixteen Churches at which there is regular preaching, and these Churches are to be supplied by only seven ordained ministers. Such being the case, we cannot—we need not—disguise the fact that action, prompt and immediate action, is demanded at the hands of your body, in the way of supplying the destitute with the living ministry and the famishing with the bread of life. The Macedonian cry coming up from the dark portions of our Zion is not to be smothered! Too loud, deep, melancholy and thrilling has it sounded in our ears, now to be hushed into silence by mere resolutions penned upon paper, contemplating no more than their genteel appearance in type, mourning the existence of these things. A corresponding exertion to remedy the evil must be put forth.

That we have the truth, as taught by Christ and his Apostles, we sincerely believe. That it is incumbent upon us to spread this knowledge, who can gainsay? We read the commission given by Christ to his Apostles, to "Go into all the world," preaching the kingdom of God is at hand. They began at Jerusalem, and soon the whole region of Judea was filled with the knowledge of Christ and him crucified; but not content with this, they pushed the triumphs of the Cross beyond the Roman Province to distant nations; and on in its redeeming power the mission rolled till we have caught the streaming light, radiating all fresh from the Son of Righteousness, enabling us to read apon the providence of God, the lines clearly drawn by the land of inspiration, "freely ye have received, freely give." We must then be up and doing. The torch of evangelical truth

must light up the hills and caves within our boundary, and then to other fields must we push, Apostle like, the standard, "for there remaineth much land to be possessed."

Your Committee would therefore suggest that your Executive

to open a correspondence with brethren in other States, for the purpose of securing an efficient missionary, whose duty it shall be to travel through the destitute portions of the Association, hold protracted meetings, organize Churches, distribute denominational books, and to solicit funds for the benefit of the Asso-

Board be requested (if a missionary cannot be had amongst us.)

and they are hereby requested to send up every year, a missionary fund, to be appropriated to the defraying of the salary of your missionary. Let no Church fail to send something, and let it be "as the Lord hath prospered" them-remembering that

BIG CREEK POST OFFICE, Phillips Co., Ark., \ Saturday, July 24th, 1858.

On this day the Educational Board met at the above place-Elder J. M. Cox, Chairman, and P. S. G. Watson, Secretary.

Members present: E. Holland, R. Brown, J. M. Cox, and P.

S. G. Watson; Dr. Wm. R. Baker, as proxy to cast the votes for A F. Dunn, of Sterling; J. P. Varm, of Harmony; and J. Satter-

white, of Bible Union. Resolved, That with the members present we proceed to business. Carried.

The subscription raised by the citizens in and near Big Creek

Post Office, (now Trenton,) amounting to about \$2,000 in cash and eight acres of land, was laid before the Board.

Speeches were then made upon a motion to locate both the contemplated Male and Female Schools at Trenton, after which

it was

Resolved, 1st. That we, the members present in person and by proxy, do adopt, so far as we can, the proposition to locate both the Schools of the Mt. Vernon Baptist Association at Big Creek Post Office, or Trenton, by receiving the subscription of land and money as above.

2d. That we report the proceedings of this meeting to the Association, and request that body to confirm our acts, as we

have not a constitutional majority present.

3d. That we will request the Association to appoint an agent

to solicit additional funds to add to the above amount.

4th. That we will do anything else necessary to carry out the present intention to establish a Male and Female High School at

the above place.

By unanimous vote, those persons whose names were to the subscription above mentioned, were requested to name the Schools and report the same to the Association in September next. Adjourned.

SABBATH SCHOOLS.

Your Committee on Sabbath Schools ask leave to report, That they have had the same under consideration, and are involuntarily forced to exclaim, "how vast the field! how little doing." There is fearful inactivity somewhere upon this subject. Its importance, all admit. Its aid in furtherance of spreading the knowledge of gospel truths, is yearly seen where Sabbath Schools are regularly attended. Other denominations understand the great utility of Sabbath Schools, and act accordingly. Baptists in many places are acting axisely on this subject, while some others do but little more than pass favorable resolutions and spread upon their Minutes approving reports. These resolutions and reports are good as far as they go, but they will effect but little, unless the design be carried forward into action! action!

Finding that so little has been accomplished by any former course adopted, your Committee would, at present, attempt nothing more than to press, urgently press, upon your body the yast importance of Sabbath Schools as a means of disseminating the truth of the gospel amongst the rising generation in your midst.

We leave the adoption of some efficient plan to the wisdom of your own body. Respectfully submitted.

COLORED POPULATION.

Your Committee on the Colored Population would respectfully submit this, their report :

That it is incumbent upon us to see that our servants have religious opportunities, none, I presume, will call in question. They are creatures of our care, and by a train of circumstances, we are so situated, that we cannot now, if we would, throw from us the responsibility of teaching them the good and the right way, that leads to an inheritance incorruptible, undefiled, and that lieth within the vale.

Your Committee, in consideration of the above, offer the fol-

lowing resolutions:

Resolved, That, as masters, we urge upon our servants their accountability to their God, the necessity of "repentance toward God and faith in Christ Jesus;" that we clear our skirts of their blood by securing, either through our pastors or otherwise, regular preaching to them at least once a month, and oftener, if practicable.

Resolved, further, That our pastors, and other ministers within the bounds of this Association be, and they are hereby requested to preach to the negroes of their respective congregations at

least once a month, during the next Associational Year.

COLPORTAGE.

Your Committee on Colportage have been unable to ascertain the amount of Books put in circulation the past year within the bounds of this Association; but having no regular colporteur in the field, and but two or three ministers who distribute books, we naturally infer that but few have been disposed of.

That our denominational works could be readily sold, there is little or no doubt; and that such works would set us correctly before the eyes of the community is certain; but your Committee is at a loss to suggest any plan by which so desirable an object can be attained, and would therefore leave the Association entirely free from any suggestion from the Gommittee, to act as the assembled body may think best, hoping that measures may be taken at once to supply such works.

The Committee rejoices in the fact, that notwitstanding our

apathy in this matter, other denominations are generously assisting us in distributing our Book of Discipline.

Your Committee on Temperance ask leave to report that we look upon the intemperate use of ardent spirits by the community in general, but by professors of religion in particular, as one of the greatest curses to christianity found in the nineteenth cen-

tary, Anno Domini.

A few years ago, hope sprang up in our hearts, on account of a movement in behalf of Temperance begun in Phillips county, included within our Association; but the temporary daming up of the stream has but caused the overbreaking flood to rush with the more wild and fearful impetuosity. Drunkenness is openly indulged in by men of the world, both old and young! And whose blood has not been chilled, and whose heart has not been made to bleed, to see the havoe this same monster of iniquity, intemperance, has made amongst the churches of Christ?

Before christians can take their proper position in the militant host of God, and wield their intended influence over the unconverted, they must thrust the monster tyrant from them; and (except for medicinal and mechanical uses,) "touch not, taste not,

handle not," the unclean thing!

Churches should control its use amongst their own members; they must do it, or suffer blight and mildew as a necessary and unavoidable consequence!

As your Committee, we, therefore, recommend the adoption

of the following resolution:

Resolved, That we carnestly recommend to the Churches composing this Association, to discountenance the use of ardent spirits as a beverage, and also the buying and selling of the article as a livelihood. 1st. By faithful and brotherly admonition. 2d. By exclusion from the Church, if such course be persisted in.

[II.] STATE OF THE CHURCHES.

The Committee on the State of the Churches, from the imperfect materials at hand, have gathered up the following, which we ask leave respectfully to submit:

HELENA.

This Church is in Helena, the county seat of Phillips; was organized in 1851. It has had as regular pastors: 1. John Bateman; 2. Reuben Jones; 3. F. M. Freeman; 4. Wm. H. Barksdale, the present. The Church owns a house worth from \$3,000 to \$4;000; has a melodeon; Sabbath school; library; weekly prayer meetings, Wednesday nights; preaching every Sabbath. John Q Taylor, Clerk. Helena.

ASH GROVE.

Ash Grove was organized in 1853, and is on Bayon DeView, St. Francis county, north-west from Helana twenty-five miles, and twenty-five miles south-east from Augusta; preaching twice a month; enjoyed a revival in August last. The Church is in a good condicion; owns a hewed log house, and is in a good neighborhood. J. M. Cox, Pastor, and Josiah Simpson, Clerk. Cotton Plant, St. Francis county, Ark.

BIBLE UNION.

This Church was organized in 1853, and is nine miles northwest from Mt. Vernon, St. Francis county. It is unrepresented this year, consequently we know nothing of its present condition. John Satterwhite may act as correspondent for the Church. Mt. Vernon, St. Francis county, Ark.

LIBERTY, (PHILLIPS Co.)

Was organized in 1848; has had as pastors J. M. Cox, A. W. Ellege, and P. S. G. Watson; mouthly preaching; occasionally to the Blacks; distant from Helena twenty wiles, near the St. Francis road, at same beautiful springs. The Association will be here next September. The Church has a large hewed log house, not entirely finished. The neighborhood is good. H. L. Cordell, Clerk. Mariana, Phillips county, Ark.

STERLING.

This Church was organized in 1854, and is at the mouth of the St. Francis river; has a small frame house; monthly preaching;

a female prayer meeting. In consequence of the caving of the Mississippi banks, the town is passing away and the population diminishing. P. S. G. Watson, Pastor. A. B. Young, Clerk. Sterling, Arkansas.

NEW HOPE.

Was organized in 1848, and has had as pastors: Porter Clay, A. W. Ellege, and P. S. G. Watson. It is on the St. Francis road, twelve miles north-west from Helena; meets twice a month in an "every body's" frame house; preaching to the blacks on every other Sunday evening. R. C. Burke, Clerk. LaGrange, Arkansas.

SALEM.

Was once connected with the St. Francis Association, but united with this in 1855; it is south-west from Helena twenty-five miles, on Coffee Creek, Philips county. It has had Ezekiel Holland as Pastor since its union with this body. Richard Brown, Clerk. Big Creek Post Office, Phillips county.

BETHEL.

Is on Hickory Ridge, Phillips county, west from Helena twenty-four miles, on a county road; monthly preaching. The Church was organized in 1854, and has has Ezekiel Holland as Pastor ever since. It is unrepresented this year. Ezekiel Holland, Clerk. Big Creek Post Office, Phillips county.

OAK GROVE.

Was organized in Monroe country, in 1854. It is north-west from Helena, on the Spring Creek road to the prairie, thirty miles. The Church has a small hewed log house: monthly preaching. J. M. Cox has been the Pastor from the beginning. Dr. J. W. Sullivan, Clerk. Moro P. O., Monroe county.

RUПАМА.

Was organized in 4855, in Arkansas county, and is south-west from Aberdeen twenty miles. W. J. Hood has been Pastor from the beginning. T. J. McAdams, Clerk. Long Point, Arkansas gounty.

HARMONY.

Was organized in 1855, in Monroe county, six miles northwest from Lawrenceville, near the Clarendon road. W. J. Hood has been the only Pastor; monthly meeting. The Church has an unfinished hewed log house. E. W. Vann, Clerk. Lawrenceville, Monroe county.

LIBERTY, (MONROE COUNTY.)

Was organized in 1853, in the south-west extremity of Monroe county, south-west from Aberdeen five miles. The Church has a hewed log house; monthly preaching by W. J. Hood, who has been the only Pastor. Benj. Walker, Clerk. Aberdeen, Monroe county.

SHILOH.

Was organized in Prairie county, in 1856. W. J. Hood has been its only Pastor. Not being represented this year, we can say but little. Its former clerk was W. B. Bailey. Aberdeen, Monroe county.

CYPRESS VALLEY. '

Was organized in 1857, twenty miles north-west from Helena. It has a large unfinished hewed log house; monthly preaching by T. S. N. King. Luther M. Roberts, Clerk. LaGrange, Ark

CLALENDON.

Was organized in 1858, in Clarendon, (or mouth of Casche). It has monthly preaching by W. J. Hood, the pastor. Joseph P. Vann is Clerk. Clarendon, Monroe county.

LINN GROVE.

Was organized in 1858, and is south-east from Lawrenceville, Monroe county, five miles. Having chosen W. J. Hood their Pastor, they meet on Monday—his Sundays being engaged. J. C. Erwin, Clerk. Lawrenceville, Monroe county.

For lack of materials, this imperfect sketch is respectfully submitted.
