CONSTITUTION

As Amended at 1933 Session and 1943 Session

Article I.—NAME

The name of this body shall be Pulaski County Baptist Association.

Article II.—OBJECT

The object of this Association shall be to aid the churches in their divinely appointed work of spreading the Kingdom of God throughout the whole world by every Scriptural means.

Article III.—MEMBERSHIP

Section 1. This Association shall be composed of messengers from regular Baptist Churches, which are in sympathy with the principles and purposes of this Constitution and desire to co-operate with this Association, who shall be entitled to seats upon the presentation of letters from their churches or other satisfactory evidence of their appointment.

Section 2. Each church shall be entitled to three messengers, with one additional messenger for every fifty members or major fraction thereof above one hundred.

Section 3. Messengers from churches desiring to affiliate with this Association shall present to the Association petitionary letters or other evidence setting forth the Articles of Faith on which the churches were organized together with satisfactory evidence of the regularity of their organization. They shall be received into the Association only by unanimous vote as cast by the body.

Article IV.—AUTHORITY

This Association shall never exercise any legislative or ecclesiastical authority over any church, nor shall it in any way interfere with the rights and absolute independence of the churches of Christ.

Article V.—OFFICERS

Section 1. The officers of this Association shall be a Moderator, Vice-Moderator, Clerk and Treasurer, who shall be elected at the opening of each annual session by a majority of all the votes cast at such meeting. Provided, however, that the Moderator shall not be eligible to serve more than two consecutive terms.

Section 2. The Moderator shall preside at all sessions of the Association or call some one to occupy the chair temporarily in his absence, and may exercise the same privilege of discussion as any other member of the Association.

Section 3. The Clerk shall keep a correct record of all the proceedings of the Association and shall superintend the printing and distribution of the Minutes of each session as he may be directed by the Association.

Section 4. The Treasurer shall receive all funds of every kind entrusted to his care, and shall disburse the same upon the order of the Association and shall make an itemized report of all such funds to the Association before the close of each annual session.

Article VI.—ASSOCIATIONAL BOARD

Section 1. The Associational Board shall be composed of one lay member, elected by each co-operating church, together with the pastors of such churches, and the officers of the Association and the Superintendents of W. M. U. Work. Seven members of said Board shall constitute a quorum to transact business, after notice has been given all members of the Board of such meeting.

Section 2. This Board shall co-operate with the churches in this Association in informing and arousing the churches in gathering and disbursing of funds for all of the causes fostered by this Association and shall transact all of the business of the Association in the interim of the annual meeting of the Association.

Article VII.—MEETING

This Association shall meet annually on Monday night after the second Sunday in October at 7:30 o'clock.

Article VIII.

This Constitution may be amended at any annual session of the Association by a two-thirds vote of the messengers present at any annual meeting, provided that the substance of Article IV shall never be abrogated.

RULES OF ORDER**(BY-LAWS)****As Amended at 1933 Session**

- I. Each Session shall be opened and closed with prayer.
- II. The following shall be the order of exercises:
 1. Body called to order by the Moderator or, in his absence, by brethren in the following order of precedence: Clerk, treasurer, pastor of entertaining church.
 2. Devotional Service.
 3. Presentation of letters and the enrollment of messengers.
 4. Permanent organization.
 5. Introductory Sermon.
 6. Petitionary Letters.
 7. Reception of visitors, corresponding messengers from other bodies and introduction of new pastors.
 8. Appointment of program committee which shall recommend a schedule for all reports and other matters to come before the body, subject to the Association's approval.
 9. Appointment of committees as follows: (1) Association Missions; (2) State Missions; (3) Home Missions; (4) Foreign Missions; (5) Colleges and Schools; (6) Religious Literature; (7) Bible (Sunday) Schools; (8) Ministerial Education; (9) Orphan's Home; (10) Christian Stewardship; (11) Hospitals; (12) Woman's Work; (13) Young People's Work; (14) Digest of Letters; (15) Obituaries; (16) Resolutions; (17) Finance; (18) Temperance; (19) Nominations.
- III. Every speaker shall rise and address the Moderator. In discussion all personalities shall be avoided. No one shall speak more than twice on the same subject, without special permission from the Association.
- IV. Mell's Parliamentary Law shall be the standard in deciding questions of parliamentary practice.
- V. The minutes of the preceding day shall be read and approved at the meeting of each morning session and at close of the Association meeting.
- VI. Such offerings may be taken at the annual meeting of the Association as the body may direct.
- VII. These by-laws may be amended at any regular meeting by a two-thirds vote of those present, or suspended by unanimous vote.
- VIII. The Associational Board shall meet monthly at such time and place as the Board itself may determine.
- IX. A doctrinal sermon shall be preached during each annual session at such an hour as each program committee shall provide.
- X. The second night of the Association shall be known as B. Y. P. U. night, and a program planned accordingly in connection with Associational B. Y. P. U.

14. One of the best services of the meeting was the Reports on Benevolent Institutions. These Reports were given and spoken to by O. A. Greenleaf and were adopted as printed below:

BENEVOLENT INSTITUTIONS

REPORT OF BAPTIST STATE HOSPITAL

Your Hospital reports the past year as one of unprecedented activity, meeting emergencies at every turn, striving with unremitting effort to maintain a high standard of efficiency in the care of the sick and suffering.

During the year the Baptist Hospital cared for around 11,000 patients. Free service was given to the amount of \$51,342.19. Babies born in the Hospital last year, 844. The scope of the Hospital's service extended to all parts of the state, and many patients were cared for from other states.

The Baptist Hospital, realizing fully war conditions that demand a large increase in the number of nurses, has co-operated fully. At the graduation exercises held in Immanuel Church Auditorium in May the largest class ever to have graduated from a School of Nursing in Arkansas received their diplomas. This class of well-trained young women numbered 38. The class admitted in June numbers 53. There are now 180 nurses in the School of Nursing. Your Hospital is doing a monumental work in training young men and women for the medical, hospital, scientific and nursing fields.

In spite of adverse circumstances, the building program is being carried through to completion. The enlargement of the nurses' home will make room for 64 additional nurses. This addition to the nurses' home was made imperative by the increase in the number of nurses entering training. The

enlargement of kitchen, pharmacy, tea room, etc., was a dire necessity. These improvements are beautiful, dignified and permanent, and increase the value and efficiency of the hospital plant enormously.

The Hospital is grateful to the kind-hearted Baptist women over the state who keep in mind the hospital's needy sick, and whole-heartedly support the work of caring for these who come to the Hospital for aid. The Hospital is deeply appreciative of the linens, the home-canned fruits and vegetables and the charity dollars given by our Baptist women, but above all the Hospital values the spirit of loyalty, of co-operation manifested by the hundreds of women over the state who give continually to the great work being accomplished in our Hospital.

The Hospital acknowledges with sincere thanks the gift to the Hospital Charity Fund of the many offerings sent in by the Sunday Schools over the state. The offerings were taken when Sunday Schools presented the Mother's Day-Hospital Day program in May.

The Student Secretary is carrying on a good work among the nurses in training, giving religious instruction and assisting with a program of recreation including many outdoor activities.

The great objective of the Hospital is life-saving. A person who saves the life of another is regarded as a hero, and medals are awarded for such a deed. Often it takes the work of many experts to save a life, but in our Hospital are to be found these experts, trained men and women, with the facilities at hand for life-saving. The saving of a human life is almost a daily occurrence in our Hospital, and medals without number could be awarded to your Hospital in its work of saving human life. Our denomination in establishing this life-saving station was but following in the footsteps of the Great Physician, who valued human life as none other.

OUR HOSPITAL

Born in a spirit of prayer, born in a spirit of high resolve to carry out fully the teachings and example of the Lord Jesus, the Baptist State Hospital came into being as the fulfillment of a burning desire of a people to serve suffering humanity and honor their Lord.

When the days of miracles ceased, the followers of the healing Christ began carrying on His healing ministry through human instruments, and Christian hospitals have

proved to be one of the greatest instruments through which God has blessed the sick, the suffering, the lame, the halt and the blind.

When our Baptist people founded the Baptist Hospital they could not possibly visualize the enormous work the Hospital is doing in its work of restoring health, of relieving suffering, of adding years to the span of human life. God is using the Baptist Hospital in a wonderful way to give relief to His suffering children.

Medals are given for life-saving. How many medals could be pinned on our Baptist Hospital as it goes about its work of life-saving every day. Some of the emergency cases brought to the Hospital are beyond description—bodies so broken and mangled, and yet through the mercy of God so many are returned to their usual walk of life restored fully in bodily vigor.

The Baptist Hospital is entirely self-supporting, and does not participate in co-operative program receipts of the Arkansas Baptist Convention. The Hospital has been able to finance the extensive improvements and enlargement made necessary by increased patronage.

The Baptist Hospital's patronage comes from every nook and corner of the state and from many states outside the borders of Arkansas. Educationally the Hospital has done a monumental work in training young men and women for the medical, hospital, scientific and nursing fields during the 24 years of its existence.

Something more is required of a Christian Hospital than that it shall function efficiently from a scientific or educational standpoint—it must serve in the spirit of the Master. Through their Hospital, in the Master's name, Baptists of Arkansas have brought joy and comfort to thousands of the sick and needy, and have ministered to those seeking spiritual guidance. Can it not be said that they have won the smile of approval from Him who "went about all the cities and villages, teaching in their synagogues, and preaching the gospel of the Kingdom, and healing every sickness and every disease among the people"?

REPORT ON BOTTOMS' BAPTIST ORPHANAGE, 1944

Once again it is our privilege to report the work of our Orphanage.

We have been wonderfully blessed this year, no illness of any serious consequence.

We have suffered from drouth as most all of you have.

We have cared for 80 children and now have 70 children in the home. Some have left who became of age. Some have joined our armed forces until now we have over 60 serving our country.

All of the religious organizations have reached their Standard.

One of our girls is in the A. & M. College, Monticello, and contemplates entering the Southern Baptist Hospital at New Orleans as a nurse.

All children will be promoted upon return to school this fall. Some few had to attend summer school to complete work in which they were behind.

We want to especially call your attention to the fact that our truck will not make any trips this fall, due to tire and gas shortage, so if you have supplies for us, please ship them to us motor freight and we will pay the freight.

15. In the matter of Church Organizations, as Sunday School and Training Union work, all were delighted with progress made by these departments in Associational work. Ralph Davis made the report for the Training Union Department and Guy Wilson reported for the Sunday School Organization. These reports were accepted and filed for information.

SUNDAY SCHOOL REPORT ASSOCIATIONAL ORGANIZATION

Another year has come and gone, and there is still some land unconquered. But in spite of the fact of so much unrest in our nation, there has been some progress in our Sunday School Organizations. The efficiency of our Sunday School work has improved, for we now have 10 Standard Schools,

with more expecting to reach the Standard soon. There seems to have prevailed among our teachers a spirit of better Bible teaching.

We had two big simultaneous training schools, one was held at First Church, North Little Rock, and one at Pulaski Heights. We also had a county-wide school at First Church, Little Rock, with approximately 400 awards given.

The average enrollment in Sunday School last year was 12,162, with an average attendance from enrollment standpoint of 5,114, with 379 baptisms being reported from the Sunday Schools.

A united effort in Vacation Bible Schools proved to be a great success. We had 30 or more schools going at once with an average enrollment of 2,179, with an average attendance of 1,735. We have this recommendation to make as an associational organization of Southern Baptists and our goal for the occasion is one million souls for Christ.

Be it resolved that we concentrate our efforts and major on evangelism through the Sunday School.

REPORT OF ASSOCIATIONAL TRAINING UNION TO PULASKI COUNTY ASSOCIATION

According to the 1943 minutes of the Association, there were 427 individual unions in the Training Union, with an enrollment of 3,114. During the year only eight churches reported no Training Union work and three of these made no report to the Association.

I. Activities

The following are some of the activities of the Associational Training Union Organization:

1. Three meetings of the Training Union Executive Committee.
2. Three mass meetings at First and Second Baptist Churches, Little Rock, and First Baptist Church, Sylvan Hills.
3. Three issues of "The Trumpet."
4. Promotion of Junior memory work and better speakers' contest. Six Juniors from Second Baptist Church were eligible to represent our Association at Siloam Springs. Two attended the Assembly, and Annette Carter won in the Arkansas contest and was eligible to represent Arkansas at Ridgecrest. Mr. Meredith Wilfong won the Young Peoples' better speakers' contest and represented our association at Siloam Springs, and having won there, was eligible to represent Arkansas at Ridgecrest.

This is the first time this type of work has been promoted in this Association for several years, and we believe the work can make greater progress during the next year.

5. The Associational Training Union officers assisted the Ironton Baptist Church in a very successful training school.

II. Study Course Awards

The following 1,018 study course awards were issued to 23 churches in Pulaski County Association, October 1, 1943, to September 1, 1944:

sions Committee, together with the recommendations for program of work for 1944-45. Report accepted and recommendations adopted as found below.

REPORT OF MISSIONS COMMITTEE

To Pulaski County Baptist Association—Greetings:

The Missions Committee of Pulaski County Baptist Association has special instructions from his body to recommend and lead in Associational Mission activities. We were named by the Association in annual session and this is the second annual report of the committee. We are pleased to give account of our stewardship as a committee in planning and directing the Associational program.

Church Centered

The City-Associational Mission program is not a new program. We are just placing a new emphasis on an old program. For years Baptist churches have been projecting themselves into other communities through teaching and preaching services. We read that Immanuel Baptist Church, Little Rock grew out of a West End Mission of the Second Baptist Church. Baptist Tabernacle, South Highland, Calvary, High Street, Bethel, Grace, Hanger Hill, Central, North Little Rock, Levy, Pike Avenue, etc., are all the result of a little Mission Sunday School and a preaching service conducted by some stronger church. So it is not new. It is a church centered and church operated program and Christ is given all the glory through the churches. The territory is too large for any one individual to make himself available to all the needs . . . so the churches project themselves into the communities about them and we now have some 20 communities served by larger churches.

Too, it is the case of the stronger helping the weak. In many instances strong churches have pooled their resources to help make available the Gospel of Christ to all the communities and in some instances a strong church has "mothered" a weak church and nursed her to increased life.

A Co-operative Program

The program of work is co-operative in that all the churches furnish the operating capital. The Home Mission Board pays the salary and travel of the Superintendent. In some states the co-operation is three-fold, in that the State Mission Boards go 50-50 in paying salary and travel of the

Superintendent. In all cases the local Missions Committee is left free to plan and direct the work in the Association. At no time have our activities been colored or directed by the Home Mission Board. As a committee living and serving in our county, it is felt that we should know how to meet the needs of our country.

A Planned Program

For the last two years, your committee has laid out its work along well-planned and directed lines. In only two or three instances have we found that our plans were not well founded. We continue to study our field and to make humble and honest effort to plan for the needs. We have selected each year a number of things we believed should be done and made effort to reach those objectives. In several instances we passed our goals and in some we fell far short. Page 20 of the 1942-43 Annual of our Association outlines our program of work for the year of 1943-44. The year is history we are reporting our progress and failures for the year.

A Long Range Plan

We made every effort to make long range plans that would be followed year after year and with the thought that well-established churches would result. The establishment and sponsoring of missions by churches is long range. Some of these have been five years in coming into a degree of maturity while others did so in 12 months time. Pike Avenue Baptist Church at 22nd and Pike Avenue, North Little Rock, is an example of rapid development. They were organized as a mission Sunday School of Baring Cross Church in May, 1943, with 29 members and in June, 1944, were organized into a church with 130 members to date and a weekly budget of \$100.00.

Four new churches were organized last year from missions of the churches. Some had been missions for as long as five years—others for a year or so. The idea is for the sponsoring church to guide and nurse the unit until there is sufficient leadership and finance in the unit to become a self-supporting church. We now have 19 such units in the county and in one instance we have a mission Sunday School that operates a mission Sunday School. It has been a real joy to watch these missions grow into good substantial churches with full-time pastors and a well-directed program of work.

Again, we felt that all the missions and churches—70 or more in all—should have a full-time preaching ministry. We

are happy to report that in a fine measure all the 70 points in the county have the Baptist message each Lord's Day. We are not as yet able to see a full-time resident pastor in all communities, but we have seen a full-time preaching service in all of them. In some instances our Association has supplemented salaries and the results have always been gratifying.

Revival Meetings

In so far as possible we have made effort to conduct revival meetings in all the communities of our county. It has been a fine year of revival effort. However, we hoped to follow up with a continuous program of worship and service in each instance. We found it impossible to "pump enough life into a community in one revival meeting to last until the next revival meeting." Your committee believes that as important as revivals are, they must be followed by a continuous program of work. So we have made it a part of our work to keep a preaching and teaching program in all our missions and to assist in any way possible that such be maintained in all our churches.

Training Schools and Vacation Bible Schools

We have had a well-defined training program in co-operation with our Associational Sunday School and Training Union Organizations. Simultaneous and group schools have been held in both Sunday School and Training Union Work. Rev. Ralph Davis, Director of Training Union Work, and Rev. Guy S. Wilson, Superintendent of Sunday School Work, did a good job in Training last year. The Woman's Missionary Union were of great help in Vacation Bible School Work, especially with the colored churches. There has been a beautiful spirit of co-operation with all the existing Associational organizations. In the case of Vacation Bible School Work we had the Sunday School Board and the Religious Education Department of our State Convention and the Pulaski County Associational Organizations and the Home Mission Board all co-operating together. The results were gracious in the 30 or more Vacation Bible Schools. No one organization or unit wanted the credit for the good work. The results were main objective for Christ's Glory. If there is any desire of one group being envious or even "bossy" toward any other organization, we have not detected it. It has been a beautiful picture of Christ-like co-operation.

**Not Primarily A Promotional Program, Yet We
Do Promote the Co-operative Program**

We made it one of our points of work to promote the co-operative program in all our churches . . . BECAUSE all the work of the Kingdom waits on our stewardship at this point. We have discouraged direct missions where there was a tendency to neglect larger missions. However, we have found there is ample people and money to be distributed in local and direct missions and in so doing we encourage and promote co-operative missions. We are happy to note that our total co-operative contributions for 1943-44 will pass the \$40,000 mark. That exceeds by far any other association in our state. At the same time thousands of dollars have gone into direct or local missions . . . BUT not at the cost of co-operative missions.

Recommendations

Your committee held a fine meeting recently and made a careful study of our needs and we offer you the following long range program of work to be followed in 1944-45 for your consideration and adoption:

1. Establish additional missions and chapels, all to be church sponsored and church directed. We now have 19; had 21 at the peak. Four new churches were organized last year from missions.

2. Where possible, advisable and agreeable, organize additional churches. We have three or four privileged areas that are not mission fields, BUT are fields where good organizations must be set up from the beginning. We believe that special attention should be given these fields next year and for several years. To purchase desirable and well located lots in Oak Forest, on Park Hill and on South Broadway area and and perhaps on Cross near Third and Fourth Streets, looking to the erection of good buildings on these lots is a long range work. We believe special attention should be given such areas this year. The office of the Superintendent will make the surveys and make reports to your committee from time to time about such areas.

3. Continue our beautiful co-operation in all existing Associational Organizations. We hope, through the Budget Committee, that you will allocate each organization sufficient funds to adequately promote their work and we urge these organizations to put their best in their monthly programs and group meetings.

4. Look to the organization of a school to training ministers and workers who are not privileged to go to college or seminary. This is to be done in co-operation with existing correspondence courses offered by our seminaries, but under the leadership of an approved faculty. All courses are to be accredited courses.

5. Personalize the co-operative program through schools of missions, bringing to our association each year a number of missionaries from all fields to be rotated among churches and to organize and plan mission study courses in all our churches.

6. Continue Vacation Bible School plans. Use summer field workers if they are available in co-operative effort as in previous years.

7. As a part of the Centennial Year program to win 1,000,000 people to Christ that we plan a simultaneous evangelistic campaign in April, 1945. Same to begin Easter Sunday, 1945. Each church to select own team of workers, make own plans for meeting, BUT that all churches hold their meetings simultaneously. THINK of 70 revival meetings in progress at the same time, with some 150 workers meeting each morning for breakfast and fellowship and prayer!! If wise, another could be held in the fall, say in September. If we win 2,000 people to Christ in our country next year GREAT STRESS MUST BE PLACED ON REVIVAL MEETINGS. EVANGELISM should be and must be the main work. A simultaneous effort will greatly strengthen us. We hope the Association will adopt a budget to allow at least \$1,000.00 to advertise these meetings.

8. Continue to help with leadership and finances, where possible and where needed any and all rural needs, to help all the churches in a full-time preaching and teaching ministry.

9. Promote the co-operative program and urge all churches to make regular contributions to the existing Associational program of work.

10. Intensify our work with colored leadership. Seek in every way possible to avoid race clashes and make available our talent and leadership to help our colored churches in teaching and training work. Encourage Vacation Bible School work among the Negroes.

Your committee would be happy to see all the colored churches—Baptist—conduct their revivals in April simul-

taneously with us. They could share in cost of advertising these meetings and would receive benefits of a great united effort to reach all people for Christ.

18. Time having arrived for report of the work of the Associational Woman's Missionary Union, Mrs. J. L. Fisk prepared and read the printed report below. The report was discussed in a very helpful manner by Mrs. C. A. Riley, Field Worker for Associational W. M. U. Organization.

WOMEN'S MISSIONARY UNION REPORT

"That the generation may know." Psa. 145:6

It has been said that life is a one-way street and that we will not pass this way again. The opportunities we now have will never be our's again. This generation is the only one we will be permitted to contact personally and we are responsible to God for how we meet the opportunities that are our's.

The training of our women and young people in Christian living is of vast importance. Through our programs we have taught missions and the Bible way of giving, not only to our own groups but to the peoples in the Negro churches we sponsored four Daily Vacation Bible Schools in four of the Negro churches.

There have been four new W. M. S. organized this Associational year and 14 new young people's organizations, eight churches with full-graded unions, 68 W. M. S. completing study classes, 46 young people completing classes. There is an increase in tithers. The amount given to all causes is \$36,511.45.

There seems to be a greater interest among the people in our Association than ever before. Our greatest difficulty is to find leaders for these young people. The harvest is white, yet we find the laborers few.

26. R. O. Barker prepared the report on State, Home and Foreign Missions. It was read by Taylor Stanfill and Robert Ricketson of the Foreign Mission Board discussed the report. Adopted as follows:

MISSIONS

State, Home and Foreign

The present war has somewhat hindered our foreign mission program, making mission work difficult in several foreign lands. We are glad to say that some of our missionaries are beginning to return to their respective fields of service, more than 43 have already gone back. There are now 300 on foreign fields. After the war has ended the opportunities for missions for Southern Baptists will be the greatest they have ever been. We have more money, our MISSION BOARDS are out of debt, a great host of well trained and experienced workers stand ready to go at the given word. Let us pray "The Lord of the Harvest" will bless and guide our every effort.

Home and State Missions have reached an all-time high. We now have the funds to carry on adequate work. In the main we have enough workers, but still we need many more for the task is great. There are five million foreigners in the bounds of the Southern Baptist Convention. One million five hundred thousand Spanish, 700,000 French, 600,000 Italians, 225,000 or more Indians living in seven of our Southern States. At the close of 1943 there were 288 workers in these departments. We now have 35 City Missionaries working in the larger cities of our Southern States.

Our State Mission Program has also enjoyed a good year. We now have four District Missionaries:

Rev. J. I. Cossey of Northeast District.
Rev. E. F. Cox of Northcentral District.
Rev. Jones of Southeast District.
Rev. Zimmerman of Southwest District.

We do not have a missionary for Northwest District at present. However, two or three men are now being considered by the Mission Committee of the Executive Board. We have two "Soldier Centers" to work with our Soldiers. Rev. Pearl Stockton is Director of the Center in Little Rock, and Rev. Ford Gauntt is Director of the Center located in Fort Smith.

Our State Board is also helping 21 Associations to employ Associational Missionaries. The proposed budget to be

presented to the coming Convention calls for a bigger and better program than ever. It also calls for an assistant to work with Dr. B. L. Bridges in our State Mission work.

Many of our Associational Missionaries report fine things of their mission work during the past year. With the wonderful opportunities before us, may we continue to pray that the Holy Spirit will lead us and bless us as we as Baptists carry out the "Great Commission."

27. The report of the Committee on Christian Education was made by Otto Sutton, who discussed it briefly.

CHRISTIAN EDUCATION

How pressing is this need upon our people today. All education is incomplete without a knowledge of God for we read in the Word of God "the beginning of wisdom is the fear of the Lord," and in much of our learning today the opposite of this is the vogue.

If the churches today occupy their places of being a blessing to the world, our society must be permeated with men and women of Christian education. The command of Christ to "teach all nations" has a broader meaning than just to evangelize and to teach them to observe all things whatsoever He has commanded us means more than the fundamentals of our church ordinances, as important as these be, but a system of education that will have its influence in the various fields of world endeavor.

Free thinking and investigation in education can be carried on and great truths in science can be discovered without denial of God's Word. Men do not have to be infidels to be learned. This can be proven a force by education that is Christian. Learning and the Bible is not in contrast but are in the deepest harmony with each other. How different America would be today if more of its people had been educated in Christian institutions or if the institutions began a Christian would have remained such.

Christian education is especially vital in the realm of training our young men and young women in Christian work.

Arkansas Baptists maintain two colleges for this purpose: Ouachita College at Arkadelphia, a standard four-year college offering degrees in the Arts and Sciences and special stress is laid on the training of ministerial students. Central College at Conway is a standard two-year college for girls, which through the years has done wonderful work. More interest should be taken in these institutions by all Baptists of Arkansas to insure the highest type of Christian education to our young people of Arkansas. They need your prayers and support, both morally and financially and by so doing we can send forth men and women that shall make a great impact for Christianity on a Godless and darkened world.

28. L. H. Roseman, Chairman of the Committee to report on Stewardship, presented a good report on this vital subject. He spoke briefly to the report and it was adopted.

STEWARDSHIP

Your Committee on Stewardship wishes to make the following report:

As the reports come in to the Association this year from our churches of Pulaski County it is probable that they will show the largest offerings for the past year in the history of our Association. This, at least, will be true of many of our churches.

We believe that this splendid record of the giving of our people is due not merely to the fact that our people are making more money than they did a few years ago, but also to the fact that during the past two or three decades our denomination has sponsored a program of education and training in Christian stewardship. We are now reaping the results of that training and teaching.

In all of our Sunday School literature, our Training Union literature, our Women's Missionary programs, and in our Baptist Brotherhood movement, this teaching, which had been for so long neglected, has been constantly kept before our people. Our children have been taught that a tenth of what they earn belongs to the Lord. And as these children have grown up and are now earning wages and salaries they are, many of them, following the teaching which they learned in childhood. Many of our older people have come to enjoy the blessings of faithful stewardship.

The Apostle Paul, in writing to the Philippians, commended the saints of Philippi because they had "sent once and again unto his necessity." And then he said: "Not that I desire a gift: but I desire fruit that may abound to your account."

We believe this to be the highest motive of Christian stewardship, the bearing of fruit in the life of a believer. Our church treasury may show a balance, or it may show bills yet unpaid. But the obligation and privilege of every member of the church is the same in either case, as stated in Paul's first letter to the Corinthians: "Upon the first day of the week let every one of you lay by him in store, as God hath prospered him." And in so doing he is producing the fruits of a grateful heart that are abounding to his account.

We believe that the teaching and training that has been so worthily begun in Christian stewardship should be continued with increasing emphasis and earnestness. Many of our people have not as yet been brought into the blessings of faithful stewardship, and our children and young people are looking to us to teach them the right ways of the Lord. We must not fail them.

We believe that Christian stewardship is not confined to the giving of our money, but that it includes the whole of life: Our time, our talents, our abilities, and our capacities for service. And believing as we do that we shall all be called upon to give account before the Judgment Seat of Christ for the way in which we have spent our lives here upon earth as Christians we urge our people to be faithful stewards of all that God has given to us, whether of money, or of time or of other resources held by us in sacred trust.

29. P. A. Stockton, director of the Baptist Soldier Center made the following report of the work for the last year, introduced some members of the armed forces and spoke to his report.

SOLDIERS' CENTER

"Be not forgetful to entertain strangers for thereby some have entertained angels unawares." (Hebrews 13:2.) The policy of your workers at the Soldiers' Center at Little Rock is to promote Christian fellowship and evangelism among the men in the armed forces.

Our responsibility is great, but we have a great message of love, grace and hope and we are trying to give this message to these men. Many hours have been spent at Camp Robinson making contact with the men there. Our services rendered to the men is varied. Groups of women are taken to the camp each week to alter clothing, and to make curtains for day rooms and mess halls.

Each Tuesday night we have a Bible Class at the Center with an average attendance of 75. Each Sunday at 12:30 lunch is served free to the men. Many contacts and lasting friendships have been made with Christian people.

Our Sunday afternoon services are well attended, and many souls have been saved and lives rededicated to the service of the Master.

The W. M. U. organizations of the county have co-operated in a splendid way, bringing sandwiches and cakes to be served to the boys. Many of the boys attend service and young people's meeting at the various churches, often taking part on the programs. Most every Sunday one or more soldiers supply for some church or mission in the city. One Sunday seven soldiers were sent from the Center for these services.

We are in no way trying to compete with other organizations in the city, but we are trying to win the lost to Christ. We work from 12 to 14 hours every day. Our report for the Associational year is as follows:

30. M. E. Faulkner read a wonderful report on Temperance and Prohibition. He asked Clyde C. Coulter of the Anti-Saloon League of Arkansas to speak. The report and speech were well received.

REPORT ON PROHIBITION AND TEMPERANCE

1. Drunkenness is steadily increasing in Arkansas and throughout the nation, wherever liquors are sold openly. The liquor "termites" are weakening the very foundations of homes, churches and the nation itself. Drs. Haggard and Jellinek, of the Yale University School of Alcohol Studies state there are now 13,000,000 women and 27,000,000 men drinking liquors in America. Among these are 600,000 to 2,500,000 CHRONIC ALCOHOLICS — hopeless drunkards; and to ranks of these victims of alcohol are being added 40,000 to 60,000 each year. The situation is tragic and growing worse.

2. One of the great PUBLIC HEALTH problems now is ALCOHOLISM. When the SOURCE of some dread disease is discovered by medical science, immediate action is taken to destroy that source. Alcoholism is a disease—a HORRIBLE disease—which destroys body, mind and soul. The Christian conscience DEMANDS the complete destruction of the foul, disease-breeding, crime-breeding traffic in alcoholic beverages. Every Christian should feel and possess a burning hatred against it and join heartily, militantly in helping to destroy it.

3. Both juvenile and adult delinquency have reached an alarming stage throughout the nation, including Arkansas. J. Edgar Hoover, Director of the F. B. I., states, " * * * A creeping rot of moral disintegration is eating into our nation." What a challenge to every decent man and woman, especially to Christians!

4. Drinkers in America spent for liquors last year SIX BILLION DOLLARS—\$46.00 for each man, woman and child in the nation — \$16,438,000 for EACH DAY in the year. CRIME caused by liquors cost SIX BILLION MORE. These enormous amounts stagger the imagination. At one million dollars per year, it would require 12,000 years to pay what BOOZE cost America in 1943. And we sing "God Bless America"!

5. Drinkers in Arkansas spent for liquors last year nearly \$29,000,000. And AUTO accidents caused by liquors cost the state \$1,500,000 plus. CRIME caused by liquors cost

the state \$30,700,000 plus. Those three items alone total more than SIXTY MILLION DOLLARS. The WETS "holler" much about the REVENUE from liquors. The "revenue" to Arkansas from liquor in 1943 was \$3,000,000 plus. Each \$1.00 of "revenue" from liquors COST above \$19.00!

6. Washington, D. C.—WOMEN: In 1932, with prohibition, 104 women were arrested in Washington for drunkenness. In 1942, with legal liquors, 2,106 women there were arrested for that offense. An increase of above 2,000 per cent!

In an Arkansas town in 1932 there were 118 arrests for drunkenness. In that same town in 1942 there were 604 arrests for that offense. Similar increases are reported throughout the state and the nation.

7. We urgently recommend that our pastors preach against drinking and against the man-polluting, soul-destroying racket. We denounce and condemn the liquor traffic in its entirety. We urge all members of our churches to abstain from drinking beer, whiskey, wine, etc., and from buying it or selling it, or renting property for the manufacture or sale of it. We urge them to prayerfully and courageously work for the extermination of this ENEMY OF THE INDIVIDUAL, THE HOME, THE CHURCH, THE NATION, and of OUR LORD.

8. We recommend that our pastors and people co-operate vigorously in local option elections in their counties, etc. Local leaders who want to start such campaigns should write to Mr. Clyde C. Coulter, Superintendent of the Anti-Saloon League of Arkansas, Donaghey Building, Little Rock. He will furnish petitions, helps, etc., and work with you in planning and carrying through your campaigns.

9. We commend the Anti-Saloon League and its efficient Secretary, Mr. Clyde C. Coulter, and we recommend that our people and our churches give financial support to the League.
