CONSTITUTION

As Amended at 1933 Session and 1943 Session

Article I.—NAME

The name of this body shall be Pulaski County Baptist Association.

Article II.—OBJECT

The object of this Association shall be to aid the churches in their divinely appointed work of spreading the Kingdom of God throughout the whole world by every Scriptural means.

Article III.—MEMBERSHIP

Section 1. This Association shall be composed of messengers from regular Baptist Churches, which are in sympathy with the principles and purposes of this Constitution and desire to co-operate with this Association, who shall be entitled to seats upon the presentation of letters from their churches or other satisfactory evidence of their appointment.

Section 2. Each church shall be entitled to three messengers, with one additional messenger for every fifty members or major fraction thereof above one hundred.

Section 3. Messengers from churches desiring to affiliate with this Association shall present to the Association petitionary letters or other evidence setting forth the Articles of Faith on which the churches were organized together with satisfactory evidence of the regularity of their organization. They shall be received into the Association only by unanimous vote as cast by the body.

Article IV.—AUTHORITY

This Association shall never exercise any legislative or ecclesiastical authority over any church, nor shall it in any way interfere with the rights and absolute independence of the churches of Christ.

Article V.—OFFICERS

Section 1. The officers of this Association shall be a Moderator, Vice-Moderator, Clerk and Treasurer, who shall be elected at the opening of each annual session by a majority of all the votes cast at such meeting. Provided, however, that the Moderator shall not be eligible to serve more than two consecutive terms.

Section 2. The Moderator shall preside at all sessions of the Association or call some one to occupy the chair temporarily in his absence, and may exercise the same privilege of discussion as any other member of the Association.

Section 3. The Clerk shall keep a correct record of all the proceedings of the Association and shall superintend the printing and distribution of the Minutes of each session as he may be directed by the Association.

Section 4. The Treasurer shall receive all funds of every kind entrusted to his care, and shall disburse the same upon the order of the Association and shall make an itemized report of all such funds to the Association before the close of each annual session.

Article VI.—ASSOCIATIONAL BOARD

Section 1. The Associational Board shall be composed of one lay member, elected by each co-operating church, together with the pastors of such churches, and the officers of the Association and the Superintendents of W. M. U. work. Seven members of said Board shall constitute a quorum to transact business, after notice has been given all members of the Board of such meeting.

Section 2. This Board shall co-operate with the churches in this Association in informing and arousing the churches in gathering and disbursing of funds for all of the causes fostered by this Association and shall transact all of the business of the Association in the interim of the annual meeting of the Association.

Article VII.—MEETING

This Association shall meet annually on Monday night after the second Sunday in October at 7:30 o'clock.

Article VIII.

This Constitution may be amended at any annual session of the Association by a two-thirds vote of the messengers present at any annual meeting, provided that the substance of Article IV shall never be abrogated.

RULES OF ORDER

(BY-LAWS)

As Amended at 1933 Session

- I. Each Session shall be opened and closed with prayer.
- II. The following shall be the order of exercises:
 1. Body called to order by the Moderator or, in his absence, by brethren in the following order of precedence: Clerk, treasurer, pastor of entertaining church.
 2. Devotional Service.
 3. Presentation of letters and the enrollment of messengers.
 4. Permanent organization.
 5. Introductory Sermon.
 6. Petitionary Letters.
 7. Reception of visitors, corresponding messengers from other bodies and introduction of new pastors.
 8. Appointment of program committee which shall recommend a schedule for all reports and other matters to come before the body, subject to the Association's approval.
 9. Appointment of committees as follows: (1) Associational Missions; (2) State Missions; (3) Home Missions; (4) Foreign Missions; (5) Colleges and Schools; (6) Religious Literature; (7) Bible (Sunday) Schools; (8) Ministerial Education; (9) Orphans' Home; (10) Christian Stewardship; (11) Hospitals; (12) Woman's Work; (13) Young People's Work; (14) Digest of Letters; (15) Obituaries; (16) Resolutions; (17) Finance; (18) Temperance; (19) Nominations.
- III. Every speaker shall rise and address the Moderator. In discussion all personalities shall be avoided. No one shall speak more than twice on the same subject, without special permission from the Association.
- IV. Mell's Parliamentary Law shall be the standard in deciding questions of parliamentary practice.

V. The minutes of the preceding day shall be read and approved at the meeting of each morning session and at close of the Association meeting.

VI. Such offerings may be taken at the annual meeting of the Association as the body may direct.

VII. These by-laws may be amended at any regular meeting by a two-thirds vote of those present, or suspended by unanimous vote.

VIII. The Associational Board shall meet monthly at such time and place as the Board itself may determine.

IX. A doctrinal sermon shall be preached during each annual session at such an hour as each program committee shall provide.

X. The second night of the Association shall be known as B. Y. P. U. night, and a program planned accordingly in connection with Associational B. Y. P. U.

PROCEEDINGS

FIRST EVENING

Monday, October 14, 1946

1. The THIRTY-FIRST ANNUAL SESSION of the Pulaski County Baptist Association was called to order by the Moderator, Rev. W. H. Hicks, at 7 P. M., Monday, October 14, 1946, in the auditorium of the Baptist Tabernacle Church, with a large attendance of messengers and visitors present. Thirty-nine of the fifty-three churches of the Association were represented, their letters in the hand of the clerk.

2. Messengers and visitors sang "Leaning On The Everlasting Arms," and "Trust and Obey," led by Virgil Tyler with Mrs. L. H. Roseman at the piano.

3. Rev. R. C. Otey led in prayer. Rev. E. S. Ridgeway read from Thes. 4:13-18; Rev. 20:1-6; 11-15, and Thes. 5:1-4, giving us some thoughts on the facts, purpose and time of the resurrection and led in prayer.

4. Rev. W. H. Hicks elected Moderator by unanimous vote cast by clerk. Rev. W. O. Vaught, Jr., elected as Vice-Moderator; Rev. John Collier elected Clerk; Rev. Taylor Stanfill elected Treasurer.

ASSOCIATIONAL SUNDAY SCHOOL REPORT

The Associational Sunday School organization conducted 10 Associational Sunday School rallies this year, with an average attendance of approximately 150 Sunday School workers each meeting. There were some 10 or 12 selected teams that visited in the majority of our churches in behalf of our Southwide associational program, its slogan being, "Into Every Church With This Program." The purpose of such meetings was to increase the enthusiasm toward developing and training more of our workers. There have been more training schools this year than before, with an approximate of 1,000 to 1,200 awards given for study courses.

We now have enrolled in our Sunday Schools between 12,000 to 15,000 people, meeting with the 53 various Sunday Schools and 12 mission Sunday Schools in the county. There has been between 500 and 800 additions to our churches of our Sunday School effort.

Our Vacation Bible School work this year, under the leadership of Mrs. George Cornell, has been most gratifying. We have 41 schools that have been reported in the county with an approximate enrollment of 1,500 and an average attendance of 1,100, and a great number of boys and girls have made professions in Christ as a result of these schools.

Recommendations

We recommend that this organization continue its co-operation with our State and Southwide Sunday School organizations, co-operating with the following dates: Simultaneous Associational Sunday Meeting, January 22, 1947, Southwide Sunday School Study Course month in April, 1947, our Arkansas Baptist Assembly, Siloam Springs, Ark., July 1st through 9th, 1947, and State Sunday School Convention to be held sometime in October of next year.

Also, we recommend that the Association enter into and co-operate in a big training school, to be county-wide the last week of February. We will co-operate with the State Religious Department in this school, the date being the week of February 23rd.

May we adopt the Southwide slogan, "Into Every Church With This Long Range Program."

BAPTIST STATE HOSPITAL

Our Baptist Hospital at Little Rock has experienced its greatest year from the standpoint of volume of work and service rendered. For the year ending June 30, 1946, 10,240 patients were treated, not counting the out-patients, 1,004 which were part pay cases and 594 free cases. Of the free cases, 105 were ministers and their dependents. The hospital spent on free hospitalization \$58,399.89 of which \$6,955.76 was for ministers and their families, and \$51,444.13 for others. The gross business done for the year was \$759,550.80; the gross expense was \$686,925.30. These figures do not show depreciation.

The Woman's Auxiliary to the Baptist Hospital and the State W. M. U. have made substantial gifts in linens, fruits and other supplies, as well as money to the amount of \$7,757.15 for charity. For the first 25 years of the life of the hospital the women of the State donated \$125,125.00 for charity.

Our hospital annex, called Pine Lake Annex, located 17 miles from Little Rock, is gradually getting to the point where income will meet expenses. We are operating an up-to-date convalescent hospital and a farm at our annex. The farm furnishes supplies for the hospital.

The greatest grief of our Baptist Hospital at present is the fact that the hospital is compelled to turn away many who apply for admittance for medical treatment of surgery because of the lack of room. If the convention votes approval, our hospital will begin construction of a \$750,000 addition to take care of the thousands of people that are turned away each year from our doors.

The hospital is in constant need of new classes of student nurses. The times for beginning these classes for the future are September and February. The various Women's Missionary Societies over the State have co-operated with the hospital in encouraging girls to enter training for nursing which has made it possible for the hospital to have one of the largest classes of student nurses ever applied for the next February class.

With a full-time hospital pastor and a student secretary who directs the Christian activities of the nurses, a definite effort is made to make and keep the hospital as a great Christian institution.

DENOMINATIONAL LITERATURE

We, your committee on the Arkansas Baptist, and other denominational literature, bring our report to the Pulaski County Baptist Association. We are pleased to report that your paper has had another successful year. We wish to call your attention to several things of interest at this time.

There has been a gratifying increase in the circulation of the paper. We now have 28,308 subscribers. Knowledge of kingdom progress and matters of interest to Baptists are almost entirely learned from the Baptist state paper. Our children need this paper to counteract some of the obscene literature that they come in contact with from time to time.

The best plan for the circulation of the Arkansas Baptist among our Baptist people is (where all things are equal) to put it in the budget of our churches.

What can be said of the Arkansas Baptist can be said of the "Commission" which carries the news of our work on the foreign field.

Then we also have that wonderful little messenger, "Home Mission," that is packed with inspiring news of the work being done by our missionaries and others on the home field.

Last and by far the greatest literature in all the universe is our blessed Bible. No other, yea, all other reading matter, cannot take the place.

REPORT ON PROHIBITION

LIQUORS AND PUBLIC HEALTH: Top-ranking medical authorities state there are now about fifty million Americans above 15 years old who drink alcoholic liquors. Even MODERATE drinkers run the risk of becoming CHRONIC ALCOHOLICS. There are already more than 3,000,000 of them in the United States; and it is estimated that 600,000 of them are WOMEN. A wise philosopher once said that, when the WOMANHOOD of any nation begins to break, that nation's doom is sealed. Better look out, America! Better look out, Arkansas!

LIQUOR TRAFFIC AND CRIME: During 1945, there were 1,565,541 MAJOR CRIMES committed in the United States—one every 20.1 seconds—more than 4,000 every day. The number of lesser crimes was far greater. There is even now an INCREASE in crime throughout the country, including Arkansas; and a large part of crime is caused by beer, whiskey, etc.

LIQUOR AND ECONOMICS: During 1945, Americans spent for "legal" liquors, \$7,770,000,000.00. Some authorities estimate that at least half that much was spent for bootleg liquors. Let's be very conservative and say the TOTAL, for both "legal" and illegal liquors was \$9,000,000,000.00. Other authorities estimate that CRIME caused by liquors costs the American people \$6,000,000,000.00 each year. These two items ALONE make the staggering sum of FIFTEEN BILLION DOLLARS per year. Added to that is the cost of lost earning power caused by liquors, and also the cost of ill health and of deaths caused by LIQUORS. These items together total SEVERAL BILLIONS MORE in economic loss to the people of the nation annually, caused by alcoholic drinks. In the light of these facts, the "revenue" argument becomes absurd—SENSELESS—insulting to intelligence!

IN ARKANSAS: During 1945, Arkansas drinkers spent for "legal" liquors, \$49,461,000.00; added to that, CRIME caused by liquors cost the people of the State, \$30,700,000.00; and auto accidents caused by liquors cost Arkansas people, \$2,394,000.00; TOTAL cost to the state's citizens, chargeable to liquors, \$82,555,000.00.

Arkansas' loss in money spent for liquors and in costs caused by liquors amounted to far more than THREE-AND-ONE-HALF TIMES the State's expenditures for EDUCATION. Truly this is DISGRACEFUL and DANGEROUS situation.

LIQUORS AND YOUTH: The youth of the nation are being debauched and destroyed by thousands. Girls under 21 years old arrested for prostitution and other sex offenses increased 64.7% in 1943; and there was further increase in 1944, and again in 1945. The largest number of males arrested throughout the nation in 1944 and again in 1945, when put in age groups, were 17 years old. The picture is a DARK one! It must be CHANGED! Every Christian should PRAY for the WILL and for the ABILITY to be USED in the warfare against this great DESTROYER of the bodies, minds and SOULS of men, women, and children.

LOCAL OPTION ELECTIONS: As this report is being prepared, we have had 10 county-wide local option elections in Arkansas in 1946, and eight of them voted DRY. Three townships have voted this year, two of them voting dry! Since January 1, 1943, (the date Act No. 1 became effective), 34 counties have voted, and 29 of them went dry. Six other counties, that voted BEFORE 1943, (under the OLD setup), voted out hard liquors, and two of those also voted out beer. A total of 35 counties, with six partly dry, and 29 BONE DRY. Real progress has been made, and it is the earnest hope and prayer of Arkansas Christians that much more may be made. EVERY CHRISTIAN should gladly help. Write the Anti-Saloon League, Little Rock, for information and suggestions.

REPORT ON THE CO-OPERATIVE PROGRAM

A Baptist church is a venture in co-operation. The church is composed of redeemed individuals voluntarily banded together for greater effectiveness in evangelism, missions, Christian education, worship, and service. Such co-operation was begun under the direction of Christ who taught the dis-

ciples in groups and sent them out two by two for winning. Under the direction of Paul and the other apostles, the growth and spread of the church increased.

In our day and situation, the spirit of co-operation has brought Baptist churches together into associations, state conventions, and the Southern Baptist Convention. The co-operative program of Southern Baptists has proved itself in the promotion of evangelism, education, training, and worship. In missionary giving it has enabled each contributor to invest a part of every dollar in a world-wide enterprise according to the pattern of the Great Commission. One-half of the mission dollar remains in Arkansas to promote missions, education, and evangelism in our state. The other half is used for similar south-wide and world-wide purposes. Such a system enables every contributor to spend his money under the direction of trained and informed leaders all over the world. The participation and distribution is more complete and intelligent than could possibly be the case without such a co-operative program.

With such a plan and with world needs so acute, the present call is for every member to do his best for the sake of Christ. Surely this best is never less than the tithe of one's income which was the first scripture standard for co-operative giving. Every day it matches the resources of a great people against the needs of a spiritually destitute and devastated world.

WOMAN'S MISSIONARY UNION REPORT

We have an extra good report to bring to the Association because of the new interest and zeal shown by the presidents and chairmen of the local societies, for which we are indeed thankful. More and more are we depending upon the local chairmen for the promotion of all our work in Pulaski County and, in our united efforts, "to the uttermost parts of the world."

We have at present 32 Missionary Societies, 20 Y. W. A.'s, 34 G. A.'s, 20 R. A.'s, and 20 Sunbeams, making a total of 126 organizations in our County Union, giving through our local churches about \$85,000.00 for all causes, both missions and local expenses.

Through our Community Missions we have had about 50 converts in Vacation Bible Schools and other services conducted by the local societies. We have a full time field worker for the County, Mrs. C. A. Riley.

Our total disbursements are \$282.17, including a gift of \$100.00 to Miss Amanda Tinker, Missionary to Africa, leaving a total balance of \$17.83 of the \$300.00 given to us by the Association.

REPORT ON CHRISTIAN EDUCATION

Christian education is education that has Christ at its center and Christian service as its objective. Arkansas Baptists believe that all education is incomplete that does not provide for the knowledge of God and of God's Word. We also believe that means should be provided for the young people of our churches to receive a thorough education and preparation for life in an atmosphere that is Christian and under instructors who are in sympathy with the teachings of the Word of God.

And in keeping with these convictions Arkansas Baptists are vitally interested in our colleges and theological seminaries.

Southern Baptists maintain three great theological institutions: Southern Baptist Theological Seminary, in Louisville, Ky.; Southwestern Seminary in Fort Worth, Tex., and New Orleans Baptist Theological Seminary, in New Orleans, Louisiana.

Southern Seminary is our oldest theological institution. It enrolled nearly 1,000 students last year. This enrollment includes the women of the training school, who attended classes at the seminary. A total of 679 men were enrolled preparing for the Christian ministry. One hundred and sixty-seven received degrees at the close of the school session last Spring. This was the largest class in the history of Southern Seminary.

Southwestern Seminary enrolled 1,195 students last year. Of these, 658 were enrolled in the School of Theology, and

486 were enrolled in the School of Religious Education. In May of 1946, 148 students received degrees.

New Orleans Theological Seminary is the youngest of our theological institutions, but it is making steady progress and is rendering valuable service to the churches of our Southland. Pulaski County Baptist Association is maintaining an extension school of New Orleans Seminary in the Second Baptist Church, Little Rock.

Arkansas Baptists have two colleges under Convention control, and give recognition to Southern Baptist College at Pocahtontas.

Ouachita College is our only four-year college. More than 600 students enrolled last year at Ouachita. Of these, more than 100 were ministerial students. Probably no college anywhere has so large a proportion of ministerial students as does Ouachita. And yet, we recognize that the main purpose of Ouachita College is to train Christian workers, and especially ministers. Arkansas Baptists are now engaged in a campaign to raise \$1,000,000 for Ouachita. The Baptists of Pulaski County will do all within their power to make this campaign a success.

Central College is our only school for girls, and the only school of its kind in the State. It had an enrollment last year of over 100 girls. Prospects for this year are for an even larger enrollment. Dr. W. L. Whipple came to Central College as president in June of this year. He is making a fine impression on Arkansas Baptists, and will undoubtedly lead Central on to greater achievements in the days ahead. Central is greatly in need of stronger financial support, if it is to be operated in a way to bring honor and respect to Arkansas Baptists.

Arkansas Baptists should pray for and support our own schools now as never before.

FOURTH SESSION

Thursday, October 17, 1946—7 P. M.

32. The fourth, and final, session of the Pulaski County Baptist Association was called to order by Moderator W. H. Hicks. Congregation sang "We're Marching to Zion" with the choir from Pulaski Heights Baptist Church, under the direction of Miss Wandasue Patterson. Miss Christine Raetz at the organ. Rev. W. C. Halsell led in prayer. Special music by the Pulaski Heights choir.

33. Rev. Jack Hogue led in our devotional by reading Matt. 28:10-20, and Acts 1:1-9. Led in prayer.

34. Rev. Taylor Stanfill read report on Budget and Program. Motion that report be adopted. Second. The surplus fund mentioned in the report was discussed by Rev. L. H. Roseman, stating the need of mission points in Park Hill and Oak Forest and that this money could be used to purchase lots in these additions, urging the churches of the Association to continue giving as able. Report adopted.

SUGGESTED PROGRAM OF WORK

Thursday, October 3, 1946, about 20 of the pastors of our Association met at the First Baptist Church, North Little Rock, and planned a suggested program of work for the Associational year—October 1, 1946 through September 30, 1947. As chairman of the Program and Budget Committee, I submit the following as Program of Work, as suggested by our pastors.

(I) Encourage our churches to establish new units of work, either as chapels, mission stations or branch Sunday schools, wherever possible and needful. Keep before our people always, that it is a church centered, church directed and church promoted program. We now have 10 such points in the county. There is immediate needs in Cammack Village, Park Hill and Oak Forest. It has been suggested that the Second Baptist Church operate in Cammack Village, the First Baptist Church in Oak Forest and the churches on the North side of the river combine their efforts to build a good work on Park Hill. These are all privileged sections.

(II) Look to the organization of new churches as wisdom may direct.

(III) Continue our co-operation with the existing Associational organizations—Sunday School, Training Union and Woman's Missionary Union. There is a suggested allocation of funds from our budget to implement this co-operation.

(IV) Urge all of our pastors and ministers, who have not had the privilege of complete college and seminary education, to attend the Extension school of New Orleans Theological Seminary. About 30 are now enrolled in the two classes held weekly. Give support by prayer, encouragement and finances to this school.

(V) Conduct Simultaneous Evangelistic Campaigns in all our churches and Mission Chapels, beginning April 6, 1947. Each church to arrange for personnel of their meeting, BUT all of the churches and Mission Stations or Chapels to have the meetings running simultaneously. Associational wide publicity for this campaign.

(VI) Provide funds for and leadership in, Vacation Bible Schools to be held in as many of the Negro churches and Missions as needed, and as opportunity affords, through the Sunday School organization of the County.

(VII) Do all we can to strengthen the work in rural and village churches, where needed and where opportunity affords, by supplementing the salaries of pastors, assisting in training schools, conducting revival meetings, promoting Christian fellowship. Five rural churches now receive pastors supplement. Assist where we can in budgeting these churches and in conducting Stewardship Revivals. Churches desiring this supplement to apply for same.

(VIII) Promote the Co-operative Missionary Program of Arkansas and Southern Baptists.

PROPOSED BUDGET

At the same meeting, the pastors made the following suggested budget. It is not large. We do not encourage a large Associational budget, as our program is a church centered and church directed and church operated program. Some of our churches have large sums in their budget for this work—Local Missions.

STATE MISSIONS

We have five state missionaries working at large throughout the State. They are: H. A. Zimmerman, Arkadelphia; C. C. Roberts, Bentonville; Virgil Defreece, Batesville; James Fitzgerald, Jonesboro, and E. D. Estes, Pine Bluff. You can see that these men are evenly distributed so that any section can speedily get in touch with them.

Missionary John Stratton is laboring among the churches and missions in Newton County. W. B. O'Neal is doing the same thing in Marion County.

The State Board is helping to pay the Associational missionaries in all but three or four associations. In some instances the State Board is carrying the heavier end of the load. It is doing its best to see to it that every needy section has a Baptist missionary available.

The State Mission Board is helping about 15 weak church organizations to build church houses. It is also helping to pay pastors where a pastoral field has been formed with weak churches, and where associations are willing also to help finance a small church. In some instances the State Board is giving some help where revivals are being conducted at mission points.

The Challenge for Home Missions in Our Day

Dr. J. B. Lawrence, secretary of the Home Mission Board, says: "The strategic point of approach to this world task is the homeland. Keep the homeland evangelized and mobilized for service and we have the hope and the assurance of a world evangelization."

Dr. W. R. White, in his "Re-Statement of Missions," says that world conditions have left a displaced and upset homeland, that Rome is going after the Negroes, that Russia is championing the cause of little nations, and that the challenge to Home Missions today to evangelize the homeland is great.

The man without a chance, underprivileged, cut off by language barriers, tenant farmers segregated by poverty, migrant workers, those in isolated sections, and those in congested city areas, Negroes, and others in our homeland, challenge the best there is in us.

The spirit of the Home Mission Board is to "help where help is needed." Many of our strongest churches in the South were mission stations operated by the help of Home Missions in an earlier day. Many churches now helped by the Home Mission Board will grow into large and potent churches. A little help now means a great future for some community.

The Home Mission Board has work among Spanish-speaking Americans (Mexicans), Indians, French, Italians, Chinese, and other language groups. There are mission centers, city and rural missions, work among the deaf and among Negroes, Cuban missions, and work in Panama, Costa Rica, and the Canal Zone, in addition to miscellaneous special mission enterprises. The Home Mission Board sponsors work in 587 churches and missions and needs 327 more. It has 700 missionaries and workers and needs 389 more. It needs more than two million dollars for mission properties and over a million dollars a year for operation. The Board is now housed in its own building at 161 Spring Street, N. W., Atlanta, Ga.

Keep Home Missions vigorous as a good springboard for world evangelization.

Foreign Mission Board

During the first 100 years of its existence, the Foreign Mission Board of the Southern Baptist Convention appointed 1,347 missionaries to foreign fields, including 44 appointed at its April meeting this year. These missionaries have wrought

in 20 nations. At the close of the century five and a half million Baptists were represented by five and a half hundred missionaries.

As we enter the second century we face open doors and many adversaries. Some of the favorable conditions are accelerated transportation; a more compact world; a more intimate acquaintance with the whole world; the appeal from various nations for preachers, teachers, medical missionaries, and others who can help rebuild wrecked countries; growing literacy; opportunities for giving relief, and the failure of human philosophies and religions.

We have a three-fold task: Relief, Reconstruction, and Reinforcement. Our most urgent task is that of ministering in the name of Jesus to needy millions around the world. Multitudes of people are starving and next year will be too late to save them. It is estimated that approximately half of the world, or more than a billion people lack sufficient food. We must answer to Christ at the judgment for our failure to feed the hungry, clothe the naked, shelter the homeless, minister to the sick, visit those in prison. The Southern Baptist Convention in its recent meeting in Miami launched a program for three and a half million dollars for Relief and Reconstruction. The immediate response justifies the belief that this amount and more will be provided this year.

In war devastated areas there is a tremendous job of rehabilitation, providing buildings and equipment for churches, schools, hospitals, missionary homes, and we must in every land reinforce our missionary program. Instead of 560 missionaries, we should have 1,000 missionaries on the field within the next 12 months. Men and money are greatly needed for this urgent task. The Foreign Mission Board joins heartily in the decision of the Miami Convention to fortify and enlarge the Co-operative Program.

Already Southern Baptist missionaries are returning to China as rapidly as transportation facilities across the Pacific and in China enable them to get to their fields. Some 40 missionaries have already gone to China. Dr. Rankin, executive secretary of the Foreign Mission Board, left late in June, accompanying Dr. Baker James Cauthen, regional secretary for the Orient, in order to make a first-hand survey of desperate needs and to reinforce the missionaries and the national Christians in their relief and rehabilitation program. Dr. George Sadler recently spent some time in Europe and the Near East and we shall be getting missionaries back to our several mission fields in Europe as rapidly as conditions permit. Dr. Everett Gill is spending two years in residence

in Latin America and our fellow-workers in that great continent of opportunity write us about the glorious service which he is rendering. Every mail brings a plea from Africa—a new continent since the people in that land have become acquainted with the whole world—begging for reinforcements. Our missionaries there are breaking under the terrific load. In every one of our mission fields we desperately need more missionaries.

We are face to face as never before with the choice—one world or none. Life and death have been set before us. The choice is ours between the annihilating power of the atomic bomb or the redemptive power of the Cross of Christ. Which shall it be?

39. The closing message of the Associational meeting was brought by Dr. R. Paul Caudill, Pastor, First Baptist Church, Memphis, Tennessee. Dr. Caudill has recently returned from a five-week tour of the Mission stations in South America and brought us some valuable information on this work.
